In accordance with 24 CFR 58.43 and 58.70, this notice shall satisfy two separate but related procedural requirements for activities undertaken by the City of Detroit.

# **REQUEST FOR RELEASE OF FUNDS**

On or about June 2, 2025, and in accordance with 24 CFR 58.71, the City of Detroit will submit a request to the U.S. Department of Housing and Urban Development (HUD) Detroit Field Office for the release of 1. HOME Funds authorized under Title II of the National Affordable Housing Act of 1990 (HOME), and 2. Project Based Vouchers from the Detroit Housing Commission, to undertake a project known as:

Project Title: Brewster Wheeler I, II & III: 631, 651, and 671 Alfred Street, Detroit, Michigan.

For the Purpose Of: This project is a portion of the multi-phased Brewster Wheeler project in the City of Detroit. The project includes new construction of three buildings for a total of 159 units of housing. Brewster Wheeler I, located at 671 Alfred Street, includes new construction of one four-story mixed-use building containing 53 units of housing, a community space on the first floor, 23 parking spaces, and an accessible pavilion. Brewster Wheeler II, located at 651 Alfred Street, includes new construction of one four-story mixed-use building containing 53 units of housing, a community space on the first floor, 23 parking spaces, and an accessible pavilion. Brewster Wheeler II, located at 651 Alfred Street, includes new construction of one four-story mixed-use building containing 53 units of housing, a community space on the first floor, and 30 parking spaces. Brewster Wheeler III, located at 631 Alfred Street, includes new construction of one four-story mixed-use building containing 53 units of housing, a community space on the first floor, and 30 parking spaces. Brewster Wheeler III, located at 631 Alfred Street, includes new construction of one four-story mixed-use building containing 53 units of housing, a community space on the first floor, 27 parking spaces, and an accessible pavilion.

Mitigation Measures/Conditions/Permits: 1. Remedial action must be employed under the guidance of the Michigan EGLE to address onsite contaminants. 2. Noise attenuation measures will be incorporated into the building. 3. Historic Preservation: The Unanticipated Discoveries Plan will be followed. 4. Hours of construction shall be in accordance with local code to mitigate temporary construction phase noise.

## **ENVIRONMENTAL CERTIFICATION**

The City of Detroit certifies to HUD that Ms. Julie Schneider, in her capacity as Certifying Officer consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the recipients to use Program funds.

#### **OBJECTIONS TO RELEASE OF FUNDS**

HUD will accept objections to its release of fund and the City of Detroit's certification for a period of fifteen (15) days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Detroit; (b) the City of Detroit has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the U. S.
