LEGISLATIVE UPDATES

With the help of key stakeholders, advocates, and City departments, my Language Access Ordinance (LAO) is now law! We did it!

The LAO, which makes permanent the language access services that City has already been providing under Executive Order 13166, requires all City departments that provide "direct public services" to have a language access plan on file with the Civil Rights, Inclusion, and Opportunity Department (CRIO) and to have a designated staff member to carry it out. The passage of this ordinance is in alignment with Detroit's status as a Certified Welcoming City and further helps build more inclusive and accessible communities where all residents, regardless of their English Language Proficiency, can be fully engaged in the programs and services in which they may be eligible. Thank you to my colleagues for their unanimous support!

We are still tackling Truck Routes!

I am continuing to work with the Administration to enact a Truck Routes Ordinance (TRO) to protect our infrastructure and improve our quality of life. We are currently working on key definitions and finalizing the process by which a street may be designated a truck route. As we continue to advance this critical piece of legislation, know that I will provide updates via our social media and enewsletter as they become available.

Further, Team GSR has also been committed to helping our residents build power through capacity trainings. In May, we organized a Mutual Aid 101 Training because while I will always fight for you at the Council table, I know government alone won't save us. Thank you to Detroit Hispanic Development Corporation, Detroit Southwest Pride, Unity in Our Community TimeBank, and Urban Neighborhood Initiatives for serving on our panel and sharing your expertise!


MONTHLY D6 MEETING AT CLASS ACT DETROIT
