

Budget: \$330,000



PLAN AREA

- 2.36 square miles
- Bounded by Kingsville St, Hayes St, Harper Avenue, I-94, and Kelly Rd
- Comprised of four (4) neighborhoods:
 Moross-Morang, Denby, Yorkshire Woods,
 and Outer Drive-Hayes
- Total population is approx. 16,000 people*





PILLARS



HOUSING & NEIGHBORHOOD STABILIZATION

Explores opportunities for housing and vacant land (re)development



COMMERCIAL & ECONOMIC DEVELOPMENT

Explores opportunities commercial and small business development



ENVIRONMENT & THE PUBLIC REALM

Explores opportunities for public space improvements and climate mitigation



Explores opportunities for safety improvements and multi-modal connectivity

- ENGAGE A MINIMUM OF 500 RESIDENTS/STAKEHOLDERS IN THE PLAN AREA BETWEEN IN-PERSON AND VIRTUAL ACTIVITIES

- SOLICIT COMMUNITY AND STAKEHOLDER FEEDBACK ON PLAN RECOMMENDATIONS
- 4 CREATE A COMMUNITY SUPPORTED AND INFORMED VISION AND ACTION PLAN
- ALIGN ENGAGEMENT & DENBY/WHITTIER NEIGHBORHOOD PLAN WITH THE UPDATING OF THE CITY-WIDE MASTER PLAN
