## FREE SEWER REPAIR FOR 97 NEIGHBORHOODS

### YOU MUST BE ELIGIBLE TO APPLY

1. Your Property must be located in an eligible neighborhood. Review the eligible neighborhoods at website: [detroitmi.gov/psrp](http://detroitmi.gov/psrp). ONLY listed neighborhoods qualify. paragraph text
2. Households must be at or below 80% of the Area Median Income (AMI) as determined annually by HUD. (See Chart below\*)
3. You must live in a single-family residential structure (1-4 units).
4. You must be able to demonstrate damage directly related to the June 25-26, 2021 flood event.
5. Your property cannot be in a floodplain.
6. You must be able to demonstrate that there is no duplication of benefits.

### IF YOU DO NOT MEET ALL 6 REQUIREMENTS YOU ARE NOT ELIGIBLE FOR THE PROGRAM

### REPAIR SERVICES

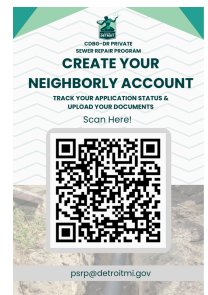
- Clean and inspect private lateral sewer line
- Repair or replace private lateral sewer and install cleanout
- Install backflow water valve on private lateral sewer
- Install backflow water valve and sump pump with overflow
- Disconnect downspout and install extension, where possible to a proper place of disposal.

**CDBG Disaster Recovery Private Sewer Repair Program  
Required Documents**

- **Proof of Income for each member of the household 18 years and over (ALL ITEMS BELOW)**

**2023 and 2024 Tax Returns  
or**

**2 months bank or credit union statements accompanied with the following listed below:**

**Copy of 2 most recent months' paycheck stubs, if applicable  
2 years W-2s, if applicable**

**Other items may include:**

**Social Security Award Letter SSA Form 1099  
Pension Statements MDHHS Award Letters**

- **Affidavit of Non-Employment Income (document provided by City of Detroit)**

**Signed, dated, and notarized for each household member 18 years of age and older who is not employed and/or has no income.**

**Self-Employed**

- **Self-employed applicants must submit: two years tax returns with Schedule C showing amount earned two months bank statements; and, a notarized profit & loss statement**

Proof of Impact - Insurance Claim, DWSD Claim or FEMA Claim (Approval or Denial Letters)

- **Proof of residency**

Photo identification for each member of the household 18 and over:

- **Current driver's license, State ID card or City of Detroit ID card**

- **Proof of ownership**

Must show ownership for at least six (6) months at the time of application:

- **Recorded Warranty Deed, Quit Claim Deed or Land Contract (Warranty Deeds must accompany all recorded Quit Claim Deeds)**
- **Death and Marriage Certificates must be provided, if applicable**
- **Probate documents or Divorce Decree must be provided, if applicable**

- **Proof of Current Property Taxes**

Current, paid property tax bill (city or county) or Approved and current payment plan with the Treasurer's Office with evidence of at least one (1) consecutive payments in accordance with the agreed upon terms of the plan. Or proof of enrolling /applying to Tax Assistance Program

- **Proof of Occupancy**

Copy of current utility bill or copy of merchant's statement.

Credit card bills, delivery notices or other first-class mail addressed and received within the last 2 weeks.

- **Proof of Fire or Hazard Insurance (or waiver) (document provided by City of Detroit)**

- **Copy of current fire hazard home insurance policy**

- **Birth Certificates, or guardianship papers, for each dependent residing in the house**

Religious, hospital or physician's certificate showing date of birth or

Adoption record or

Previously verified school records or

Affidavit from a parent
