

# Celebrating 15,000 Expungements

On June 10, 2025, PCS held a celebration recognizing 15,000 expungements for Detroit residents. Over 200 attendees participated in the event, including clients, court officials, members of the Detroit Police Department and Michigan State Police, and invited guests.

Guest speakers included Deputy Mayor Melia Howard, Police Chief Todd Bettison, Corporation Counsel Conrad Mallett, and Presiding Judge of the 3<sup>rd</sup> Circuit Court criminal bench, Hon. Donald Knapp. Clients Autumn Thompson and Richard Walker also spoke at event, sharing their experiences with PCS and letting the audience know how expungement has impacted their lives.


Chief Bettison spoke about the importance of PCS' work for the Detroit community.

#### A STORY OF REDEMPTION

Marvin Smith was released from prison in 1996. After serving his sentence, Smith's criminal record followed him for decades, which created obstacles in his life. He said there was a time when he and his wife applied to rent a house, but he was rejected due to his felonies.

"My wife was looking at me like, because of your felonies, we can't proceed on this," Smith said. "I've been looked at like a failure because of these felonies." However, Smith heard about Project Clean Slate on the news and registered for the program. He found the expungement process easy and organized. Through PCS, Smith was able to get his record expunged. "I learned my lesson," Smith said. "I have a family, four children, a lovely wife, belong to a church, have a good job, and nice house. Everything is beautiful now."

#### DAVID CAHANA, PROJECT MANAGER

David began working for PCS in January 2024. David has extensive experience in the nonprofit field, specifically working with the



homeless community. He was drawn to PCS by his desire to help give people a second chance.

"The folks we work with have paid their debts," David said. "The fact that people are still being punished long after these things happen is unfair, so I think it's important that we remove those barriers so that everybody has the same chances."

As Project Manager, David works behind the scenes to facilitate and improve the processes PCS relies on. He enjoys working with the team and said one of the highlights of his time here has been watching the program grow.
