## RESOLUTION SUPPORTING DIVERSE ATHLETIC OFFERINGS AT THE PROPOSED PISTONS' WATERFRONT MULTISPORT COMPLEX

- WHEREAS Detroit is celebrated for its rich sports tradition, proudly hosting four professional teams across the major North American leagues; and
- WHEREAS The City is further renowned for its unique sports achievements, being one of only twelve U.S. cities to host teams in all four major sports and the only U.S. city where its MLB, NFL, NBA, and NHL teams all play within the downtown district; and
- WHEREAS A coalition led by Pistons owner Tom Gores and Vice Chair Arn Tellem has put forward a bold bid to return a WNBA franchise to Detroit in a proposal that hinges upon transforming the former Uniroyal industrial site along the Detroit River into a mixed-use athletic campus, featuring a dedicated WNBA practice facility and a team headquarters, alongside publicly accessible youth sports courts and fields for basketball, volleyball, soccer, football, and lacrosse;<sup>2</sup> and
- WHEREAS The bid reflects a convergence of women's sports momentum, community priority and urban revitalization. The initiative embeds sports infrastructure into the heart of the community and may serve to address longstanding inequities in youth sports access; and
- WHEREAS The vision for the facility promotes athletic excellence, community engagement, and youth development, <sup>3</sup> and the inclusion of a broader range of diverse sports and recreational offerings would provide transformative opportunities for young Detroit athletes, ensuring equitable access to experiences and professional pathways, potentially contributing socioeconomic advancement; and
- WHEREAS Youth participation in organized sports has been shown to promote critical outcomes such as psychosocial development, emotional resilience, leadership, and academic success, as youth athletes exhibit stronger social skills, greater self-esteem, better mental-health outcomes, and are more likely to graduate from college compared to non-participants; <sup>4</sup>and
- WHEREAS This serves as a critical opportunity to provide young Detroiters with a diverse array of athletic experiences, including tennis, sailing, rowing, track and field, and other such programs that not only promote physical fitness, but also cultivate teamwork, discipline, and community engagement, while offering pathways to Olympic competition, collegiate scholarships, and professional advancement, thereby significantly contributing to the personal growth, academic success, and long-term well-being of Detroit's youth; NOW, THEREFORE BE IT
- **RESOLVED** That the Detroit City Council strongly advocates for the inclusion of **world-class indoor tennis** courts in the proposed waterfront multisport complex, capable of hosting United States Tennis Association (USTA) tournament-level events, to promote competitive tennis, youth participation, and community engagement in this globally recognized sport; **BE IT FURTHER**
