Opening Remarks

Mr. Rising stated that Public Act 182 (PA 182) requires the City to hold two revenue estimating conferences annually (one in February and another in September) to set the City's official economic and revenue forecasts. The principals of the conference must be the Chief Financial Officer for the City of Detroit (Jay Rising); the State Treasurer or his or her designee (Eric Bussis); and a third person affiliated with a public entity with experience in economic forecasting and revenue projection (George Fulton).

He noted the revenue estimates approved today will set the revenues the City uses develop the FY 2026 budget and FY 2026–FY 2029 Four Year-Financial Plan.

Election of Chair

Mr. Rising stated that under PA 182, the Conference must elect a new chair for a one-year term. Motion to elect Dr. George Fulton as the new chair of the Revenue Estimating Conference. Motion moved and supported. The Conference approved Dr. Fulton as the new chair.
