Detroit City Council President Pro-Tem Tate requested the Legislative Policy Division to provide a report regarding the presence of tax abatements within the boundaries of the City of Detroit's District 1 during the period of 2023 through 2025.


After conducting a review of city records, including the Detroit Economic Growth Corporation (DEGC) database, City of Detroit Assessor's Office property tax records, and available City Council resolutions, the following information lists the active and current tax abatements in District 1 for the years 2023, 2024, or 2025.

This memorandum provides an overview of development projects within the boundaries of District 1 that were associated with tax abatements during the period 2023 through 2025. A total of 26 projects were examined; 18 were found to have active tax incentives during the review period, while 8 had abatements that ended prior to 2023. Many of the active incentives are long-term PILOT agreements tied to affordable housing developments, while a small number of PA 381 Brownfield TIFs remained active until their termination in 2024.

- Total projects reviewed: 26
- Projects with active tax incentives (2023–2025): 18
- Projects with incentives ended prior to 2023: 8
- Most PILOT agreements are tied to LIHTC affordable housing developments with 50-year terms.
- Several PA 381 Brownfield TIF projects were active until their termination or completion in 2024.
