RESOLUTION TO RECOGNIZE THE INDIGENOUS PEOPLES' DAY CELEBRATION

- **WHEREAS;** In 2017, the Detroit City Council officially recognized the second Monday in October as Indigenous Peoples' Day; and
- WHEREAS; The Detroit City Council acknowledges that the City's land originally belonged to the Council of Three Fires (Ojibwe, Odawa, and Potawatomi); and
- WHEREAS; The history of the land now known as Detroit, formerly and still known to some as Zagajibiising and Waawiyaatenong to the Anishinaabe in what is now known as the state of Michigan, whose name is derived from the Anishinaabe term for the great lakes, Michigami, includes the neighborhood of Delray that contains burial mounds common throughout the Mississippi River Valley, Canada and Mexico, connecting indigenous people to each other in ways that are not typically disclosed through contemporary histories; and
- WHEREAS; Indigenous Peoples' Day is a day to reflect upon the ongoing struggles of Indigenous Peoples on this land and to celebrate the thriving cultures and values that Indigenous Peoples contribute to our community; and
- **WHEREAS**; To celebrate Indigenous Peoples' Day, the City of Detroit will be hosting celebration in Hart Plaza on October 13, 2025; and
- WHEREAS; This event builds on the work of former District 6 Council Member Raquel Castañeda López, whose office championed the 2017 City Council resolution recognizing Indigenous Peoples' Day; and
- WHEREAS; It is the City Council's hope that year's celebration will not be just a one-time return to a tradition once held at Hart Plaza more than three decades ago, but the continuation of a cultural staple that endures for generations to come; NOW THEREFORE BE IT
- **RESOLVED;** That the Detroit City Council hereby recognizes that the City of Waawiyatanong/Detroit will be hosting an Indigenous Peoples' Day Celebration on Monday, October 13, 2025, at Hart Plaza from 12:00 p.m. until 6:00 p.m.; **NOW BE IT FURTHER**
