## RESOLUTION IN SUPPORT OF CREATING A POLICY TO ENSURE SUSTAINABLE WATER ACCESS FOR DETROIT URBAN FARMERS

- Detroit's urban farms are vital community assets that address food insecurity and strengthen the city WHEREAS by prioritizing community, spurring local economic development, promoting demonstrated sustainability practices, and fostering community resilience and autonomy; and
- WHEREAS The city's local urban farms provide profound economic, social and environmental value through the revitalization of vacant land, the practice of soil stewardship, the expansion of green space, the unification of community members and the promotion of sustainable agricultural practices; and
- WHEREAS Urban farmers in Detroit encounter significant challenges in accessing reliable and affordable water sources, which can pose a potential threat to the long-term sustainability of Detroit's urban farms and the wealth of benefits they provide to our residents; and
- Many local urban farms operate on formerly residential vacant lots from which the city has WHEREAS disconnected municipal water service making reconnection prohibitively expensive, which absent affordable options, will in turn force some farmers to rely on insufficient, unreliable, or potentially contaminated sources for water:2 and
- Reconnecting many of Detroit's urban farms to the municipal water system often requires farmers to WHEREAS hire a master plumber and a Detroit Water and Sewerage Department (DWSD) engineer to locate shut-off valves and to access water or re-tap water mains,<sup>3</sup> and
- The cost of installing a dedicated water connection can exceed \$10,000, and recent quotes from WHEREAS master plumbers have been as high as \$21,000.4 Even when water service is restored, farmers incur significant ongoing expenses associated with their water-bill obligations;<sup>5</sup> and
- WHEREAS A collaborative, multi-departmental, community stakeholder-inclusive approach is necessary to develop a comprehensive and effective policy that addresses the unique needs of urban farmers and to ensure the responsible and effective use of City resources; and
- A collaborative policy development team may explore the feasibility of working with the Water WHEREAS Consortium to advance pre-existing efforts<sup>6</sup> to ensure Detroit farmers have access to water and could further explore the use of innovative methods that involve capturing rainwater through green stormwater infrastructure (GSI) projects and nature-based solution typology; <sup>7</sup> and
- WHEREAS The effective management of water resources can be further enhanced through a range of proven conservation practices and infrastructure solutions, as well as complementary practices such as irrigation water management and soil health testing, which are recognized as high-priority practices that align with state conservation goals, and which can be incentivized through targeted policy;8 NOW, THEREFORE, BE IT
- RESOLVED That the Detroit City Council, in recognition of the immensely valuable contributions of local urban farms to the health, resilience, and food sovereignty of Detroit residents, hereby urges the relevant City departments—including, but not necessarily limited to, the Detroit Water and Sewerage Department (DWSD), the Planning and Development Department, the General Services Department
