

# Housing and Revitalization Department

#### **Section 3 Income Information**

Individuals seeking to certify as a Section 3 worker (or Targeted Section 3 Worker) shall submit evidence (using Worker Certification Form) to their employer and the City of Detroit Housing and Revitalization Department (HRD), as requested, verifying that the individual meets the requirements as a Section 3 worker (or Targeted Section 3 Worker).

Use the individual's hire date to determine if the individual has met the income limit when hired (5 years or less), unless the individual currently meets the income limit based on the individual's place of residency (not project location). The income charts below are updated every year by July.

For your convenience, refer to the charts (1 through 11) below for Wayne and surrounding counties in southeast Michigan and few counties in northern Ohio. As a reminder, the employee's income is based on the county where the employee lives.
