Request for LPD to Provide a Report on Potential Revenue Sources to

Increase the Salaries of Rank and File Detroit Police Officers

As the City of Detroit has known for some time, attrition among the rank and file at the Detroit Police Department far exceeds the national average due to the disparity in the pay for our officers and officers from most other departments across the Nation. Thus, I am requesting that LPD provide a report which outlines potential revenue sources to increase the starting pay and average pay for DPD's rank and file to the national average.

The report should outline the difference in pay for DPD and the national average and quantify the amount of funding needed based on current DPD employment levels. The report should also include exploring a requirement for developers to pay a portion of the tax abatements they receive, equal to the projected cost of City services for the development over the life of the abatement, into a fund dedicated to increasing the pay of rank and file DPD officers.

Request for the Legislative Policy Division to Provide a Report on the Fiscal

Impact of Reducing Parking Fines for Expired Meters and No parking Violations

As a result of the City of Detroit paying off the C-Note Bonds, parking revenues are no longer pledged to any debt and no longer have an effect on the Plan of Adjustment. Therefore, I am requesting that LPD, in consultation with the Municipal Parking Department and the OCFO, provide a fiscal analysis of reducing fines for expired meters and no parking from \$45 to \$30 with a 50% discount for fines paid within 10 days of issuance.

Also, again in consultation with Municipal Parking and the OCFO, I am requesting that the Legislative Policy Division provide a report which details the budgetary implications of making the requested changes while factoring in collectability and other variances in account receivables related to reduced fines and discounts for early payment.
