The Federal Highway Administration has awarded the City of Detroit Department of Public Works with the FY 2017 Advanced Transportation and Congestion Management Technologies Deployment (ATCMTD) Grant for a total of \$2,182,500.00. The Federal share is 50 percent or \$2,182,500.00 of the approved amount, and there is a cash match requirement of 50 percent or \$2,182,500.00. The total project cost is \$4,365,000.00. The grant period is September 1, 2017 through August 31, 2020.

The objective of the grant is to improve intersection safety and connectivity, and provide data analytics and video analytics to conduct evaluations of City of Detroit streets. The application submitted by the City of Detroit for the "Improving Safety and Connectivity in Four Detroit Neighborhoods" project has been selected for a grant award under the Fiscal Year (FY) 2017 Advanced Transportation and Congestion Management Technologies Deployment (ATCMTD) program. The complete list of ATCMTD awardees is attached.

As background, section 6004 of the FAST Act created a new section – 503(c)(4) – under title 23 of the United States Code (23 USC 503(c)(4)) to establish the ATCMTD program. The ATCMTD program provides funding to eligible entities to develop model deployment sites for large-scale installation and operation of advanced transportation technologies to improve safety, efficiency, system performance, and infrastructure return on investment. The ATCMTD program is funded at \$60 million per year for Fiscal Years 2016 through 2020, for between 5 and 10 awards per year. The FY17 solicitation for applications under ATCMTD was issued on April 12 and applications were received by June 12 requesting nearly \$363 million.

Please provide a contact in the Division to assist in finalizing the award agreement with Detroit. An important first action is to explore the potential for using a Local Public Agency (LPA) agreement for providing the Federal ATCMTD funds to the project, versus a direct Cooperative Agreement between Detroit and FHWA (through the Office of Acquisition and Grants Management). A final statement-of-work, based on the application requesting \$2,182,500, will need to be negotiated with Detroit. A preliminary kickoff meeting, to include FHWA-HQ/Division staff and the awardee to discuss these issues will be coordinated with the Division POC.

C. WHEREAS, the deployment of technologies will: reduce costs and improve return on investments, including through the enhanced use of existing transportation capacity; deliver environmental benefits that alleviate congestion and streamline traffic flow; measure and improve the operational performance of the applicable transportation network; reduce the number and severity of traffic crashes and increase driver, passenger, and pedestrian safety; collect, disseminate, and use real time transportation-related information to improve mobility, reduce congestion, and provide for more efficient and accessible transportation; monitor transportation assets to improve infrastructure management, reduce maintenance costs, prioritize investment decisions, and ensure a state of good repair; deliver economic benefits by reducing delays, improving system performance, and providing for the efficient and reliable movement of goods and services; or accelerate the deployment of vehicle-to-vehicle, vehicle-to-infrastructure, autonomous vehicles, and other technologies.

The FHWA intends for these model technology deployments to help demonstrate how emerging transportation technologies, data, and their applications, which also link to Beyond Traffic 2045, can be effectively deployed and integrated with existing systems to provide access to essential services and other destinations. This also includes efforts to increase connectivity to employment, education, services and other opportunities; support workforce development; or contribute to community revitalization, particularly for disadvantaged groups: low-income residents, persons with visible and hidden disabilities, elderly individuals, and minority person and populations.

D. WHEREAS, the Recipient, pursuant to section 6004 of the FAST Act which sets forth the ATCMTD program, has requested that the FHWA enter into an agreement to develop a model deployment site for large scale installation and operation of advanced transportation technologies project entitled "Improving the Safety and Connectivity of Four Detroit Neighborhoods" described in Attachment A, hereinafter referred to as the "proposal"; and

E. WHEREAS, the FHWA approved the proposal and determined the proposal to be eligible for participation in the program. See approval memorandum, Attachment B, entitled "Grant Award Selection Under the ATCMTD Program" dated "October 11, 2017".

NOW, THEREFORE, the Recipient, and the FHWA hereby agree as follows:

1. Funding. Once the project agreement is authorized in FMIS, the Recipient shall be reimbursed for allowable costs incurred in the performance of work under this Agreement in an amount NOT TO EXCEED \$2,182,500 in ATCMTD Program Funds. The Recipient agrees to meet its minimum 50 percent matching funds (\$2,182,500), in accordance with applicable requirements. FHWA will consider the following funds or contributions as a local match for the purpose of this program: non-Federal funds, toll credits under 23 U.S.C. 120(i); and non-monetary match that complies with the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards specified in 2 CFR Part 200, including section 200.306 of Part 200 on Cost Sharing or matching. Further State DOTs can use matching strategies available to them under the Federal-aid Highway program such as "tapering match."

I am pleased to inform you that your Byrne Justice Assistance Grant (JAG) application to the Michigan State Police (MSP), Grants and Community Services Division, has been selected to receive funding. 

This Fiscal Year (FY) 2017 Homeland Security Grant Program (HSGP) grant agreement is hereby entered into between the Michigan Department of State Police, Emergency Management and Homeland Security Division (hereinafter called the Recipient), and the

COUNTY OF MACOMB
(hereinafter called the Subrecipient)

I. Purpose

The FY 2017 HSGP supports state, local, and tribal efforts to prevent terrorism and other catastrophic events, and prepares the Nation for the threats and hazards that pose the greatest risk to the security of the United States. The FY 2017 HSGP provides funding to implement investments that enhance terrorism preparedness and serve to build, sustain, and deliver the 32 core capabilities essential to achieving the National Preparedness Goal of a secure and resilient Nation.

The purpose of this grant agreement is to provide federal pass-through funds to the Region 2 Homeland Security Planning Board (hereinafter called the regional board) through the Subrecipient, which has been voted and approved to act as the Fiduciary Agent on behalf and as a part of the regional board for the FY 2017 HSGP.

The HSGP is comprised of three grant programs, two of which are covered by this grant agreement:

State Homeland Security Program (SHSP): The SHSP assists state, local, and tribal preparedness activities that address high-priority preparedness gaps across all core capabilities where a nexus to terrorism exists. All supported investments are based on capability targets established in the Threat and Hazard Identification and Risk Assessment (THIRA) process, and gaps identified in the State Preparedness Report (SPR). Activities implemented under the SHSP must support national terrorism preparedness by building or enhancing capabilities related to preventing, preparing for, protecting against, or responding to acts of terrorism to be considered eligible. However, many capabilities which support terrorism preparedness simultaneously support preparedness for other hazards. Subrecipients must demonstrate this dual-use quality for any activities implemented under this program that are not explicitly focused on terrorism preparedness.

Urban Areas Security Initiative (UASI): The UASI program is intended to provide financial assistance to address the unique multi-discipline planning, organization, equipment, training, and exercise needs of high-threat, high-density urban areas, and to assist these areas in building and sustaining capabilities to prevent, protect against, mitigate, respond to, and recover from threats or acts of terrorism using the whole community approach. Activities implemented with UASI funds must support terrorism preparedness by building or enhancing capabilities that relate to the prevention of, preparedness for, protection from, or response to acts of terrorism in order to be considered eligible. However, many capabilities which support terrorism preparedness simultaneously support preparedness for other hazards. Subrecipients must demonstrate the dual-use quality for any activities implemented that are not explicitly focused on terrorism preparedness.

Urban Areas must use UASI funds to employ regional approaches to overall preparedness and are encouraged to adopt regional response structures whenever appropriate. UASI program implementation and governance must include regional partners and should have balanced representation among entities with operational responsibilities for prevention, protection, mitigation, response, and recovery activities within the region. Identified Urban Areas

must take an inclusive regional approach to the development and implementation of the UASI program and involve the contiguous jurisdictions, mutual aid partners, port authorities, rail and transit authorities, state agencies, statewide Interoperability Coordinators, Citizen Corps Council(s), and campus law enforcement in their program activities.

Allowable activities must comply with the *FY 2017 Homeland Security Grant Program Notice of Funding Opportunity* located at <http://www.fema.gov/grants>, align with Michigan's FY 2017 HSGP investments, clearly address capability targets identified in the THIRA and gaps noted in the SPR, and align to projects specifically approved by the Recipient.

Subrecipients must take a regional approach when determining the best use of FY 2017 HSGP funds. Subrecipients must consider the needs of local units of government, tribal governments, whole community and individuals, children and individuals with disabilities or access and functional needs, nonprofit communities, and applicable volunteer organizations in developing their HSGP projects and activities.

II. Statutory Authority

Funding for the FY 2017 HSGP is authorized by Section 2002 of the Homeland Security Act of 2002, as amended (Public Law 107-296), (6 U.S.C. § 603).

Appropriation authority is provided by the *Department of Homeland Security Appropriations Act, 2017*, (Public Law No. 115-31).

The Subrecipient agrees to comply with all FY 2017 HSGP program requirements in accordance with the *FY 2017 Homeland Security Grant Program Notice of Funding Opportunity* located at <http://www.fema.gov/grants>, the *U.S. Department of Homeland Security (DHS) Standard Administrative Terms and Conditions* located at <https://www.dhs.gov/publication/fy15-dhs-standard-terms-and-conditions>, the *FY 2017 HSGP Agreement Articles Applicable to Subrecipients*, and the *FY 2017 HSGP Michigan Supplemental Guidance* provided electronically by Michigan State Police, Emergency Management and Homeland Security Division (MSP/EMHSD). The *FY 2017 HSGP Agreement Articles Applicable to Subrecipients* document is included for reference in the grant agreement packet.

The Subrecipient shall also comply with the most recent version of:

1. 2 C.F.R., Part 200 of the Code of Federal Regulations (C.F.R.), *Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards* located at <http://www.ecfr.gov>.
2. 44 C.F.R., Part 10, *Environmental Considerations*

III. Award Amount and Restrictions

- A. The County of Macomb, acting as the Fiduciary Agent on behalf of and as a part of the Region 2 Board, is awarded \$4,518,751.00 under the FY 2017 HSGP. The grant agreement shall be administered based on the Subrecipient's policies and procedures, provided they conform to state and federal rules, laws, and/or regulations.
- B. The FY 2017 HSGP covers eligible costs from September 1, 2017, to May 31, 2020.
- C. HSGP funds may not be used to support the hiring of any personnel for the purposes of fulfilling traditional public health and/or safety duties or to supplant traditional public health and/or safety positions and responsibilities.
- D. At least \$1,129,688.00 of award funds must be dedicated towards Law Enforcement Terrorism Prevention Activities (LETPA). Activities eligible for use of LETPA-focused funds are outlined in the National Prevention Framework (and where capabilities are shared with the protection mission area, the National

Protection Framework) located at <http://www.fema.gov/national-planning-frameworks>. The Subrecipient must meet its minimum LETPA funding requirement for the FY 2017 HSGP.

- E. A maximum of **\$187,375.00** of SHSP award funds and **\$2,072,000.00** of UASI award funds may be used for personnel and personnel-related activities as directed by the *Personnel Reimbursement for Intelligence Cooperation and Enhancement (PRICE) of Homeland Security Act of 2008* (Public Law 110-412). In general, the use of HSGP funding to pay for staff and/or contractor regular time or overtime/backfill is considered a personnel cost. A definition of personnel costs is provided in Appendix C of the *FY 2017 Homeland Security Grant Program Notice of Funding Opportunity*.
- F. Exactly **\$18,737.00** of SHSP award funds and **\$207,200.00** of UASI award funds may be retained and used solely for management and administration (M&A) purposes associated with the SHSP and UASI portions of the HSGP award. M&A allowable costs are defined in the *FY 2017 Homeland Security Grant Program Notice of Funding Opportunity* located at <http://www.fema.gov/grants>.
- G. Exactly **\$89,004.00** of SHSP award funds and **\$984,200.00** of UASI award funds are allocated to Region 2 for use as the Region 2 HSGP Designated Funding Allocation. These funds will be used to support regional projects as determined by the Region 2 Homeland Security Planning Board.
- H. The following grant award funds are allocated by the Recipient, acting as the State Administrative Agency (SAA). The identified local governmental units are entitled to the reimbursement of allowable expenses from the Subrecipient in the amounts listed below:

**RESOLUTION SUPPORTING GOVERNOR WHITMER'S EXECUTIVE ORDER
CREATING A NEW MICHIGAN DEPARTMENT OF ENVIRONMENT, GREAT
LAKES AND ENERGY FROM THE CURRENT MDEQ**

WHEREAS, Governor Gretchen Whitmer has issued an Executive Order that creates a new Michigan Department of Environment, Great Lakes and Energy from the current Michigan Department of Environmental Quality (MDEQ). The renamed and restructured department would emphasize and pursue public policy directions that center on preserving and enhancing the State's natural resources, and especially on protecting safe drinking water; and

WHEREAS, Unfortunately, the Republican-dominated State House of Representatives subsequently passed a measure opposing the Governor's executive order, and the Republican-dominated State Senate can be expected very soon to do the same, based on an extensive history of Michigan GOP efforts to undermine environmental protections by attacking the integrity and competencies of the DEQ and its predecessor State Government departments; and

WHEREAS, In particular, the recent lame duck State Legislature passed inappropriate and ill-advised statutory restrictions on the DEQ that would subject environmental protection measures to onerous, unfair and result-oriented so-called environmental oversight panels that threaten Michigan's precious natural resources and public health by fiscally straitjacketing the DEQ and substituting the bottom line of corporate polluters' profits for sound environmental protection; and

NOW, THEREFORE, BE IT RESOLVED THAT the Detroit City Council strongly supports Governor Whitmer's Executive Order that creates a new Michigan Department of Environment, Great Lakes and Energy from the current MDEQ; and

BE IT FURTHER RESOLVED THAT copies of this resolution shall be delivered to the Governor, Detroit's State Legislative delegation, the City's Lansing lobbyist, the State's Congressional delegation, and media.
