2019 – 2020 BZA BUDGET ANALYSIS RESPONSES

1) For FY 2020, Salaries and Wages are decreasing by \$68,141 or 20.1%: however, Employee Benefits are increasing by 2,217 or 2.4% Please explain why this is occurring.

The decrease in Salaries and Wages is due primarily to the transfer of funding for one (1) Administrative Special Services Staff II position to Miscellaneous Professional Services and the re-allocation of a second Administrative Special Services Staff II position to an Office Assistant position.

2) For FY 2020, Professional and Contractual Services are increasing by \$54,210 or 55.8%. Please explain the reason behind the increase.

Professional and Contractual Services are increasing due to the transfer of funding for one (1) Administrative Special Services Staff II position to Miscellaneous Professional Services.

3) For FY 2020, Sales and Charges for Services are decreasing by \$35,000 or 280%. Please explain the reason for the decrease.

The increase in appeals, fueled by the Marijuana Ordinance, has peaked, and revenues are expected to return to pre-ordinance levels.

4) For FY 2020, BZA is losing one budgeted employee; please explain.

BZA is not losing a position. Funding for one (1) Administrative Special Staff Services II position was transferred from Salaries/Benefits to Miscellaneous Professional Services.



5) The BZA has one Zoning Inspector – Zoning Appeals budgeted for FY 2020. Does having one Zoning Inspector impede BZA's operations? How many additional employees would aid in improving BZA's operations?

In order for the BZA to fully execute mandated and professional services we would need two full time Inspectors, one Office Assistant and one Administrative Assistant. We currently have one full time Inspector, one Office Assistant and one Administrative Assistant position filled.

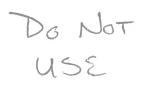

2019 - 2020 BZA BUDGET ANALYSIS RESPONSES

1) For FY 2020, Salaries and Wages are decreasing by \$68,141 or 20.1%: however, Employee Benefits are increasing by 2,217 or 2.4% Please explain why this is occurring.

The decrease in Salaries and Wages is due to the recommended elimination of one of the two yet to be filled Administrative Special Services Staff II positions. The increase in benefits is because of the reallocation of Administrative Special Services Staff II position which has no benefits, into an Office Assistant III position that has benefits, these of two budgeted positions in October 2018.

2) For FY 2020, Professional and Contractual Services are increasing by \$54,210 or 55.8%. Please explain the reason behind the increase.

Professional and Contractual Services are increasing due to the increase demand for Court Reporting Services mandated by ordinance for BZA transcripts.

3) For FY 2020, Sales and Charges for Services are decreasing by \$35,000 or 280%. Please explain the reason for the decrease.

The Department anticipates before the end of this fiscal year we will hit our target revenue that was projected for this fiscal year.

4) For FY 2020, BZA is losing one budgeted employee; please explain.

BZA is losing one budgeted employee because the Administration has recommended the action. BZA is NOT in support of losing this budgeted position.



5) The BZA has one Zoning Inspector – Zoning Appeals budgeted for FY 2020. Does having one Zoning Inspector impede BZA's operations? How many additional employees would aid in improving BZA's operations?

In order for the BZA to fully execute mandated and professional services we would need two full time Inspectors, one Office Assistant and one Administrative Assistant. We current have one full time Inspector, one Office and Administrative Assistant positions filled.

Re: Questions for the Non - Departmental Budget Hearing for FY 2019-20

- 1. The Administration's Proposed Budget has an increase in expenditures of nearly \$70 million. What is the source of this significant rise in expenditures? What is the justification for reducing expenditures by \$41 million in FY 2021?
- 2. Revenues are projected to increase by \$76 million over last year's adopted budget.

 What is the source of the increased revenue and were adjustments made during this year's Revenue Estimating Conference to provide a more accurate depiction of projected revenues?
- 3. Land Bank Operations expenditures are proposed to be \$13 million for FY 2020 and beyond. What is the source of the funds to cover this expenditure? Are the funds available for other uses if the Land Bank's MOU extension is not granted?
- 4. There is currently legislation moving in Lansing to allow online gaming in Michigan.

 Will such a measure impact the revenue received from the three Detroit Casinos? If so, what are the current estimates?
- 5. There is a proposed expenditure of \$7.5 million for Equipment Acquisition up from \$494,000. What does this expenditure represent and what is the justification for the significant increase?
- 6. Operating Services are proposed to increase by nearly 50% from \$33 million to \$49 million. What is the reason for the significant increase in this appropriation?

Re: Questions for the Mayor's Office Budget Hearing for FY 2019-20

1. Council offices field several calls every day, a number of which are directed to our offices from the Mayor's office.

How many staff are dedicated to handling constituent relations on behalf of the Mayor's office outside of District managers?

- 2. There is a \$780,000 or 11% increase in salaries and wages for the Mayor's Office. What does this increase represent and what is the source of the funding for the increase?
- 3. Professional and Contractual Services have more than doubled from \$177K to \$393K. What is the reason for this significant increase and why is it forecasted to continue in subsequent years? Also, what is the source of the funding since it is recurring?
- 4. There is a new appropriation for a Financial Empowerment Coordinator.

 What are the responsibilities for this position and what is the source of the funding?
- 5. There is no City funding appropriated under Motor City Makeover which had \$50K in funding last year through the City.

What is the reason for the lack of City funding for Motor City Makeover in the budget? Although there are donated funds for the initiative, is there money available to expand the programs and provide more resources/assistance to the community?
