

Dear Board of Ethics:

I am writing to request that I be appointed to The Board of Ethics, City of Detroit.

As Senior Pastor of Greater New Mt. Moriah Missionary Baptist Church in Detroit for the past 24 years and as a Minister of The Gospel for 41 years, I strongly believe that I am qualified to serve on this auspicious Board. I have governed my life and my Ministry on the Christian Ethics and Values of Jesus the Christ and God Almighty, Who has taught me to ALWAYS do what is right, what is just and what is fair. The Bible teaches us to follow "The Golden Rule," which says to "do unto others as you would have them do unto you." It further says, "He has shown thee O man what is good, and what does the Lord require of thee but to do justice, love mercy and walk humbly with thy God. Ethics is doing what is RIGHT based on the universal norms of goodness, mercy, kindness, mutual respect and tolerance for all.

Likewise, as a graduate of Morehouse College in Atlanta, Georgia (the alma mater of The Reverend Dr. Martin Luther King, Jr.) and Colgate Rochester Cozer Divinity School in Rochester, New York (also Dr. King's alma mater), where I received my Master of Divinity Degree, I learned firsthand how to apply Ethics to any given situation. One of Dr. King's Professors, Dr. Kenneth "Snuffy" Smith, who taught him Christian Ethics and Social Policy also taught me Christian Ethics and Social Policy. He taught me about Situational Ethics and how as a Christian Minister and Social Justice Activist, I must always ask the question, "Am I making my decisions based on my individual biases and opinions, or based on higher ethical norms and guiding principles that are universally accepted by civilized human society?" Dr. King himself said, "Vanity asks the question, 'Is it popular?', Politics ask the question, 'Is it expedient?', Cowardice asks, 'Is is safe?', and Ethics/Morality ask, 'Is it right?'. There comes a time in everyone's life when he or she must make a decision not because it is popular, expedient, or safe, but because it is RIGHT!!!" I have lived my life striving to make decisions that are ethically RIGHT. Dr. King's widow, Mrs. Coretta Scott King "adopted" me as one of her Sons in 1983 and further instilled Ethics and Values in me to NEVER forget my roots and ALWAYS treat everyone fairly and justly and fight for universal human rights for the oppressed and downtrodden.

Moreover, I have worked in Civil Government as Commissioner and President of The City of Los Angeles Civil Service Commission from 1989-1993, appointed by then Mayor Tom Bradley. I served during the City's turbulent Riots after the infamous 1991 Rodney King Beating by the Los Angeles Police. My Commission recommended Willie Williams from Philadelphia be appointed as the new Police Chief and helped bring stability to a City in Crisis and unrest. When I relocated to my hometown of Detroit in 1995, then Mayor Dennis Archer appointed me as a Commissioner of The Detroit Fire Commission. I served under Mayor Archer and was re-appointed by then Mayor Kwame Kilpatrick. I served honorably and ethically during my entire tenure.

Finally, my work in the Interfaith Community in Los Angeles and Detroit have also shaped who I am ethically in terms of my ability to work with The Jewish Community, The Muslim Community and other Faith Communities. I have learned that all religions share universal ethics and values of treating all people humanely, fairly and with basic kindness and decency. Together, these myriad experiences MORE than qualify me to serve humbly and ethically on The Board of Ethics for The City of Detroit.

About The Reverend Kenneth J. Flowers:

Rev. Kenneth J. Flowers Born on March 17, 1961 in Detroit, Michigan. He accepted Christ at the age of 8 and was baptized at the Dexter Avenue Baptist Church in Detroit by the late Reverend Dr. William R. Haney in May 1969. He accepted his Call to the Ministry at the age of 16 and preached his first sermon on April 12, 1978 Rev. Flowers was Ordained on August 17, 1983.

Educational Achievements:

Received his Bachelor of Arts Degree in Sociology, from Morehouse College, Atlanta Georgia, 1983. Received a Caribbean Summer Scholarship, to study human suffering and human rights in Haiti, 1982. Received a \$10,000 Thomas J. Watson Fellowship to study Christianity in West Africa for 7 ½ months, 1983-1984. Received his Master of Divinity Degree in Pastoral Ministry from Colgate Rochester Divinity School, Rochester, New York, 1987

Accomplishments:

In August 1987 - Relocated to Los Angeles, California He became the Director of the Ecumenical Black Campus Ministry at UCLA. He served as Associate Minister for Evangelism and Pastoral Care at Wilshire United Methodist Church. In 1989 he was called to Pastor Messiah Baptist Church in Los Angeles. Several new ministries were started, as well as a covenant relationship with Temple Israel of Hollywood.

As a community/social activist for human rights issues, Nationally and Internationally Pastor Flowers:

Spoke at World Trade Center in Johannesburg, South Africa, September 25, 1993. He was the Keynote Speaker at 1994 Martin Luther King Jr. Interfaith Breakfast, Los Angeles, California. He has traveled to Israel on (5) occasions to build better relations between Jews and blacks. He traveled to Seoul, Korea to build better relations between blacks and Koreans. He has preached in the Bahamas, Africa, Israel, and throughout the U.S. He maintained a closed relationship with Coretta Scott King until her death and continues to maintain a close relationship with Rev. Jesse Jackson & Congresswoman Maxine Waters.

In January 21, 1995 - Called to Pastor Greater New Mt. Moriah Missionary Baptist Church in his hometown, Detroit, Michigan and was installed in July 1995. Under his leadership many new ministries: The Mt. Moriah Community Development Corporation (a non-profit 501c.3) started. He was the first Pastor ever at Greater New Mt. Moriah to license and ordain females to the preaching ministry and to ordain females as Deacons. In 2007- Grand Opening of Newly built Banquet/Conference Center.

Other Accomplishments:

Rev. Flowers Chaired the Ecumenical Committee of the Council of Baptist Pastors of Detroit & Vicinity. He was the Keynote Speaker-World Sabbath Service of Religious Reconciliation, in which he addressed Christians, Jews, Muslim, Hindus, B'Hais, and others, and gave the Christian Response after the September 11th Terrorist Attack in an Interfaith setting. On April 12, 2003, the Reverend Flowers celebrated 25 years of Preaching the Gospel. The Gala, which was featured in Jet Magazine, was attended by Mrs. Coretta Scott King, the Reverend Jesse Jackson, the Reverend Dr. Benjamin L. Hooks, Michigan Governor Jennifer Granholm, and Detroit Mayor Kwame M. Kilpatrick. Noted TV/Radio Personality Tavis Smiley gave a video tribute to his friend. He presented a Paper at The Oxford Round Table at Exeter College in the University of Oxford, Oxford, England, August 15-20, 2004. His paper was entitled, "How the Black Church Has Impacted American Society to Bring About Social Justice Vis-à-vis the Modern Civil Rights Movement." He was Elected First Vice President of the Michigan Progressive Baptist Convention-July 2006. Rev. Flowers spoke at the Abraham Joshua Heschel School and at Congregation B'nai Jeshurun in January 2007 in honor of the Annual Martin Luther King Day Celebration. In 2007 he traveled with a Jewish delegation to Morocco, Africa to look at how Judaism has survived in an Arab/Muslim Country, June 24, 2007 to July 2, 2007. He also served on the National Committee as Coordinator for Religious Affairs for the 98th Annual Session of the NAACP, held in Detroit in 2007. From January 8, 2008 to January 16, 2008, Reverend Flowers participated in the African American Leaders Mission to Israel, (sponsored by American Israel Public Affairs Committee, funded by American Israel Education Foundation). While in Israel, Reverend Flowers was honored to be the first American Recipient of the Martin Luther King Jr. Israel Award, presented to him, on January 15, 2008, (the actual birthday of Martin Luther King Jr.), by Fellowship of Israel and Black America (FIBA), at the home and in the presence of the President of Israel, His Excellency, Shimon Peres. In January of 2009 Pastor Flowers received the Global World Peace Award at the Tenth Annual World Sabbath of Religious Reconciliation Service in Bloomfield, Hills, Michigan. In February of 2009, Pastor Flowers attended the Global Baptist Peace Conference in Rome, Italy where he taught a workshop on the Six Steps In Kingian Non-Violence.On May, 3, 2009, in Washington, DC., Pastor Flowers spoke before some 7-8000 Jews and other supporters of Israel, as one of the Keynote Speakers for the American Israel Public Affairs Committee (AIPAC) Annual Policy Conference. On October 4, 2009 Pastor Flowers received the Interfaith Partnership Award from the Council of Islamic Organizations of Michigan at their 23rd Annual Unity Banquet. On November 4, 2009, Pastor Flowers spoke at 3 different events in Los Angeles, CA for the Jewish Community. On that morning he spoke at the Milken High School, at an Afternoon Private Luncheon he spoke before VIP donors for AIPAC and that evening he spoke before members of AIPAC. (America Israel Public Affairs Committee) September 13, 2010, Pastor Flowers was installed as President of the Michigan Progressive Baptist Convention.

In November of 2010, Pastor Flowers traveled with some 36 clergy and religious leaders to Israel on a Educational mission trip coordinated by AIPAC. Pastor Flowers has been to Israel eight (8) times.

Reverend Flowers is married to the former Terri Lynne King, the father of three daughters, Kierra Tenine, Kaletah Marie and Kristiana Rose.


