RE: **GSD: District 6 DFD Concerns**

Please respond to the following questions regarding the Detroit Fire Department:

1. During a recent visit to fire houses in District 6 it came to my attention that the ground maintenance falls to the firefighters on site.
 - a. Whose responsibility is it to maintain the grounds at each fire house/engine?
 - b. If it is not GSD's, how do we shift this to GSD's purview?
 - c. What are the staff and budgetary implications for doing this?
2. What is the status of completing the following capital improvement projects at:
 - o Engine 29, 7610 W Jefferson: Roof repair
 - o Ladder 22, 6830 McGraw: Roof and gutter repair and window replacement
3. Engine 34 (6345 Livernois) has experienced multiple power outages.
 - a. What can be done to improve the facility to prevent this?
 - b. What outreach has been done to DTE to address this problem?
 - c. Lastly, when a generator has been supplied to the fire house it is placed in the alley with a padlock. Due to the dangerous conditions in the alley, can the generator be placed in the parking lot?
