- 1. The corporation is organized on a nonstock basis.
- 2. The description and value of its real property assets are: community house building, adjacent facilities and park grounds: \$755,000.00 at 12/31/10
- 3. The description and value of its personal property assets are: office equipment, furniture and furnishings: \$10,000.00 at 12/31/10
- 4. The corporation is to be financed under the following general plan: Membership dues, rental income, contributions from the general public and grants from foundations
- 5. The corporation is organized on a membership basis.

Article IV

- 1. The address of the registered office is 18445 Scarsdale, Detroit, MI 48223
- 2. The mailing address of the registered office is the same as above.
- 3. The name of the resident agent at the registered office is Lynn Garrett.

Article V

The corporation will at all times be conducted as an organization described in Section 501(c)(3) of the Code. The corporation will not carry on any activities which are not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501(c)(3) of the Code, (b) a corporation eligible to receive tax deductible contributions under Section 170(c) and Section 2055, Section 2522 or Section 2016 of the Code, or (c) a nonprofit corporation organized under the laws of the State of Michigan pursuant to the Act.

No part of the assets or net earnings of the corporation may inure to the benefit of or be distributable to its directors, officers, or other private persons; provided, however, that the corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its charitable process.

No substantial part of the activities of the corporation will be the carrying on of propaganda or otherwise attempting to influence legislation. The corporation will not participate or intervene in any political campaign on behalf of or in opposition to any candidate for public office and will not publish or distribute statements relating to political campaigns.

Article VI

Except as otherwise provided by law, a volunteer director or volunteer officer of the corporation is not personally liable to the corporation for monetary damages for a breach of the director's or officer's fiduciary duty.

The corporation assumes all liability to any person other than the corporation for all acts or omissions of a volunteer director incurred in the good faith performance of his or her duties as a director.

The corporation assumes the liability for all acts or omissions of a volunteer director, volunteer officer or other volunteer provided that:

- (a) the volunteer was acting or reasonably believed he or she was acting within the scope of his or her authority;
- (b) the volunteer was acting in good faith;
- (c) the volunteer's conduct did not amount to gross negligence or willful or wanton misconduct;
- (d) the volunteer's conduct was not an intentional act; and
- (e) the volunteer's conduct was not a tort arising out of the ownership, maintenance or use of a motor vehicle as described in Section 209(c)(v) of the Act.

Article VII

Upon termination or winding up of the corporation, the board of directors will distribute all remaining assets of the corporation for a purpose or to an organization or organizations described in Section 501(c)(3) of the Code and having the same or a purpose similar to that of the corporation.
