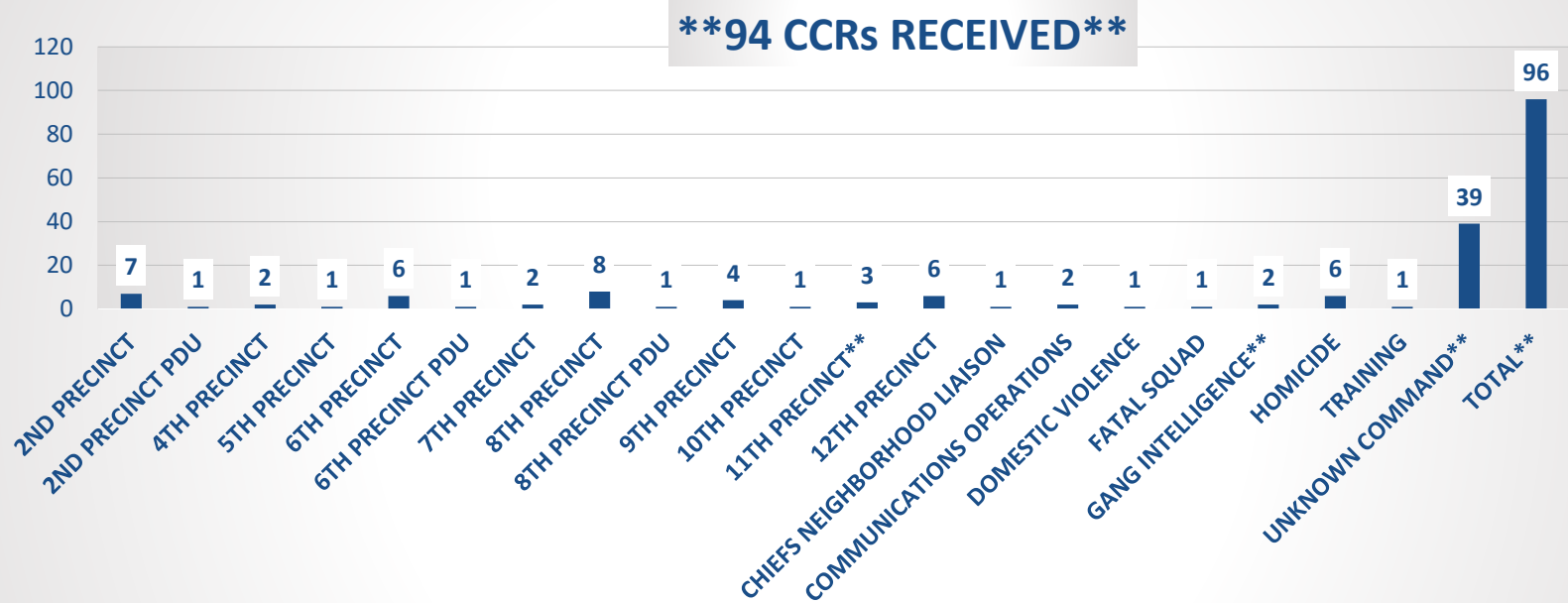

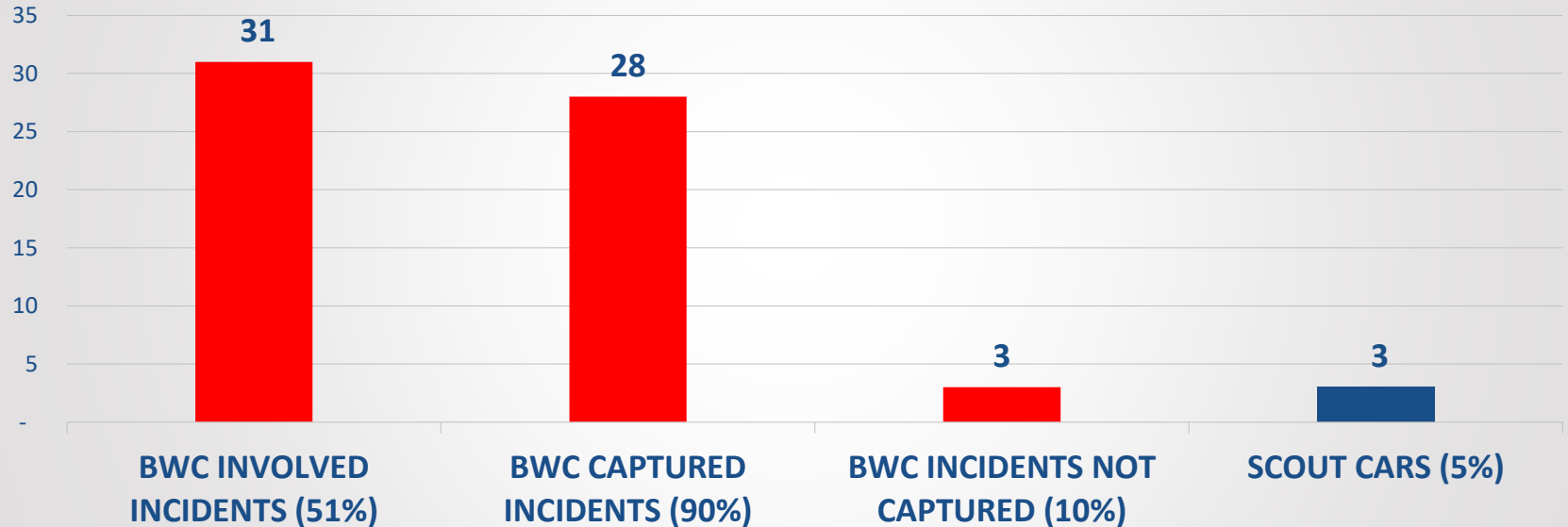

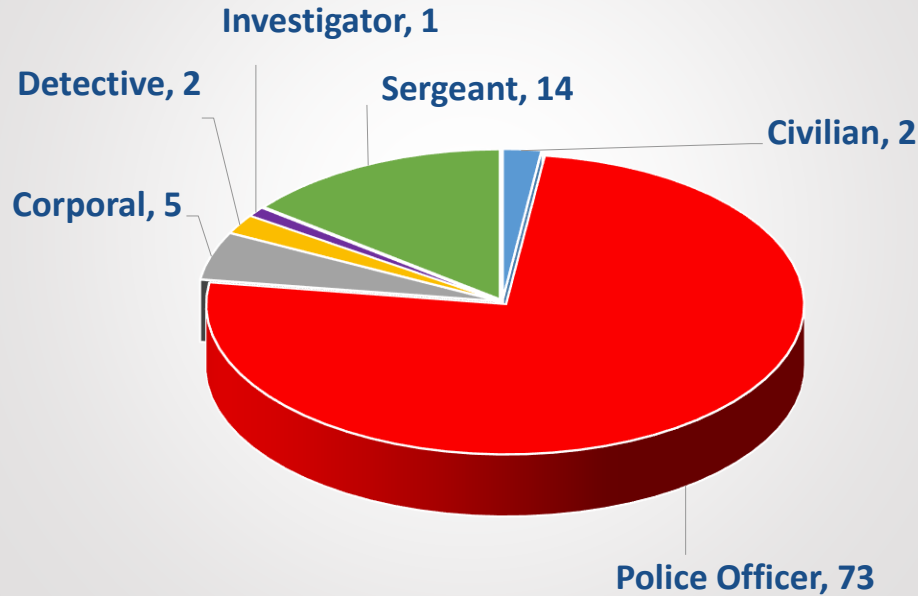

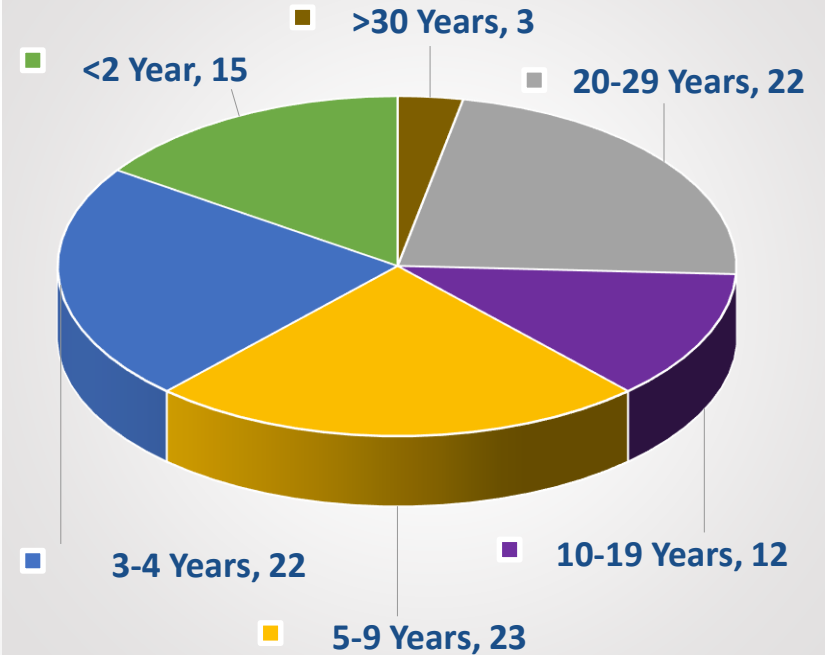
DPD MEMBERS BY RANK & SENIORITY

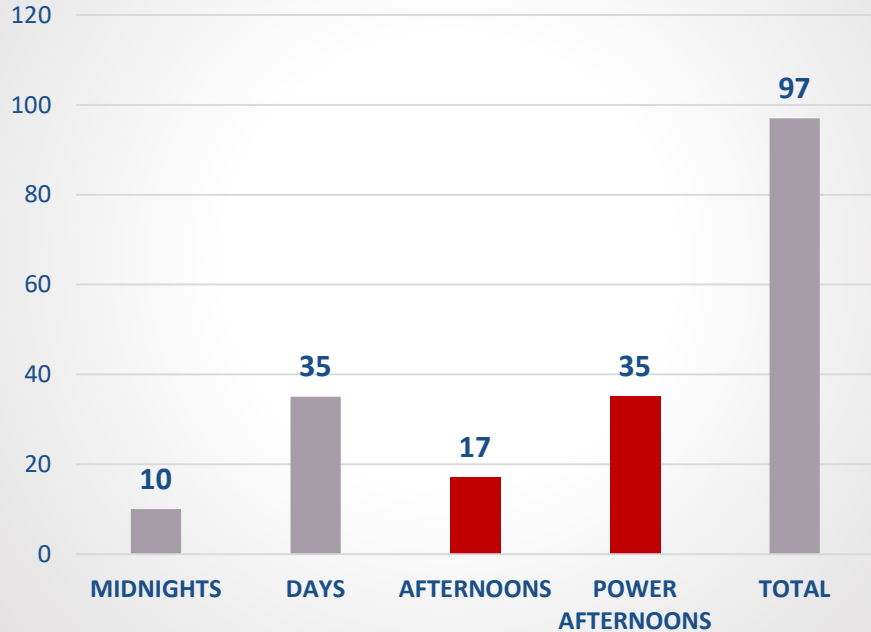

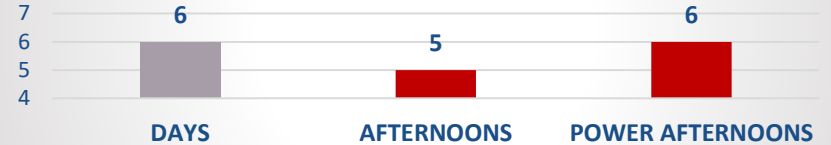

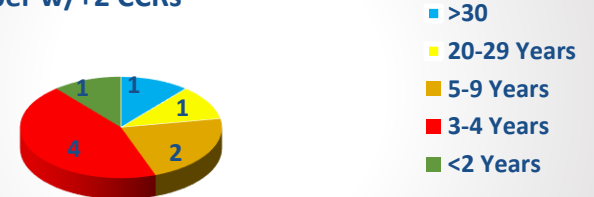
