Solution Summary

ISSUE: "We cannot have this party atmosphere breaking out in front of homes, in neighborhoods, neighborhood parks at 2, 3, 4 o'clock in the morning; wild music, fights, people bringing guns to what should be peaceful events," White said.

SOLUTION: White said he will deploy extra officers on overtime to carry out the plan's **five components**: Increasing police presence, strict enforcement of noise code violations, cracking down on parking lot owners who allow tailgating parties, curbing drag racing and drifting, and community engagement.

- **SOLUTION** Work together, unify and live the strategy (This has improved tremendously)

Solution Summary

ISSUE: Crowd Control

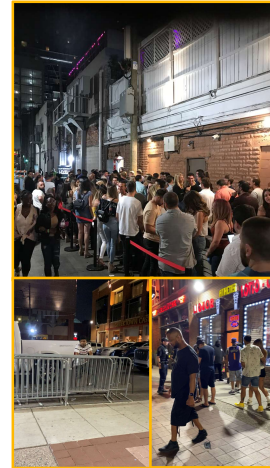
SOLUTION: Move club lines sustainably to alley on Fridays, Saturdays, Sundays (additional busy days)

Follow 'The Belt' alley protocol. (long term)

Police vehicles parked on both sides of the alley to block vehicular traffic.

Install ballards

- Enforce single file lines at liquor store pizza window. (any business with a line)
- Implement private security and strolling DPD in alley to keep pedestrian traffic moving.
- Keep crowds moving and pedestrian traffic flowing on Monroe. No long term congregating. (DPD)
- **Long term:** Activate empty spaces in Greektown with a multi tier of inclusive options for everyone.



Solution Summary

ISSUE: Parking lot tailgating

SOLUTION: Responsible parking lot strategy and enforcement (Business owner / DPD / Business Licensing)

- **Parking lot attendants are requested to provide proactive signage** and verbal messaging of ordinance upon arrival and accepting payment from each customer.
- The Detroit City Code regulates the operation of commercial parking lots. Chapter 32, Article 1.
- It is a misdemeanor to violate the Code in any of the following ways:
- Failing to have an attendant present during operating hours (DCC 32-1-4)*
- Permitting loitering on the lot (DCC 32-1-7)
- Failing to keep sidewalks safe and clear (DCC 32-1-8);
- Conducting business without a valid license. (DCC 32-1-14)
- Business owners who repeatedly refuse to cooperate with DPD enforcement around parking lots will be subject to business license review, suspension or revocation through BSEED and the Law Department. DCC 28-1-16.
- There is an exception for "Park & Lock" scenarios.
- **Venue owners** will request promoters to advertise parking options and protocol on their socials and invites.



Solution Summary

ISSUE: Noise complaints

SOLUTION: Responsible sound protocol

All venues are committed to positioning speakers away from the street and closing garage doors or windows by 10:00 p.m. (Exception Special Events permit)

Notes for DPD on Controlling Loud Noise

- Certain loud noise is prohibited by the Detroit City Code, Chapter 16, Article 1.
- It is a misdemeanor to create unreasonably loud or disturbing noise. DCC 16-1-12.
- For example, outdoor music whose source can be identified from more than 50 feet away is illegal after 10 pm. DCC 16-1-1 and 16-1-13.
- Music played from a car that can be clearly heard from more than 10 feet away is illegal at any time of day. DCC 16-1-1 and 16-1-22.
- Business owners who repeatedly refuse to cooperate with DPD enforcement around loud noise will be subject to business license review, suspension or revocation through BSEED and the Law Department. DCC 28-1-16.
- Proactive street signage to create awareness of ticketing loud music from cars and motor vehicles
- Peddle Cabs and party buses are mandated to follow sound ordinance.

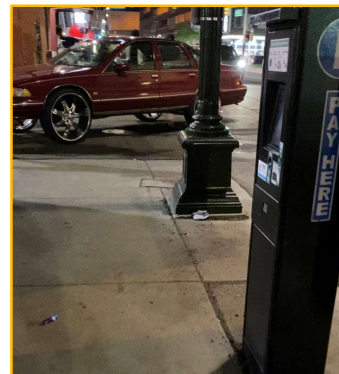


Solution Summary

ISSUE Traffic / Illegal Parking

SOLUTION

- Street closures will occur only for swift crowd and traffic control. Streets will remain open w/ special exceptions. (Discretion of DPD)
- Suggested Monroe to I75 direct route if traffic becomes problematic
- Off road street bikes and ATV's (DPD taskforce / Five Point Plan)
- Drag racing (DPD taskforce / Five Point Plan)
- Scooters Geo fencing is currently active. (Exception blue scooters)
- MDP ticketing and towing / strict parking enforcement (see photo)



Solution Summary

ISSUE: Lawless drinking (open intoxication / full bottles of liquor)

SOLUTION: DPD will confiscate

ISSUE: Excess debris on and around Monroe Street

SOLUTION: Assure post garbage pick up / clean up

- DDP is committed to picking up debris earlier on Saturday and Sunday morning.
- Additional garbage receptacle have been added.

ISSUE Irresponsible, harmful, reckless, lawless, misguided conduct.

SOLUTION Community engagement / Ambassadors program

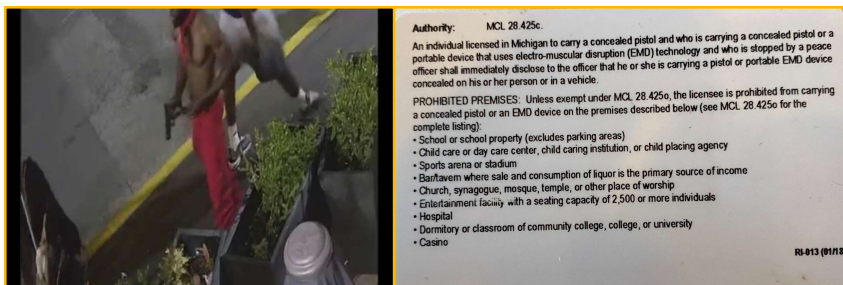
- The party in Greektown and Bricktown is the convening place for all corners of the City in addition to visitors. Community groups such as **Detroit 300** and **Cease Fire Detroit** have the opportunity to proactively engage the crowds and de escalate issues or irresponsible behavior. A **sustainable** Ambassadors program is needed to assist in this multi tier effort to create a safe, healthy, equitable and sustainably responsible Night Time Economy. The mission is to retain current Detroit and attract new Detroiters and visitors that compliment the foundation of Detroit.

ISSUE Firearms; open and concealed, legal and illegal.

SOLUTION (potential) Proposed ordinance that recognizes Greektown as a entertainment zone with seating capacity of more than 2,500 or more individuals.



Solution Summary

ISSUE Gun case processing back-log.

- **Pain points and contributors to the problem:**

1. Staffing and resource constraints due to COVID-19 pandemic has slowed down information request processing
2. CPL permitting process experiencing major delays at County Clerk's office due to limited resources to process and appointment dates that have been pushed out to over 6 months
3. Lack of timely and accurate information delays the ability for prosecutors, defense attorney, and judges to close cases
4. Appreciable number of individuals are legally purchasing guns, but then not following through on registering the weapon and obtaining a permit - driven by both a lack of awareness/education and personal responsibility

- **SOLUTIONS currently being explored**

1. Deploying process improvements to increase quality and completeness of information provided to prosecutors office
2. Securing additional human capital resources to increase processing capacity at 36th district court and County Clerk's CPL renewal and application process
3. Establishing robust data sharing across judicial system stakeholders to reduce time required to obtain critical information
