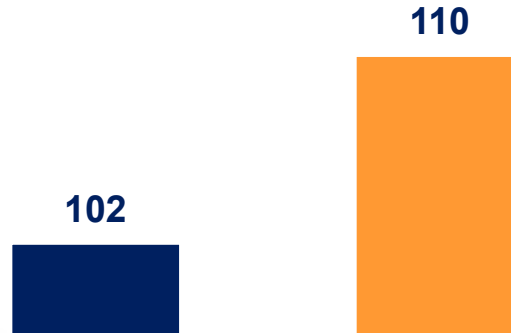

CITIZEN COMPLAINTS RECEIVED JULY 2021 vs JULY 2020

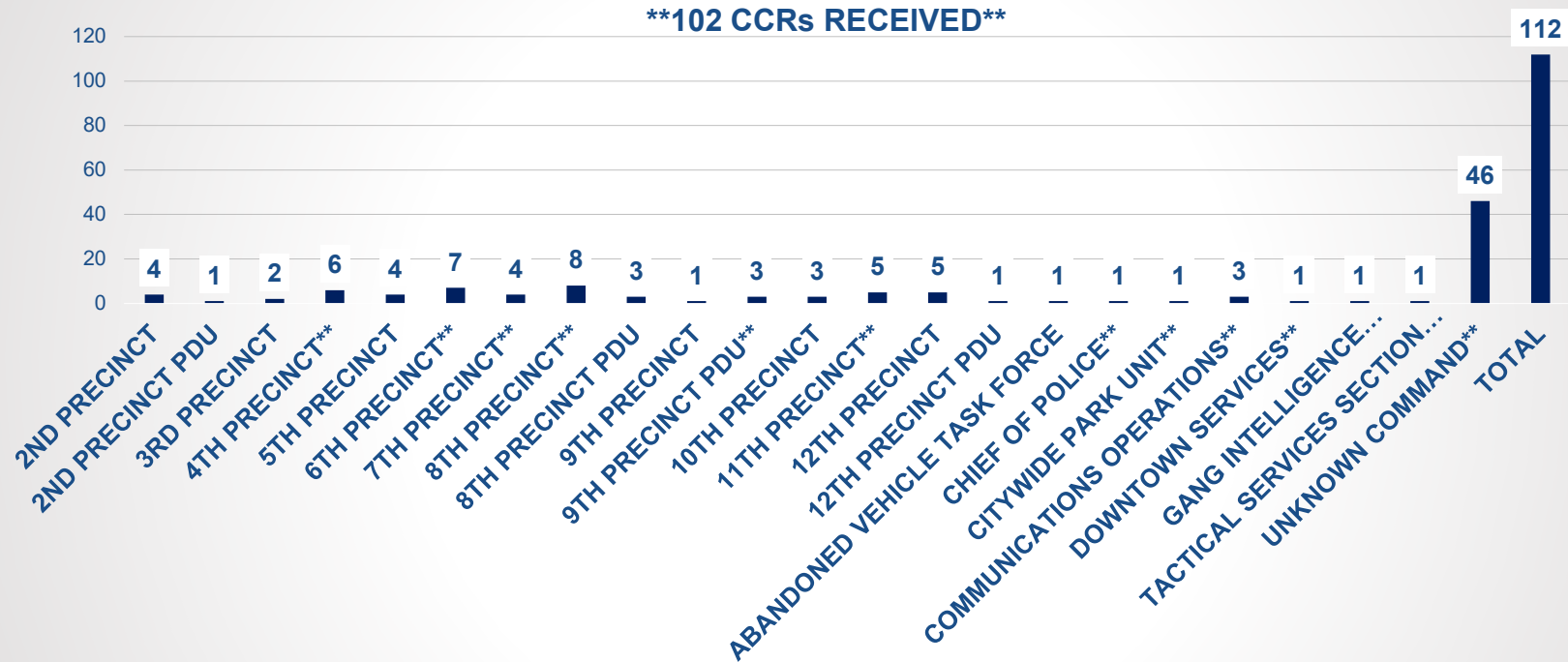

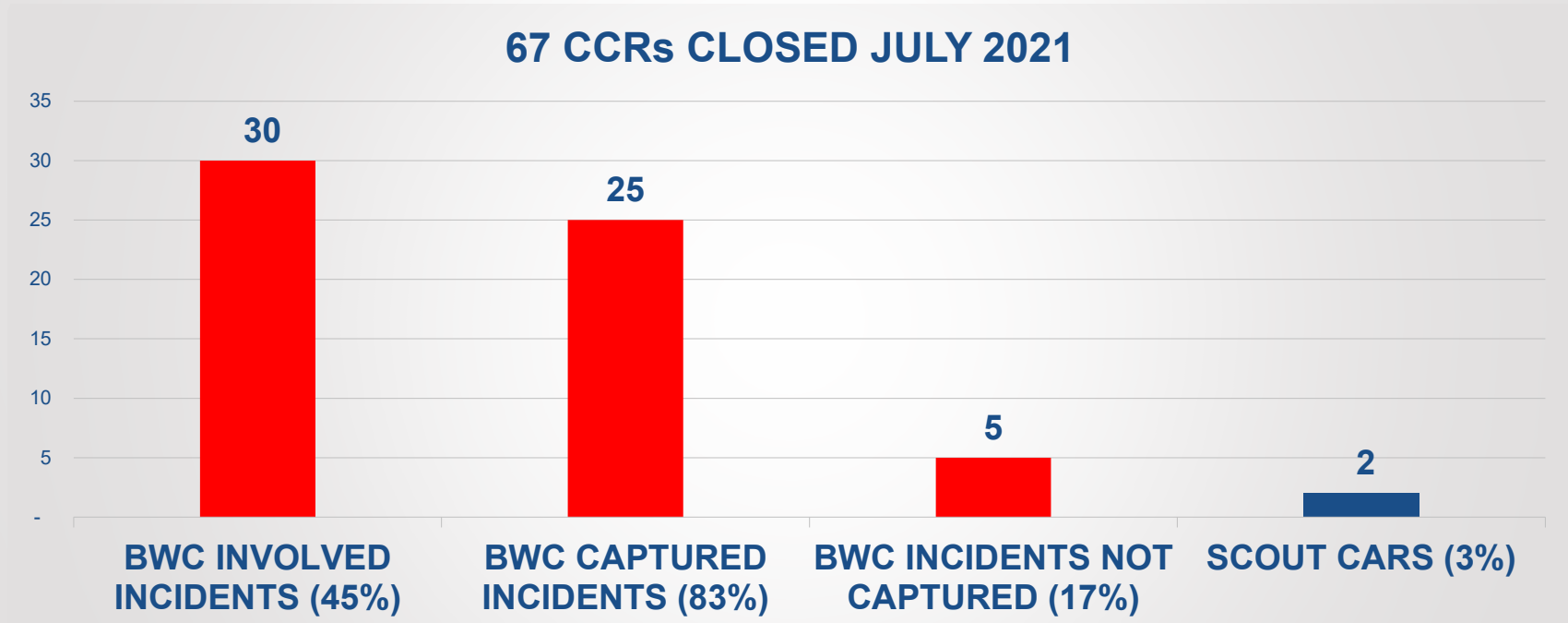

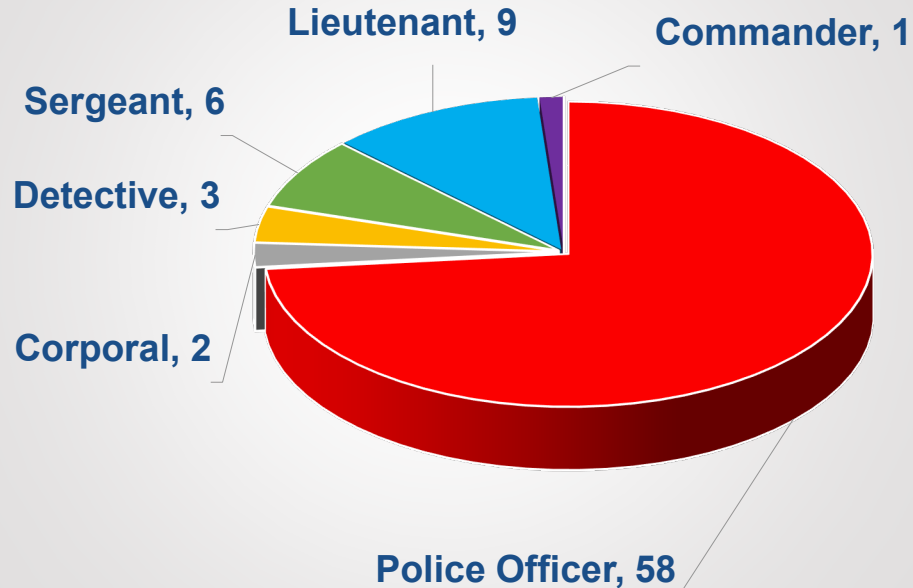


CLOSED INVESTIGATIONS JULY 2021

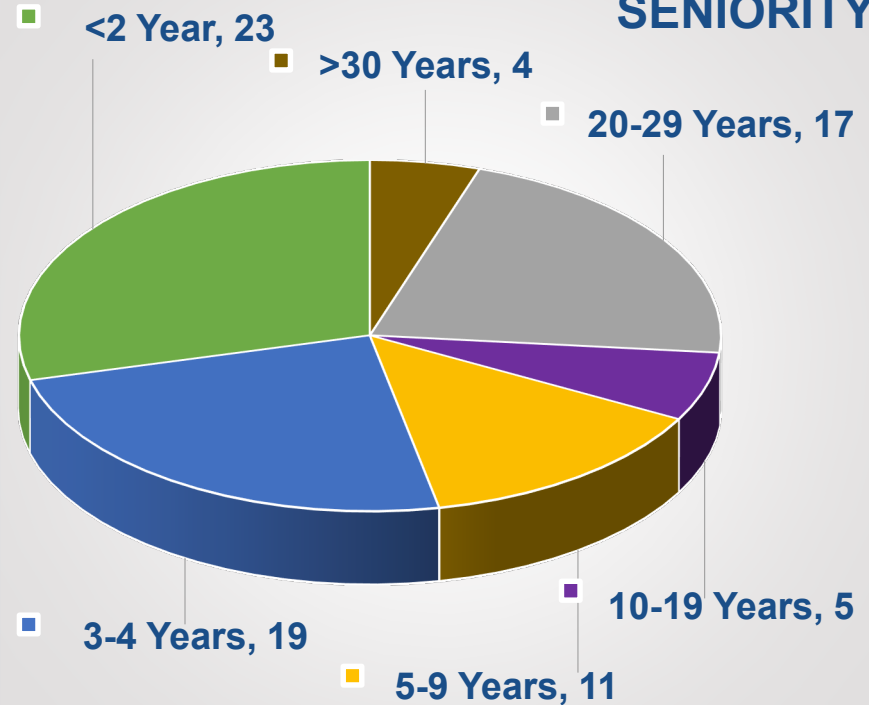
