4 CHAIRPERSON HOLLEY: Good afternoon. Thank you so 5 much, Ms. White. Jim Holley, Chairperson of the Board of 6 Police Commissioners. The meeting will now come to order. 7 At this particular time, I'm asking that Chaplain Curtis 8 Longstreet, I welcome you, and we thank God for you. If 9 you would, at this time, give us the invocation.

10 CHAPLAIN LONGSTREET: Dear Heavenly Father, we want 11 to thank you on behalf of all who are gathered here 12 today. And we pause for a moment to pray for, to 13 acknowledge, to lift up the Chairperson Jim Holley and 14 his health challenges, oh God that you would touch him 15 right now from the top of his head to the soles of his 16 feet. I pray, Father, that you would strengthen him that 17 you would cause your healing mercies to touch every issue that he's challenged with here today. And we thank you 18 19 for your rich mercies right now, touching him in the name of your son, we pray. We also pray for the loss of the 20 Vice-Chair and the loss of his aunt. 1 CHAPLAIN LONGSTREET: And likewise, we pray over 2 every Board member. We ask your grace, oh, God that you will grace them, that you will strengthen them, that you 3 would enthuse them with your strength and your loving-4 5 kindness. And we will be so careful to give you and you alone, the praise, the glory, and the honor. And so 6 Father thank you for life itself, for the measure of 7 health we need to fulfill our calling for the provision 8 and for friendship. Thank you for the ability to be 9 involved in useful work and for the honor of bearing 10 appropriate responsibility. In scripture, you have said 11 12 that citizens ought to pray for and obey civil authority 13 since you've established those very authorities to 14 promote peace, honor, and justice. Therefore, I pray for 15 our president, for our governor, for our mayor, for the 16 city council, and most importantly for the Detroit Board of Police Commissioners. I pray, oh God, that you would 17 grant them wisdom to govern in the middle of conflicting 18 19 interests and issues, of our times

20 CHAPLAIN LONGSTREET: I pray and ask, oh God, that 21 you will grant them a sense of welfare and true need of 22 our citizens and the members of the Detroit Police 23 Department. I pray, oh God, that you would give them a 24 king thirst for justice and rightness. I pray, oh God, 25 that you would give them confidence in what is good and



1 fitting that you would give them the ability to work together in harmony, even when there is honest 2 3 disagreement and I pray for and over the agenda that is set before them this day. Heavenly Father, please give 4 5 them an assurance of what would please you and what would benefit those who live and work in and around our beloved 6 City of Detroit. It is in your most blessed name I pray. 7 8 Amen.

9 COMMISSIONERS: Amen.

10 CHAIRPERSON HOLLEY: Thank you so much, Chaplain 11 Longstreet. What a wonderful and beautiful prayer. We 12 thank you so much. Excuse me, for being with us today. 13 Thank you so much. Mr. Brown give us the mission 14 statement please.

15 MR. ROBERT BROWN: Yes sir. Good afternoon, Mr. 16 Chair, this Honorable Board and citizens of Detroit. The Board of Police Commission Mission summary. The Board of 17 Police Commission, BOPC is a civilian agency that 18 19 exercises supervisor control and oversight of the Detroit Police Department DPD as set forth in the charter. The 20 Board has 11 members, 70 elected by District, 4 appointed 21 by the mayor with the consent of the Detroit City 2.2 23 Council. The Board meets every week as a committee of the whole, including 12 communities/evening meetings in the 24 district. The BOPC is the oversight agency for the 25



1 Detroit Police Department. That department policy rules and regulation governs the Detroit Police Department is 2 jointly developed by the mayor, chief of police, and the 3 Board. The Board has subpoena power under the charter 4 that can be used for investigative purposes. The 5 6 commissioners also review and approve the DPD budget pursuant to the charter, investigate non-criminal citizen 7 complaints, acts as the final authority in opposing and 8 reviewing the discipline of employees of the department, 9 receives and hear disgualification appeals from police 10 recruits hoping to enter the Detroit Police Academy. The 11 12 BOPC makes an annual report to the mayor, city council, 13 and the public of BOPC activities and accomplishments. 14 Mr. Chair, the reading of the summary.

15 CHAIRPERSON HOLLEY: Thanks you so much Mr. Brown, At 16 this time, Ms. White, would you give us the roll call, 17 please?

MRS. WHITE: Yes sir. Through the Chair, Vice-Chair,Martin Jones.

20 VICE-CHAIR JONES: Vice-Chair Martin Jones is 21 present. Thank you and welcome to all of our community 22 partners, DPD, all of our men in blue, and all of the 23 executive staff of Chief White and congratulating Chief 24 White on his promotion, again. We thank you so much for 25 being with us today. I'm Vice-Chair Martin Jones,

First of all, the 4 5 approval of the agenda. And what she's saying is, there 6 is no motion needed on the agenda. Just approval or disapproval.  Whitley, Board Parliamentarian, Dr. Francis Jackson,
 Interim Chief Investigator Lawrence Akbar, Supervising
 Investigator Ansley Cromwell, Acting Supervising
 Investigator LiSonya Sloan, Acting Supervising
 Investigator Rosalia Madrigal. And that concludes
 staff introductions today.

8 CHAIRPERSON HOLLEY: Do you have any VIPs while 9 you're there, Mrs. White? Do you have any VIPs that are 10 visiting us today?

11 MRS. WHITE: Yes, sir. Through the Chair. Ms. Marie 12 Overall of State Representative Tyrone Carter's Office, 13 Community Advisory Council Chair, Scotty Bowman. DPOA 14 Vice-President, Ron Thomas and Ms. Emily from 15 Representative from Karen Whitsett's Office. Thank you. 16 CHAIRPERSON HOLLEY: Thank you so much. First Assistant Chief Bettison, is that it? Did I get it right? 17 FIRST ASSISTANT BETTISON: Thank you, Chairman. 18 19 CHAIRPERSON HOLLEY: And it's always good to see you as Commissioner Burch indicated but thank you for sitting 20 in for, and let the Chief know that we wish him the best 21 and congratulate him from each and every one of us on the 2.2 23 approval of the appointment from the city council. At 24 this time, would you tell us who's with you today?

25



FIRST ASSISTANT BETTISON: Yes, sir. Thank you, Chairman. And the Chief would have been here and he's just out at the scene. The barricaded gun person situation that we all saw in the media has successfully come to a conclusion. The suspect gave himself up, so all safe, no one injured. And so I'll jump right into who's

6 here. So we have Captain May with us, we have Captain 7 Liddell with us. Captain Ian Severy is with us. Director 8 9 Chris Graveline is on, Deputy Chief Deshaun Sims is on the call, Captain Gary Johnson is on the call. I see 10 Director Patillo, Lieutenant Coles from Recruiting, and 11 12 Sheila McBride from Chief White's Office, executive to 13 Chief White. And that appears to be it from the DPD's 14 side of the house.

15 CHAIRPERSON HOLLEY: Thank you so much. As always,16 it's good to have you with us today as well.

17 FIRST ASSISTANT BETTISON: Yes, sir.

Thank you. If you could do that for me, 8 Vice-Chair Jones? 9

VICE-CHAIR JONES: Alright, thank you so much. 10 Through the Chair, it would be an honor to do the 11 12 Chairperson's remarks for you. Again, the Board is glad 13 to congratulate Chief James White as the city's 43rd 14 Police Chief. City councilors this week confirmed his 15 appointment seven to zero on the votes. The Board 16 continues to extend the best wishes and support as we 17 work together with the Chief, his executive team, and the department to ensure excellence in the police department 18 19 and public safety in our city. Again, congratulations. First Assistant Chief Bettison, please accept these 20 remarks and forward them to the Chief for us. We're glad 21 to have him on board. The City council kind of got it 2.2 right. We got a good man in place. Thank you, sir. 23 FIRST ASSISTANT BETTISON: Thank you. 24

VICE-CHAIR JONES: Alright. The Board extends its 1 prayers and condolences on the loss of Devonte Jones of 2 Wayne County. The corrections officer was killed while 3 4 off duty. We continue to pray for the Wayne County 5 Sheriff's Department, the law enforcement community, and 6 the family of Devante Jones, regarding this senseless and 7 fateful encounter. We speak each week about this pandemic of gun violence and it is our priority to do all we can 8 9 to stop these senseless shootings and killings. The Board is currently working on and hopes to impanel a forum to 10 discuss strategies to combat and deter gun violence and 11 12 violent crimes here in the City of Detroit. Our community 13 deserves better and we will be working with the law 14 enforcement department and the court system towards that 15 endeavor. Human behavior also must change. We must learn 16 how to control our tempers; we must learn how to resolve 17 conflict peacefully and how to value and respect our lives and the lives of others. 18

19 VICE-CHAIR JONES: As part of the Board's charter 20 mandate and supervisory oversight role, I have designated 21 several Commissioners to serve on the RFP tow selection 22 committee in connection with the Office of Contracting 23 and Procurement, OCP and DPD will tow monitor, and other 24 authorized parties. The committee will review and 25 evaluate the tow RFPs to qualified Police authorized



1 towers based on requirements outlined in the RFP and other relevant city rules. Designated Commissioners will 2 serve as voting members of the RFP. The Commissioners 3 selected for the committees are Vice-Chairperson, Martin 4 Jones, Commissioner, Willie Bell, and Commissioner Linda 5 Bernard. The selected Commissioners have a accepted the 6 challenge, and I thank you for your cooperation. Through 7 their involvement and reporting back to the Board, the 8 9 Board looks forward to helping to ensure fairness, objectivity, and inclusiveness as part of the police 10 authorized towers process. The RFP evaluation process 11 12 will start soon and further details are forthcoming for 13 the Board's consideration.

14 VICE-CHAIR JONES: Thank you for your cooperation. As 15 a reminder the Board members requesting a legal opinion 16 on a particular legal issue, must give them prior of 17 introducing a motion, to request a legal opinion from the city law department and the State with a legal issue. If 18 19 the motion is properly seconded and adopted the Board staff will prepare a written request to the law 20 department on behalf of the full Board, requesting a 21 legal opinion on a legal issue. This process is in place 2.2 to help ensure that we work together to make decisions, 23 maintain order and ensure clear, accurate reporting. 24 Also, a reminder, registration for the NACOLES annual in-25

person conference is underway. Commissioners who are seeking to attend please confirm by the end of the business day today with Ms. White and Mr. Brown. Please note that NACOLES is requesting that all conference attendees be vaccinated and be prepared to provide confirmation.

VICE-CHAIR JONES: As a reminder, as we worked 7 through the process of reinstating the committee 8 structure and to continue with all of our required 9 10 meetings in alignment with the open meetings act, OMA, Board members are required to follow all governing 11 12 documents, the OMA, open meetings act, the Board bylaws, 13 parliamentary rules, and standing rules, especially 14 regarding meeting decorum. All relevant documents have 15 been distributed on a continuous basis. The expectation 16 is that all Board members will read the document, adhere 17 to the rules, help to keep order, get the business done, and probably resolve any issues that may arise. 18 19 Therefore, in seeking action on a particular item or seeking additional information on a matter, please refer 20 21 to all governing documents to show that you are following the process. And thank you for your cooperation. This 2.2 23 Board has done a great job here as of late, as far as 24 coming together and trying to get the business of the Board done. 25

1 VICE-CHAIR JONES: So I complement each and every one of you. The Board staff distributed a revised proposed 2 bylaw amendment for your review. No action will be taken 3 today. However, please review the documents and send any 4 written feedback, recommendations that you have so that 5 we can approve the final document within the next two 6 weeks. Please send items in writing to the Board's staff. 7 Also, Dr. Jackson, the parliamentarian is here with us 8 today and is available should you have any questions 9 regarding the revised amendment. As previously discussed 10 11 the Board voted to adjourn filling the vacancy for the 12 senior investigator position next week, September 30th, 13 2021. In the interest of time and to help us fill past 14 appointments and requesting that all Commissioners submit 15 their top two preferred candidates for the position to 16 Interim Board, Secretary White, who will then tally the top two candidates from the list of names submitted so 17 that we may vote on them next week. 18

19 VICE-CHAIR JONES: I'm requesting that you submit 20 your two candidates' names by next Tuesday, September 21 28th, 2021 by the close of the business day. Next, we 22 have congratulations on two new investigators regarding 23 their recent investigative work and conducting a thorough 24 investigation in locating the complainant's property, a 25 cellular phone in the street while conducting a canvas.



This type of investigative work helps to maintain trust 1 and confidence in the Board's investigative division, and 2 in our oversight process. We continue to thank Chief 3 Investigator Akbar, supervisors, and all OCI staff for 4 the hard work on a daily basis and the leadership 5 6 example, and the training that they are providing to our new investigators. And we have to especially commend our 7 two investigators, Ellen Counts and Pastella Williams for 8 a job well done. We look forward to the Chief's report 9 discussing important updates, including, but not limited 10 to, crime and critical incidents impacting the department 11 12 and the community. Facial recognition technology report, 13 Commissioner Willie Burton, Captain Severy, DPD, report, 14 Detective Bureau, Deputy Chief Marlon Wilson will be 15 reporting out today. All the agenda items are listed for 16 your review. We want to thank you very much. And these are the Chairman's remarks. I turn the meeting back over 17 to the Chairman. 18

19 CHAIRPERSON HOLLEY: Thank you so much, Commissioner 20 Vice-Chair Jones. Thank you so much. It helps me a whole 21 lot tonight. I appreciate you doing that for me.

22 VICE-CHAIR JONES: You're welcome.

23 CHAIRPERSON HOLLEY: I just want to make sure that 24 again, we congratulate, once again, Chief White. Also, I 25 want to just make sure to remind you of the meeting



1 decorum openly meetings act, we must adhere to the rules, if you would, please. I also remind you that the senior 2 3 investigator vacancy, I really ask that based on what took place last week, I think this is the best way to do 4 5 it in terms of giving us two names and we'll try to work through this. If you have a problem with it, I'm 6 7 available to talk to you about it. I want to also let you know that hopefully, by now you've received your 8 windbreaker, your cap, your polo shirt with your name on 9 it. COMMISSIONER BURCH: I know you joshing but I always 17 say thanks to anybody who gives me a pencil. I say, thank 18 you. Very nice items, sir. 19

20 CHAIRPERSON HOLLEY: Commissioner Holt, I'd like for 21 you to do the Resolution, if you were pleased, for 22 Detective Knox.

23 COMMISSIONER BERNARD: Mr. Chairman, before the 24 Resolution, just a point of order. I just want to make a 25 remark to you. I sent you a text but I know you didn't



1	read it. Please go to the hospital right now. I'm
2	serious. You had a stroke before; you've had heart
3	issues. These things can creep up on you. My father had a

Hearing none, the Resolution has been adopted. At this 8 Time, Vice-Chair Jones, could you give me the pleasure 9 of the detective bureau? 10 VICE-CHAIR JONES: Yes. It is with great pleasure 11 12 that I do so. Resolution honoring Corporal Rickey 13 Townsel, Sr. 14 WHEREAS Rickey Townsel was appointed through Detroit 15 Police Department on June 26th, 2000. He graduated from 16 the Metropolitan Police Academy, Police Officer Townsel 17 was assigned to the Eighth Precinct; and, WHEREAS he dutifully served the Eighth Precinct 18 19 Northwestern District, the Sixth District. Officer Townsel displayed tremendous (Audio Distortion] and 20 21 aptitude in his assignments. On August 1st, 2016, he was promoted to the rank of corporal and served at the Crime 22 23 Intelligence Unit until his retirement; and, 24 WHEREAS during his law enforcement career, Corporal Townsel was a deserving recipient of a Military Service 25



1 Award, Perfect Attendance Award, Lifesaving Citation, and Medal, both Consent to Judgment Awards, the Major League 2 Baseball All-Star Recognition Award, the Rosa Parks 3 Funeral Recognition Award. The Super Bowl XL Recognition 4 Award, as well as commendations from supervisors and 5 numerous letters of appreciation from the citizenry; and, 6 WHEREAS Corporal Townsel has tirelessly served the 7 City of Detroit Police Department, the citizens of 8 9 Detroit, and its neighboring communities for 21 years. His professionalism, commitment to public service and 10 integrity, and dedication have been a credit to the 11 12 Detroit Police Department, He is highly respected as a 13 consummate professional.

14 NOW, THEREFORE BE IT RESOLVED that the Detroit Board 15 of Police Commissioners, speaking for the citizens of 16 Detroit and the Detroit Police Department awards this 17 Resolution in recognition of Corporal Rickey Townsel's 21 years of dedicated and diligent public service. His 18 19 professionalism, integrity, and lifelong commitment to the City of Detroit and its citizens merit our highest 20 regard. We thank and congratulate you, Corporal Rickey 21 Townsel, Sr. Through the Chair. 2.2

23 CHAIRPERSON HOLLEY: Yes.

24 VICE-CHAIR JONES: I recommend that we adopt this25



Resolution and place it in the archives of the
 BOPC. What say you?
 COMMISSIONER BERNARD: Second.

4 CHAIRPERSON HOLLEY: Any objections? Hearing none, 5 the motion is carried. Thank you so much to both of you. 6 Assistant Chief Bettison, it's always good to see you and 7 certainly, it's good to hear from you at this particular 8 time.

9 FIRST ASSISTANT BETTISON: Yes, sir. Thank you, Chairman Holley, and you know, just prayers with you, and 10 11 I just want to let you know, sir, you're doing a fine 12 job, and even though you're not so good that you're still 13 better than most. So I just want to send that to you, 14 sir. I'll start with the Chief's report. Just an update 15 on our injured officers. There are currently five members 16 of the department who are currently disabled and recovered at home due to an on-duty injury. I won't list 17 18 names but we have one Sergeant from the Seventh Precinct, two officers from the Seventh Precinct, one officer from 19 the Eleventh Precinct, and one officer from the Technical 20 21 Services Section. You know, we know that our COVID 22 numbers, just looking around what's happening with the 23 Delta variant, and everyone is curious as to how it affects the first responders, but in regard to DPD, 21 24 25 members are currently quarantined or isolated.



1 FIRST ASSISTANT BETTISON: So not in the workforce, 2 18 of the quarantine or isolated members are currently positive with COVID-19. And so in regard to our crime 3 data, homicide at this point, we're 5% up. So we've been 4 trending down since Chief White has taken the reins and 5 6 right now our whole numbers compared to last year 238 last year, this time we had 226. Non-fatal shootings, 7 we're standing at 0% change. So last year we had 831. As 8 9 of right now, we're at 828. So in robberies, we're down 23% and so for our total part one crime we're down 2%. In 10 regard to drag racing, drifting, and force-fit stats, I'm 11 12 not nearly getting the complaints that I was in regard to 13 the large group of drag racing drifting and donuts. And I 14 haven't been getting the complaints like I was for possibly three, four weeks now. 15

16 FIRST ASSISTANT BETTISON: So in that spin, that activity has been trending down and we attribute that to 17 our enforcement efforts. So our traffic stops, 68 traffic 18 stops over the past weekend, we've issued 56 citations, 19 we have impounded 7 vehicles. Our stolen vehicle recovery 20 21 is at zero, Felony arrest is 2, misdemeanor arrest 1, and 2.2 weapons recovered 1. In regards to that and then if we 23 listed year-to-date stats, just talking about what we've done in regards to the drag racing drifting, we've done 24 2,482 traffic stops, and we've impounded 252 of those 25



1 vehicles, and we've made 137 felony arrest and more significantly when doing traffic stops and with the folks 2 who are engaged in that activity, we recovered a lot of 3 weapons out of those cars as well. So we've recovered 4 over 100 firearms. Moving into significant incidents on 5 6 September15th, in the 10,000 blocks of Roxbury, three people were victims of non-fatal shootings and their ages 7 were 34, 23, and 41. The victims were sitting in a 8 vehicle in the driveway of the residence when two unknown 9 subjects in a white Malibu Impala began firing shots at 10 the victims. Just to update, members of the Ninth 11 12 Precinct are still actively investigating that following 13 up on leads.

14 FIRST ASSISTANT BETTISON: Of course, if anyone is on 15 the listening audience who has any tips to provide, of 16 course, crime stop is 1800 speak up. We had another 17 incident on September 18th in the18000 block of West Seven Mile at a Mobil gas station. Two victims were shot. 18 19 And the victims' ages were 27, 3, and 17. The victims were at the location where a silver Malibu exited the 20 parking lot. Upon exiting the parking lot occupants in 21 the Malibu began firing shots at the victims. The 3-year-2.2 23 old victim was being carried by the 27-year-old victim. Shots were fired, both the 3-year-old and the 27-year-old 24 were taken to the hospital in stable condition. The 17-25



year-old is also taken to the hospital, but in critical condition. The update on that case is one of the subjects has been arrested in conjunction with the matter and a warrant request has been submitted to the Wayne County Prosecutor's Office is under review.

FIRST ASSISTANT BETTISON: And then one of the 6 positive activities is you know, last weekend was pride. 7 They had the pride festival and parade in the city. So on 8 9 Friday, September 17th our DPD LGBTO liaison section hosted a family reunion, pride picnic at Palmer Park for 10 the LGBT community. It was a free event for the public. 11 12 It included food, games et cetera, intended to encourage 13 and engage the community while strengthening our 14 relationship with members of the LGBTQ community and 15 resources on-site partnering with our nonprofits and 16 others. The matrix house, which provided HIV testing, Sasha Center for survivors of sexual assault victims, 17 life support services, and LGBTQ Detroit. Other things to 18 note is that on Monday, September the 20th, the 19 bankruptcy court approved the extension of the DROP 20 21 program. So many of our members were anxiously awaiting what the decision was going to be so that it was approved 2.2 23 and the DROP stands for.

FIRST ASSISTANT BETTISON: It's an acronym and it stands for the Deferred Retirement Option Program and

1 that will allow members now to participate in that program with the approval of the Chief longer than the 2 10-year. It did have a 10-year deadline, but with this 3 approval of members now with the approval of the Chief 4 5 can participate longer than the 10-year deadline. On Tuesday, September 21st, has already been announced. 6 Chief James White was officially confirmed as the Chief 7 of Police by city council and the DPD command staff, and 8 9 I think the entire DPD is very, very happy about that. I know the command staff is, and from everyone I've heard 10 he's been celebrating, and that includes community as 11 well. So we worked with him and we're glad to have our 12 13 permanent chief. I definitely thank the Board for the 14 process. And I can tell you that Chief White said that it 15 has to be one of the most strenuous chief processes in 16 the country. So, kudos to the City of Detroit, for 17 selecting the best person. On Friday, September 24th at 10:00 AM, which is tomorrow DPD basic recruit class, 21-I 18 19 will graduate. There is going to be a graduation ceremony. And if I'm looking right, it's going to be a 20 class of 14 and it's going to be held at the Wayne County 21 Community College Northwest Campus, 8200 West Outer 22 23 Drive. It's going to be at the Larry K. Lewis Education 24 Center. But at this time, this concludes my report.

25



1 CHAIRPERSON HOLLEY: Thank you so much, First 2 Assistant Chief Bettison. 3 FIRST ASSISTANT BETTISON: Yes, sir. CHAIRPERSON HOLLEY: At this time, Chair Vice-4 5 Chairperson Jones, can you do the round robin for me, 6 please? 7 VICE-CHAIR JONES: Yes, sir. Thank you, sir. District 1. Vice-Chair recognizes Darryl Brown. Do you have any 8 questions for the Chief? District 2, Vice-Chair, Martin 9 Jones recognizes Commissioner Linda Bernard. Do you have 10 any questions for the First Assistant? 11 COMMISSIONER BERNARD: Yes, I do, Assistant Chief 12 13 Bettison and it's good to see you today. 14 FIRST ASSISTANT BETTISON: Thank you, ma'am. 15 COMMISSIONER BERNARD: As part of our package today 16 there was a listing of officers who have left the force, 17 six of those officers were only on the job 30 days. I've asked that first question, only you can answer the 18 19 question because you're the department. And then secondly, an additional three people left the department 20 21 within 90 days. So, I mean, we are getting them in and you say you have 14, who are going to graduate next week. 2.2 23 Are we going to lose seven of those within the next 30 24 days too, or can you help me understand, please? 25



1 FIRST ASSISTANT BETTISON: So, the Director of 2 Personnel, we conduct exit interviews and so members, as 3 some of them retired, when you say 4 COMMISSIONER BERNARD: These are people that are on a 5 job, 30 days, they were hired 8-30-21 and they retired 9-6 10-21. They were on the job, less than 30 days. 7 FIRST ASSISTANT BETTISON: I'm sorry. I misunderstood that right there. 8 9 COMMISSIONER BERNARD: These are people that have 10 been on the job for less than 30 days, most of them came on around 9-30 or the 30th of September of '21, and then 11 12 according to this, they separated almost immediately. 13 FIRST ASSISTANT BETTISON: Okay. I can definitely 14 answer that for you. In looking at it the majority of 15 members that leave very, very quickly like that, they 16 typically site, and we can get you the exact numbers 17 because we do an exit interview and they are quite frankly, they will tell you that they'll need to be 18 19 employed by another agency. And one of the main things that they list is they're going for higher pay, better 20 21 benefits. And so that is the bulk, the majority of why 22 members leave, and many of them actually also when they 23 leave before that 30-day mark, where they leave very, very quickly, oftentimes they will... Some of them were 24 25 very disingenuous. They will come here to get the great



1 DPD training because our training is paid for, they 2 actually received a salary while they're here. And then 3 they have desires to go work for another agency because 4 once they received that training, they're very, very 5 marketable.

FIRST ASSISTANT BETTISON: And so in the State of 6 7 Michigan, you have the Michigan State Police, and then you have a training academy. And then you have the 8 Detroit Police Department, and we're the ones who will 9 put members through at no cost. And so that is a primary 10 11 motivation, and that is one of the effects. So what we've 12 pushed for, and I know that it's a city building 13 legislation. I've had a conversation with various State 14 legislators where we want to definitely change State laws 15 so that persons will have to pay back. If they get that 16 training from us, it's going to have to be, you know, 17 where they can't just leave us like that because we invest a lot of money in training people to be Detroit 18 19 police officers. And we take it very, very seriously to 20 recruit and it takes money to recruit. It takes money to train in the City of Detroit taxpayer dollars that we're 21 utilizing to do that. So we will vigorously be continuing 2.2 23 to push for that. And I know that the Board is pushing 24 for that as well.

25



1 COMMISSIONER BERNARD: Just as a follow-up, can you have someone in your office, maybe do a survey of other 2 cities who provide training like ours and pay people 3 while they're in training and how do they keep their 4 people? Because this is like a street hustle at this 5 point for the department. And if we're not the only ones 6 who do this, but we need to find out even without the 7 legislature acting, if there's something else ... that 8 9 there's a best practice on this that someone else is utilizing. And thank you. 10 11 FIRST ASSISTANT BETTISON: Yes, ma'am. 12 VICE-CHAIR JONES: The Vice-Chair recognizes 13 Commissioner Shirley Burch. Do you have any questions for 14 First Assistant Bettison? 15 COMMISSIONER BURCH: Yes, sir, co-Chair. Thank you so 16 much. Hello, again, to AC Bettison, it's quite a bit going on. I won't go through it all because there's too 17 much Reverend Holley that I've shared with you before. 18 19 And there's something really that needs to be investigated in Number Eleven, with the lag evidently of 20 leadership, because I'd be getting calls from leaders in 21 2.2 the community. They can't reach anyone at the Precinct 23 when they do reach them at the Precinct, they're given the wrong information. So without calling out people's 24 names, I have asked before for someone to find out what's 25



1 going on in Number Eleven, with the lack of communication, when there are things happening in our 2 3 community, they don't know or the community relations 4 doesn't let the people know. It's like a certain group 5 knows what's going on in Eleven. And then sir, I get complaints from Number Nine from the chair over there at 6 the Bronx community relations. So it's not my duty as a 7 commissioner to be in my home on a Sunday evening to 8 receive calls from leaders that they should know the 9 10 questions they're asking me. So is something wrong with 11 what they're asking as leaders, they should know this. So 12 I'm just wondering AC, when are you going to make 13 changes? That's the bottom line? When are you going to 14 make direct changes to see what it is please? COMMISSIONER BERNARD: Board of evaluation, I think 15

16 what she's asking for.

FIRST ASSISTANT BETTISON: Yes, I definitely hear and 17 so before we make changes in, you know, I definitely have 18 19 influence with that and I've discussed it with Chief White. The thing about it Commissioner Burch, one of the 20 21 things you said is your leaders, they don't know who to contact. And so with that they can definitely contact me 2.2 23 and do that evaluation and with that investigation, we take that very, very seriously. So please have them 24 25 contact me. As a matter of fact, I'll do it myself. So,

1 just get me the names of the individuals so I can hear their grievances, their concerns. And then we can take it 2 from there, we'll do a full investigation into what those 3 complaints are and why they can't get a hold of folks. So 4 5 I've dealt with things at the Ninth Precinct before when 6 I've gotten complaints from community leaders and we've done investigations and we've handled things. And so 7 we'll do the same thing, again. 8 9 COMMISSIONER BURCH: One more thing Mr. Co-Chair, one more and I don't know if this is proper, I'll just say 10 it. And then you say, if it's not proper to discuss, I'll 11 12 understand what happened to the first duty status of Sergeant Kue, I believe his name is at least, can we 13 14 discuss that or we can't Reverend Holley? CHAIRPERSON HOLLEY: I don't think ... Let him see if 15 16 we can let him ... You heard the question, 17 COMMISSIONER BURCH: AC Bettison, you heard me FIRST ASSISTANT BETTISON: Yes, I did hear you, and 18 19 right now the Chief is evaluating that, and I know that the Chief is looking into the matter and that is 20 21 currently you know, an investigation is ongoing. And so 2.2 based on that the sergeant was actually placed where his 23 duty status is, I believe it's restricted duty or if he's at our communications operations section right now. But I 24 always say to our officers that with this it's always due 25



1 process, and so with the due process piece of it, they have the right to that. And at the appropriate time we 2 3 will definitely update and address the Board. 4 CHAIRPERSON HOLLEY: Thank you so much, Assistant Chief Bettison. 5 6 COMMISSIONER BURCH: Thank you Chair Holley. Thank you AC Bettison. 7 VICE-CHAIR JONES: The Vice-Chair recognizes 8 9 Commissioner Willie Bell. Do you have any questions for the Chief? 10 11 COMMISSIONER BELL: Thank you, Vice-Chair. I do have 12 a brief question, I guess, more or less have two statements to make. First of all, AC Bettison, could you 13 report out the end of the year, the situation, how many 14 15 barricaded gun situations that we have encountered? And 16 also the outcome of those? I think most of them have been 17 positive, but I think we need to hear from you. And perhaps we might want to give some recognition to those 18 19 officers who put in a whole lot of work in terms of barricaded gun situations. My second statement is to 20 Commissioner Bernard, the issue about why people are 21 leaving has been debated for what, 15, 20 years. And one 2.2 23 way we can keep people very simple. We can wait, raise the pay scale to \$50,000 a year. 24

25



COMMISSIONER BELL: That might make a difference. 1 We'd be competitive. What other cities engage in, that's 2 not our concern, but the bottom line is this what 3 happened in Detroit? There are two bills pending but they 4 can't come out of committee because those other votes 5 6 control policy. But we are going to continue to fight in 7 those areas, but I tell people you're wasting your time 8 in resident and why people leave. We know why they are leaving. They cite it over and over, but we have three 9 directors of personnel, and they would say that clearly 10 on their exit interview, why they're leaving. So we 11 12 understand, number one is salary and benefits. So that's 13 the bottom line. I just want to share that with us, so we 14 won't keep debating the same issue over and over again. 15 VICE-CHAIR JONES: All right. Thank you. Commissioner 16 Willie Bell. The Vice-Chair recognizes Lisa Carter. Commissioner, Lisa Carter, do you have any questions for 17

18 the First Assistant Chief?

19 COMMISSIONER CARTER: Thank you Vice-Chair Jones. I 20 do have a couple of comments. I totally agree with 21 Commissioner Bell's assessment of the situation. And to 22 answer that retirement benefits are huge as well. It's my 23 understanding that when Detroit police officers, because 24 of the bankruptcy, they don't have medical care when they 25 retire. And I think that that's something that needs to



be addressed. The second thing is congratulations to 1 Chief White on his permanent appointment to chief. The 2 question that I have for you First Assistant Chief 3 Bettison is, the neighborhood beliefs, police officers, I 4 don't know if Chief White has laid out his plans yet, but 5 are there any plans to change their duties and 6 responsibilities? Are they still going to be a part of 7 the plan and what does it look like going forward, if you 8 know? 9

FIRST ASSISTANT BETTISON: So Chief White has just 10 joined, but as far as changing their duties and 11 12 responsibilities, you know, it's a very, very successful 13 program. And so the only thing that we want to do is continuously improve it, but we're not dismantling, like 14 15 I've heard rumor of, and I know some of our neighborhood 16 police officers were worried that, you know, under this 17 administration that we would get rid of the program. That is absolutely not true. There are no plans to get rid of 18 19 the neighborhood police officer program. It's a signature program that's helped us bridge the gap in the City of 20 Detroit, between community and law enforcement. And I see 21 Chief White is on. 2.2

VICE-CHAIR JONES: Okay. Well, what I want to do is go ahead and just take a quick break from the questions and definitely want to acknowledge Chief James White, who

1 is now officially Chief of Police of the City of Detroit.
2 Thank you for coming into the meeting Chief White. Would
3 you like to make a quick comment?

CHIEF WHITE: Yes, sir. Through the Chair. First of 4 all, I want to thank the Board of Police Commissioners 5 for their support of me and this administration in my 6 work and this team's work. I was very humbled by the 7 comments yesterday by Commissioner Holt, and I know it 8 9 represented the entire body and I very much appreciate 10 it. And my commitment is to work as hard as I possibly can to make the city safer. And we're already off to a 11 12 good start with the team that we have assembled with more 13 to come on that. So I just want to start with a heartfelt 14 thank you to all of you as well as the city council for 15 the unanimous vote of me yesterday or Tuesday. So thank 16 you very much.

CHIEF WHITE: In addition, with regards to the 17 question that came up, and I apologize, I don't know who 18 19 asked the question, but there was absolutely no desire, no intent to dismantle and reduce the NPO program. I 20 don't know where that came from. I'm very happy with the 21 work that they're doing. The only thing that I want to do 2.2 23 is enhance the work and maybe add capacity. I'd like to see some evening hours and some weekend hours but they 24 can't be everywhere with the numbers that they have. So 25



1 we're looking at how we can maximize their presence. As I've said many, many times and demonstrated that the 2 community is what we do, it's a central part of our 3 success, and I want to make sure that we're out in the 4 5 field, we're bringing foot assignments, foot beat assignments and enhancing our NPO program. It's a 6 7 signature program that works very well for our community and our police department. 8

CHIEF WHITE: And it will be here as long as I'm 9 here. And that's my commitment to this body. And then 10 finally, the reason I was not here on time is we had yet 11 12 another barricaded gunman situation in the city that resolved peacefully due to the hard work of the men and 13 14 women. I tell you, I was there last night. Many of the 15 people that were there last night were there today when I 16 went back, and many of them worked yesterday. So we had 17 to force them to go home and get some rest. It is absolutely amazing to see the work that they put into 18 19 what they do. Our negotiators are second to none, and we had a very violent situation at an assisted living home 20 21 with over 200 residents.

22 CHIEF WHITE: Many of them well, almost all of them, 23 senior. Many of them need assistance, you know, due to 24 various issues. The officers' restraint and 25 professionalism and patience, not to mention our mental



1 health trained officers, our CIT program. It was incredible. It was absolutely incredible. They evacuated 2 the twelfth floor. This gentleman indicated that he 3 wanted to die. He has a history of violence, have a 4 5 number of weapons in his home. One of our negotiators, 6 watching her work was amazing. I'm going to be commending her in front of his body very soon. She talked that 7 hostage out loud, which I don't want to give away her 8 trade secrets, but she did a lot of work to get him to 9 release that hostage. And he was talking about injuring 10 her. She was already a victim of domestic violence, and 11 12 he was, you know, very focused on hurting her further. 13 CHIEF WHITE: We got her out safely and then the 14 officers, you know, just went into a mode of patience and 15 conversation that lasted 18 hours, ultimately resulting 16 in him giving himself up and safely. And we're getting 17 him the help that he needs and we'll deal with whatever charges that he has pending afterwards, but just fine end 18 to a very, very difficult situation that could have been 19 a lot worse. I hope they all end like this. 20 Unfortunately, the reality of it is with the numbers that 21 2.2 we're seeing, they probably will not, but when you can 23 end them like this, it's an incredible thing. Also, the last thing I want to say is, I want to thank the 24 Salvation Army who came out with water for our residents. 25



1 The DLT system provided us buses for those residents, we had to move and they prepared us enough buses where we 2 could have evacuated the entire building. But the 3 commander on the scene made the decision that the twelfth 4 floor was secure enough where the residents could remain. 5 And that was Commander Szilagy, who again, did amazing 6 work and I also want to thank the Michigan State Police 7 and the Wayne County Sheriff's SRTs. They were able to 8 give our team a break and take over the command. So just 9 10 great work by all.

11 VICE-CHAIR JONES: Well, great. Thank you. The Vice-12 Chair recognizes Commissioner William Davis. The Vice-13 Chair recognizes Commissioner Jesus Hernandez, At-Large. 14 Do you have any questions for the Chief?

COMMISSIONER HERNANDEZ: Good afternoon. Through the 15 16 Chair, just really a feeling of ongoing appreciation for the entire department and all the work that you do. I 17 think it's easy for us to get caught in headlines and in 18 19 snapshots of moments that occur in our community. And it takes a well-centered person, a well-centered resident to 20 be able to take a step back and appreciate the broader 21 impact this department is having, especially in the last 2.2 23 18 plus months. And I think yesterday's confirmation from the city council puts somewhat of a stamp on that as 24

25



well. So ongoing appreciation, damn good job by you
 and the team Chief White.

CHIEF WHITE: Thank you, thank you very much. 3 VICE-CHAIR JONES: Thank you, Commissioner Hernandez. 4 The Vice-Chair recognizes Commissioner Annie Holt. 5 COMMISSIONER HOLT: Thank you Vice-Chair Jones. I too 6 7 make the same observation as Commissioner Bernard, as it related to the attack with the resignations that were 8 submitted by new law enforcement members who came on 9 board as she's also indicated on August 30th. Now, we are 10 aware that those two bills in Lansing authored by Senator 11 12 Santana, Sylvia Santana, as well as Representative Tyrone 13 Carter are, sorry it snagged. I believe we, as Board of 14 Police Commissioners, realize the valuable resources we are investing in DPD law enforcement members to only have 15 16 those investments go out into the various other 17 communities. We need to, I don't know, present at committee meetings, we need to take a more active and 18 19 engaging position. And it's noted that one of the reasons these young officers leave DPD is because of more 20 attractive offers by other municipalities. But Detroit 21 citizens are the ones who are funding that, and I like to 2.2 label it whenever I've had the opportunity to speak at 23 the graduation DPD, you come through a training program 24 based on MCOLES curriculum. 25

1 COMMISSIONER HOLT: You're getting close to what I like to term as a Harvard caliber education in law 2 3 enforcement. So again, I believe we, as the Board of 4 Police Commissioners, could somehow become more engaged 5 in what's happening in Lansing, and to let the folks in Lansing know, you know, people like to say we're one of 6 7 the poorest cities in the nation. Well, okay, but we are sponsoring one of the highest caliber Detroit police 8 9 training systems in the nation, so yes. Two years ago when we had NACOLES, one of the presentations they made 10 11 was how the City of New York had this, walk the block, 12 what translated to me neighborhood police organizations 13 or police officers. And it was a big deal at NACOLES. So 14 I don't know who put it out that we're not going to have 15 neighborhood police officers because I know, over here in 16 District 1, we appreciate them, I won't give names and we 17 expect that to be a continued part of policing under the leadership of James White, who shows a humanitarian side 18 19 to policing. So thank you for the opportunity, Vice-Chair Jones. 20

VICE-CHAIR JONES: Alright, thank you very much. The Vice-Chair right now recognizes and he sees that Commissioner Darryl Brown, District 1, has come on the line. Commissioner Brown, did you have a question or comment for the Chief?



COMMISSIONER BROWN: Yes I do and thank you. Sorry 1 2 for my tardiness. I had some challenges with getting on through another system. I echo the sentiments of my 3 colleagues, Commissioner Bernard and Commissioner Holt 4 about the leaving. So the question is Chief, where are we 5 6 with the program that Reverend Holley was trying to put together with Wayne County Community College because this 7 goes along the lines of what I said years ago is that if 8 the Academy becomes a regional training facility, then it 9 makes them an educational facility and then maybe people 10 can come and just sign up and just pay for their 11 12 education and pay for their training to get through the 13 academy. And then the City of Detroit can just hire them 14 with minimal training dollars needed to train them. And 15 it would still be open to City of Detroit residents. 16 COMMISSIONER BROWN: But I think that may be an

avenue that we need to look at because I know the Fire 17 Department is a regional training facility and they have 18 19 the ability to certify. And I know that was a roadblock with that because of the surrounding schools that have 20 the same capability of making people go to their schools 21 and get their police certification. Then they go out and 2.2 23 look for jobs. I think that may be along the lines we may need to start looking at. Secondly, I just want to thank 24 you for the good job with everything that has been going 25



1 on. I've been really proud to see the things that are going on with the department and how we're responding to 2 emergencies and situations throughout the City of 3 Detroit. I know the men and women of the Detroit Police 4 Department are just doing a fantastic job and maintaining 5 6 it. I was impressed with the officers walking the 7 neighborhoods. We got great coverage with that. That's a great idea. I know that is something that's close to your 8 heart, it is close to mine. And also I needed to know, I 9 understand that there was an accident. And one of our 10 vehicles from the Office of the Chief Investigator, can 11 12 that report be forwarded to me or can it be made public 13 before this Board. I'd like to see a copy of it. CHIEF WHITE: Through the Chair. I'll start with the 14 15 last question first. Yes, I will have my chief of staff 16 get that over to you at the conclusion of this meeting. 17 And thank you for your comments with regards to the officer's response. Prior to you joining the call, I 18 19 talked extensively about the work that I've seen and I could not be prouder, and we're going to keep that going 20

and keep that momentum going. The hardest working under appreciated group. But we're going to make sure we appreciate them. We know this community appreciates them, and we're going to make sure that we tell them, thank you more than we have recently. It has been amazing and their



commitment is second to none. As far as the recruiting
 piece goes, we did in fact unpack a number of issues that
 are going on with our recruiting.

CHIEF WHITE: And I think, you know, we're doing a 4 good job, but there are a couple of obstacles that we're 5 running into. One as was stated, the Detroit Police 6 Department gives you great training and outstanding 7 experience and people, you know, candidly take our people 8 and make them great offers that it's sometimes difficult 9 for us to compete with. So what we try to do is, you 10 11 know, bolster the many opportunities that we have in the 12 department, as well as, you know, constantly having conversations about economics. The mayor is committed to 13 14 that. I'm committed to that. We've had some conversations 15 recently about what that looks like, and more to come on 16 that later. But the regional police academy, as you 17 indicated, Commissioner Brown, there are a lot of people lobbying against that. We had that designation many years 18 19 ago. We lost that designation because of the educational 20 facilities near us that do the exact same thing. It also, if you look at the numbers that we have, we don't have a 21 number of people in this region that are looking at a 22 23 pre-service, meaning they pay themselves, particularly when you look at the levels of which we're hiring. But 24 the good news is we did finalize our agreement with Wayne 25

State or Wayne County Community College. October 13th, we will be announcing that signing. I will be asking,

obviously, for the Commission to be there. Those that 3 want to participate Dr. Ivory has committed to being 4 there. And we're excited about that program brought to us 5 by way of the Chair, Chair Holley. And I think it's going 6 7 to be a very positive program for our students because there's a two-tier track in this program, high school 8 students that will get a certificate in law enforcement 9 in their senior year and be eligible to apply for the 10 Detroit Police Department upon graduation. 11

12 CHIEF WHITE: And then there are the people that have 13 already graduated, who will have a dual track to 14 education, as well as joining the Police Department. So 15 we're happy about that. And the last thing I'll say 16 though, about the recruiting and the attrition report 17 that you all are reviewing, there are some numbers on that report that we're going to capture a little bit 18 19 differently. Some of the resignations you see on that report are actually discipline- related. And they are 20 resigning in lieu of one, in particular, the officer who 21 graduated and promptly went downtown and got arrested. I 2.2 23 was going to terminate him and he chose to resign in lieu of termination. Something that I obviously cannot stop 24 from happening, but that number is captured as 25



resignation as well. So there are some disciplinary cases. So, what we will do for the Board is capture or at least isolate those resignations, in lieu of on the attrition report, and make sure that you see that some of those are occurring there as well. So every person on that report isn't just simply leaving to go to other agencies.

COMMISSIONER BROWN: So, Chief, I know that we talked 8 about it a while back when we have officers that resign 9 in lieu of discipline or under investigation, what's our 10 status with getting their certifications revoked, because 11 12 I know, and that's, what's allowing them to go to these 13 other departments, but if we can work with MCOLES or go 14 through something to revoke that certification, then you 15 know, they can't go anyplace else and be a police 16 officer, because that's why they resigned. You and I both understand that they can go to another department because 17 even though they resigned under some type of 18 19 investigation or discipline, but they still have their certification that they were certified police officer in 20 the State of Michigan, but where are we at and how can 21 2.2 this Board help, you know, get that change instituted 23 that when they do that their certification is revoked. 24 CHIEF WHITE: So obviously, you know, I have zero authority over MCOLES. However, what do we do when 25

there's a resignation in lieu of I author a letter and send it to MCOLES expressing that this was a circumstance that was done with this last case and then MCOLES can make whatever decisions that they want to make. But from my seat I just make the notification that, you know, this resignation was in lieu of disciplinary action on this candidate.

8 COMMISSIONER BROWN: Okay. Thank you, Chief.9 CHIEF WHITE: Yes, sir.

10 VICE-CHAIR JONES: Okay. The Vice-Chair recognizes 11 Commissioner Bernard but due to the interest of time, I'm 12 going to give my time over to you. And I'm going to have 13 you ask your question. If you can ask your question 14 quickly, please go ahead, you have the floor.

15 COMMISSIONER BERNARD: Two things. Number one, first 16 of all,

17 VICE-CHAIR JONES: I said quickly.

COMMISSIONER BERNARD: Chief, you have complimented 18 19 the response of your team at this hostage situation, et cetera. But I heard on the radio yesterday that you were 20 there all day and I guess all night as well. So I think 21 that the Board, I'm sure all of us agreed that you should 2.2 23 be committed as well. You didn't have to be there. You could have had the deputy chief or somebody there, when 24 you were there yourself and that means that all your work 25



1 on your desk was simply piling up. So I want to commend 2 you for what you did personally, in terms of this 3 situation. Secondly, these people that leave, I like your idea about, you know, making that designation and 4 5 certainly sending the information to MCOLES. But if they 6 reapply to us, I'd like something in the record that indicates that they were cherry picking, you know, that 7 they did this, that they hustled us, you know, to me, 8 9 it's a hustle, you know, and they hustled the program and now they want to come back. So that it's there, so people 10 don't forget that. 11 VICE-CHAIR JONES: Thank you, Commissioner. 12

13 COMMISSIONER BERNARD: Thank you, Commissioner Jones,14 very much.

15 VICE-CHAIR JONES: Okay. All right. I'm going to turn 16 the meeting back over to,

17 COMMISSIONER HOLT: Excuse me, Vice-Chair Jones. I 18 believe Commissioner Jesus has his hand raised, I don't 19 know if there's time for his comments.

20 VICE-CHAIR JONES: I'm sorry, Commissioner Jesus, did21 you have another question?

22 COMMISSIONER HERNANDEZ: A very quick ten second 23 supplement to Commissioner Bernard. I just want the 24 community to recognize what yesterday's confirmation of 25 Chief White means. I was driving downtown last Friday



1 down Woodward Avenue, and I saw a caravan. I was very confused at first, traffic was slightly stopped. I saw a 2 3 caravan that's running. And at first I thought, hey, maybe the movie industry's back shooting scenes here, 4 downtown. Low and behold. It was Chief White with an 5 6 entire crew of what I'm going to assume more, either new recruits or cadets. And they were running, their typical 7 run down Woodward. That to me, you had people, and Chief 8 9 White, maybe you didn't recognize this because you were focused running, but you had people in the street 10 recording you. You had people clapping, you had just so 11 12 much emotion going on. And I'm just super appreciative of 13 where we are right now as a department and as a Board. 14 COMMISSIONER HOLT: Thank you Commissioner Jesus for 15 sharing that.

16 CHIEF WHITE: Thank you very much.

17 VICE-CHAIR JONES: Alright, Chairman Jim Holley, I18 turn the meeting back over to you.

19 CHAIRPERSON HOLLEY: Thank you so much, Vice-Chair. 20 Thank all of you for your comments. Chief, I thank you so 21 much. I wanted to ask you, I wanted to put this in your 22 spirit. You know, we don't have the ROTC anymore at the 23 high schools. Can we start thinking about having a cadet 24 at maybe three high schools as a pilot program where they 25 started and give them uniforms and maybe a little

stipend? I was on the White House call Monday; I think it was and they've got about 5 million that we can go for. I was honored to be there because I was representing this Commission, allowing me to do this.

CHAIRPERSON HOLLEY: I just want you to know, I'd 5 6 like to put it in your spirit that perhaps it may be a place, for example, like the civics it could be worth 7 first responders. It could be a class in 11th and 12th 8 grades where they could start looking and talk about 9 being mayors or council people, being servants of the 10 City of Detroit and somehow understand that they are the 11 12 future. So I just put it in your spirit. If we could have 13 a cadet pilot program like it used to be, an ROTC or 14 whatever it was in those days but give them uniforms and 15 a sense of direction and mentoring. Just think about it 16 if you would please. But I'm saying to you, there's a whole lot of money for 2022, and I really want us to 17 really go for all 5 million if we could, but just know 18 19 this, they're going to share it with other cities, but this city is worthy. Your department is worthy. This city 20 21 is worthy, and I'm just asking you to really put it... I want to put it in your spirit to think about that, if you 2.2 23 would please. And I thank you for your time this afternoon. We've been lengthy but I think all the 24 questions have been very appropriate. 25



1 COMMISSIONER BURCH: Chair Holley, Chair Holley. May I please comment, it's Commissioner Burch? 2 3 CHAIRPERSON HOLLEY: I'm asking... My question is... I know Commissioner, I'm just trying to get through this, 4 but this is the time for the Police Chief and I'm just 5 6 trying to make sure of your other Commissioners... my 7 unreadiness doesn't get you ready. So I'm just asking the Chief, if he wants to say this so we can, and I apologize 8 to you Miss Burch but I will get to you before the day is 9 over. Chief White. 10 11 CHIEF WHITE: Yes, sir, absolutely. I think that's a 12 fantastic idea. I mean, that's a community bridge builder, and certainly having law enforcement in the 13 schools and having students committed to a cadet program 14 15 could be a very powerful tool for us. So it's something 16 that we will take up. I will get back with the Commission on where we are with it, but I like the idea and we'll 17 see how we can make it happen, and I'll report back to 18 19 you. CHAIRPERSON HOLLEY: Thank you and judging me with 20 that. Commissioner Burch, you got 10 seconds. 21

22 COMMISSIONER BURCH: Just 10 seconds, thank you. I 23 just want to commend what you just said. Chief White, do 24 you know about the Youth Connection that there are youth 25 from that organization that is painting fire hydrants.



1 And then we also have the Explorers. I've mentioned a long time ago that if we would take the kids from Wayne 2 3 State University and start allowing them to come into our meetings, to be like sub commissioners, these children 4 5 are actually out there painting fire hydrants, 6 beautifying the community. Are you aware of that, and what do you think of using the Explores and the Youth 7 Connection, the youth that they have, that they can come 8 out and learn how to volunteer in their community, 9 supporting the police and their community. What do you 10 think of that, sir? 11

12 CHIEF WHITE: I'm open to anyone who wants to work 13 with the Police Department and the community volunteer or 14 otherwise to support the efforts that we're doing. So 15 that's not something that I would be opposed to at all. 16 COMMISSIONER BURCH: Thank you.

17 COMMISSIONER HOLT: Thank you, Commissioner Holley18 for your focus. Thank you so much.

19 CHAIRPERSON HOLLEY: Commissioner Brown, I want you 20 to know Chief, we have already received the documents 21 about the vehicle of OIC. They already have that and I 22 also want to remind you that anything you guys would like 23 to have, just run it through the Chair and we'll get it 24 to you, but I don't want you to have 11 people asking for 25 things, just run it through the Chair. And Commissioner



Brown, if you look in your package from last week, if you didn't get it, I would have it to you but no later than Monday. I really can't do it today, but I'll try to get it to you on Monday. And if you have any questions or concerns about the report that I gave, then I will certainly sit with you and get what you really want from

the Chief or from anyone else. I thank all of you so much. Facial recognition technology, you have 10 minutes. 8

9 MRS. WHITE: Captain Severy.

10 CHAIRPERSON HOLLEY: Captain I saw you. Are you still 11 with me?

CAPTAIN SEVERY: Yes, sir. Good afternoon. 12

CHAIRPERSON HOLLEY: So good. Thank you for your 13 14 patience with me.

15 CAPTAIN SEVERY: So my name is Ian Severy. I'm the 16 captain over the Detroit Police Department's Crime Intelligence Unit. I'm fortunate enough to have just 17 taken over the seat at the end of June. I'm very 18 19 impressed with the things that we have going on here. And I think we're headed in very strong direction as we get 20 the PowerPoint set up. 21

CAPTAIN SEVERY: So, when DPD first started using the 2.2 facial recognition technology, we had a loose set of 23 quidelines that we followed but with the help of the 24 25 Board and the Police Department and the community we've



1 really tightened up our process and our procedure and policy within this, so much so that the for me, I'm 2 sorry, Christy Lopez was the former deputy chief of 3 special litigation section of the civil rights division 4 under President Obama, noted at a speech that she made in 5 front of the national association for civilian oversight 6 of law enforcement, that the DPD facial recognition 7 policy is the model facial recognition policy in America. 8 9 So I believe that's a pretty strong statement from someone that would have the knowledge of others. So what 10 it boils down to is that when we identify a crime, you 11 12 can actually go to the next slide, please.

13 CAPTAIN SEVERY: So we identify a crime, which is a 14 part one crime, a violent crime or home invasion. We have 15 members from within the crime intelligence unit that use 16 standalone software, which is DataWorks Plus to search for mugshots, for potential matches from the probe photo. 17 What a probe photo is, is a still image from the video or 18 19 social media that we have identified as a potential person that will forward an investigation into one of 20 21 those part one crimes. The trained members who are 2.2 trained by the FBI undergo a three-day process. Of course the training which has a very in-depth and analytical 23 training. They go not only through that, but then they 24 have another four to six hours of Detroit's specific 25



1 training to make sure that our policies are being 2 followed. So once they get the probe photo, they enter it into the DataWorks. DataWorks Plus uses analytics and 3 returns, mugshots that are likely matches and ranks them 4 in the likelihood of a match probe photo, and they are 5 matching the probe photo. And now we have two analysts 6 that do this. Another analyst that's trained that reviews 7 it, and then a supervisor that's also trained that 8 reviews their work to see if there's an investigative 9 lead. Next slide, please. 10

11 CAPTAIN SEVERY: Now it's not only the probe photo 12 and the mugshots that they use, if they can identify a 13 talent, which is a law enforcement information network, 14 police reports, and social media to compare the images, 15 to see if they believe that lead is the true lead. The 16 detectives are producing the best

17 CHAIRPERSON HOLLEY: Captain, is this, the slide I'm18 looking at, is that the one you on?

19 CAPTAIN SEVERY: Oh, no, I'm sorry. If you go to the20 next one, please, sir.

21 CHAIRPERSON HOLLEY: There you go, thank you.

22 CAPTAIN SEVERY: So on the right-hand side here, 23 you'll see a report and it shows the original image, an 24 inquiry image in the investigative lead. So the first 25 image, the image source is g green light video, and as

you can see, it's dark and the only manipulation of a photo that our analysts are allowed to do is cropping the photo to make it to eliminate anybody else being captured that photo they can lighten it a little bit for poor lighting situations. But that is the only cropping that

6 they're allowed or editing that they're allowed to do. There's no other editing that's allowed or done. And so 7 in this instance, you see that the investigative lead was 8 9 produced. The investigative lead gets sent to the detectives for up investigation. Now this is something 10 that we've stressed before, but I can't stress it enough. 11 12 Just because we have a potential investigative lead based 13 on facial recognition that is not evidence alone to make 14 an arrest. We absolutely cannot make an arrest based only 15 on that information.

16 CAPTAIN SEVERY: The next slide please. And that leads into the policy I earlier spoke about. And this 17 breaks down the main points of our policy and it is part 18 19 one violent crimes, which home invasion is included in. And then if you go to the next slide, this is where we 20 really kind of get into what's allowed and what's not 21 allowed. One more slide, please. So prohibited uses, 2.2 23 surveillance. We cannot use facial recognition to surveil the public through any camera or video device. We don't 24 have that ability. We don't want that ability and we 25



don't do it. Live streaming or recording videos. We
cannot use facial recognition on livestream or recorded
videos. And this prohibition applies to all videos,
wherever it originated from. We can own it from still
images. Mobile facial recognition goes right into what is
kind of talking about a week?

7 CAPTAIN SEVERY: We don't use that. We can't use it 8 for predictive analysis. And we are very concerned about 9 not violating anyone's first amendment rights. We are not 10 allowed to perform or request facial recognition searches 11 about individuals based solely on the following, such as 12 their religious political, or social views,

13 participation, in particular non-criminal organization, 14 or lawful events their race, ethnicity, citizenship 15 places, origin, age, disability, gender, gender 16 identities, and so on. That is not the goal of facial recognition and we will not violate anyone's rights with 17 that facial recognition. And additionally we will not use 18 19 it for immigration status as that is obviously outside of the part one violent crime in home invasion. Next slide 20 please. So if this policy is violated it is major 21 misconduct within the Detroit Police Department and the 2.2 23 remedy for this is dismissal from the department. In addition, if facial recognition policy is violated the 24 department will notify the Board of Police Commissioners, 25

1 the mayor, city council president, and city council

2 president pro tem within 24 hours of the violation.

3 CHAIRPERSON HOLLEY: Captain, can I see this slide? I4 don't see this slide.

5 CAPTAIN SEVERY: Oh, next slide. I'm sorry.

6 CHAIRPERSON HOLLEY: Okay. Here we go.

CAPTAIN SEVERY: So one thing that we've done, we've 7 put multiple layers of review into the facial recognition 8 9 policy process, our request process. We have a dedicated analog of all requests. In addition, in my prior seat, at 10 the Tenth Precinct the policy was to, if a detective had 11 12 a case that he or she believed was adequate or allowed 13 under policy that would have to go through the sergeant to the captain, and then the commander prior to that 14 request being made. So there are multiple layers of 15 16 redundant checks to make sure that we are not violating 17 this policy.

CAPTAIN SEVERY: Next slide please. So our use is 18 19 limited to still images, as I mentioned before, we can't use rolling video. We can't use live streaming video. 20 21 It's only a still image that we can use, and it has to be for a criminal investigation. We can't use it for the 2.2 23 technology for anything else, unless it is in support of an active or ongoing part, one violent crime 24 investigation, which is robbery, sexual assault, 25



1 homicide, aggravated assault, or a home invasion one 2 investigation. We also absolutely cannot use facial 3 recognition technology on any person unless there's reasonable suspicion that such use of that technology 4 will provide information relevant to that ongoing 5 investigation. Next slide please. So the process kind of 6 touched on it a little bit. What's the policy that I put 7 into place in the Tenth Precinct, but the request comes 8 into the crime intelligence unit with photographs to be 9 reviewed. The incident number of the crime and other 10 pertinent information about the case. A crime 11 12 intelligence unit shall perform facial recognition, 13 certainly utilize a statewide network of agency photos or 14 snaps, which include criminal mugshot images. In addition CAPTAIN SEVERY: In the event that we don't get any 15 16 potential leads. A formal request may be made to Michigan 17 State Police to search the State's database, which is different from ours. Any such request must be approved by 18 19 one of the supervisors within the crime intelligence unit. If the examiner detects an investigative lead, the 20 examiner must corroborate this lead with at least one 21 other examiner and a CIU supervisor. All of these people 2.2 23 have been trained within the facial recognition process before. Upon final approval, we'll submit a supplemental 24 25 report in our report management system saying that



1 there's a potential lead with some pretty specific verbiage that says the result of a facial recognition 2 3 search is provided by the Detroit Police Department only as an investigative lead and is not to be considered a 4 positive identification of any subject. Any possible 5 connection or involvement of any subject to the 6 investigation must be determined through further 7 investigation, an investigation in investigative 8 9 resources.

CAPTAIN SEVERY: So, it just reiterates again, that 10 it's only a lead and it is at no level any probable cause 11 12 based upon a potential lead. In the event that without further investigation, once that further investigation 13 14 reveals probably because that changes things, but just 15 the picture alone does not give us that ability. In the 16 event that a viable candidate cannot be located, the requester will be notified that no candidate was 17 18 identified, and that photograph of that person that we're 19 trying to identify will be removed from a facial recognition system. So that picture is not a sword. 20 21 CAPTAIN SEVERY: Next page, please. And this is a copy of a teletype that we frequently reflash throughout 2.2 the department to remind everybody that this is a tool 23 that's available to them, but the policy and procedure 24 must be strictly adhered to. And the next slide. This 25



1 just defines what crimes or investigations are allowed 2 under our policy, which is aggravated assault, home invasion one, homicide robbery, or sexual assault. And 3 next slide, please. And the next two slides are the 4 weekly report that is provided to all of the 5 Commissioners. It should look familiar to you if you have 6 any questions on this, it breaks down the number of times 7 we've used facial recognition and the different types of 8 cases. This was from the week of 23rd through the 29th. 9 So the information has changed a little bit, but since 10 then I can tell you that year-to-date in 2021, we have 11 12 used facial recognition technology on 76 distinct cases. 13 And that includes about 97 photos, I'm sorry, 98 photos, 14 98 probe photos. Some of those may be duplicates of the 15 same individual that we didn't initially have. But that's 16 76 cases this year that we've used face recognition on 17 and of the 98 pictures that we've submitted as probe photos. We've got a potential lead on about two-thirds of 18 19 those.

20 CAPTAIN SEVERY: And then the next slide. If you have 21 any questions, I'm happy to answer whatever you may have. 22 And once again, my name is Captain Ian Severy from the 23 Detroit Police Department's Crime Intelligence Unit. 24 CHAIRPERSON HOLLEY: Thank you so much, Captain. 25 Captain, I have a Commissioner that's on oversight. Is



that working out good? Are you taking care of my

2 Commissioner? You're making sure that he knows everything 3 that he's supposed to know and everything, is he working 4 with you on this good?

1

5 CAPTAIN SEVERY: Yes sir, he was actually in training 6 at the end of August and I believe that it went well and 7 we actually have more training coming up if there's 8 additional interest, we can try to get some people in 9 with the Chief's blessing.

10 CHAIRPERSON HOLLEY: Very good. Thank you so much. 11 I'll see Commissioner Holt first and then Commissioner 12 Bernard coming.

13 COMMISSIONER HOLT: Thank you, Chair Holley, and 14 thank you Captain Severy for your presentation. Now, when 15 the incident involving another citizen hit the media, 16 which was in, I think, 2000, well, the incident, you know, percolated over 2019 into 2020 the assumption was 17 that the Board of Police Commissioners were taking a 18 19 blind stance and that we did not understand that the detective who maverickly went about pursuing the citizen 20 21 under the lack of policy, then we didn't know what it was 2.2 as we were doing. Your presentation and I hear you saying over and over again, how the process should 23 work. And I appreciate that because we also need to 24 understand that when we were first made aware that the 25

citizen had been victimized by a misidentification of using facial recognition by this detective, Chief Craig brought it to the attention of everyone. So, you have basically validated the way facial recognition should be used. You've also indicated that the policy instituted by the Board of Police Commissioners, basically leads to how this facial recognition should be used. Thank you again for your presentation. Thank you for giving us the history as it relates to, perhaps, some ways in how

10 facial recognition was not used for the purposes of the 11 policy that it should be used. So, that's all I have to 12 say. Thank you.

13 CHAIRPERSON HOLLEY: All right. Thank you. I want to 14 let the record show that Commissioner Davis has arrived 15 and we'll get to him in a few minutes. Commissioner 16 Bernard, you are on.

17 COMMISSIONER BERNARD: Thank you, Mr. Chair. Just 18 really some questions that I hope you can respond to. 19 Number one, have any cases that you're aware of in court been dismissed because in Wayne County and the federal 20 court here, as a result of anything that we did with 21 respect to facial recognition, I don't know. Secondly, 2.2 23 how many black people work in the department that handles this because 90%, really about 95% of the facial 24 recognition of photos or images that you have inquired 25



1 about, you know, using the process you just explained were all black people. So I was just wondering if they're 2 black people in your office, because in almost all of the 3 cases, only three, I think, were white people, as I 4 5 recall from the last report. And then finally, are there any federal policies that you've reviewed concerning this 6 for other best practices sorts of policies. And thank 7 you. Thank you, Mr. Chairman. 8

9 CHAIRPERSON HOLLEY: You get all that Captain? Do you 10 want me to start? You want me to give you the...?

CAPTAIN SEVERY: I think I've got... So currently we 11 12 have 69 total members within the crime intelligence unit that are trained to perform facial recognition technology 13 14 searches, excuse me. And of that, about 52 to 53% are classified as white. So, just over 38, 39% are African 15 16 American, with one Hispanic and five of Asian descent. So we do have a diverse team and we are aware of that and we 17 will continue to make strides towards inclusion. 18

19 CHAIRPERSON HOLLEY: What about the federal court,20 Captain?

21 CAPTAIN SEVERY: Federal court. So, in my short time 22 here, no, I have not but my predecessor may be able to 23 answer that better. I can reach out to him and get back 24 to you on the specifics of that question. And then 25 regarding court cases dismissed for facial recognition

1 technology. I am not aware of any, but since they are 2 only an investigative lead, facial recognition, and it's 3 not enough to establish probable cause. In any case, 4 facial recognition shouldn't be the reason for any case to be dismissed. 5 6 COMMISSIONER BERNARD: Thank you. CHAIRPERSON HOLLEY: Commissioner Davis. 7 COMMISSIONER DAVIS: Oh, well, good afternoon, 8 9 everyone. My question is this, in so much the recent 10 United Nations, has recommended an outright ban of facial 11 recognition and indicated that it has continued to be 12 biased, has the department reassessed this position or do 13 they plan to reassess it, or do they think it's all right 14 to go against the overall recommendations of the United 15 Nations? Also, it should be noted that I was on the call 16 for a while on my city cell phone, but I was never 17 elevated to the panelist, so I ended up putting my laptop 18 on. So, I understand why some people say there are a lot 19 of problems with these zoom calls. 20 CHAIRPERSON HOLLEY: Captain, do you want to take 21 that or do you want me to ask him to wait until Chief

FIRST ASSISTANT BETTISON: So this is First ChiefBettison. You know, I'll take that one right now.

White comes on next week? Do you want to take this?

CHAIRPERSON HOLLEY: I'm sorry. I didn't know you
 here. Go ahead, my friend.

3 FIRST ASSISTANT BETTISON: I was hanging with you all. I'm still here. So, I haven't seen the study or the 4 article that Commissioner Davis is referring to. So, I 5 6 can't answer that at this time, but I will definitely 7 hear what he stated. At this point, the department feels that just like Captain Severy said that we've gotten 8 9 accolades from the department of justice, as far as 10 having a sound policy. And we believe that our sound 11 policy and policy have to be there to direct behavior, 12 and we will hold anyone accountable who abuses our 13 policy. So, at this point, the department is still of the 14 position that it is a tool, an investigative lead that 15 helps us solve a crime and bring justice to citizens in 16 Detroit. So at this particular point in time, our 17 position is we're still standing by the technology, 18 CHAIRPERSON HOLLEY: Commissioner Brown. 19 COMMISSIONER BROWN: No, Mr. Chairman. Between 20 Commissioner Bernard and Commissioner Davis, some of the 21 questions I had were already asked and answered. Thank 22 you, sir. 23 CHAIRPERSON HOLLEY: All right. Any other

24 Commissioner, Commissioner Bell.



VICE-CHAIR JONES: You're muted, you're muted, you
 muted. Commissioner Bell.

3 COMMISSIONER BURCH: Wake up, you're muted. COMMISSIONER BELL: Okay, can you hear me now? Sorry 4 5 about that. I didn't want to interrupt with a couple of 6 things going on. I just want to say this, there's been a 7 great deal of focus on facial recognition, but I would hope that some of you take time to look at the criminal 8 9 justice system that impacts an investigation. Number one, eye witnesses are not reliable. Number two, lineups are 10 not reliable. Number three, photo lineups are not 11 12 reliable. So with all the crime, we have in Detroit, the 13 issue of being an African American predominant black 14 city, and most of the department is African American. I 15 just feel as though you spend a whole lot of time on the 16 issue that we wrote a policy on and we impact. So you 17 don't have to come... you should have gone through this process back when it first started. All of us had the 18 19 opportunity and some of us never took the time, but they became a critic. Thank you, Mr. Chair. 20

CHAIRPERSON HOLLEY: All right. Thank you. Any other
 questions? Commissioner, Vice-Chair Jones.

VICE-CHAIR JONES: Absolutely. Thank you. Mr. Chair.
I, for one, think I bring a different perspective to this
whole position on facial recognition, being that I've

1 worked the streets myself, being that I've been out there 2 in the community, being that I've been out there with the 3 mothers, which I've met many mothers who wish they had this, this type of technology in place and wish that the 4 harm or the gun violence that their sons and daughters 5 6 had felled to, or caught on tape some kind of way so that 7 they would have a lead on something that happened to a family member of those. I cannot see anyone suggesting 8 9 that this program is inherently biased, that it violates 10 anybody's rights if it brings to justice the person that 11 committed this gun violence in our community. This gun 12 violence is completely out of control. And I guarantee to 13 bet you, if it fell within the households of some of the 14 people that were opposing this kind of technology that 15 they would certainly change their mind and they would 16 step up because they want justice for the family that 17 they lost as a result of this gun violence. 18 VICE-CHAIR JONES: This gun violence is out of

19 control. If this kind of tool, which is only an
20 investigative tool, is one of many that are used to
21 probably bring a person of interest into custody. If this
22 technology were to be used to get justice for these
23 families, then guess what? So be it. I haven't had
24 anybody that I've dealt with that did not want this

1 technology to expose a person that committed this crime

2 against their loved one. Thank you.

3 CHAIRPERSON HOLLEY: I thank all of you. There are no4 other questions.

5 COMMISSIONER HOLT: Well,

6 CHAIRPERSON HOLLEY: Who's well?

7 COMMISSIONER HOLT: This is Commissioner Holt.

8 CHAIRPERSON HOLLEY: But I thought you already had,

9 didn't you have a question?

10 COMMISSIONER HOLT: I know. My hand is raised again,

11 but if you want to go on, I'm okay.

12 CHAIRPERSON HOLLEY: I really want to go on since you13 gave me the option.

14 COMMISSIONER HOLT: But I'd like to also reference 15 the fact that when commissioner Griffie was with us, she 16 was one of the commissioners that insisted that the facial recognition reports reflect ethnicity, sex, as it 17 relates to those individuals who have been targeted by 18 19 facial recognition. And Captain Tosqui, recognizing that facial recognition being used in a city of predominantly 20 black folks, it would appear that facial recognition was 21 being used as a tool against black folks. But the shared 2.2 23 nature of the fact that facial recognition was being used in a community of black folks. So to that point, you will 24 have a representation of black folks being identified in 25

1 the statistics because we are a city of black

2 individuals.

3 CHAIRPERSON HOLLEY: Thank you, ma'am. Again, remember this is just a question, it's not to debate this 4 5 thing over and over again every time it comes up. It's 6 the question to make that we are oversight and that we are doing everything we can to make sure they're doing 7 what they're supposed to do. And we have a Commissioner 8 that's assigned to this. And that's the reason why we 9 have him there. I also want to 10

11 COMMISSIONER HOLT: Chair Holley, one last point. I promise you the very last. We received an invitation to 12 13 watch a documentary that's called Code Bias. Now, I also 14 shared this title with Captain Tosqui. That Code Bias documentary is a wake-up call for the potential for 15 16 facial recognition to be used internationally. So we were 17 educated, those of us, who watched the video, the documentary, we perhaps, ourselves are more educated on 18 19 the potential misuse of facial recognition.

20 CHAIRPERSON HOLLEY: All right. Thank you very much. 21 I thank you very much. Commissioner Davis, my 22 understanding is I don't know much about this stuff, but 23 when you are on the phone, zoom does not allow you to 24 elevate it to another panel, so that's the reason why, 25 but once we recognize my staff indicated that once we

1 recognized that you were near we put you right on the panel here. So, I want you to know we're doing everything 2 we can to make sure everybody is connected on the zoom 3 call. I thank all of you. I want to move on if you don't 4 5 mind and go to the Detective Bureau if you please. And I think Deputy Chief Wilson, I think it is, and if you got 6 7 anybody else Deputy Chief with you if you can introduce them. 8

9 MRS. WHITE: Captain Johnson.

CHAIRPERSON HOLLEY: It's not Deputy Chief Wilson?
 MRS. WHITE: No, sir, it's Captain Johnson.

12 CHAIRPERSON HOLLEY: I'm sorry, Captain Johnson. I 13 see Gerry Johnson, but I don't see the Captain. So I want 14 you to understand I don't mean to be disrespectful, but 15 to Captain Johnson, I'm sorry, I thought it was someone 16 else, but welcome.

17 CAPTAIN JOHNSON: Thank you. Good afternoon, everyone. Captain Gerry Johnson, Detroit Police organized 18 19 crime under the Detective Bureau. I'm presenting, I don't know if the slide is up, on organized crime. First, my 20 condolence to you Vice-Chair Jones for your family. 21 VICE-CHAIR JONES: Thank you, sir. I appreciate you. 2.2 23 CAPTAIN JOHNSON: I don't know if we have the slides 24 up.

25



CHAIRPERSON HOLLEY: I'm working on it now, here we
 go.

CAPTAIN JOHNSON: Thank you. As you see the Detroit 3 Police Department, Detective Bureau of Organized Crime. 4 5 The next slide, please? The Detective Bureau is made up of organized crime. Here are some of the entities under 6 Organized Crime, Major Violators, Vice, Task Force 7 Administration, Gang Intelligence, and our Public Order 8 9 Crimes, which are the General Assignments Unit and our Cyber Crimes Unit. We also have an Investigative 10 11 Operations Section and that's our Crime Scene Services, 12 our property control, our precinct detective units, our 13 court section, Data Quality Control, our Records 14 Management System, and our NIBIN. I'm going to talk about 15 each real thing briefly. Next slide, please. Our major 16 violator is made up of our Narcotics, two red crews so 17 far for narcotics, and we enforce all illegal marijuana dispensaries right now. Our Vice Enforcement is of course 18 19 enforcing prostitution illegal liquor activity, sales, 20 illegal gambling. We also do enforcement on city 21 ordinances relating to hotels, motels, rental halls, massage parlors, and any adult entertainment venues. We 22 23 also conduct enforcement and investigation on human trafficking, which is very, very important. 24

25



CAPTAIN JOHNSON: Also Planning Analysis Section. We 1 evaluate the process and distribute all narcotic 2 complaints within the City of Detroit. We capture and 3 maintain all statistical data and we maintain cases and 4 complaint files regarding that. We also have a Prisoner 5 Processing Unit, where we review all arrests for 6 violations of the controlled substance act. Next slide, 7 please. This is some of our narcotics year-to-date, as 8 you saw earlier on our previous slide, only two narcotics 9 groups. We've executed 24 search warrants, street 10 enforcement is down, felony arrests are down, but our 11 12 quality went up. That's the most important as you see 13 from the cocaine seized, over 2000 grams or more. The 14 heroin seized, close to 2000 grams or more, also an 15 increase in marijuana seized but we're doing more quality 16 raids, while we have a reduction of personnel in the narcotics unit, just fantastic work regarding that. 76 17 weapons were recovered and 24 vehicles were seized. Next 18 19 slide. Our Gang Intelligence, which I consider the hub of organized crime, our Gang Intelligence, we perform an 20 analysis of all legalized, organized gangs and group 21 dynamics within the city. 22

CAPTAIN JOHNSON: We conduct precision enforcement,
 basically target enforcement through intelligence led
 policing, organized gangs, and groups. Most importantly,



1 we provide support to the community outreach, the Precincts, the Detroit public schools, homicide, State, 2 and our federal law enforcement partners. We investigate 3 and suppress emerging gang members involved in violence 4 5 in all Precincts. And we promote the cease-fire initiative throughout the City of Detroit. Next slide, 6 please. As you see just based on the results, this is a 7 collective, not just organized crime, just throughout all 8 9 the Precincts. You see a reduction in gang incidents from 2020 to this year, 2021 year-to-date. Last year it was 10 107, this year, 85. So we're moving in the right 11 12 direction regarding gang violence in our city. Next 13 slide. This is our Task Force Administration. What this 14 is, is all our entities that work with our federal 15 partners.

16 CAPTAIN JOHNSON: We have our Violent Gang, Violent Crime Taskforce, investigate violent crimes with our 17 18 federal state prosecution. We investigate groups or gang 19 violent crimes. We investigate the bank robberies, ATM thefts, and murder for hire. Our Firearms Investigative 20 Team, which is our ATF partner, investigates violent gang 21 activity for federal state prosecution, investigates all 2.2 23 firearms, all trafficking with firearms, and reviews all qun arrests for federal prosecution. Our Joint Terrorism 24 Taskforce. That's with our FBI. We investigate 25



allegations of terror threat for federal prosecution. We 1 also have a Detroit fugitive apprehension team. That's 2 with the US Marshall. We serve certain fugitive warrants 3 for violent crimes, both federal and state, and also our 4 violent crime reduction initiative. That's our 5 6 partnership with our Wayne County Sheriff and Detroit 7 Police Department, and we serve warrants for violent crimes committed within the City of Detroit. Next slide. 8 9 CAPTAIN JOHNSON: I'm not going to go over this. This is just phenomenal work on everyone. The drag racing 10 stats. I know First Assistant Chief Bettison reported 11 12 this out. Just phenomenal work regarding our drag racing. 13 We've seen a tremendous decrease regarding that, and 14 we're going to keep it up. We just conducted a search 15 warrant on an individual that was really putting out 16 where to go to drag racing. So he was very upset that we 17 made a visit to his home regarding that. We're really trying to suppress this reckless behavior. Next slide. 18 19 This is our General Assignments Unit, our Public Order Crimes. We deal with the quality of life issues, 20 electricity theft, scrappy, graffiti, and cyber-crimes 21 issues. Very, very important unit to keep the quality of 2.2 23 life within the City of Detroit in the upward direction. Great unit. Next slide. Ceasefire Outreach. We all know 24



the importance of our community partners, the ceasefire

25

development administration and implementation of 1 2 strategic initiatives that support DPDs community policing platform provides tremendous support to the 3 community Precincts, Detroit public schools, and 4 5 homicide, and most importantly, they do liaison between the community and the police, emergency and temporary 6 relocations of groups and gang members. We use them a lot 7 for that and also the peace walks within the community. 8 Next slide. 9

CAPTAIN JOHNSON: This is our Crime Scene Services. 10 This is our evidence text, our latent prints, our 11 12 property control, and our NIBIN unit. We have processed 13 over 5,000 firearms with our NIBIN unit. That is our 14 partnership with our ATF, just a fantastic partnership 15 regarding that, really helped us solve a lot of cases, 16 non-fatal shootings. Next slide. This is our records, our 17 Data Quality Control. This will review all our record management system reports for proper coding and 18 19 assignments, report all crime stats to our MIC, which is Michigan Incident Crime reporting. In our record 20 21 management system, we maintain and disseminate department records, and what's been an increase, we respond to all 2.2 23 those FOIA requests. The Customer Service Desk for crime reports, accident reports, and firearms, registration, 24 then Identification Section. We positively identify all 25



arrestees, our MDOC checks and applicants, and background
 checks for clearances. Next slide.

CAPTAIN JOHNSON: The PDU is our investigative 3 liaison. What that is, is just to make sure all our 4 Precinct Detective Units are all on the same page. We 5 coordinate, investigate policies, processes among all 6 Precinct Detective Units. We have a Court Liaison 7 Section. So, liaison with DPD and the courts. And we also 8 9 assist with all the arraignments regarding that. Our PDU court officers will manage all court work regarding in 10 11 custody, prisoners, and non-in custody warrants. And also 12 they are liaisons with the Wayne County Prosecutor's Office. Next slide. That's it. If you have any questions, 13 14 that's the conclusion of organized crimes. You see, it's 15 a lot of entities just fantastic work with every member within this unit. 16

17 CHAIRPERSON HOLLEY: Are you telling me, Captain, all18 of this is under the Detective Bureau?

19 CAPTAIN JOHNSON: Yes, it's all under organized 20 crime, including drag racing detail, that's correct. 21 CHAIRPERSON HOLLEY: How many people are in your 22 department?

23 CAPTAIN JOHNSON: That's a great question. I have24 close to 165 members, personnel.

25



CHAIRPERSON HOLLEY: Any other questions? Vice-Chair
 Jones, Commission Jones.

VICE-CHAIR JONES: All right. Thank you, sir. Through 3 the Chair. Thank you for your report. Captain Johnson. So 4 5 much of that information is so useful and people have no idea. Like Chairman Holley was just explaining, people 6 have no idea how much personnel and how many resources it 7 takes to bring a case together, especially when you're 8 doing them all across the city. But just to bring one 9 case together, takes an incredible amount of resources. 10 Now you talked about the NIBIN system. Can you explain to 11 12 our audience and also to our Commissioners, what that 13 NIBIN system is all about? Because I've asked if they 14 partner with any other agencies to help with identifying a casing or a led bullet. Can you explain to them what 15 16 NIBIN is about?

CAPTAIN JOHNSON: Yes. To put it in very simple 17 18 terms, when we go to a shooting scene or any scene or 19 recover a weapon, of course, if casings are recovered, they put those casings in the machines and they try to 20 21 match it up for a weapon. And with that casing, they can match it up to other shootings in the area. How that's so 22 23 important as far as trackback and really close the case. And what we talked about earlier, those families that 24 suffer from violence from their kids, and it's just been 25



1 a useful tool. Regarding other agencies, yes, all the 2 time departments reach out, can you rush this weapon into NIBIN? No problem. We put it in and there are so many 3 cases as we know, we're so mobile now. So our residents, 4 5 our criminals are in Sterling Height, Southfield. Southfield is in Detroit. So we have been able to partner 6 and really solve some great, great crimes using that 7 NIBIN system, just fantastic. 8

9 VICE-CHAIR JONES: Okay. So if a person... Say, if 10 you had a case from five years ago, and there was a 11 casing that was recovered and the NIBIN system helped to 12 close the case from five years ago.

13 CAPTAIN JOHNSON: Absolutely. Absolutely. I mean, 14 it's a fact. It goes back, it's just a fantastic tool. We 15 use it all the time within the Detroit Police Department. 16 l have a unit dedicated, just to go back, just for that 17 Vice-Chair Jones. It's to go back five years, two years 18 to try to open up those closed cases to make them keep 19 going. It's a whole NIBIN unit for that.

20 VICE-CHAIR JONES: Oh, I have some more I could throw21 at you, but I'm going to let you off right there.

22 CHAIRPERSON HOLLEY: Commissioner Brown.

23 COMMISSIONER BROWN: Yes, sir. Chairman Holley. Thank24 you for the report. I mean, it's a fine report.

25 CAPTAIN JOHNSON: Thank you, sir.



COMMISSIONER BROWN: It really laid out everything 1 2 you guys do, and I really appreciate it but I just had a question concerning liquor licenses at the stores. A lot 3 of these stores are raided and busted for selling to 4 5 underage people and different things like that. How are 6 they able to stay in business and then open back up once they've been shut down when it has been deemed that you 7 have raided them and caught them in violation of their 8 9 license, how are they able to stay in business? Because we have one in particular in the Eighth Precinct as an 10 11 ongoing problem. So how are they able to stay in 12 business?

13 CAPTAIN JOHNSON: Absolutely. Thank you, for that 14 question. Sometimes we do a thorough document regarding 15 that and sometimes it is fostering, but as you know, it's 16 a legal process. We put it through our legal department, 17 they run it through, it's just a process that we have to 18 deal with, but as long as we document, we continue to 19 conduct enforcement action writing the tickets, but it's usually the legal processor that slows things up. 20 21 CHAIRPERSON HOLLEY: Thank you so much. Thank you, Commissioners. Are there any other questions? 2.2

COMMISSIONER BURCH: Here I am. You can't see me?
CHAIRPERSON HOLLEY: All right, Commissioner Burch. I
can see you, but I couldn't hear you. Go ahead.



1 COMMISSIONER BURCH: Bless your heart. Okay. I wanted 2 to say, thank you, Captain. How many detectives are per 3 Precinct?

4 CAPTAIN JOHNSON: How many detectives per Precinct?
5 COMMISSIONER BURCH: Yes, in each Precinct?
6 CAPTAIN JOHNSON: Great question, again. It all
7 depends on the Precinct. I know Number Nine is a busy
8 Precinct, so they have more detectives than Number Seven
9 or Number Four.

10 COMMISSIONER BURCH: Here's the question. I'm sorry 11 to break you because Reverend Holley will say next. I 12 want to say this to you, sir, he gives Miss Annie all the 13 time and I'll have to talk to him about that later, but 14 this is what I want to say, how in the world, with what you have the manpower of a hundred for the whole city, 15 16 right? A hundred. And then if you have a few at Number 17 Eleven, that's my example to you right now. You have 18 neighbors that say they remove the gangs and they come 19 right back. So, it looks like, to me, there are no solutions, Captain. That when the gang members are gone 20 21 away and they come back and then the citizens too are 2.2 intimidated by reporting these gangs. Did you know that? 23 CAPTAIN JOHNSON: Yes ma'am.

24 COMMISSIONER BURCH: So what are you going to do?25 What are you going to tell the citizens?



1	CAPTAIN JOHNSON: Well, this is what I would tell the
2	citizens regarding Number Eleven. We have all our
3	resources assisting Number Eleven Precinct at all times
4	regarding that. We just had a meeting regarding that at
5	Number Eleven, and also, I have a plan in place because
6	the most important is to youth. We spend a lot of time
7	with our youth and getting into mentorship, and that's
8	how you stop the recurrence of gangs. You have to get
9	into those middle schools and high schools and have those
10	mentorships, and I'm not calling them high impact
11	offenders. I'm calling them high risk
12	youth. You have to recognize them, identify them and
13	mentor them. That's the only way you're going to stop,
14	COMMISSIONER BURCH: But Captain,
15	CHAIRPERSON HOLLEY: Commissioner.
16	COMMISSIONER BURCH: Wait, one more. Captain.
17	CAPTAIN JOHNSON: Yes, ma'am.
18	COMMISSIONER BURCH: What I'm saying is that you
19	mentioned youth, I'm talking about grown folks. These
20	people are well grown like you and their gangs. So I'm
21	saying they're out there, you know that. So I'm not
22	telling you something you don't know. My question is you
23	cannot handle that with the few you have. So Number
24	Eleven is trying to become like Number Nine full of gang,
25	gang, gang, that I'm trying to, as long as I breathe, I'm



09/23/2021 1 going to tell it, and I'm going to tell the truth. I 2 thank you, sir. 3 CAPTAIN JOHNSON: Thank you, ma'am I appreciate it. CHAIRPERSON HOLLEY: Commissioner Bernard, do you 4 5 have your hand up or are you just relaxing? 6 COMMISSIONER BERNARD: No. I have no other questions. 7 CHAIRPERSON HOLLEY: Very good. Okay. I hear no other Commissioners; can I move on? Okay. Commissioner Davis, 8 9 can I move on?

10 COMMISSIONER BURCH: Be quiet, Annie.

11 COMMISSIONER DAVIS: You definitely can move on, sir. 12 CHAIRPERSON HOLLEY: I thank you so much. Secretary 13 White, you may go to the next item.

MRS. WHITE: Yes, sir. Good afternoon, Honorable 14 15 Board. Through the Chair and DPD executives and meeting 16 attendees. Please note the following information for 17 incoming correspondence for this week. The Honorable Board, please see the weekly DPD facial recognition 18 19 technology report for September 13th through September 19th. Please keep in mind that these FRT reports are 20 posted to the Board's web page each week for the public's 21 inspection and consideration. Additionally, the Board 2.2 23 received City of Detroit, a lawsuit with case number 21-24 011843. Also the Board received the Michigan occupational safety and health administration response, the Neosho 25



1 response providing clearance regarding the City of Detroit Merrill Plaisance administrative office facility 2 involving building plumbing and other alleged safety 3 hazard complaints. The Merrill Plaisance is a city owned 4 building with OCI and DPD offices. And Neosho provided a 5 response again to the complaint, closing the fire and 6 7 noting the building is up to health and safety standards. MRS. WHITE: The Board also received various staff 8 reports, including, but not limited to the revised 9 proposed bylaw amendments. Also other Neosho responses 10 regarding another complaint that was lodged. Additional 11 12 information was supplied regarding various personnel 13 items and other administrative information for the 14 Board's consideration. Also regarding NACOLES updates. 15 Please note that the NACOLES virtual conference is still 16 underway. This week's webinars were focused on jail and prison oversight and also provided attendees with a range 17 of topics specific to both the culture of correctional 18 19 institutions and the oversight of jails, prisons, and lock ups. So please continue to tune into those webinars 20 21 and know that NACOLES will provide recordings and PowerPoint presentations regarding all conference 2.2 23 webinars. And lastly, the NACOLES in-person conference is 24 upcoming December 11th through December 17th. The inperson conference will include four days, approximately 25



four days of more in-depth training for those interested 1 in or doing the work of civilian oversight of law 2 enforcement, jails, or prisons. And the in-person 3 component again, will be held in Tucson, Arizona for your 4 5 information and please check your inboxes for additional inquiries so that we can process the registration. And 6 that concludes my report. Thank you. 7 CHAIRPERSON HOLLEY: Thank you. 8 COMMISSIONER BELL: Mr. Chairman. 9 CHAIRPERSON HOLLEY: Yes, Commissioner Bell. 10 11 12 COMMISSIONER BELL: Yes sir. Thank you. I do have a 13 question for Ms. White. In the last two weeks, even this 14 week, the issue being raised about OCI vehicle being 15 involved in an accident when we raised the issue in the 16 public setting, I would like to get Ms. White to respond 17 in a public setting, even though we receive a copy of the report last week and Ms. White, we would appreciate it 18 19 for us to clarify this matter. COMMISSIONER BELL: You want that done now? 20 COMMISSIONER BELL: Yes, sir. She could speak briefly 21 to it. 2.2 23 CHAIRPERSON HOLLEY: Okay, go ahead, Ms. White. MRS. WHITE: Yes, sir. Through the Chair yes, the 24 Honorable Board did receive information regarding the hit 25

and run the City of Detroit vehicle accident that 1 2 occurred involving one of the OCI vehicles. The hit and 3 run accident, as we shared with the Board last week, was parked legally at the location. Proper notifications were 4 made to communications operations, as well as DPD 5 6 officials and DPD officers responded from the Twelfth Precinct to the location, conducted an investigation and 7 prepared a traffic crash accident report for record 8 9 keeping and also security cameras, surveillance cameras, 10 that information was shared with the full Board so that you could view what actually happened as a result of that 11 12 hit and run accident. And so we have just recirculated 13 that information. Thank you. 14 COMMISSIONER BELL: Thank you, Mr. Chairman. 15 CHAIRPERSON HOLLEY: Do I see another hand? 16 COMMISSIONER HOLT: Yes, Chair, Holley, thank you for 17 recognizing my electronic hand. Mrs. White did reference 18 the fact that the NACOLES meetings are recorded and 19 accessible to us, but I believe, and Mrs. White, of 20 course can validate this fact. Those video recordings or 21 those audio video, audio recordings of the NACOLES 22 meetings are out there for us, like within a 30-day 23 timeline. So of course, Ms. White can again address that 24 timeline as I understand it.



COMMISSIONER BURCH: Here I am, back, Chair Burch. I 1 2 mean, this is Commissioner Burch. 3 CHAIRPERSON HOLLEY: You want to address? COMMISSIONER BURCH: Yes, I want to address what 4 Commissioner Bell said. When he said that he would like 5 6 for Ms. Melonie to say on the Board what happened with 7 the suspicion of the car being hit, one of the OCI people's car being hit, why does that need to be 8 9 publicized on the Board, sir? Wait a minute, it's just 10 like when we were on the zoom last week and AC LeValley 11 was on the news and I'm looking right at his face and 12 they reported that the Board of Commissioners are talking 13 about this case right now, and that wasn't true. So, 14 Chair Holley, nobody got on the air to say that was not 15 wrong, that reporter made a mistake in saying about what 16 AC LeValley was interviewing. We didn't discuss that at 17 the meeting last week.

18 CHAIRPERSON HOLLEY: No, ma'am.

19 COMMISSIONER BURCH: How come we don't get on things 20 like that? Wait a minute. How come, we don't get on 21 things like that Chair Bell, you're supposed to be 22 supporting the gas station issue. I don't hear you 23 getting on the Board to say the gas station issue so we 24 can stop.



COMMISSIONER BURCH: Yes, I'm just saying. You aren't
 going to let me talk, Annie can talk.

3 CHAIRPERSON HOLLEY: But you're right, but I'm just 4 saying to you Commissioner, you have to address your 5 remarks to me, not to the Commissioner, you got to come 6 through me.

7 COMMISSIONER BURCH: Okay, well I'm going to talk to 8 you.

9 CHAIRPERSON HOLLEY: So I'm just saying to you, is that commissioner Davis raised a question, which he had a 10 right to raise, and I had a right to find out the answer 11 12 to his question. And I put it in my remarks, I answered 13 his question because, and I put it in the record in 14 public. What Commissioner Bell is saying that since he 15 was asked publicly, he felt like he should respond 16 publicly? So all this well, and Commissioner Davis had 17 the right, Commissioner Bell has a right. I was trying to 18 make sure that I answered his question as a chairman 19 should do. And so I'm just saying that's how it rolled. 20 And then you have a right to say what you had to say, but 21 I just want to make sure... I don't want to get too 22 personal, just come to me so I can handle this and give 23 me a chance to do it. Commissioner Jones, is that your 24 hand.

1 VICE-CHAIR JONES: Yes. I have a question through the Chair. I just wanted to first say that it is a violation 2 for any Commissioner to call another Commissioner out by 3 4 name. That's not what we're supposed to do. It goes 5 against Robert's Rules of Order, and it goes against our bylaws. Also, we are to refer to each other as 6 commissioner or the other commissioners, as opposed to 7 calling the other commissioner out by name. You are 8 9 perfectly correct when you say that everybody's inquiries 10 should be addressed directly to the Chair and anybody who addresses those inquiries to the Chair needs to bring 11 12 proof if they're bringing an allegation about somebody 13 else to the chair for the proper resolution. So everybody 14 making an accusation, you have to be prepared to name your source, you have to be able to identify the Chair in 15 16 order for us to move forward. That's all I have to say. CHAIRPERSON HOLLEY: Thank you. Unfinished business. 17 Any unfinished business. 18 19 COMMISSIONER DAVIS: Yes. CHAIRPERSON HOLLEY: Yes, Commissioner Davis. 20 21 COMMISSIONER DAVIS: I have two things. One, as I've stated a number of times, I'm sure the previous chair 2.2 23 probably remembers this. I previously requested and

24 wanted clarification on the fact that we, like in the war 25 department, anytime any of our vehicles are in an



1 accident, we get a report. And anytime that there's a 2 vehicle accident, if somebody was driving, I'm not saying 3 this particular time, you know, they should go to the clinic and get, you know, that should be a standard 4 policy. We shouldn't be doing so much stuff that looks 5 6 like we are trying to cover up our friends and what have 7 you. Also separately as it relates to unfinished business. When are we ever going to start interviewing 8 9 for the Board Chair, you know, I mean for the Board 10 Secretary and the chief of OCI? It seems like this Board 11 has been dragging its feet for like two years or more, 12 you know, and this is just wrong on so many levels. 13 CHAIRPERSON HOLLEY: Okay. But first of all, I thank 14 you for both questions. And it's on me about your first 15 question. It's on me. I should have handled it better. 16 And I didn't in terms of the vehicle's situation. The HR 17 is handling the other two situations that you asked and 18 they have closed it. They're ready now to move forward 19 with the candidates. So I should have this at the next 20 meeting, how are we going to roll this out? But you're 21 absolutely right. I'm just saying to you that HR has 22 informed me that they have closed the post seat. So we 23 should by next week know how we're going to handle this 24 going forward, but you're absolutely right. Commissioner



Bernard, just have mercy on me, and just to tell me what
 you want.

COMMISSIONER BERNARD: Mr. Chairman, I think that the 3 Board's emphasis on a fender bender accident is quite 4 5 frankly, no offense to anyone, a waste of time. And it's not something that comes before a board of directors of a 6 multi-million-dollar organization. A fender-bender is 7 something that is handled at a much lower level. We have 8 9 zillions of people in the city to handle it. I don't know 10 why we are even talking about it.

11 CHAIRPERSON HOLLEY: Yes, you're probably right. And 12 again, like I said, it's on me,

13 COMMISSIONER HOLT: Chair Holley, you do good work. CHAIRPERSON HOLLEY: But it's on me, it's on me. And 14 15 so right now, I'm going to new business. Let me just ask you, I want to move on. I do have Dr. Jackson here and 16 17 I'm paying so much money and I'm trying to make sure that 18 she has something to say so she can at least let the 19 people who pay her know that she's here. So I'm giving her like three or four minutes just to give you a hello 20 and her evaluation of how you guys did. I know I did 21 22 well, how you guys did.

23 DR. JACKSON: Good afternoon to the Board and to the 24 public who are watching. Chairman Holley asked me to 25 provide some feedback in terms of parliamentary



1 procedure, based on my evaluation of some things that have happened in the meeting. It's kind of awkward 2 because it sounds like personal criticisms of individual 3 commissioners. And I hope it won't be taken in that way. 4 One of the great things about Robert's rules is that it 5 doesn't have any favorites, it doesn't play sides, 6 there's no favoritism. It's just what the rules are. Very 7 quickly, just a few things that I have observed. Your 8 9 rules don't provide for you to yield time or save time. You speak or you don't speak but you cannot take your 10 11 time and give it to someone else, nor can you say I'm 12 saving my time for something else. As you saw from the 13 beginning of the meeting, I pointed out to Chairman 14 Holley, the many items of a non-controversial nature can 15 be handled by unanimous consent, as long as he asks, if 16 there is any objection.

DR. JACKSON: And at any time, if you object to 17 something being handled by unanimous consent, you are 18 19 free to say, I object. And if there's an objection, we have a motion and we have a vote. Once you get to, if you 20 do, with the bylaws and to establishing committees, I 21 just want to make sure you know, that whatever name is 2.2 23 called first is automatically to the chair of that committee. So Chairman Holley and the Board need to be 24 25 very careful about which name goes first, because the



1 first name is going to automatically be the chair. And that's true for everybody, not just for the Board of 2 3 Police Commissioners, that's Uncle Henry and what he has to say. I noticed that there are times when the 4 commissioner started speaking without being recognized. 5 6 The fact that you call the chair by name does not mean 7 that the Chair has recognized you and given you the floor. 8

9 DR. JACKSON: And so you can raise your hand or you might call out and say, Chairman Holley, but until 10 11 Chairman Holley says a name, nobody has the floor. And so 12 you just need to be careful about that. I'm not sure the 13 Board understands, when you approve this agenda today, 14 you approve 10 minutes for two reports. That means if you 15 go over that 10 minutes, you need another motion. You 16 need a motion to extend the time. You cannot just go into 17 remarks and keep talking. When you approve that agenda, 18 and it says 10 minutes. That means that at the end of 10 19 minutes that report was finished. And that means all 20 comments are cut off, all questions are cut off. And the 21 way to handle that is that if you don't want to finish 22 within that 10 minutes, then you have to make a motion to 23 extend the time that motion is not debatable and requires 24 two-thirds vote.



1 DR. JACKSON: So in the future, when you approve an agenda that has a time on it, you are basically saying 2 3 that report and all comments and questions must be incorporated within that time limit. Now, if you feel 4 5 like you're not through, you want to say something, then 6 you can move to extend the time. And you have to say by how long, extend the time two minutes, extend the time 7 five minutes. It's a non-debatable motion. It can be 8 9 amended, but it cannot be debated. And it requires two-10 thirds to be adopted. You cannot, it's pointed out I believe by Commissioner Jones. We make comments and 11 12 debates, it is out of order to refer to someone's 13 motives. One cannot say, I think Commissioner ex, wants 14 to do that or Commissioner X, is not concerned. You can 15 absolutely express your own opinion about why you think 16 something is good, better or different.

DR. JACKSON: You cannot refer to the motives of 17 another individual that you cannot do. And the last thing 18 19 I want to say, I have some questions about disruptive behavior during the meeting. And I said to Chairman 20 21 Holley, the chairman does not have the authority to discipline someone who's disruptive in the meeting. The 2.2 23 chairman cannot do that, but the commission can. It is 24 also true that the chairman and any commissioner can identify what they believe is behavior that is our order 25



by calling that person's name, which is why when 1 2 Commissioner Jones says you're not supposed to call 3 people by their names, he was 100% right. Because calling somebody by name is tantamount to saying, what you're 4 5 doing is out of order, you can say the previous speaker, 6 or you can say another person another commissioner said that, but when you call someone by name that is done when 7 you are applying discipline because that person's actions 8 were out of order. And you can say, I call Commissioner 9 Willie Bell to order. 10

11 DR. JACKSON: Now, the chairman cannot impose a 12 penalty, but he can call someone to order. And when he 13 says that person's name that is tantamount to that 14 chairman saying your behavior is not consistent with what 15 we expect of this commission. And you have standing rules 16 that speak to decorum in a meeting. So those are the 17 observations I made about today's meeting. I hope I have said nothing offensive because I know that you all work 18 19 very hard. You give up a tremendous amount of time doing the best job that you can. And it's very inspiring to me 20 21 as a lifelong citizen of this city to see the dedication and hard work of this Board. I never really knew and 2.2 23 understood how much you give and do to keep us all safe. 24 Thank you very much. Are there any questions before I move back? 25

Don't get confused with the charter commissioner. That's Jonya Underwood that she actually 24 said that she had gotten everything to all the 25



1 Commissioners, but it had not gotten to them. So that is 2 a problem and it really needs to be addressed. Someone 3 needs to find out who's pulling interference and there, I 4 think it's Mr. Bell, but I don't know for sure. Please 5 investigate that.

6 MR. ROB BROWN: Mr. Chair, your next two speakers 7 Would be Ms. Bernie Smith followed by Minister Eric 8 Blunt. Ms. Smith.

MS. SMITH: Good afternoon. I got good news or maybe 9 I'd better say the bad news first, Reverend Holley. Yes, 10 I get around. I was down there downtown on Monroe Friday 11 12 and Saturday. And I did see some things that I wasn't too 13 pleased about. And especially when the girls stopped 14 right there at Monroe and Beaubein where the police were 15 standing there observing the traffic. They have a 16 conversation with the police and they're standing there drinking. So I was quite upset about that because they 17 stayed there over 15 minutes and I got out of my car with 18 19 my cane and I walked towards them and they wanted to know who I was. I said, well, I'm here to observe what the 20 police are doing. And they do not have the time to 21 converse with you, and you stand in here drinking. 2.2 23 MS. SMITH: So one of the inspectors came that I quess was in Boston. He came to me and said, Mother 24 25 Bernice, we're going to take care of it, so don't worry



about it. So that was one incident that I had. I'm not 1 going to go into the other. I want to give you some good 2 news. I had a call today from Chicago. I want to let you 3 know here in Detroit; we are the best city I can ever 4 5 live in. They are acting so ugly over there; you know 6 what they're doing? They're downtown, robbing downtown. And I remember a time when I lived there, blacks couldn't 7 8 even go downtown. You had to have some money to go 9 downtown and shop. They are having the nerve to go into the stores, stealing out of the stores and then run out. 10 Then also there on the Northside where it was nothing, 11 12 but all white, over there on the Northside, they have 13 invaded the Northside.

14

15 MS. SMITH: They are stealing the people's cars, 16 making them get out of the car. There was an elderly 17 couple that was in the car. They made them get out, open both doors, and what is going on with this world? And I'm 18 19 telling you, I love my police. You are doing a hell of a good job here in Detroit, and we're going to keep it up. 20 21 Do not, never be like Detroiters. And that was my home, but they are killing, yesterday they killed a 14 and a 2.2 23 15-year-old youngster coming out of school. They are robbing people like mad out of their cars. 24 MR. ROB BROWN: Minister Eric Blunt. 25

MINISTER BLUNT: Can you hear me Board?
 CHAIRPERSON HOLLEY: Yes, we can.

MINISTER BLUNT: Yes. This is Minister Eric Blunt 3 from Sacred Heart Catholic Church. We need to be very 4 5 clear that anyone that supports facial recognition 6 technology is a supporter of white supremacy. This 7 technology, if you want to call it that, has been known, 8 has been analyzed. We have data to prove that it is 9 racially biased. And I hope people on this call and in this meeting took note of Commissioner Jones' comment. He 10 said, and I quote, he knows of nothing that is biased 11 12 about this system. Commissioner Jones, you have a lot to 13 learn and I wish you would really just resign. The 14 corruption on this Board is just appalling. And when you 15 talk about the youth, this department of facial 16 recognition technology, recall this department installed 17 it and was using it without a policy in place. How do you do that on law enforcement of this magnitude? And then 18 19 again, at the presentation today, it was noticed that this technology will only be used if there is a 20 21 reasonable suspicion. That is the logic that is used on black people. Reasonable suspicion is why there is a case 2.2 23 in front of the Michigan Supreme Court that is deciding 24 on whether or not reasonable suspicion can be used to 25 stop, photograph and print and fingerprint someone

without arresting them. There's something very wrong and
 this needs to be investigated to the highest degree
 possible. I yield my time.

Also, 9 how dare you all have Willie Bell back on the towing 10 commission when he is probably being investigated by the 11 12 FBI. He was a commission of one on towing, and now you 13 are, I mean, this is why nobody trusts you, believes in 14 you, and you can be disbanded. And also now that we have 15 two appointees as chair and vice-chair of the police 16 commission, both of you all need to go. One person should 17 have stepped down for the good or the commission, but you all want to bring the whole system down, bring it down, 18 19 and let's start all over


