



PROPOSED TOW ORDINANCE: Please note that City Council recently held a public hearing discussing the proposed tow ordinance introduced by Council President Jones. Our Board Attorney, Attorney Whitley will provide a copy of the revised proposed tow ordinance and share updates next week.

DPD Members responded to the scene; completed an accident report; and are currently investigating this matter to identify the unknown offending driver who struck one of the vehicles. **B. DPD Risk Management – Director Christopher Graveline, Professional Standards Bureau and Constitutional Policing** provided an overview of the Department’s revised Risk Management System discussing the following: historical background regarding the risk management system and the disciplinary process; recent events that led to the Department enhancing the system; and historical data involving citizen complaints from the OCI Investigative Division along with corresponding dispositions. The presentation also included a comparison of Police Officers assigned to Platoon 4 Special Operations for 2016-2018 and Citizen Complaints and PEERS for members assigned to Platoon 4/Special Operations in 2016, 2017, and 2018 and other key statistical data. The Department’s New Risk Management Strategy and Plan were discussed regarding the DPS’s Risk Management Unit; Investment in New Technology; Staffing; DEI Manager; Disciplinary Administration; and Amassing Complaints.

**Chief of Police James E. White** also discussed other strategic measures the Department will employ to ensure the success of the new Risk Management Program by providing internal oversight processes; ensuring command, supervisory, and DPD member accountability; employing other key initiatives to include equity and inclusion throughout the DPD’s job descriptions and work performance requirements; and implementing an evaluation process regarding qualifications and eligibility for DPD Promotions. *See* attached Meeting Transcripts and PowerPoint Presentation for more information.
