Chairperson Bell called the meeting to order and invited Chaplain Carol Caldwell to provide the invocation.

Chairperson's Report: Chairperson Bell provided the following remarks: recognition of OCI Supervisory Staff Member, Supervising Investigator Ainsley Cromwell and his 20 plus years of dedicated service and contribution to the BOPC-OCI. Chairperson Bell also discussed recent events regarding the police-involved shooting of Mr. Jacob Blake, recent events surrounding the protests in

Kenosha, Wisconsin, and efforts to update/advance 21st Century policing within the Kenosha Police Department. Chairperson Bell also highlighted remarks notably made by Congressman John Lewis citing, "Nothing can stop the power of a committed and determined people to make a difference in our society." Highlighting the importance of policing, civilian oversight, and other key information, Chairperson Bell also stated, "The Board stands against police brutality, senseless killings, and racism against unarmed black people who are going about their business and attempting to peacefully live their lives. It is time for people to put down the guns, create change at the ballot box, and prioritize human life." Commissioner Griffie also provided remarks discussing her upbringing and background, the importance of making positive contributions for the betterment of the society, and making decisions in the best interests of the community. Commissioner Griffie shared that she would be leaving the Board at the end of the year and was honored to serve on the Board to learn and make valuable, important decisions. Commissioner Griffie also emphasized the importance of treating people with civility and respect, the need for civilian oversight, and the strong historic background of the Board of Police Commissioners. Chairperson Bell also thanked Commissioner Griffie and all Commissioners for their service and contribution to the Board, the Department, and the Community. Chairperson Bell discussed civilian oversight of law enforcement, important DPD updates and invitations, news, and information for the Board and the community's awareness.

#### Resolution opposing the deployment of law enforcement at polling locations

Whereas, the U.S. Constitution provides a fundamental right to vote. Since our federal charter took effect in 1789, the Fifteenth, Nineteenth, Twenty-Fourth, and the Twenty-Sixth Amendments had to remove inherent barriers against voting by black men,

women, working and poor people, and young adults. Civil rights movements, new laws, and numerous court actions also have been needed to protect this basic right for everyone and in every state, like the landmark Voting Rights Act of 1965

and efforts against restrictive Voter IDs and gerrymandering; and

Whereas, even as our nation celebrates 100 years of women's suffrage, partisan and racist attempts to undermine voting rights

remain constant. The latest tactic is to deploy police officers at election sites, mainly to suppress voter turnout in

communities of color this November; and

Whereas, there is no factual basis to use uniformed and armed police forces at polling sites anywhere in the United States except as

a weapon against voters. In fact, the use of law enforcement at polling sites is a waste of taxpayer dollars and an abuse of first responders when a global health crisis already is constraining public safety resources needed to patrol our streets,

keep our neighborhoods safe, and protect our communities; therefore be it

Resolved, that the Board of Police Commissioners is against the deployment of any law enforcement officers at election polling

locations and opposes other measures and tactics used to intimidate and frustrate people exercising their Constitutional

right and civic duty to vote.

Resolution: Commissioner Jones read the Resolution calling for a national agency on Police Standards and Practices.

#### Resolution calling for a national agency on Police Standards and Practices

Whereas, police-involved shootings of unarmed, non-threatening black people continue to occur some three months since global

protests began a call for reform and the end of such lethal police brutality. The protests were sparked by the death of George Floyd, who died when a Minneapolis officer pinned him to the ground and suffocated him as other officers stood by on

Memorial Day, and

Whereas, the recent police-involved shootings of Jacob Blake in Kenosha, Wisconsin, Rayshard Brooks in Atlanta, Georgia; Breonna

Taylor in Louisville, Kentucky; and Atatiana Jefferson in Fort Worth, Texas also underscore that reforms must happen now in every municipality. These and other recent cases signify a centuries-old truth for people of color: no offense at all or an

allegation of a minor offense can get you killed by law enforcement, and

Whereas, while not every police department should be blamed for the actions of a few agencies, and not every police officer should

be vilified by the brutality or lack of intervention of others in uniform, it is clear that the United States is experiencing a crisis

of trust in law enforcement rooted in racial bias and injustice. It is a national problem, and action must occur urgently on a national scale to restore public trust in justice and liberty for all so that no person, and especially no person of color, will fear immediate death or injury when encountering police; therefore be it

Resolved, that the City of Detroit Board of Police Commissioners calls for the

that the City of Detroit Board of Police Commissioners calls for the creation of a national bureau for Police and Law Enforcement Standards and Practices. Its mission would include raising criteria for and auditing professional standards and best practices in U.S. law enforcement agencies, including the use of equipment like body-worn cameras, electronic weapons, and other special technology. It also would serve as a forensic monitor on cases of officer-involved shootings and fatal police encounters, and require every law enforcement agency to report disciplinary cases and the adjudication of those cases so the Bureau can review for systemic problems, as well as review data on use of force and other categories now reported to the FBI. The new bureau, which could result from re-organization at the Justice Department, would issue annual reports on its work and findings; and be it further.

that the Board will hold a panel discussion on such a national agency and other national reforms on Thursday, September 3, 2020 as part of its weekly meeting at 3 p.m., and later make a formal proposal.

#### Chief of Police Report: Chief of Police's Summary of CompStat Data and other Crime Information/DPD Information:

Chief of Police James E. Craig reported on the following items: Assistant Chief James E. White's recent selection as Executive Director for the Michigan Department of Civil Rights (MDCR). Chief of Police Craig thanked Assistant Chief White for his years of service, his partnership, and tremendous contributions to the Department and to the City of Detroit. Assistant Chief White thanked Chief of Police Craig for his leadership and direction as well as the Board of Police Commissioners for holding the Department accountable and professionalism. Assistant Chief White also discussed that he looked forward to working with the Board, the law enforcement agencies across the state, and the State of Michigan to implement and replicate some of the initiatives and policies enacted by the Board and the Department. The Board of Police Commissioners thanked Assistant Chief White for his service and contributions and expressed congratulatory remarks in his new career endeavor.

Chief of Police Craig also reported on the following: Officers Injured in the Line of Duty; Comp Stat Crime and Statistical Data for the reporting period noting a 9% increase in Part I Violent Crimes and a 22% reduction in Part I Property Crime; COVID-19 impacts, and recent critical incidents impacting the Detroit Police Department and the community. See attached Meeting Transcripts for more information.

**Barricaded Gunman Incidents.** YTD: 20 barricaded suspects, where 60% - 70% are suffering from some form of mental illness; mental health initiatives are forthcoming that will be beneficial to the Department and the Community; and incidents have concluded without incident. **Protests.** The City has observed (13) weeks of police protests, with only a few days of violent encounters, with the vast majority of protests having been peaceful. **Chief of Police Craig** noted that (44) arrests were made at the last protest of individuals who attempted to set up a "Seattle type No Cop Zone where lawlessness is allowed to flourish." There were 150 protesters in attendance prepared to deploy a variety of weapons, some of whom possessed green lasers and deployed toward officers; no officers sustained any injuries. Additionally, projectiles were also deployed at officers. After the zone was arranged for approximately one (1) hour, DPD gave approximately (8) warnings prior to making arrests; some force was used and allegations of force were made, which Professional Standards Bureau is currently investigating. **Protest Arrest Stats:** 44 persons arrested; (1) felony offense for Disorderly Conduct and Inciting a Riot; and weapons offenses (possession of collapsible baton, possession of ASP; and dawning body armor). The offender has since been released and the Department is currently preparing a warrant package for review by the WCPO. Additionally, (16) protesters who were arrested were from Detroit; (27) outside the City including one (1) from California.

The deployment of officers to the protest events have not resulted in any interruption of police service. Chief of Police Craig highlighted that the Department is averaging 80-130 CCW arrests per week. Chief of Police Craig also discussed the recent incident that occurred involving persons shooting at officers while officers were making a CCW arrest. Officers observed a vehicle traveling on Telegraph and several shots were fired toward the officers in close proximity, the individuals left the location and returned near the scene firing several more shots toward the officers. No officers were struck by gunfire. A brief pursuit ensued, and a witness later observed individuals at a gas station, observed an assault type rifle on the dash of the vehicle and heard persons

stating they had just shot at some police officers. All three (3) of the involved offenders were detained: (1) fourteen-year-old and two (2) teenagers. It is unknown whether any individuals will be charged.

Commissioner Davis shared commendations from members of the community regarding the Department helping to deter unlawful activities (i.e. drifters and drag racers, etc.) in the neighborhoods. Commissioner Davis raised the issue of legal observers and media personnel being harmed during recent police protests and asked follow-up questions regarding the recent police-involved shooting incident involving the pit bull animal. Chief of Police Craig emphasized the impact on nightly management of protests and continuance of mitigating violence by identifying individuals who are illegally carrying guns. Chief of Police Craig reiterated there is never an intention by the Department to use any force during arrests during protests and otherwise, and the Department does not seek out legal observers. Chief of Police Craig discussed the circumstances surrounding the police-involved shooting incident (conducting a search for a gun article) noting the officer asked the resident of the location to put any dogs away if she had any dogs; the resident indicated that she did not have any dogs. Additionally, unknown to the officer, the resident's pit bull was able to place full head in between the rails through the iron gate fence, the dogs made contact, leading to the pit bull's attack on the K-9 officer's snout and began to attach. The pit-bull's attack caused injury to the K-9 officer, a two-inch laceration to the K-9, and after repeated attempts to dislodge the pit bull from the K-9, the K-9 Officer fired a single round striking the dog. Commissioner Davis also shared an article with the Department regarding the circumstances surrounding the legal observers. Chairperson Bell reiterated the Department's Press Conference held on Monday. Commissioner Burch inquired about the Department's strategies to prevent crime; also discussed the news media interactions with the Board of Police Commissioners regarding oversight; and the Department's efforts to engage in community relations with former law enforcement police chiefs. Commissioner Brown commended the Department regarding their enforcement and police response efforts; discussed the recent incident involving persons shooting at the officers. Commissioner Brown also read the tribute honoring Lieutenant Geraldine Atkinson, Badge L-24, with over 34 years of service to the Detroit Police Department, the community, and the Eighth Precinct. Commissioner Brown and Commander Gardner read the last call for Lieutenant Atkinson and Commander Gardner went over the air to make the announcement. Commissioner Burton raised concern(s) pertaining to the police shooting of the dog that bit the K-9, and expressed concern regarding the protesters as well as measures taken by members of the DPD during protests.

Commissioner Burch inquired about whether or not vans for community events are assigned to precincts and if the purchase of vans were included in the budget. Commissioner Burton referenced the use of Reserve Police Officers in conjunction with members of the DPD for "Protests" as a budgetary item regarding overtime and police response time.

B. Use of Force Presentation - Commissioner Evette Griffie reported on the Department's final draft proposal of the Use of Force Policy 304.2 and 201.11, highlighting the prior presentation provided on June 4, 2020, detailing the Board's

policy process, the proposed policy's alignment with national best practices (also highlighted in distributed reports), citing the inclusion of the Board's recommendations along with reemphasized related procedures. Commissioner Griffie also emphasized the strong collaboration between the Board and the Department to produce sound, comprehensive, and safe policy.

# VII. MOTION: For Adoption of Recommended Changes to the Use of Force Manual Directive 304.2 and Recommended Changes to the Use of Force Reporting Manual Directive 201.11.

**Motion:** Commissioner Griffie Second: Vice-Chairperson Holt Discussion: Commissioner Burton moved that the Board table the vote to seek best practices from the National Association for Civilian Oversight of Law Enforcement (NACOLE), noting the national umbrella of civilian oversight. Chairperson Bell discussed his role with the national board of NACOLE, and cited that NACOLE has no authority over any local entity of civilian oversight.

# VIII. MOTION: To Table the Vote for the Use of Force Manual Directive 304.2 and Use of Force Reporting Manual Directive 201.11.

**Motion:** Commissioner Burton **Second:** Commissioner Brown **Discussion: Commissioner Griffie** emphasized the time span of three (3) months that the Board's staff and DPD staff have collaborated together on this policy. The Board's staff had already reviewed the recommendations against best practices. Commissioner Griffle asked that the Board consider its competent staff that has already performed benchmarking and review. Commissioner Davis called the question. Commissioner Brown stated the motion to table had nothing to do with the competency of the Board and the work involved; however, referenced other Departments or practices such as Elgin, Illinois, using NACOLE as a resource as well, and noting that this is a landmark decision, a landmark change in the department that will impact Department training. Commissioner Griffie reiterated the Board voted as a body on June 4th to proceed with writing this exact directive today and expressed that the Board owed it to the community to pass this directive as soon as possible. Interim Secretary to the Board White reiterated the policy process as previously outlined by Commissioner Griffie citing the Board had already approved all of these recommendations back in June. This process simply consists of the Department reviewing and evaluating the Board's recommendations and the Department collaborating with the Board to agree with the final draft policy. All of material distributed over the past two (2) weeks consists of the Board's prior approved recommendations and the Department's agreement and confirmation of the Board recommendations. Vice-Chairperson Holt expressed the urgency to move forward with the acceptance of the proposal based on the work that has occurred, the agreement obtained from the Department, and discussed sharing the recommendations with the Department, a reliable, professional institution. Commissioner Burch inquired about whether her policy recommendation on police training of police shootings were included in the recommendations. Interim Secretary to the Board White reiterated that any recommendations made by the Board were included in the policy recommendations submitted to the Department for their review and consideration. Commissioner Burton urged the Board to table the vote to allow the community and NACOLE to weigh in regarding the policy

closed during the public health crisis period. **Commissioner Brown** inquired about the percentage of complaints completed with some cases past the deadline. Additionally, **Commissioner Brown** inquired about the transfer of an OCI staff member to the BOPC staff.
