- IV. Chairperson Ferguson requested to remove the Closed Session item from the Agenda; the Agenda for Thursday, August 11, 2022 was accepted and adopted.
- V. Chairperson Ferguson called for any corrections to the Meeting Minutes for August 4, 2022. The minutes were adopted as presented.
- VI. Introductions of Board administrative and investigative staff, Chief of Police, Elected Officials or Representatives.
- VII. Chair's Report. Chairperson Ferguson reported on the following information: "Thank you for attending today's Board Meeting. Today, we are meeting in the Fifth Precinct area at Wayne County Community College District's Eastern Campus. We are proud to hold our monthly community meetings at Wayne County Community College Eastern District and we thank Dr. Ivery, Chancellor for hosting us. We also remind everyone about the partnership between Wayne County Community College Downtown and DPD regarding a pipeline to success dual track program where DPD's new recruit members may earn a degree while earning certification as a law enforcement officer. This is a unique program and we know that this educational program will benefit the Department, the college and the City by making sure that our officers are model 21st Century Police Officers with the knowledge, skills, and resources for today. During the HR Presentation, we will hear more about the Department's Retention and Recruitment Program and the progress of the DPD and Wayne County Community College Program. At this time, I would like to invite Mattie Porter, Executive Dean for WCCCD Eastern Campus to bring welcoming remarks. Also, Commissioner Bell and Commissioner Burton represent this Precinct. At this time, I ask Commissioners Bell and Burton to bring greetings.
  - (1) DPD UPDATES: CHIEF OF POLICE REPORT AND OFFICER-INVOLVED SHOOTING INCIDENT: We look forward to receiving updates from the Department regarding crime stats and trends and other key items for our consideration. # RESOLUTION HONORING SERGEANT RAYMOND YEE

WHEREAS Raymond Yee was appointed to the Detroit Police Department on February 15, 1971. Upon graduating from

the Detroit Metropolitan Police Academy, Officer Yee began his career at the Tactical Mobile Unit; and

WHEREAS Officer Yee's assignments with the Detroit Police Department included the Tactical Mobile Unit, First Precinct Patrol Operations, Vice Section, Training, Tenth Precinct Patrol Operations, Major Crime Mobile Unit,

Thirteenth Precinct, and Sex Crimes; and

WHEREAS

Officer Yee displayed tremendous knowledge and leadership skills and earned promotion to the rank of Investigator on July 13, 1994. As Investigator, he was assigned to the Eleventh Precinct Investigative Operations Unit. On April 10, 1998, Investigator Yee was promoted to the rank of Sergeant. As Sergeant, his assignments included the following units: Thirteenth Precinct Patrol Operations, Eleventh Precinct Patrol

Operations, Fourth Precinct Investigative Operations Unit, First Precinct Investigative Operations Unit, Central District Investigative Operations Unit, and Criminal Investigation Unit, where he served until his retirement;

Sergeant Yee was the deserving recipient of the following awards: Citation Award, two Chief's Unit Awards, both Consent Judgment Awards, the Ford Fireworks Award, the Major League Baseball All-Star Recognition Award, the Rosa Parks Funeral Recognition Award, and the Super Bowl XL Recognition Award. He also

received numerous letters of commendation from citizens and superiors; and

These many accolades are only part of a remarkable testament to Sergeant Yee's outstanding and steadfast performance throughout a career that spanned six decades. During changes in law enforcement and society, Sergeant Yee tirelessly served the Detroit Police Department, the citizens of Detroit and its neighboring communities for 51 years. He has served the Detroit Police Department and the citizens of the City of Detroit with loyalty, professionalism, integrity and dedication, and is widely respected throughout the law

enforcement community as the consummate professional.
