OVERVIEW

- The Detroit Detention Center (DDC) opened in August of 2013, in partnership with the Michigan Department of Corrections (MDOC).
- It is a centralized holding facility responsible for the intake, processing, and lodging of all individuals detained by the Detroit Police Department.
- The DDC is comprised of two buildings:
 - Building 100 for initial intake
 - Building 500 for processing and lodging of detainees
- With DPD approval, other local, state, and federal law enforcement agencies may also house individuals at the DDC. Examples include:
 - Detroit Public Schools Community District Police
 - Wayne State University Police
 - Michigan State Police

- FRONT DESK – LOBBY
- AREA 1 (Initial Intake)
- AREA 2 (Search and Control)
- AREA 3 (Report Room)
- Breathalyzer Room
- Interview Rooms (5)
- Detainee Information Call Center
- Live Line-Up Room
- Attorney Visit Booths (2)
- Administrative Offices
- Identification Section

BUILDING 500

The following areas and services are housed in Building 500:

- Final Processing Stage
- Female Detention Cells (50 capacity)
- Male Detention Cells (150 capacity)
- Video Arraignment Rooms (1 each side)
- Arraignments are held:
 - Mon. – Fri: 10:30a & 2:30p
 - Weekends and Holidays: 12:30p
- 24-hour healthcare services:
 - COVID-19 testing within 24 hours of lodging
 - COVID-19 prevention countermeasures are in place
 - All detainees receive a health screening during intake (Building 100)





DETROIT DETENTION CENTER

- ATM available for detainees to self bond
- Detainee funds are stored in the Bubble Safe which undergoes an accounting on each shift

DDC SUCCESS HIGHLIGHTS

- DPD and MDOC are utilizing the same record management system, therefore reducing duplication of tasks.
- Four (4) new Livescan adult fingerprinting systems installed
 - one (1) additional Live Scan in storage
- Two (2) new Juvenile Livescan machines installed
- COVID – Preventive Measures:
 - Weekly testing for DPD and MDOC employees
 - Every Detainee undergoes COVID-19 testing upon intake
 - COVID-19 testing of detainees in Building 500 for initial refusals
