X. Presentation to the Board – Use of Force Qtr. #3 – Captain Dietrich Lever, Civil Rights Division

A. Civil Rights Division - Captain Dietrich Lever, Civil Rights Division provided a summary of data, statistics, and initiatives regarding the Department's efforts to collect use of force data and metrics. See the attached Meeting Transcripts and DPD PowerPoint Presentation for more information, which are also posted to the Board's webpage.

The following inquiries require responses from the BOPC and/or DPD: Commissioner Pressley asked whether the Use of Force Continuum has been updated since the copyright date of 1997. Assistant Chief LeValley stated that MCOLES (Michigan Commission on Law Enforcement Standards) uses the Use of Force Continuum as a statewide standard to train and license police officers statewide. MCOLES conducts continuous reviews to determine whether the Use of Force Continuum should be updated. In addition, Assistant Chief LeValley discussed training information related to the Use of Force Continuum, which allows officers to take action based on the subject's actions. Also, Commissioner Pressley expressed concern about the officer potentially escalating an incident versus deescalating the incident. Assistant Chief LeValley explained there is no concrete line regarding the officer's response when using use-of-force continuum techniques, and the techniques deployed are dependent upon the subject's actions. Commissioner Hemandez asked whether the Department is currently tracking deployment/brandishing the PR-24. Captain Lever stated the Department is not currently tracking this area. However, he added the Department investigates allegations and use of force incidents to take appropriate action. Commissioner Bernard asked that the next presentation include the statistics on the number of people requiring medical attention, particularly Tasers, and all other uses of force. Commissioner Bernard also asked a policy question relating to traffic stop investigations, searching and removing all individuals from the vehicle during the traffic stop investigations. Captain Lever stated that all Taser discharges against individuals where it takes effects receive medical attention. Assistant Chief LeValley explained that in order to remove individuals from a vehicle, officers must establish reasonable suspicion or cause. It is not DPD policy on every traffic stop to remove every individual. Officers may, however, remove individuals from vehicles if they have reasonable suspicion and cause to do so. Commissioner Bernard requested the Department to record the demographics of the individuals stopped, including their race and gender, as well as whether the stops and removals are justified.
