- V. Chairperson Ferguson requested that approval of the Meeting Minutes for February 2, 2023, with any corrections. The minutes were adopted as presented. Chairperson Ferguson requested the approval of the Closed Session Minutes for February 2, 2023, with any corrections. The closed session minutes were adopted as presented.
- VI. Introductions of Board administrative and investigative staff, Chief of Police, Elected Officials or Representatives
- VII. Chair Report: Chairperson Ferguson reported on BOPC and DPD activities and provided updates, and reports for the Board and the community.
- VIII. Chief of Police Report: Chief of Police's Summary of CompStat Data and other Crime Information/DPD Information:

  Deputy Chief Tiffany Stewart reported on current CompStat Crime/Statistical Data for Violent Crime and Property;
  COVID-19 impacts; and recent critical incidents impacting the DPD and the community.

The following inquiries require responses from the BOPC and/or DPD: Commissioner Banks inquired about an incident with a Captain detaining a 19 year old. Deputy Chief Stewart stated she was not aware of the incident. Commissioner Holley inquired about the carjacking incident and helicopter pursuit. Deputy Chief Stewart stated it was a targeted carjacking. She mentioned when DPD is pursuing a vehicle they sometimes call for the helicopter which takes about 10 minutes to continue the air pursuit. Commissioner Bernard suggested that everyone should see the movie She Ball. It show you how to stop juvenile crime by engaging youths. Commissioner Bell asked Deputy Chief Stewart to talk about attributes of Police Athletic League (PAL) and Explorer programs. Deputy Chief Stewart explained that PAL and the Explorer programs has benefited many youths in the city of Detroit. Commissioner Hernandez commented on Detroit (PAL) program in partnership with Ford Motor Company Critical Conversations which is a six week course for youth in this area and across the city.

Vice Chairperson Holt discussed the Public Act 1 recently passed by Governor Whitmer which mandates Michigan police officers additional training. Director Patillo asked the DC to respond. Deputy Chief Stewart stated she has to look into the new mandate, but there is a 40 hour training requirement. Commissioner Bernard asked the director to explain why there are 229 people awaiting MCOLES testing. Director Patillo stated they are being contacted to be scheduled for the physical agility and written test. Commissioner Pressley requested clarification on training hours for the year asking is it 40 hours twice a year and reporting the residency of the officer by zip code or precinct. Director Patillo stated she can have that by tomorrow. Commissioner Banks inquired about the reason for the 322 disqualified candidates. Director Patillo stated that some can be because they were disqualified by psychologists, and arrest history. Commissioner Holley expressed the biggest challenge in recruitment has been the physical agility test. Director Patillo stated that they are doing better because the recruits is given the physical agility test first and then the written test. Commissioner Burton asked for elaboration on the hiring process. Director Patillo stated that's a loaded question, and it depends on if it's a sworn or civilian employee. Commissioner Hernandez gave an overview on the process of the interviews that will take place tomorrow, and commented on the 9th Precinct tour, renovations and construction.

**B. Ninth Precinct – Commander Ryan Connor** provided a summary report of overall crime within the Ninth Precinct and activities and operations.

Commissioner Holley inquired about the demographics of the precinct. Commander Connor stated the precinct is just under 12 square miles with 70,000 to 80,000 residents. Vice Chairperson Holt mentioned the Academy is now involved in CIT training, which is to train those law enforcement members who volunteer to receive the training so that they know how to help to deescalate a situation involving a citizen that's in a mental crisis. Commissioner Pressley inquired about the mental health runs by the precinct and the capacity in addressing those runs? Many citizen complaints that OCI receives rely on Body Worn Camera (BWC) footage and we have found that, in certain instances there's been a challenge with having enough for each precinct. And then there are also these other circumstances that we've been made aware of where officers aren't able to turn on BWC. Regarding the 9th Precinct is that something you see as an issue officers wearing and utilizing their BWC or is there overwhelming adherence to the policy? Commander Connor stated No, he does not find that to be a big challenge at the Ninth Precinct. We have occasional battery life issues. However, with proper supervision and proper management of our resources, we're able to handle our problems. Commissioner Banks discussed the recent promotion of Commander Connor and inquired about his adjustments. Commander Connor stated the adjustments are going well; he has a lot of resources.
