


# OCI MISSION Statement

#### SUMMARY INVESTIGATION

IN CERTAIN CIRCUMSTANCES AND ONLY WITH THE APPROVAL OF THE SUPERVISING INVESTIGATOR, THE REQUIREMENT FOR CERTAIN INTERVIEWS MAY BE WAIVED WHEN THE EXISTING EVIDENCE LENDS ITSELF TO A DEFINITIVE CONCLUSION (EX. BODY-WORN CAMERA FOOTAGE)

#### ADMINISTRATIVE **CLOSURE**

DUPLICATE COMPLAINTS, TRANSFERS TO APPROPRIATE OUTSIDE AGENCIES, COMPLAINTS AGAINST FORMER MEMBERS, NO MISCONDUCT ALLEGATIONS, AND COMPLAINTS THAT LACK SUFFICIENT DETAIL/ MERIT AND LACK COOPERATION FROM THE COMPLAINANT.





RESOLUTION

THE RESOLUTION OF CITIZEN COMPLAINTS THAT ALLEGE ONLY INADEQUATE SERVICE OR THE COMPLAINANT'S INNOCENCE OF A CHARGE.

# OCI - SOPAdministrative Closure

Citizen Complaints, which may be closed without a formal investigation, shall include the following:

(1) Duplicates

(2) Transfers

- (3) No longer employed
- (4) Does not violate law or policy
- (5) Lacks sufficient detail

# OCI -SOP Administrative Closure

### Actions Taken by the Investigator (when applicable)


- Contact the complainant to take their statement
- Obtain, review & electronically store all relevant documents related to the allegation(s)
- Watch body worn camera and car video footage or any other relevant electronic evidence
- In some instances a canvass of the incident location is conducted
- Research the relevant law or policy concerning the allegation(s)
- Write a detailed report summarizing their findings


# OCI STATS FOR SEPTEMBER 2023







#### **CASES RECEIVED VS CLOSED VS INVESTIGATORS - YTD**







UNKNOWN COMMAND NUMBERS ARE GENERALLY HIGH AT CITIZEN COMPLAINT INTAKE. HOWEVER, THOSE COMMANDS ARE IDENTIFIED DURING THE COURSE OF THE OCI **INVESTIGATION AND THE DATA IS UPDATED ACCORDINGLY.** THIS DOES NOT MEAN THAT THE OFFICER IS UNKNOWN, JUST THAT THEIR ASSIGNMENT HAS NOT BEEN UPDATED IN THE MAS SYSTEM. A CITIZEN COMPLAINT MAY HAVE SEVERAL ALLEGATIONS. EX: DEMEANOR, PROCEDURE, FORCE.
