
The BOPC September

Rationale & Remediation:

- A. BOPC Staff Team still with some vacancies, many of these open positions now hired into and filled
- B. Surplus primarily a result of delayed Avima contract renewal and PSHQ billings. Awaiting new DBA PSHQ PO#



What progress has been made so far on the Budget front?


- FY 2023-24 Budget Amendment Request Approved by BOPC
- FY 2024-25 Budget Submission Approved by BOPC and Submitted to Finance
- Stipend Analysis Tracking (quarterly)
- Class Compensation Analysis, positions complete:
 - ➤ Administrative Assistant → Salary Adjustment
 - ➤ Office Assistant → Title Change and Salary Adjustment
 - ➤ Legal Assistant → Title Change
 - ➤ Attorney → Salary Confirmed
