Subpoena of Detroit Police Department Data and Information

Dear Corporation Counsel Conrad Mallett and Adam Saxby,

The Detroit City Charter Sec. 7-803. Duties of the Board of Police Commissioners states in parti

The Board may subpoena witnesses, administer oaths, take testimony, and require the production of evidence. To enforce a subpoena or order for production of evidence or to impose any penalty prescribed for failure to obey a subpoena or order, the Board shall apply to the appropriate court.

Pursuant Detroit City Charter Sec. 7-803, the Board requests that you leverage the Board's Charter-Mandated subpoena authority to subpoena the following data from DPD:

- Data Sharing
  - A list of all law enforcement and non-law enforcement agencies with which DPD has a data sharing agreement currently, and updated monthly.
- Citizen Complaints Outcomes
  - From 1/1/2022 5/31/2023 and then each month thereafter, the corresponding action taken for each citizen complaint sent to DPD as "sustained".
- Internal Controls Report
  - From 1/1/2020 5/31/2023 and then each month thereafter, an Excel report of Internal Controls Investigations (Internal Affair + Force Investigations) with the following or similar elements:
    - Case # (or some unique identifier)
    - # of DPD members involved
    - Date of report
    - Allegations
    - Source (i.e. Critical Incident, Citizen Complaint, etc.)
    - Status (Open/Closed)
    - Findings/Outcome
    - Closed date (once closed)

- Take Home Vehicles (May 1, 2023 May 31, 2023)
  - o The daily number of vehicles used in a take-home capacity by non-executive personnel.
  - The daily number of vehicles used in a take-home capacity by executive personnel.
  - o The daily number of marked and partially marked DPD vehicles on the streets.
- Critical Incident Footage
  - Release to the Board copies of all edited and unedited video and audio footage of the October 2, 2022 Porter Burks critical incident.
- DPD Cases and Closures Report
  - For 1/1/2022 5/31/2023 and monthly thereafter, provide an Excel report of all cases investigated by DPD including the following or similar elements:
    - Case# (or some unique identifier)
    - Case Type (i.e. Homicide, Missing Person, etc.)
    - Investigative Unit (i.e. Precinct #, Homicide, etc.)
    - Open date
    - Status (Open/Closed)
    - Closed date (once closed)
- DPD Members Suspended With Pay
  - For 1/1/2021 5/31/2023 and monthly thereafter, provide an Excel report including all members with a suspension with pay start date within that month, and any members continuing on suspension with pay from the previous month(s) including the following elements:
    - Name
    - Badge
    - Infraction
    - Start date of suspension with pay
    - End date of suspension with pay (if ended within that month)
    - Next employment status after end date of suspension with pay (i.e. active duty, suspension without pay, termination, etc.)
