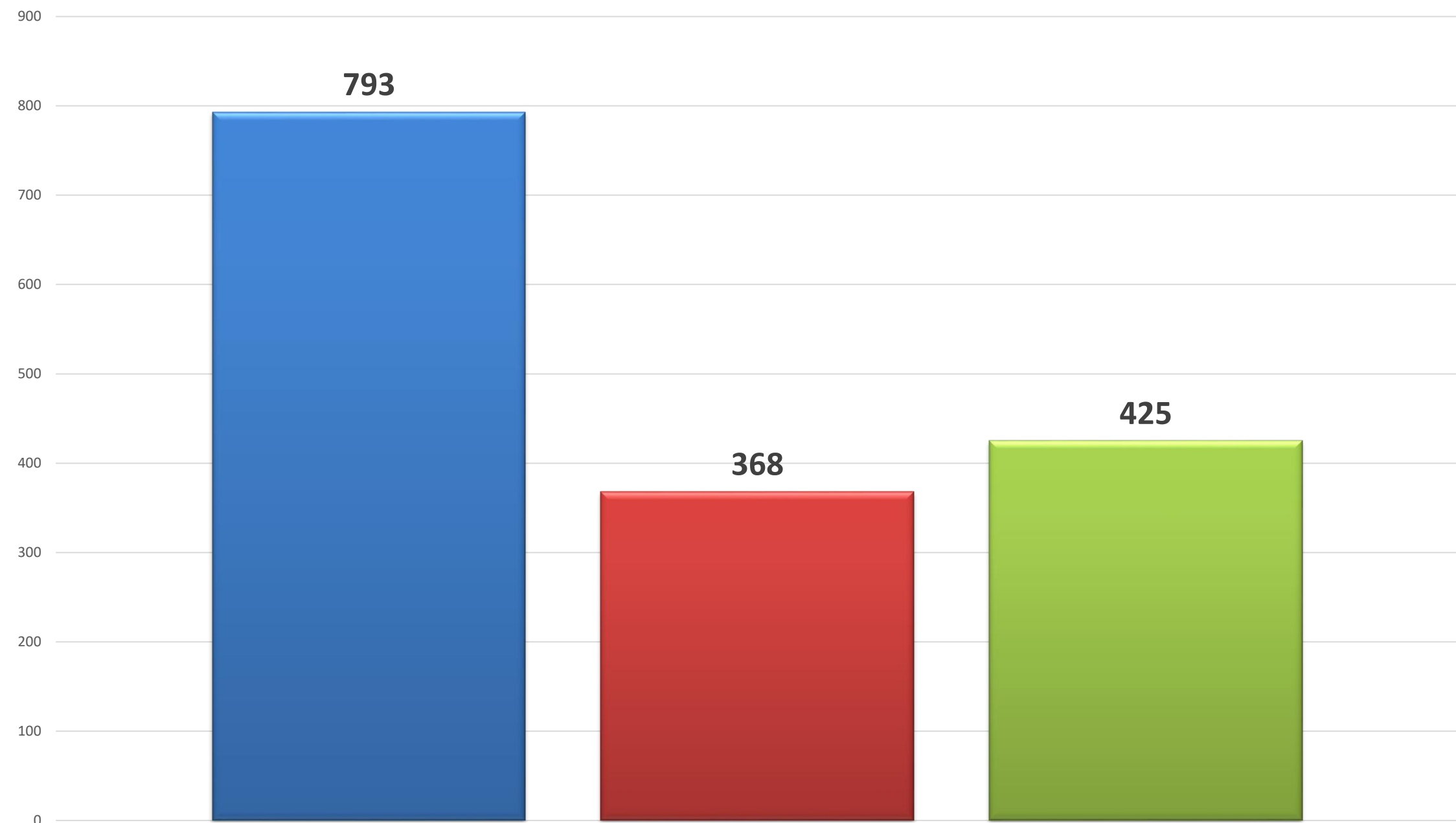




OCI STATS FOR JULY 2023



OPEN CASES AS OF JULY 31, 2023



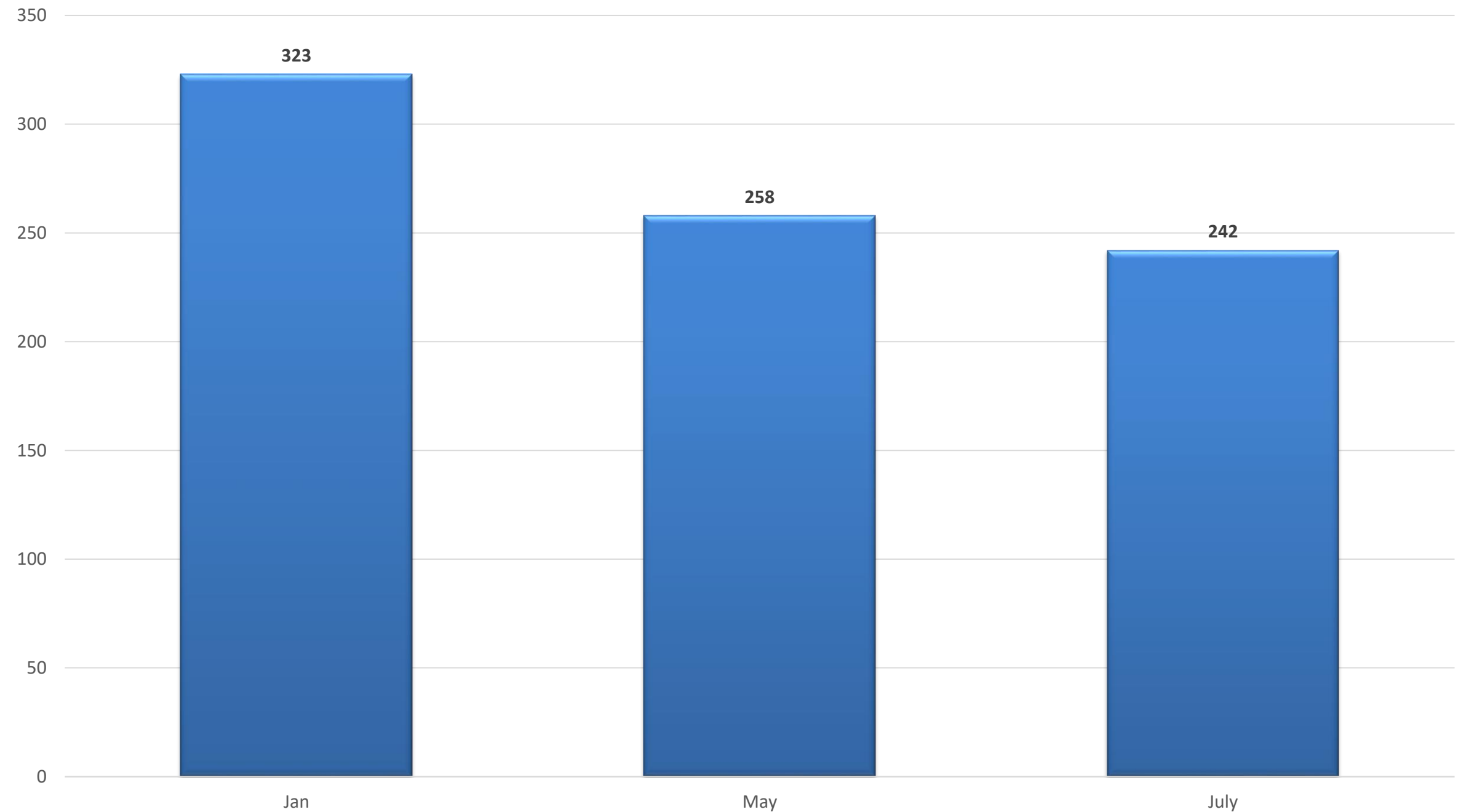

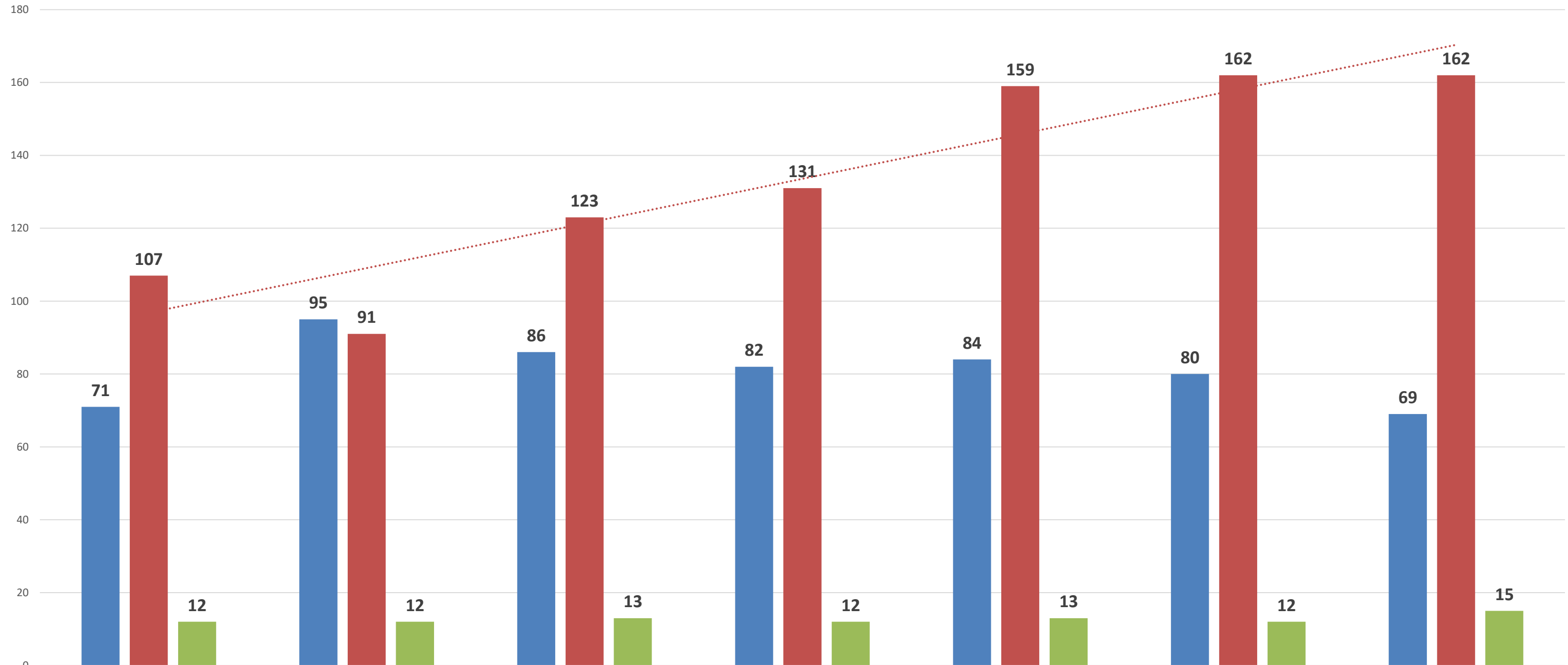


***PROJECT CASES SINCE JAN 2023**

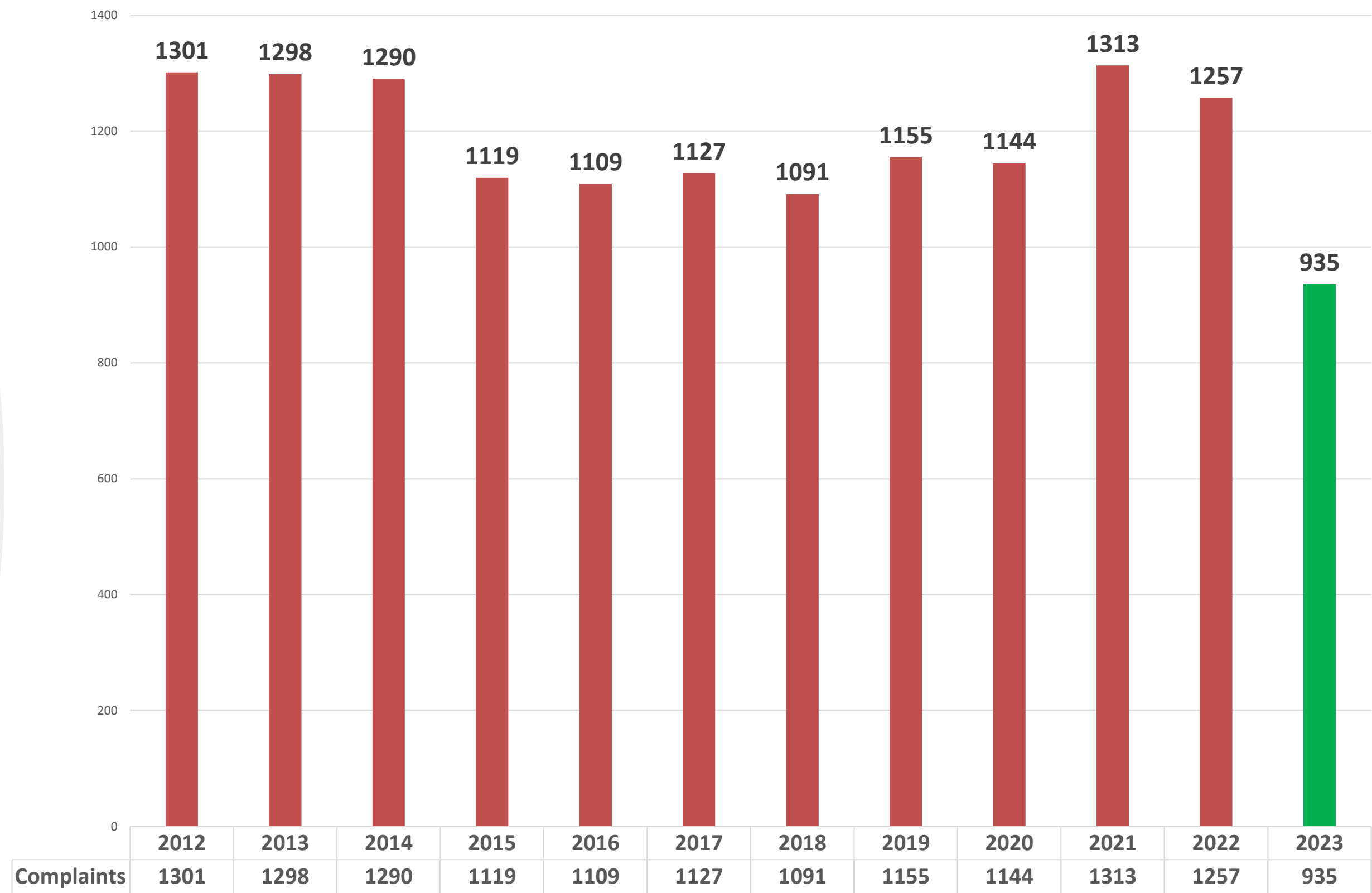

INCOMING CITIZEN COMPLAINTS BY YEAR

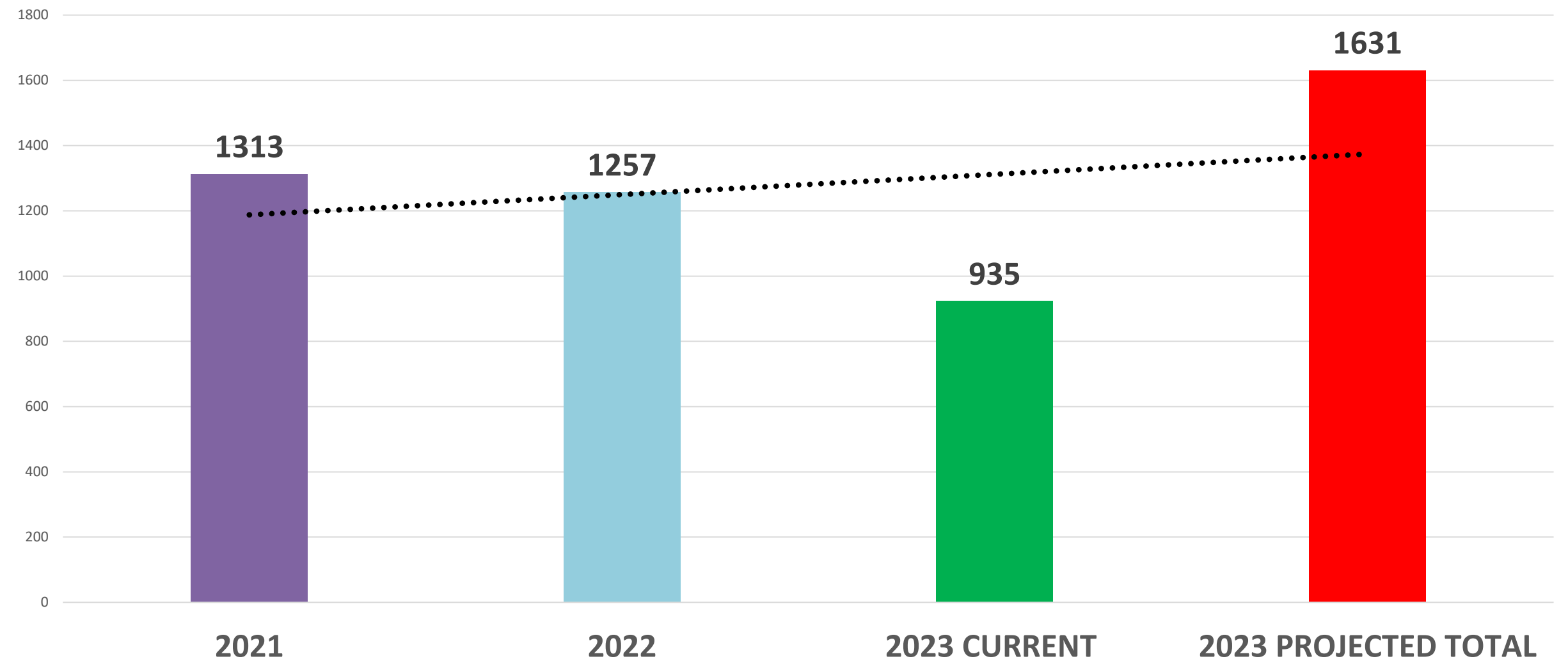

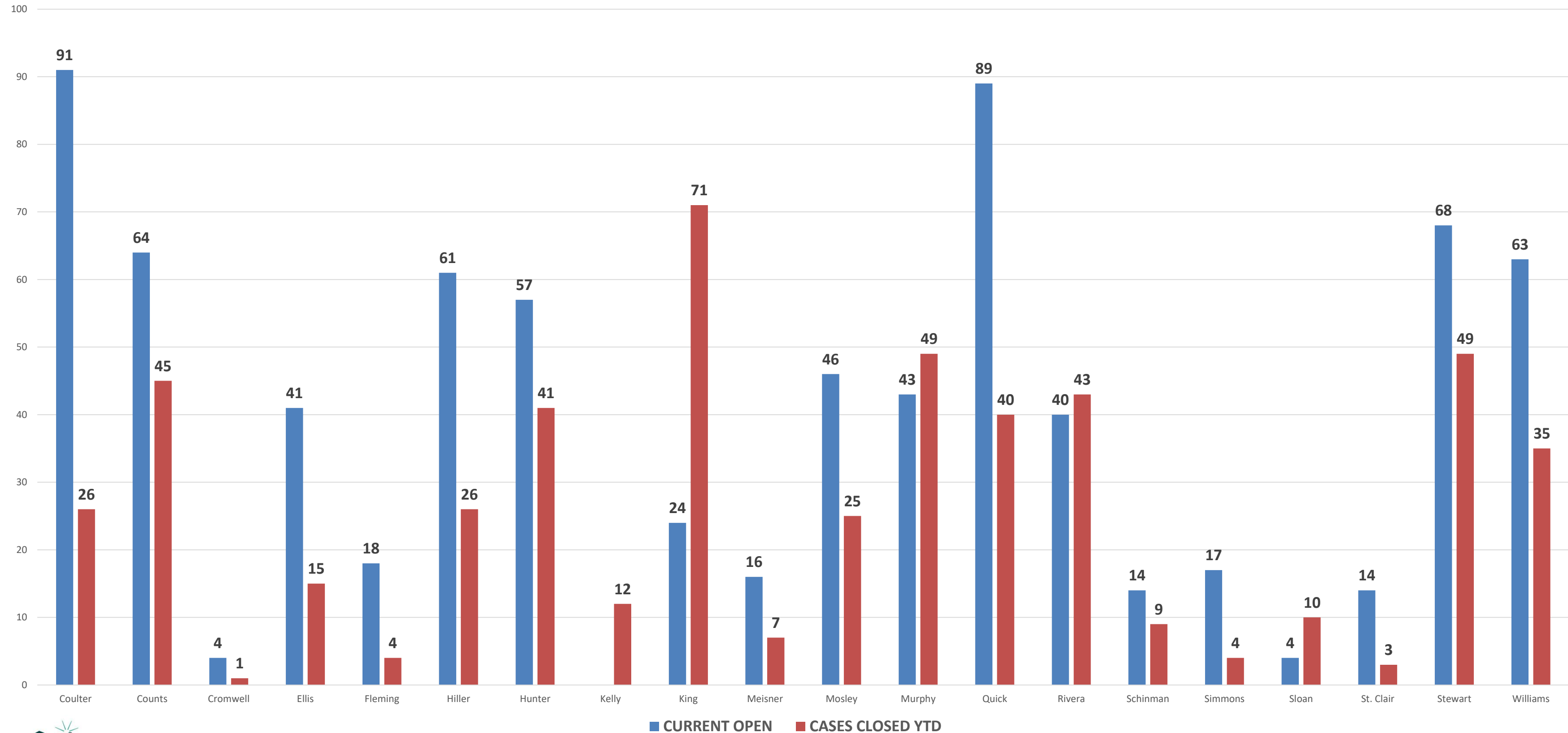


**PROJECTED CCRS FOR 2023
BASED ON 2021, 2022, AND 2023 DATA TO DATE**



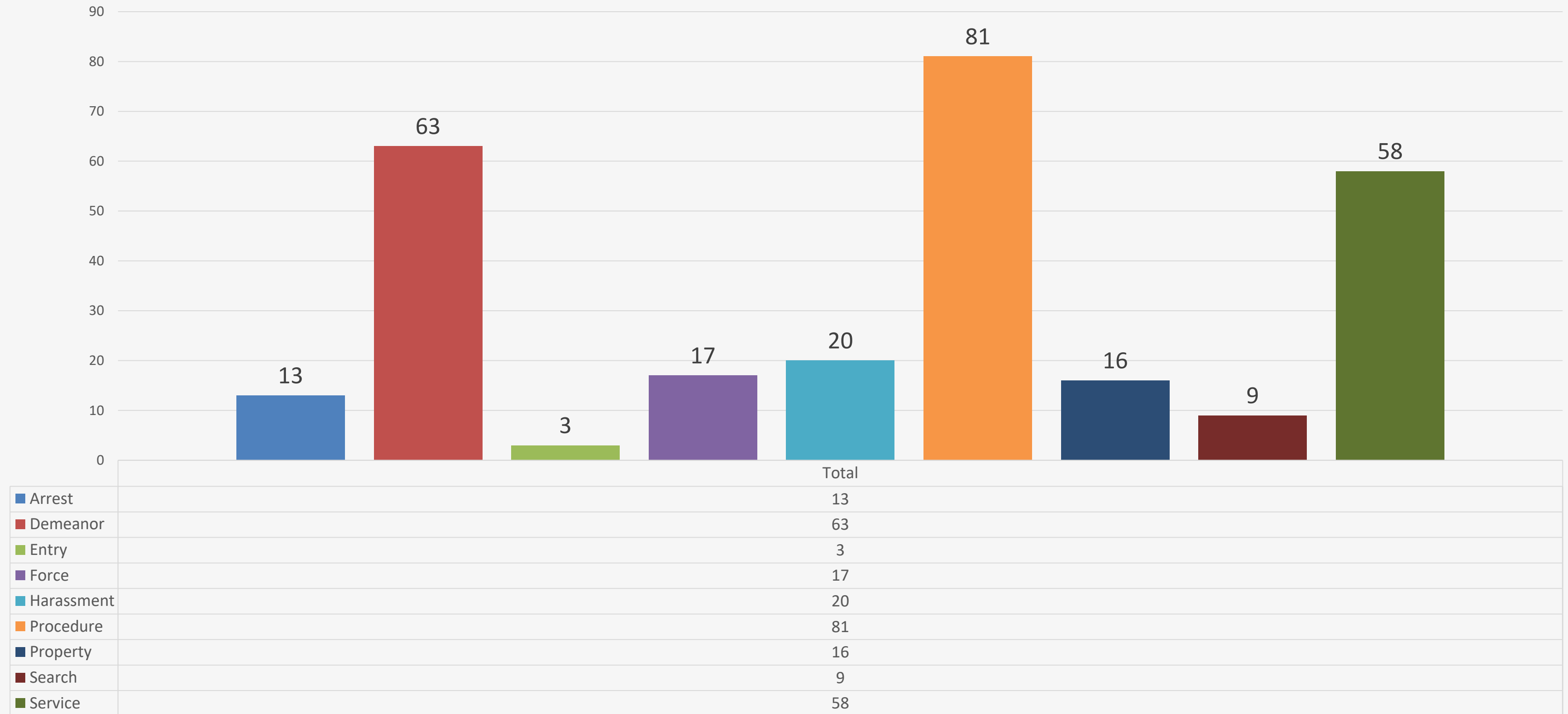


INVESTIGATOR CASES CURRENTLY OPEN AND CASES CLOSED YEAR TO DATE

 THIS DOES NOT MEAN THAT THE OFFICER IS UNKNOWN, JUST THAT THEIR ASSIGNMENT HAS NOT BEEN UPDATED IN THE MAS SYSTEM.
 A CITIZEN COMPLAINT MAY HAVE SEVERAL ALLEGATIONS. EX: DEMEANOR, PROCEDURE, FORCE.
