4. Are there any major changes in Contract Services for FY 2021?
5. Are there any initiatives the Department is undertaking to reduce overtime?
6. Please provide a breakdown of the cost for Towing.
7. Are there any plans to update any other precincts/command locations in the new fiscal year? If so, please explain.
8. It is the Board's understanding that the Department will be purchasing new vehicles. Will they be purchased from the FY 2020 Budget or FY 2021 Budget?
