Citywide Summary

Within the past 28-days, the city experienced an overall decrease in violent crime categories, with the exception of 7th and 11th Precincts. 7th Precinct experienced most notable increases in sexual assault and robbery cases within the past 28 days. Homicide showed decreases in all precincts except for 3rd and 12th Precincts. Aggravated Assault number overall decreased within most precincts (with the exception of 4th Precinct). When looking at robbery numbers, numbers have increased significantly for most precincts – this is to be expected during holiday season. However, there were still several precincts that showed significant decreases for this crime category – especially 11th and 9th Precincts. When looking at year-to-date numbers, however, robbery has shown strong decreases amongst all precincts. Again, many of these violent crime cases were gun-related, with a gun being present or shots being fired in both aggravated assault and robbery cases.

Regardless of the holiday season, and the upward trends the city tends to see during this time of the year, property crime has shown strong decreases, overall, for all precincts **Citywide**, **there has been large decreases in burglary, larceny and stolen vehicle cases, when comparing year-to-date numbers**. This has been an ongoing trend that conflicts with usual holiday trendlines. It is clear that COVID19 Restrictions have played a role in these reductions as more people tend to stay at home during times burglaries and larcenies are most prevalent. This December was has reported the lowest overall property crime, when comparing to the last 5 years. Arson and Damage to Property – two categories that consistently saw increases in 2020 – continue to trend downward.
