## 203.11 Eyewitness Identification and Lineups

This policy outlines the procedures that DPD must adhere to in the identification of eyewitnesses, Live Lineups, Photo Arrays, and Showups.

- DPD transmitted this revised directive to BOPC on August 17, 2023.
- The Policy Committee met and discussed this policy at open meetings on 12/5/2023 and 1/9/2024.
- The Committee has reached out and is waiting for feedback from Judge Deborah Thomas, the ACLU, and Acting Board Attorney LaBelle.

## Key Recommendations/Questions

- Facial Recognition:
  - *The policy does include “The photographic lineup shall not contain an image derived from facial recognition.”*
- Photo Lineups
  - Research is needed to determine the photo lineup procedures in the policy align with industry and legal standards.
- One Photo Lineups
  - These are not mentioned in the policy, but there is concern that they are occurring.
