### 907 Partners - Minimum of 4,034 cameras

- How many of PGL cameras are monitored at any given moment?
- How many officers and/or civilians are dedicated to watching them?
- To what extent is facial recognition used with PGL?
- What impact does Priority 1 classification have on other calls?

## How much does it cost?

"The City, Detroit, the police department. We're not paying for Project Greenlight."

PGL costs are split among departments. Public budgets describe only bureaulevel funding allocations. Primary sources don't address PGL expenditures as line items.

2016 - 2020

At least \$15 million in public funds, including:

- \$1.2 million for the facial recognition software in 2017
- \$7.5 million for an expansion of the Real Time Crime Center in 2016
- \$4 million for an expansion of Real Time Crime Centers in 2019
- \$1 million for Data Works LLC facial recognition contract in 2017
- \$220,000 Data Works LLC contract renewal in 2020

#### WHAT CRITERIA IS BEING USED TO EVALUATE PGL?

DPD commissioned study by MSU School of Criminal Justice – DPD promised study to evaluate PGL but the study did not examine PGL individually.

U.S. Department of Justice's National Institute of Justice -

"There was **no statistically significant difference** in violent crime reporting for treated businesses that implemented Project Green Light, compared with matched untreated control businesses that did not implement the initiative, from the preintervention period to 1-year postimplementation,"

- Why hasn't DPD complied with CIOGS Ordinance?

Sec. 17-5-451 1(q) defines technology subject to the Ordinance as including:

Software designed to integrate or analyze data from surveillance technology, including, but not limited to, remote video and/or audio monitoring social media monitoring, surveillance target tracking, and predictive policing software.
