- Draft Policy Legal Observers: In reference to Congresswoman Rashida Tlaib letter to the Board of Police regarding mistreatment of legal observers by DPD. Shea Howell shared concerns about the BOPC's support for the role of support personnel during demonstrations and the lack of a clear policy articulating DPD's responsibility concerning the First Amendment. Shea and Victoria shared with the committee examples of other cities that have detailed policies supporting legal observers' rights. DC Franklin Hayes discussed the challenges of distinguishing between legal observers who are observing and those who are protesting. He also emphasized a commitment to working together on policy creation and enhancing the transparency and accountability of DPD. The discussion of the challenges continued with Attorney Julie Hurwitz joining in. In conclusion, during the June 20, 2024 board meeting. Commissioner Bernard stated that the policy committee would bring a response back to the board within 14 days regarding the letter from Congresswoman Rashida Tlaib. Shea, Victoria and Attorney Hurwitz agreed to assist in the drafting of the policy on legal observers.
