RESOLUTION

- WHEREAS, on June 21, 2016, Public Act 192 of 2016 (Act 192) amending Revised School Code, 1976 PA 451, as amended, MCL 380.1 et. seq. (School Code), was enacted with immediate effect; and
- WHEAREAS, once Act 192 took effect, the School District of the City of Detroit (DPS) became a qualifying school district under Section 12b of the School Code, MCL 38012b, and a Community District was created for the same geographic are of DPS (Community District) and subsequently replaced DPS, pursuant to Section 383 of the School Code, MCL 380.383; and
- WHEREAS, in Transition Manager Order No. 1, dated June 22, 2016, the Transition Manager for the Community District designated "Detroit Public Schools Community District" (DPSCD) as the official name for the Community District, and directed that the name be used for resolutions, orders, documents, accounts, agreements and other instruments and proceedings that bind the Community district; and
- WHEAREAS, in accordance with Section 301 of Michigan Election Law, MCL 168.301, school district elections are governed by the provisions of Chapter XIV of Michigan Election Law, School and Community College Elections, or by the general provisions of Michigan Election Law if not specifically addressed in Chapter XIV; and
- WHEREAS, Section 4 of Michigan Election Law, MCL 168.4, provides that the City Clerk is the School District Election Coordinator for a school district whose entire territory lies within a single City; and
- **WHEAREAS**, the DPSCD lies within the City of Detroit and the City Clerk is the Election Coordinator for DPSCD; and
- WHEAREAS, in accordance with Chapter XIV, Section 301 of Michigan Election Law, MCL 168.301, the School District Election Coordinator for a School District shall conduct each regular election for school districts, including receiving nominating petitions and affidavits of identity from candidates for the School District School Board; and
- WHEREAS, in accordance with Section 303 of Michigan Election Law, MCL 168.303, for an individual's name to appear on the official ballot as a candidate for school board member, the candidate shall file a nominating petition and the affidavit required by Section 558 of Michigan Election Law, MCL 168.558, with the school district filing official not later than 4 p.m. on the fifteenth Tuesday before the election date; and
- WHEREAS, in accordance with Section 558 of Michigan Election Law, MCL 168.558, when filing a nominating petition, qualifying petition, filing fee, or affidavit of candidacy for a federal, county, state, city, township, village, metropolitan district, or school district office in any election, a candidate shall file with the officer with whom the petitions, fee, or affidavit is filed 2 copies of an affidavit of identity; and
 - WHEREAS, in accordance with MCL 168.303, MCL 168.558, and Michigan Election

Law, 1954 PA 116, as amended, MCL 168.1 et. seq., twenty two (22) individuals have timely filed at the office of the City Clerk the requisite nominating petitions or filing fees and affidavits of identity for placement on the November 5, 2024, General Election Ballot as candidates for the office of school board member of DPSCD; and

WHEREAS, the Detroit City Clerk has submitted to the Detroit Election Commission the names of the twenty two (22) individuals for certification for the November 5, 2024, General Election Ballot as candidates for the office of school board member of DPSCD – also known as Detroit Public Schools Community District School Board; and NOW THEREFORE BE IT

RESOLVED, that, in accordance with Section 3-103 of the 2012 Detroit City Charter and Michigan Election Law, MCL 168.1 et. seq., the Detroit Election Commission certifies the attached names for the November 5, 2024, General Election Ballott as candidates for Detroit Public Schools Community District School Board.
