- A. Budget Committee Report. **Chairperson Dewaelsche** provided key updates from the Budget Committee held August 14, 2024.

“By order of the Budget Committee 931440 Administrative Assistant to the Board of Police Commissioners compensation to bring this employee salary up to \$57,550.” The motion passes.

“By order of the Budget Committee regarding the Supervising Investigator of the Board of Police Commissioners compensation to bring the Supervising Investigator salary up to \$82,450. In addition, we provide the employee, the prorated amount of \$40,505 in back pay for the three (3) plus years this individual has been working out of class as Supervising Investigator.” The motion passes.

“By order of the Budget Committee 932503 Investigator of the Board of Police Commissioners compensation to bring the Investigator salary up to \$54,500. In addition, we provide the employee, the prorated amount of \$550 in back pay for the 15 months this individual was being paid below the standard union-guided salary.” The motion passes.

“By order of the Budget Committee regarding Standing Secretary of the Board of Police Commissioners to provide the employee, the prorated amount of \$34,318 in out-of-class-pay for the eight (8) months our Standing Secretary has stepped up into this role and responsibility for the Board.” The motion passes.
