BOARD OF POLICE COMMISSIONERS MEETING  
October 3, 2024 at 3:00 P.M.

1 CHAIRPERSON WOODS: It's 3 o'clock, PM. Today is  
2 October 3rd, 2024. The Board of Police Commissioners  
3 meeting is called to order. Invocation by Chaplain David  
4 Boyd. Are you on Zoom, Chaplain?

5 MS. GARNIER: Start your invocation, sir.

6 CHAPLAIN BOYD: You want me to go ahead and get  
7 started? Chaplain David Boyd. Can everybody hear me?

8 CHAIRPERSON WOODS: Yes.

9 CHAPLAIN BOYD: Okay. Let us pray. Father, in the  
10 name of Jesus, first we want to tell you, thank you,  
11 Lord. Thank you that last night wasn't our last night,  
12 but that we are so grateful. So now, God, we ask that you  
13 enter into this room, God. We ask that you would give us  
14 vision in God, bind us together in unity and peace, God.  
15 Lord, we pray for the chief of police, we pray for the  
16 community, Lord. We pray for every Detroit police  
17 officer. We ask that you continue to protect him and  
18 watch over him, Lord; our whole city. We pray that this  
19 meeting will go in order, God; that we would be lined up  
20 with your will, and God, we give you all the honor,  
21 glory, and praise. It is in your Son Jesus' name we pray.  
22 Amen.

23 CHAIRPERSON WOODS: Amen. Introduction of  
24 Commissioners. Please call the roll.

25 MS. GARNIER: Commissioner Woods - Present.

1 MS. GARNIER: Commissioner Smith - Present.

2 MS. GARNIER: Commissioner Bernard -

3 MS. GARNIER: Commissioner Banks - Present.

4 MS. GARNIER: Commissioner Bell - Present District 4.

5 MS. GARNIER: Commissioner Burton -

6 MS. GARNIER: Commissioner Carter -

7 MS. GARNIER: Commissioner Moore has asked to be  
8 excused.

9 MS. GARNIER: Commissioner Hernandez - Present.

10 MS. GARNIER: Commissioner Pressley - Here.

11 MS. GARNIER: Commissioner Dewaelsche - Present.

12 MS. GARNIER: Chairman Woods - 7 present, sir.

13 CHAIRPERSON WOODS: Thank you. So, we have a quorum.

14 So I entertain a motion for the approval of the October  
15 3rd, 2024 agenda.

16 COMMISSIONER HERNANDEZ: So moved.

17 CHAIRPERSON WOODS: Moved by Commissioner Hernandez.

18 COMMISSIONER DEWAEELSCHÉ: Support.

19 CHAIRPERSON WOODS: Supported by Commissioner  
20 Dewaelsche. All in favor say aye.

21 COMMISSIONERS: Aye.

22 CHAIRPERSON WOODS: Any discussion? The motion is  
23 carried. I entertain a motion for the approval of the  
24 minutes for September 19th, 2024.

25 COMMISSIONER PRESSLEY: So moved.

1 CHAIRPERSON WOODS: Moved by Commissioner Pressley.

2 COMMISSIONER HERNANDEZ: Second.

3 CHAIRPERSON WOODS: Second by Commissioner Hernandez.

4 All in favor say aye.

5 COMMISSIONERS: Aye.

6 CHAIRPERSON WOODS: Any discussion? The motion is  
7 carried.

8 DR. JACKSON: Mr. Chairman, if you could please ask  
9 for discussion before you carry the vote.

10 CHAIRPERSON WOODS: Thank you.

11 DR. JACKSON: Thank you.

12 CHAIRPERSON WOODS: Thank you. Get me together.  
13 Alright. So I entertain a motion for the approval of the  
14 minutes of September 26th, 2024.

15 COMMISSIONER HERNANDEZ: Can I ask a question,  
16 through the Chair?

17 CHAIRPERSON WOODS: Yes.

18 COMMISSIONER HERNANDEZ: Do we actually have minutes  
19 given if we didn't have quorum?

20 CHAIRPERSON WOODS: Yes. We have the minutes that  
21 were done, thus for public comment and all that type of  
22 stuff.

23 COMMISSIONER HERNANDEZ: Okay.

24 CHAIRPERSON WOODS: Yeah. And let the record reflect,  
25 I was online in Chicago. But I do entertain a motion for

1 the approval of the minutes of September 26th, 2024.

2 COMMISSIONER HERNANDEZ: So moved.

3 CHAIRPERSON WOODS: Moved by Commissioner Hernandez.

4 Any discussion? Am I going right, madam.

5 DR. JACKSON: Yes, sir.

6 CHAIRPERSON WOODS: All in favor, say aye.

7 COMMISSIONERS: Aye.

8 CHAIRPERSON WOODS: The motion is carried. Thank you  
9 very kindly. Introduction of BOPC Staff, Chief of Police,  
10 and Elected Officials and Representatives.

11 MS. GARNIER: Present today, Chief Investigator  
12 Warfield, Parliamentarian, Dr. Francis Jackson, Robert  
13 Brown, Teresa Blossom, Artemisia Joshua, Mary Barber,  
14 Drew Fries, Supervising Investigator Sloan. Interpreters,  
15 Ms. Yakata, and Dr. Beatty. Court reporter Don Handyside,  
16 on audio is Sergeant Quinn, Media Services is present as  
17 well. Police Chief James White. Elected Officials and  
18 Representatives are Marie Overall of State Representative  
19 Tyrone Carter's Office. Fredia Butler, president of  
20 Second Precinct Community Relations, LaDon Davis from the  
21 Office of Councilman Fred Durhal III. Former Commissioner  
22 William Davis, Vice President of DPOA. Ryan Thomas. I  
23 think that is it.

24 CHAIRPERSON WOODS: Thank you very kindly. In my  
25 report, I would say I just want to absolutely applaud the

1 effort of Commissioner Tamara Liberty Smith. And I wasn't  
2 here last week, I was in Chicago on business. But for her  
3 leadership that she has displayed in this community and  
4 the leadership that she does display in this community in  
5 terms of helping those who are suffering, those who are  
6 hurting. You know commissioners are not just sitting by  
7 the sideline, but she's a leader who's been out in this  
8 community. And I know that she was deeply wounded by the  
9 situation with Na'Ziyah Harris, in which this department  
10 stepped up from the beginning. I had a chance to go out  
11 and knock on some doors and look for two days, but she  
12 was there all the way through. And I just wanted to  
13 applaud her, you know, for her leadership. I know this  
14 was something that was very, very painful for her. And  
15 then also, you know, I just want to continue to encourage  
16 this commission to continue to do the great work that  
17 they're doing. So, I'll just say that. I didn't get a  
18 chance to speak last week, but that situation was very,  
19 very troubling to this community. And the Chief's  
20 leadership on that was nothing but amazing to be able to  
21 work hard, and diligently to find answers for that  
22 family. I know that is the priority that this department  
23 has for a lot of those families that have missing  
24 children, and I've seen at work diligently; and I want to  
25 applaud Mama D, out there in the audience as well, a

1 person whose son was victimized by homicide and has been  
2 consistently participating in helping transform the  
3 system here with DPD, working with the department to make  
4 sure that there are answers for families.

5 And so I appreciate that, and thank you for being  
6 here, Mama. D, and thank you. I'll just say, let's give  
7 two of these stellar ladies a round of applause for their  
8 leadership. Having said that, we're going to go to the  
9 Chief of Police Report.

10 CHIEF WHITE: Good afternoon, board.

11 CHAIRPERSON WOODS: Good afternoon.

12 CHIEF WHITE: Thank you, Chair for your kind words.  
13 And I echo the efforts of Commissioner Smith, and her  
14 work. It has been amazing getting us in the spaces,  
15 getting us able to talk to folks who may not have  
16 necessarily had the comfort without her to talk to us.  
17 And she has been pounding the ground on poor little  
18 Na'Ziyah Harris since the day it happened. And  
19 unfortunately, I don't know if the board recalls, but an  
20 additional tragedy for that family was that her dad died,  
21 you know, clearly from a broken heart; literally from  
22 heart failure, while searching for the little girl. The  
23 unfortunate reality is that the investigation reveals  
24 that the perpetrator was in fact a person who was a  
25 pedophile. A person who intentionally pursued women who

1 had young children. We have records and evidence to  
2 suggest that he was very deliberate in who he chose as a  
3 partner, for the purpose of victimizing their children.  
4 And I'll leave it there because anymore would jeopardize  
5 the investigation. But I'm very thankful to Vice Chair  
6 Smith, as well as the prosecutor who stayed locked in  
7 with us, and our team. Things that we cannot talk about  
8 publicly to not compromise investigations. And  
9 unfortunately, we took a tremendous amount of criticism,  
10 but we knew we had to be delicate in our approach in this  
11 investigation, because there were a lot more victims that  
12 we didn't want to scare off. But through the diligent  
13 work of our Homicide team, Shannon Jones, over our  
14 missing persons' report, Amber Roberson, our deputy chief  
15 and our commander as well as our captain in that unit  
16 Homicide and Missing Persons. They knew what they had.  
17 Once they found out that it was unlikely to bring her  
18 home alive, we knew we were on a recovery mission, and we  
19 had to be extremely cautious and deliberate in our  
20 approach. So thank you to this board for allowing us to  
21 do that without asking us those sensitive questions  
22 publicly. Everything will come out in court. Some have  
23 already come out at the prelim, and more will come out  
24 during the trial. But we've got a very dangerous person  
25 off the street. And the investigators should be applauded



1 for it.

2 CHAIRPERSON WOODS: Absolutely.

3 CHIEF WHITE: Moving on to stats very quickly, the  
4 department continues to see a record number of crime  
5 decreases contrary to what some may think. And as I  
6 always say, we are not celebrating these numbers, but we  
7 have to have a basis for the work that we do, and  
8 recognize that what we are doing is in fact working. When  
9 you look at what we did last year, we came in at record  
10 numbers lowest since 1966. We knew we were up against a  
11 very stiff challenge because we were competing against  
12 ourselves, quite frankly for this year. The interesting  
13 thing about major city crime numbers and having a lot of  
14 colleagues around this country that I talk to on a weekly  
15 basis about crime, many of them have returned to their  
16 pre Covid numbers, which was their normalization of what  
17 their data looked like. Covid threw everybody's charts  
18 off, you know, off the rails. When they returned back to  
19 their Covid numbers, they were able to classify that as a  
20 reduction in crime. Detroit, along with a number of other  
21 major cities, have blown past our pre Covid numbers.

22 And so the numbers we look at are, quite frankly,  
23 historic. We have a 20% homicide reduction that's 41 less  
24 families victimized by homicide this year than at the  
25 same time last year. We have a 15.5% reduction in

1 criminal sexual conduct, that's 79 people that have not  
2 been victimized, aggravated assault, are down, roughly  
3 500. Robberies are down over 200. Burglaries are down,  
4 roughly 50. Motor vehicle theft are down 946. Our part  
5 one violent crime, overall reduction is 8.6%. Our  
6 property crime is 6%. Our non-fatal shooting numbers are  
7 29% reduction. That means that 191 people were not shot  
8 this year, that were at the same time last year. That  
9 means that 191 attempted murders, because, let's face it,  
10 a non-fatal shooting is in fact an attempt to take  
11 someone's life.

12       And if only 10 or 20% of those had been successful,  
13 we would be looking at a lot more people that have been  
14 killed in our city. But as you talked about, Mama D being  
15 here, and others that still feel you know the loss of  
16 their loved ones, we're never going to celebrate any  
17 murders in our city. But what we will look at is the fact  
18 that we're methodically and continuously bringing them  
19 down. And we're doing that with the hardworking men and  
20 women of the Detroit Police Department, our CVI, our  
21 community relations work that you're doing, work that  
22 that the Vice Chair is doing on a daily basis, and others  
23 on this board that continues to help heal our community  
24 as well as work with the police department, give people a  
25 degree of comfort, because without the community, we

1 couldn't police the community.

2 We don't have enough people to police 650,000  
3 registered folks and another two to 300,000 visitors. So  
4 you have to have the cooperation of the community. And  
5 when you have that, you're able to see the things that  
6 we're seeing right now as it relates to the reductions.  
7 And we're going to keep that going. As I move into some,  
8 some updates and some significant events. I want to  
9 highlight one in particular. And that's yet another young  
10 child in our city that was shot. This was a double non-  
11 fatal shooting that occurred October 1st at 5:45 PM.  
12 Officers were dispatched to the 9,200 block of Plainview  
13 to investigate a double non-fatal shooting. Officers on  
14 patrol heard approximately 13 shots fired. And again,  
15 that's officers on patrol in our neighborhoods. Those are  
16 the things that we're seeing that's causing some of these  
17 reductions that we're seeing in our B&Es, and our home  
18 invasions, all of them. If you've got officers patrolling  
19 the streets, they're not just going up and down the major  
20 thoroughfare.

21 They heard 13 shots fired in the area Plainview in  
22 West Chicago. Then the dispatch run comes out to the  
23 9,200 block of Plainview. And a ShotSpotter notification  
24 simultaneously comes out. At 5:48 PM, officers arrived on  
25 the scene, observed evidence of a shooting at the

1 location. While at the scene, officers receive an update  
2 that the victim, the first victim with a 5-year-old  
3 female. She was taken to the hospital with gunshot wounds  
4 to her leg. And then there was a second victim. Victim  
5 number one was with her mother and victim number two,  
6 leaving the 9,200 block of Plainview, the second victim,  
7 they were leaving the location and allegedly shot; the  
8 child is suspected to make a full recovery. The other  
9 victim is expected to make a full recovery. But the  
10 investigation continues. On September 27th, at 10 20:00  
11 PM, officers were dispatched to the 80, 8700 block of  
12 Epworth to investigate a fatal shooting.

13       Officers responded to the scene and observed the  
14 victim lying in the yard, suffering from multiple gunshot  
15 wounds. Officers administered first aid until the medics  
16 arrived. Medics transported the victim to a local  
17 hospital where the victim was pronounced deceased.  
18 Officers from the 10th Precinct reserved the scene, and  
19 detectives from the Homicide Section were notified. The  
20 case is still under investigation. And we had another  
21 fatal victim. September 28th, 2:00 PM in the 4,200 block  
22 of Joy Road. Also in the 10th Precinct. Officers were  
23 dispatched to investigate a suspicious person. Officers  
24 arrived at the location and observed the victim in the  
25 passenger seat of a U-Haul truck, suffering from a

1 gunshot wound. Detectives discovered that the U-Haul  
2 truck was stolen and arrested a suspect that was also  
3 linked to that vehicle nearby. The suspect was  
4 transported to the detention center.

5 Detectives were unable to determine if he in fact,  
6 shot the victim. And that is, again, still under  
7 investigation. As we move on to a few other things of  
8 importance, and switching gears a little bit, I want to  
9 bring to the board's attention that we lost a couple of  
10 people this week. Let me do something else first. I want  
11 to update on the officer that was shot in the hand last  
12 week. He has had surgery. He's recovering, and is  
13 expected to make a full recovery. We're in the course of  
14 conducting our investigation. We did, in fact, confirm  
15 that the suspect who shot him was in fact, suffering from  
16 mental illness. The officer was courageous in his  
17 actions. We're looking now at, you know, things that we  
18 could do to improve our response.

19 One of the things that gives me concern is that he  
20 was operating independent of any other officers. He was  
21 in an Adam Unit, which is common for our department. I  
22 would much rather see that not be an officer with the  
23 amount of time he had on the job, than be working by  
24 himself. He was about a year out. But that doesn't mean  
25 he did anything wrong. I just think from a management

1 perspective; we need to take that into consideration  
2 before we make those appointment decisions. So, I'll be  
3 looking at that. By all accounts, everything he did was  
4 appropriate. We're going to look at opportunities to make  
5 sure that we ensure the safety of our members and not put  
6 them in those situations going forward. So that portion  
7 of the investigation, now that the criminal part of the  
8 investigation has concluded with a warrant being issued  
9 against the suspect for attempted murder. We'll now look  
10 at the administrative components and things that we can  
11 do better for the officer's wellbeing. But preliminarily,  
12 there's no misconduct on his part. And everything he did  
13 was heroic.

14       As we move into next week, a couple really sad  
15 things, we have to start off our week with. Retired  
16 Deputy Chief Harold Cureton died. For those of you who  
17 know him, I'm sure. Commissioner Bell knows him well. And  
18 if I'm not mistaken, you all were around the same time in  
19 the department. And he died recently. And his funeral  
20 will be Monday. My partner Anthony Top, very, very  
21 difficult week for me, died 51 years old. And so it's  
22 going to be a really tough week for me next week. I've  
23 been dealing with his family. And, you know, when you  
24 have to deal with something that you never thought you  
25 would have to. It was just last week, or two weeks ago,

1 we were doing trash talk about fantasy football.

2 We are playing with each other. And a few weeks  
3 later, you're going to a funeral. So you know that if  
4 nothing else, it illustrates just how valuable time in  
5 life is, despite the fact that we seem to take it for  
6 granted and major in a minor end up in conflict over  
7 things that are just simply, not that important. So those  
8 two funerals are next week. We conclude Wednesday with  
9 our final walk a mile, Wednesday for the year. It's a  
10 program that has been very successful for us. And we're  
11 also incorporating something. This will be the last thing  
12 I have before I take any questions. If you remember I  
13 believe it was April 21, we had a student police officer,  
14 actually, it may have been April 2020 by the name of  
15 Connor. And it would've had to be 2020.

16 He was working in our Covid team response. On his  
17 way home, he sees a stray animal on the freeway. He gets  
18 out to help the stray animal. He is hit by a hit and run  
19 driver. And from that point on, he's suffering from a  
20 closed head injury. Some paralysis; he will not make a  
21 full recovery. His life has completely changed. Next  
22 Wednesday every graduating class, we do a graduation run.  
23 We incorporate it starting next Wednesday, the Honor  
24 Connor run for every graduate of the Detroit Police  
25 Department. And any proceeds raised from the Honor Connor

1 Run will go to his family from this point forward to help  
2 with his medical costs and his around the clock medical  
3 needs from nursing and, and other medical professionals.  
4 So that will start next week, we'll do our Walk a mile,  
5 and then we'll do the Honor Connor Run. And going  
6 forward, each graduating class will have their respective  
7 donations to the Honor Connor Fund, so that his family  
8 can assist him and his long-term needs, of which there  
9 will be plenty. So with that, I will take any questions.

10 CHAIRPERSON WOODS: Absolutely. Commissioner  
11 Hernandez.

12 COMMISSIONER HERNANDEZ: Thank you. Through the  
13 Chair. First, I'll start with condolences and prayers,  
14 obviously to you directly, but also to the entire agency.  
15 And if there's any way that I can be involved with the  
16 run in supporting, I mean, I don't know that I'll run too  
17 many miles, but please let me know. I have a question  
18 that's somewhat tied to our department, and it's more  
19 along the lines of what protocol looks like with other  
20 surrounding agencies. It seems that there's been somewhat  
21 of a recurrence of high speed engagements. I'm going to  
22 call them specifically from Warren Police. And there was  
23 a very recent incident, obviously that's ongoing in terms  
24 of the investigation, but two individuals were obviously  
25 fatally struck. Warren Police has come out and actually



1 confirmed that there was no high speed chase, or no chase  
2 that the officers were actually involved in. There is  
3 lots of video evidence going out into social media. Can  
4 you just speak to what that interaction or that protocol  
5 looks like whenever there are chases from other  
6 departments leading into the City of Detroit? Because it  
7 seems like there's been way too many, and specifically  
8 there have been way too many from that police department.

9 CHIEF WHITE: Thank you. Through the Chair. So let's  
10 start with outside agencies coming into Detroit for  
11 felonies, or obviously, agencies have the authority for  
12 felonies to cross jurisdictions. They should notify us to  
13 ensure that we're not in the area on another operation  
14 that could potentially create a... It is actually called  
15 deconfliction, so that we're not in conflict with what  
16 they're doing, and that we don't run into each other. I  
17 mean, that has literally happened in our own agency. But  
18 it's a very quick process to call out that we're there  
19 and to notify us. We have policies regarding chase's that  
20 actually also encompass getting engaged in chases with  
21 other jurisdictions that are in play the moment an agency  
22 comes in. So, you know, we have a very strict chase  
23 policy for felonies and the felony that we're engaged in  
24 the chase for, violent felonies, by the way.

25 And the chase itself can't be a felony. So it has to

1 be an independent, violent felony that allows us to  
2 chase. Even with that, other considerations have to be  
3 made. We have to notify a supervisor, zone dispatcher. We  
4 have to know traffic conditions, weather conditions,  
5 schools getting out, schools in the area, and a  
6 supervisor who monitors at any point can call the chase  
7 off. Obviously, our policies are not the policies of a  
8 neighboring agency. That's why that notification is so  
9 important. In an instance where a supervisor in DPD  
10 encounters or chases that he or she finds to be risky  
11 without any other information based on some other  
12 factors, they do have the authority to get engaged, and  
13 either see if we can make notification to that agency, to  
14 find out what's going on. And it's very rarely done  
15 because of how quickly things unfold, but they do have  
16 the authority. In this particular instance, as you know,  
17 that particular chase did not come to Detroit. But as you  
18 indicated, there have been many; and we have had  
19 conversations with Warren and other agencies. In fact,  
20 when the new chief is installed, it is my goal to welcome  
21 him with a meeting to talk about this very issue.

22 COMMISSIONER HERNANDEZ: Can I follow up?

23 CHAIRPERSON WOODS: Yes, sir.

24 COMMISSIONER HERNANDEZ: Thank you. Is there a  
25 pathway for accountability that exists, whether it be

1 through state police or another mechanism?

2 CHIEF WHITE: Well, it depends on the violation. I  
3 think there's accountability across the board for chases  
4 that are improper. There's accountability for chases that  
5 infringe upon civil liberty and things such as that. But  
6 there are so many variables that can impact that. But  
7 when you talk about accountability from a departmental  
8 standpoint, obviously we can't impose policy on that  
9 department and if they don't have a mirroring chase  
10 policy as we do, then there's no accountability from us;  
11 and if they're within their guidelines; there are some  
12 agencies that pit maneuver, which is essentially bumping  
13 a car and having it spin out. I've chosen not to adopt a  
14 policy such as that because I don't see a pathway to  
15 success with that in our city. The lanes are too narrow.  
16 It is a proven technique that works, but you need the  
17 space to be able to effectuate it. We have helicopters  
18 that we use and we have flares that allow us to track a  
19 vehicle, and then get to where the vehicle is headed and  
20 then meet them there, and make the arrest. And our  
21 officers have been very successful. So it's kind of a  
22 risk reward. We only engage in chases that we've got a  
23 violent predator or a violent suspect that's likely to  
24 hurt another person if we don't get him. And we've been  
25 very strict about it.

1 COMMISSIONER HERNANDEZ: Alright, thank you.

2 CHAIRPERSON WOODS: Yes. So to follow up on that, are  
3 you guys checking to see if there was any criminality on  
4 the part of those officers? You know, because it has been  
5 egregious in terms of what Warren Police has done in this  
6 city in terms of, I know at least three times that they  
7 have chased individuals into this city, and there've been  
8 horrific crashes. Is that being investigated by this  
9 department or does the state police step in?

10 CHIEF WHITE: Commissioner, I don't want to give you  
11 bad information. I would have to check. There are  
12 instances where we could run a parallel investigation if  
13 someone is dead, and it's in our city, and it's a result  
14 of a chase. But again, it could be an independent state  
15 police investigation because it's a law enforcement  
16 agency. I am not familiar with the three incidents that  
17 you speak of. I'm familiar with three incidents you speak  
18 of; let me correct that. I am not sure if we took the  
19 lead on those three. I'm actually sure we didn't, I don't  
20 think we did, rather. So let me get back with you on  
21 that. I think one of the cases MSP took, and we can run a  
22 parallel, and stay involved in the outcome, but we do not  
23 have an active investigation involving Warren PD. I'm  
24 pretty confident of that because I would've been briefed  
25 on that. But I'll get you accurate information and report

1 that back to you. I'll send an email to the body.

2 CHAIRPERSON WOODS: I appreciate that. I know the new  
3 chief is being interviewed by the commission tonight. And  
4 so hopefully they select that chief and then we can move  
5 forward, because I know they've been without a chief for  
6 a while. Any further questions? Commissioner Bernard.

7 COMMISSIONER WOODS: Thank you, Chairman Woods.  
8 Chief, our duty, everyone in this room who's involved  
9 with law enforcement, our duty is to protect Detroit  
10 citizens. And if they are, or have a pattern or practice  
11 of being threatening to Detroit citizens at all, I think  
12 we should take the initiative with respect to that. You  
13 initiated, and even Chief Craig, a no chase policy. We  
14 don't do that in Detroit because we don't want it, we  
15 don't want the consequences of it. And I understand that  
16 jurisdictional issues, you can do it all. But if it's  
17 necessary for us to go to the state legislature to make  
18 that clear that you can't chase in Detroit or wherever  
19 other communities... I don't know how other communities  
20 feel, but I think we have to take the initiative in that  
21 regard. This is totally unacceptable. And as you pointed  
22 out yourself, it's not the first time.

23 CHIEF WHITE: So with regards to that, I don't think  
24 I would support a no chase policy in Detroit. We don't  
25 have a no chase policy. We have a specific chase policy

1 where you have to meet certain criteria. But at the same  
2 time you know, I would not be a supporter of the board no  
3 chase policy, because all that will do is encourage  
4 people to run from the police the moment they commit a  
5 crime. So you'd have people walking out of stores, purses  
6 getting snatched, and people taking off in vehicles. So  
7 that's not what we would want, but I understand. But I  
8 think a responsible chase policy like we have in Detroit,  
9 is one that should be adopted. But I can't impose policy  
10 on other agencies. But I can certainly speak to the  
11 concerns that I have, which I'm prepared to do once the  
12 new chief is installed.

13         And we can talk that through. But it is not  
14 something that, you know, I can impose on Warren PD. I  
15 just want to be clear on that. But certainly much like  
16 before we go into Warren, there are certain protocols  
17 that we find. We go into Warren all the time to look for  
18 perpetrators. But we do it in a way that we make  
19 notifications and that people know that we're there.  
20 Sometimes we involve that agency. Many of these chases  
21 are hot pursuits; they're coming right into the city, and  
22 the results are very troubling.

23         COMMISSIONER BERNARD: Well, that's why I said let  
24 the legislature address the issue. They can put in place  
25 the protections that you've indicated here. I mean, if we

1 need to protect our citizens, we need to do that.

2 CHIEF WHITE: Yeah. I don't disagree, and as you  
3 know, profound as a soundbite is that you're making it,  
4 it's not realistic for me to approach the legislator to  
5 impose that rule. That would be something that maybe this  
6 body would consider doing, that would be most appropriate  
7 for me as a law enforcement person. What my job is to do,  
8 is to ensure that the chief is aware of what has  
9 happened, to work with that chief to ensure that both  
10 agencies are operating with respect to our citizens and  
11 the safety of all involved. But for me to approach the  
12 legislator to impose some type of law on Warren, would  
13 just be highly inappropriate.

14 COMMISSIONER BERNARD: Well, we could ask City  
15 Council to get involved as well, and then we can go to  
16 our legislators right now, while we can control the  
17 legislature, it's the time to do it if we're going to do  
18 it.

19 CHIEF WHITE: I don't disagree.

20 CHAIRPERSON WOODS: Okay. Any other questions of the  
21 Chief?

22 COMMISSIONER BURTON: Through the Chair.

23 CHAIRPERSON WOODS: Yes, sir.

24 COMMISSIONER BURTON: Chief, I had a meeting today  
25 with a gentleman who received you know, a few thousand

1 dollars and blight tickets. The Blight tickets were  
2 issued by DPD. And the concern that he has is that how do  
3 the department determine or differentiate whether it is,  
4 you know, bulk pickup versus paid bulk pickup. So on the  
5 city's website, a person can pay for bulk pickup to have  
6 their stuff picked up. And so that's a different option.  
7 And so I don't know if you can answer that question. How  
8 does an officer determine whether this is a pay pickup or  
9 a regular pickup? But, you know some of his tickets, he  
10 was able to get waived because they were not written by  
11 DPD, but the ones that were by DPD, he tried to challenge  
12 those, that's what he said.

13         And they couldn't waive those because they were  
14 written by DPD. And he's showing them as he goes down and  
15 he talks to Building and Safety. He's showing them where  
16 he scheduled for a bulk pickup. And so it's not one  
17 Detroit resident that is bringing this concern. There are  
18 many Detroit residents that are bringing this concern  
19 that live in, you know, the fifth district. And so in  
20 addition to that, I'd like to know, can you provide to  
21 this board, you know, a year to date, how many blight  
22 tickets that this department writes, as well as added to  
23 your weekly report breakdown by precincts? Because, you  
24 know, you have severe poverty, childhood poverty, and  
25 working class poverty. And a \$1,000 ticket here, a \$2,000



1 ticket there, it all adds up at the end of a day,  
2 especially when someone is doing everything by the book.  
3 So we know that the city picks up trash weekly, but you  
4 can also pay for additional bulk pickup, which this  
5 person has done.

6 CHAIRPERSON WOODS: Okay. Can you answer that  
7 question for him, Chief?

8 CHIEF WHITE: Through the Chair. So there are a lot  
9 there. I mean, we are going to enforce blight, we're  
10 going to enforce abandoned vehicles. Our city deserves  
11 it. We have to move past this notion that being  
12 impoverished means that we have to live in filth. They're  
13 two totally different things. I grew up very, very poor  
14 and very, very clean. Okay. So, I think they're  
15 different. If specifically, you are talking about a  
16 situation where this person has wrongly received tickets,  
17 I'm very interested in that.

18 COMMISSIONER BURTON: Yes. They wrongly received  
19 tickets they paid for. And I mean, they actually have  
20 their statements. They showed everything.

21 CHAIRPERSON WOODS: You let him finish his answer,  
22 Commissioner.

23 COMMISSIONER BURTON: No. Point of order. Oh, hold  
24 on. I'm...

25 CHAIRPERSON WOODS: Let him finish answer, then you

1 can respond. And speak  
2 through the Chair.

3 CHIEF WHITE: Through the Chair, specifically to that  
4 issue, we'll look into that because if that is, in fact,  
5 the case that he paid for bulk pickup and can prove he  
6 paid for bulk pickup then there should be a remedy  
7 outside of court that we can work through on that. And I  
8 can provide you with a report if that's what this body  
9 desires regarding bulk pickup tickets or blight tickets  
10 rather. But you're going to see them, and we're going to  
11 continue to enforce it, just like we're going to continue  
12 to enforce abandoned vehicles and we're going to continue  
13 to enforce... Because I hear from people all the time in  
14 our community that their kids can't walk to school  
15 because there's trash out front or, or people are just  
16 dumping in our community. We are going through that  
17 trash, we're finding addresses and we're writing those  
18 tickets, and we find people outside of the city that are  
19 coming in and doing it as well. But I will take a  
20 personal interest in this particular situation. If you  
21 could provide me with the name, not on the record, but  
22 offline, I will reach out, and find out precisely what  
23 happened.

24 COMMISSIONER BURTON: Through the Chair. Chief, the  
25 person that brought their concern to me, for the record,

1 I want to say that this is not a legal dumping. They are  
2 homeowners in a very influential community in my  
3 district. And they paid for you know, bulk pickup. And so  
4 there's an option where you could pay for bulk pickup on  
5 the website, as well as you have additional bulk pickup,  
6 which is like weekly. And so, you know, it's not just one  
7 or two persons who are bringing their concerns to me.  
8 Over 10 people have reached out to me about this same  
9 concern. They go on the website, they schedule for this,  
10 but somehow they get a ticket written; and the ticket is  
11 unfair, and it's unjust. And they would like the board to  
12 look into this.

13 CHIEF WHITE: So, I'll just restate what I said  
14 earlier, and add one more piece.

15 COMMISSIONER BURTON: But you didn't answer the  
16 question about how the officer determines or  
17 differentiate whether a person scheduled or paid for bulk  
18 pickup versus the weekly bulk pickup that every Detroit  
19 resident receives.

20 CHIEF WHITE: How can I tell you what?

21 CHAIRPERSON WOODS: Go ahead, Chief. You had the  
22 floor.

23 CHIEF WHITE: I can't tell you what an officer used  
24 to determine why that ticket was valid. That's why I need  
25 to look into it. Maybe the officer looked at a variety of

1 different things. Maybe the officer looked at the fact  
2 that documentation that he had was inconsistent with the  
3 bulk pickup schedule. I simply don't know because I  
4 simply don't know what you're talking about. But if you  
5 provide me with the name and the date, I can reach out to  
6 him and I can give you an informed answer and an  
7 intellectual response. Apart from that, we're both kind  
8 of talking with, you know, significant blind spots. So if  
9 you could give me the information, I can do that. Also,  
10 one last thing, sir. Through the Chair, department of  
11 administrative hearings, anytime you disagree with a  
12 ticket, you are able to file an appeal and go through the  
13 process of having a hearing and prove that you in fact  
14 did have a scheduled bulk pickup date, or a personal paid  
15 for bulk pickup. And they'll work through that. But I am  
16 going to look at these tickets...

17 COMMISSIONER BURTON: Through the Chair. Chief, you  
18 tapped into the words once again, the person received  
19 other tickets, but they...

20 CHAIRPERSON WOODS: Excuse me.

21 COMMISSIONER BURTON: No point of order.

22 CHAIRPERSON WOODS: The point of order...

23 CHAIRPERSON WOODS: No point of order.

24 COMMISSIONER BURTON: But...

25 CHAIRPERSON WOODS: Excuse me, excuse me, point of

1 order.

2 COMMISSIONER BURTON: But the thing is...

3 CHAIRPERSON WOODS: I said, point of order.

4 COMMISSIONER BURTON: The other tickets, and they  
5 were able to get those waived. You know, whether it came  
6 from...

7 CHAIRPERSON WOODS: Commissioner Burton, you are out  
8 of order.

9 COMMISSIONER BURTON: Whether...

10 CHAIRPERSON WOODS: You are out of order right now.  
11 So, he's answered that question several times, and...

12 COMMISSIONER BURTON: No, he did not.

13 CHAIRPERSON WOODS: He's asking you to provide, he is  
14 asking you... Excuse  
15 me.

16 COMMISSIONER BURTON: If everything is from...

17 CHAIRPERSON WOODS: Excuse me, Commissioner Burton.

18 COMMISSIONER BURTON: BPW...

19 CHAIRPERSON WOODS: Commissioner Burton.

20 COMMISSIONER BURTON: To get one of those, or two of  
21 those waived. But the one...

22 CHAIRPERSON WOODS: Commissioner Burton, you are out  
23 of order.

24 COMMISSIONER BURTON: Not able to get those waived.

25 CHAIRPERSON WOODS: You're not being recognized.

1 You're not recognized.

2 COMMISSIONER BURTON: And so therefore...

3 CHAIRPERSON WOODS: You are out of order.

4 COMMISSIONER BURTON: Point of order.

5 CHAIRPERSON WOODS: You are out of order.

6 COMMISSIONER BURTON: I'm bringing a concern...

7 CHAIRPERSON WOODS: I don't want your concern...

8 COMMISSIONER BURTON: To District 5.

9 CHAIRPERSON WOODS: I want your concern to be  
10 addressed.

11 COMMISSIONER BURTON: No, I'm...

12 CHAIRPERSON WOODS: Excuse me.

13 COMMISSIONER BURTON: I represent a District that has  
14 over a hundred thousand people.

15 CHAIRPERSON WOODS: I live in that District.

16 COMMISSIONER BURTON: Well, once you get elected.

17 CHAIRPERSON WOODS: Excuse me...

18 COMMISSIONER BURTON: You get elected.

19 CHAIRPERSON WOODS: Excuse me.

20 COMMISSIONER BURTON: And then you represent the  
21 people.

22 CHAIRPERSON WOODS: Yes. Excuse me.

23 COMMISSIONER BURTON: Instead of being appendage to  
24 the chief and the mayor.

25 CHAIRPERSON WOODS: Yes, praise the Lord. Yeah,

1 however you want to say it.

2 COMMISSIONER BERNARD: Mr. Chairman.

3 COMMISSIONER BURTON: I'll speak for my constituents.

4 CHAIRPERSON WOODS: Oh, no, he's out of order right  
5 now. And he's being disrespectful and disregarding other  
6 rules of engagement. And so the fact of the matter is, is  
7 that the chief has answered your question several times,  
8 and you have not provided him any information. He said he  
9 would be willing to take a look at the information. And  
10 so he's answering your questions. There's nothing else  
11 that he can do other than you providing the information  
12 to them and for them to take a look at it. Other than  
13 that...

14 COMMISSIONER BURTON: He did not answer the question;  
15 how does an officer determine or differentiate whether a  
16 person scheduled a paid for bulk pickup versus the weekly  
17 trash pickup that everyone is entitled to?

18 CHAIRPERSON WOODS: If you don't have anything  
19 further, we move...

20 COMMISSIONER BURTON: You actually can go on the  
21 website and pay and schedule for...

22 CHAIRPERSON WOODS: Okay. If you don't have anything...

23 COMMISSIONER BURTON: After that, clearly...

24 CHAIRPERSON WOODS: Move along. Alright? Yes,  
25 Commissioner Banks, you're recognized, and then

1 Commissioner Bernard.

2 COMMISSIONER BANKS: Okay. Through the Chair.  
3 Blessings and peace to you, and your household. Chief  
4 White. Chief White, you started the walk-a-thon. How was  
5 that coming and when you started the Walk-a-thon, I mean,  
6 the walk a mile, how many people started with you that's  
7 still with you, that's current with you today when you  
8 started that walk-a-thon. If you can give a roundabout  
9 number or if...

10 CHIEF WHITE: I started to walk out Wednesday, when I  
11 was the interim chief about three and a half years ago.  
12 We've kept them going. They're very popular. We move them  
13 through every precinct throughout the summer. Sometimes  
14 we get people from different precincts that attend. We've  
15 got about 20 people that are consistent regardless of the  
16 precinct we're in.

17 COMMISSIONER BANKS: From when you first started.

18 CHIEF WHITE: From when we started.

19 COMMISSIONER BANKS: Good. Okay.

20 CHIEF WHITE: But each of them range anywhere from 50  
21 to 150 people each week. They've become quite popular.

22 COMMISSIONER BANKS: Okay. I got one more, Chief.  
23 Chief, have you seen anybody in that three-and-a-half-  
24 year period? Have you seen anybody get in shape?

25 CHIEF WHITE: That's a great question. And the answer



1 is no.

2 COMMISSIONER BERNARD: He is in shape now.

3 CHIEF WHITE: There's a member...

4 COMMISSIONER BANKS: For the walk-a-thon?

5 CHIEF WHITE: Hold on. There's a member with  
6 Ceasefire who boasts that he has lost 60 pounds now. It's  
7 not my weekly walk mile. He has taken that to launch a  
8 better fitness lifestyle, and eating right. And he looks  
9 great. I just saw him a couple weeks ago.

10 COMMISSIONER BANKS: Wonderful. I'm all set, Chair.

11 CHAIRPERSON WOODS: Okay. Commissioner Bernard.

12 COMMISSIONER BERNARD: Just quickly and perhaps  
13 Commissioner Burton, the Chief can designate someone you  
14 can speak to afterward, to find out the answers to those  
15 questions regarding the issuance of tickets versus the  
16 registry of people who've paid for bulk pickup. That's a  
17 good question, actually. So perhaps Chief, would you mind  
18 designating...

19 CHAIRPERSON WOODS: He already made himself clear,  
20 Commissioner Bernard, that he would do that. We don't  
21 have to reach. He made himself absolutely clear about his  
22 answer, you know saying that was more than available to  
23 him. Anything further?

24 COMMISSIONER BERNARD: No, it's a good question.

25 CHAIRPERSON WOODS: Okay. Alright. Yes, sir.

1 COMMISSIONER PRESSLEY: I'm sorry to elongate this  
2 process, but through the Chair. My question is how are  
3 you feeling about the progress with a potential proposed  
4 strategy around communications to families who are  
5 looking to hear from detectives after cases?

6 CHIEF WHITE: Yes. And thanks for bringing that up,  
7 Commissioner Pressley. We have implemented family, our  
8 family advocacy group. And I want to speak specifically  
9 to that work not being a replacement for the detective's  
10 work because there's some miscommunication around what  
11 exactly they will do. It is still the detective's  
12 responsibility to reach out to families, and talk to  
13 families and let them give them updates. But what we  
14 found, through the Chair, and not through the Chair, but  
15 literally through the Chair, and through the Vice Chair  
16 and others, that that just wasn't consistently happening.  
17 And so the Chairman, the Vice Chair, Deputy Mayor and  
18 others have contacted me, and there are these families  
19 that don't have the cadence appropriate to know what's  
20 going on with their loved one. And so a number of  
21 different things that impact that.

22 Sometimes when the case goes cold, the person that  
23 they initially designated as the family representative  
24 has fallen out of favor sometimes; they're not  
25 necessarily communicating what we're telling them. And so

1 what this group is going to do, is close that gap.  
2 They're going to, independent of the responsibility of  
3 the detective, reach out to these families, let them  
4 know, or ask them, have you talked to your detective?  
5 What's going on? What do you need from us? Have a  
6 quarterly meeting with them, the case update for all of  
7 them and even the cold cases and have conversation. I'm  
8 going to be in attendance. The deputy chief will be in  
9 attendance so that they know that their loved one matter  
10 to us. So far we have launched, of course, but like  
11 everything else, there are some bumps in the road. So  
12 give us a couple of weeks and we'll have a strong report  
13 for you. But it has been launched. Some things that we  
14 didn't anticipate. There are a lot of people who are now  
15 coming up saying, Hey, it's been 10 years and I haven't  
16 heard anything. And so now, this has become a call in,  
17 and tells us that you haven't been heard as a unit as  
18 opposed to dealing with the cases and going out. So we're  
19 managing those. We don't want to turn them away and we're  
20 not going to, but we're going to need a little bit more  
21 capacity because it's bigger than we thought. But we're  
22 also ensuring that the folks know, and the victims of  
23 these heinous acts, know that the detectives still have a  
24 responsibility to contact these families.

25 CHAIRPERSON WOODS: Thank you. Any further... Yes,

1 Commissioner Dewaelsche.

2 COMMISSIONER DEWAELSCHÉ: Hi Chief. Yes, my question  
3 has to do with recruitment of officers. I notice in the  
4 report that year to date, we've lost 119 officers and we  
5 still have 94 vacancies. And I know you're having regular  
6 you know graduating classes and classes starting up. But  
7 how are we doing in terms of kind of reconciling that  
8 number so that we have more recruits than we have people  
9 leaving?

10 CHIEF WHITE: Yeah, so that's another fantastic  
11 question, I'm glad you asked because the data, as much as  
12 I love data, data can be shaped without context and to  
13 tell a different story. And so what is absent there, if  
14 you look at the whole number, we have 300 more officers  
15 today than we had in January, 2023. So we're plus 300.  
16 Then we took over the Transit Unit, which gave us 41 or  
17 42 openings. So immediately in that 73 number, what is  
18 it, 73 or 76? I don't have it with me, I'm going from  
19 memory; 73. So we got 41 openings right there that we  
20 created by virtue of taking over Transit. So they're  
21 still out there and they're still patrolling and they're  
22 still in uniform, still driving police cars. But I got 41  
23 officers added to my budget.

24 So that number is present and right there for you to  
25 see. I also promoted about 35 people over the last couple

1 months. And sergeants, lieutenants, captains. And so  
2 those create openings as well. So I am not concerned  
3 about our fill rate. We're still moving in the right  
4 direction. We have 117 police officers in the academy  
5 right now. We've got 17 hired. We're going to hire  
6 another 22 to start October academy before the end of  
7 this month. And we're going to be on a cadence of about  
8 35 to 40 a month by the end of the year, which will bring  
9 us up to, to full capacity. But once I hit the list, I'm  
10 going to create an opening. When you make sergeants, you  
11 take police officers up to sergeants. The recruiting unit  
12 is doing a very good job.

13       The emphasis is to recruit Detroiters. We're doing a  
14 lot of different programming. I was just talking to the  
15 HR director earlier today about some of her work with  
16 Captain Brown. And they're talking to the local radio  
17 stations. They're going to be going into churches in the  
18 week or on Sundays to actually get a couple minutes to  
19 talk about recruiting. They're doing a really good job.  
20 The other thing this board should know is we have had,  
21 since our raises, about 65 or more officers request to  
22 come back to DPD. And we have taken the majority of them  
23 back. So we're seeing our officers return. We had three,  
24 ironically worn recently. Two of them have already put in  
25 the comeback. So it's those types of things that we're

1 seeing. So we're confident that we're going to continue  
2 on the right path. The race has been a very powerful tool  
3 for us. And believe it or not, other major cities are  
4 looking at us, asking us how we're recruiting, so well,  
5 so we're doing pretty good.

6 COMMISSIONER DEWAELESCHE: Great. Thank you.

7 CHAIRPERSON WOODS: Yeah, thank you. And so, any  
8 other questions? There being no more question, let me ask  
9 you, the officer that was shot in the hand in terms of,  
10 and which I'm always interested in, and as far as the  
11 mental health response to that officer and to the various  
12 officers who find themselves being shot in these types of  
13 situations. I understand that there's a lot of PTSD  
14 there, and I want to understand what the public  
15 understands. What is that when that officer comes back  
16 online? Is he or she getting treatment? And what does  
17 that treatment look like? And are they given the time and  
18 space to be able to heal, not only physically, but also  
19 mentally from that traumatic episode?

20 CHIEF WHITE: They are. And thanks for asking that  
21 question. Through the Chair. So if an officer is shot,  
22 it's a little bit different than if an officer fires a  
23 shot. But on the same line there is a psychological  
24 evaluation done. They get treatment, there's a peer  
25 support component where they're able to talk through

1 what's happening. They go and see a psychiatrist who  
2 emote about all the different factors that led to the  
3 circumstance, and how they feel about it. And then  
4 instead of putting them right back into where they came  
5 from. They get about a 45-day rotation in the department.  
6 And generally speaking, I try to put them somewhere to do  
7 some job expectation so that, you know, if they want to  
8 do something different down the road in their career, we  
9 will give them a sneak peek at it for 45 days or so.

10 And then we check on them and see if they're ready  
11 to go back in. And if they say yes, we send them back to  
12 patrol if that's where they come from. If they say no,  
13 then we work through some options for them. But there's a  
14 lot of support that's given to the officers, particularly  
15 with the peer support. I'll give James Craig, my  
16 predecessor credit for that peer support program that he  
17 built coming from LA. It's a very valuable tool for the  
18 officers to talk through with a peer what they're going  
19 through, which is very different than talking to someone  
20 who may not have gone through it. So it's a very strong  
21 piece of the work that we do, and we make sure that the  
22 officers are both physically and mentally healthy enough  
23 to go back into patrol.

24 CHAIRPERSON WOODS: Absolutely. And then we also,  
25 finally, my final question is, and that we have been

1 getting a lot of you know, recommendations to us by  
2 members in the community, especially Reverend Blount to  
3 be able to release the video cam of those officer  
4 involved shootings. We have it on the agenda for the  
5 Policy to Committee to take a look at that. And we are  
6 asking that we come to the table and negotiate and see if  
7 we can negotiate something more robust in that particular  
8 area as well.

9 CHIEF WHITE: So, Commissioner, through the Chair, if  
10 I may comment on that.

11 CHAIRPERSON WOODS: Yes.

12 CHIEF WHITE: And I guess I would ask the body to  
13 consider a few things with that. First and foremost, what  
14 are we solving for? And before you answer, let me give  
15 you a few reasons why I ask that. So, you know, as I do  
16 that, the moment I made the decision to do that, because  
17 that's not what we used to do. That is something that I  
18 took on. It was an unprecedented act for transparency.  
19 When you make those decisions to release a body camera  
20 prior to a prosecutor making a decision on a crime, you  
21 in essence could compromise the case. But in the interest  
22 of transparency, I was willing to take that risk and  
23 implement a policy that had never in the history of the  
24 Detroit Police Department been implemented, that within  
25 45-days of using force, I will release the video, the



1 audio, the 911 call, and everything else.

2 Now, prior to that moment, it had never been done. I  
3 simply said, looking at best practices around the country  
4 and other agencies that were doing it, some did it in 90  
5 days, some did it in 30 days. What would be our best path  
6 forward? At maximum, not, not saying that it's always 45  
7 days, but at maximum it would be 45 days. Why 45 days?  
8 Because it takes time to first get all the video, right,  
9 because you have to. There is some video that, yes, we  
10 have on body camera, but there are other perspectives  
11 that we have from other sources. We don't just walk in  
12 and say, Hey, can we have your camera? We have to do  
13 search warrants. So with ring doorbell for example, the  
14 ring doorbell is not wide open and saying, come and get  
15 everything you want. You issue a search warrant for ring  
16 doorbell.

17 They execute the search warrant, and it takes time,  
18 and other sources. The 45-days was a big enough cushion  
19 for us so that we can get all of the facts, all of the  
20 circumstances, and do a presentation for this body as  
21 well as their community, and then permanently affix it to  
22 our social media pages, so people from now to eternity  
23 can download it, click on it, play it on the news without  
24 having to keep going in and changing it. Because when you  
25 have to go in and change it, or you have to add to it,

1 you lose credibility and the process and people no longer  
2 trust it. And the 45-days have been working. To my  
3 surprise, what I thought would probably be met with at  
4 least positivity has turned to no, not good enough. Now,  
5 we've gone from a place where we didn't have anything to  
6 a place where we get everything in 45-days; at maximum  
7 45-days. Now, we want to change it to lesser days with  
8 really no context to how lesser days make sense other  
9 than to say it's less than 45. So then if it's dropped to  
10 40, does that make it work? No, let's do 30. If we drop  
11 to 30, let's do 20. There's so many factors that feed  
12 into the reason why 45 makes sense.

13       Again, I close with what are we solving for if we're  
14 getting it and we're getting it when we never got it. And  
15 if you talk to the prosecutor, she was not a supporter  
16 of... She thought, this is going to hurt some cases. And  
17 she, quite frankly, it could because the same people  
18 looking at the video could actually be at trial. I don't  
19 think it's beloved by the unions, but to their credit,  
20 they understand the need for transparency. I'm not going  
21 to go on record and say that they necessarily support  
22 that piece of it, but they have understood the  
23 department's reaction. And I'm appreciative of that.  
24 Because we understand and they understand that we want to  
25 be transparent to this community, but I need time to give

1 an actual depiction of facts and circumstances. And the  
2 last thing I want to do is put a video up in 20 days, and  
3 then a search warrant comes in that shows a whole  
4 different perspective of what occurred that is not in  
5 that video, and then have to amend that video and lose  
6 the entire credibility of our process.

7 I just don't think that's a good idea. So I would  
8 ask that the board look at all factors. I would ask that  
9 we have further conversation to understand why.

10 CHAIRPERSON WOODS: Yeah. And that's why I would ask  
11 that to have somebody come and negotiate in good faith at  
12 the policy meeting because the Reverend wanted in one  
13 day, you know you know, but the fact of the matter is  
14 that we can discuss these nuances, you know, in a policy,  
15 meaning, and to have a robust conversation. Because I  
16 think all factors need to be considered, as you are  
17 saying. I mean, if you're saying up to 45 days, is then  
18 the language whenever possible that it's not going to  
19 jeopardize anything. But that's to be measured out in the  
20 policy meeting with some really good faith discussion and  
21 negotiation. And that's all I'm asking.

22 CHIEF WHITE: Yes, sir.

23 CHAIRPERSON WOODS: And if there's nothing further.  
24 Just very briefly,

25 COMMISSIONER BERNARD: Very briefly, Mr. Chairman and

1 everybody should be very brief. But anyway, Chief, the  
2 department releases the video. I listened carefully to  
3 your concerns, and they're legitimate. I understand that.  
4 But the department routinely will release video when the  
5 video totally exculpates the officer immediately. Like  
6 when that lady was shot.

7 CHAIRPERSON WOODS: Excuse me, you are out of order.

8 COMMISSIONER BERNARD: On San Juan...

9 CHAIRPERSON WOODS: Point of order.

10 COMMISSIONER BERNARD: In my District. I mean, you  
11 released it immediately.

12 CHAIRPERSON WOODS: What --

13 COMMISSIONER BERNARD: So that the community calms  
14 down. And that makes sense to me. But on the other side  
15 of that, the community wants to know why you can't do  
16 that with all video; like other cities do, Chicago, and  
17 others.

18 CHIEF WHITE: It's not true that other cities do it  
19 in 24-hours.

20 COMMISSIONER BERNARD: I'm sorry, I didn't hear you.

21 CHIEF WHITE: Through the Chair. So again, we just  
22 have to be careful searching for the soundbite, but not  
23 the facts. So when you talk about what other agencies do,  
24 we studied other agencies. And when you talk about the  
25 San Juan cases, are you speaking of the...

1 CHAIRPERSON WOODS: I can't let her talk.

2 CHIEF WHITE: Okay. So that case was very different.  
3 I wasn't the chief, number one. The department didn't  
4 have a policy on video release, a decision, an  
5 independent decision was made at that time because what  
6 was being stated during a time of protest with law  
7 enforcement was that we murdered a person, and that was  
8 not true. And so the chief, which I supported at the  
9 time, made a decision because he had to go forward and  
10 say, here's what happened; this is not the case. And  
11 thank God he did, because there was bad information out  
12 there.

13 And of course, because it was negative, people  
14 believed it. But then if you would remember from that  
15 point forward, we went right back into the same protocols  
16 that we have, and it wasn't released; other subsequent  
17 videos were not released. What I made a decision to do is  
18 to release all videos involving officer involved  
19 shootings, not when the videos exonerate officers, all  
20 videos, okay? Whether the officers had a policy violation  
21 or not, all videos, and at the maximum of 45-days. And  
22 I've already stated in detail why that 45-days is  
23 necessary. I stand behind that. I think it's important to  
24 get it right, not get it fast. We are transparent. You  
25 look at other agencies; I see shootings on the news like

1 you do. And I see a tweet about what happened. I don't  
2 see people standing up at a podium with their entire  
3 command staff flanking them, giving specific details of  
4 date and time and everything else like we do in Detroit.

5 I don't see a follow up with the media sometimes  
6 with this body standing with me discussing what happened  
7 in specific detail and then followed by that 45-days  
8 later, a video that's either supporting or refuting  
9 precisely what I said, the moment the incident happened.  
10 You've also got a command team here in Detroit that every  
11 officer involved shooting; if I'm in town, you see me. If  
12 I'm not, you see, at the very least, an assistant chief  
13 and the multitude of deputy chiefs. Why do we do that?  
14 Not because we all want to be on TV. We want the entire  
15 community to know that we are aware of what happened as a  
16 command team, and that we're going to be transparent  
17 about it. And we all speak in specifics on what we know  
18 now. Is that happening in these other cities? I don't see  
19 it.

20 I see a tweet, I see a press release, somebody got  
21 shot. We'll let you know more later, maybe. And there's  
22 no call for anything there. In Detroit, we do it  
23 differently. And rightfully so. Our community demands it,  
24 and our community deserves it. And I support it. I took  
25 it to another level because I don't want to have these

1 discussions. I don't want to have this view from some  
2 that were not being transparent. So let's now release all  
3 the videos, but I just need time to do it the right way.

4 CHAIRPERSON WOODS: Alright. Thank you very kindly. I  
5 let the record reflect that Commissioner Carter is  
6 present. And I don't know if I stated earlier, let the  
7 record reflect that Commissioner Bernard is present too.  
8 Thank you Chief.

9 CHIEF WHITE: Thank you.

10 CHAIRPERSON WOODS: And I appreciate you, and let's  
11 go to oral communications.

12 MS. UNDERWOOD: Chair, I have four speakers in the  
13 room. We'll start with Minister Eric Blount, Tenay  
14 Hankins, Ms. Joyce E. Jennings and Jahdante Smith.

15 MINISTER BLOUNT: Good afternoon board. I'm Eric  
16 Blount.

17 CHAIRPERSON WOODS: Good afternoon.

18 MINISTER BLOUNT: I'm Minister Eric Blunt from Sacred  
19 Heart Catholic Church. I have no problem speaking to a  
20 grown man face to face. So I'm sorry that Chief Craig  
21 decided to leave before public comment.

22 CHAIRPERSON WOODS: Chief White.

23 MINISTER BLOUNT: Well, one and the same. And that's  
24 one of my points.

25 CHAIRPERSON WOODS: Yes.

1 MINISTER BLOUNT: I had a moment of silence last week  
2 for Marcellus Williams because so many in Detroit could  
3 have ended up... We don't have the death penalty here, but  
4 they could have ended up on life without parole. Michael  
5 Jackson, the young man falsely arrested, charged, and  
6 accused of killing Samantha Woll. The prosecutor decided  
7 not to recharge the case. That should tell you right  
8 there, the police department did not supply enough  
9 evidence in order to charge this man. But yet he's  
10 another black person in this city that gets charged. Who  
11 else am I talking about? An 8-month pregnant black woman.  
12 The false technology arrested her for carjacking. She was  
13 nowhere near it. One of the things we need to ask  
14 ourselves, whether it is Craig or White, they run the  
15 same gamut. So we need to know what the political  
16 violence training that DPD is going through? The last  
17 election, DPD sat idly by why white supremacists banged  
18 on the window of Cobo Hall. They shouted and threatened  
19 poll workers. They took pictures of them, and DPD stood  
20 right by why? Because the chief of police then, James  
21 Craig, showed his full and unabiding support for Donald  
22 Trump. How much more time do I have? I don't have a  
23 clock. I don't know.

24 CHAIRPERSON WOODS: 10 seconds. I'll give you 20.

25 MINISTER BLOUNT: Thank you. Again, we need to know



1 how these handcuffs that OCI has determined should be  
2 investigated. Handcuffing citizens without arresting them  
3 is nothing more than intimidation and brutality against  
4 our citizens. Thank you.

5 CHAIRPERSON WOODS: Thank you.

6 MS. UNDERWOOD: Next, we have Tenay.

7 CHAIRPERSON WOODS: And please advise the citizen on  
8 the time, you guys, and let them know if they have 10  
9 seconds left or 20 seconds left. Next, you may be heard.

10 MS. HANKINS: Before my talk starts, I would like to  
11 know if I can pass something out?

12 COMMISSIONER BERNARD: Can you use your microphone?

13 CHAIRPERSON WOODS: You said you would like to pass  
14 something out to us.

15 MS. HANKINS: Yes, because it's some background  
16 information.

17 CHAIRPERSON WOODS: Yes, ma'am.

18 MS. HANKINS: I don't have copies of everything. This  
19 cover page. I have more copies than the complete packet.  
20 Okay. Thank you very much.

21 Excuse me. Sir, can she have a complete packet, so  
22 she's...

23 MALE SPEAKER: I gave her.

24 MS. HANKINS: Okay, thank you.

25 MALE SPEAKER: I did.

1 MS. HANKINS: Okay. Let me know when I can start.

2 CHAIRPERSON WOODS: Yes.

3 MS. HANKINS: Okay. Good afternoon, everybody. I'm  
4 Tenay Hankins.

5 CHAIRPERSON WOODS: Can you talk into the mic for us,  
6 please?

7 MS. HANKINS: Sorry. Good afternoon everybody. I'm  
8 Tenay Hankins. I appreciate this opportunity to talk. I'm  
9 not going to get into the background reasons why I'm  
10 here. The gentleman is passing out some of the  
11 information and I will find out before I leave how I can  
12 send you all an email of the complete report. The bottom  
13 line. I'm here because I'm going to stay alive, okay.  
14 Officer Parker, NPO, the 10th Precinct, escorted,  
15 trespassed on my property, escorting a person who was  
16 facing felonious assault charges, where she tried to kill  
17 me, threatened to kill me, et cetera, et cetera. And  
18 that's why I'm here today. Because he had no right to  
19 trespass; he had no right to assist this person who  
20 had...The case is already at the prosecutors. And more  
21 importantly, he had no right to help her build an  
22 obstruction that's keeping me from having free access to  
23 my property. And I'm concerned about that because, when I  
24 looked at my ring video, and saw armed officer escorting  
25 the person that said they were going to kill me and my

1 family; firstly, he has no right to put anybody or give  
2 anybody permission to be in my home; second place that  
3 gives her a certain amount of emboldening. You know, in  
4 other words, DPD is supporting her and more importantly,  
5 is going against the other officers. When I put in my  
6 complaint, in terms of being, you know, the bricks and  
7 all of that, to the investigators, they're the ones who  
8 called it a felonious assault and sent it to the  
9 prosecutors. Those officers at the 10th Precinct told me  
10 not to address that lady; do not move the obstruction  
11 without calling them. And if I call them, call 911, tell  
12 them I need an assist. This is the situation. So what I  
13 want to know is how do we prioritize my safety? What do I  
14 do now? I'm ready to get my stuff back on my property  
15 that Officer Parker has helped...

16 MS. UNDERWOOD: Stop time.

17 MS. HANKINS: You know what I'm saying?

18 CHAIRPERSON WOODS: Yes, ma'am. We're going to have  
19 one of the officers to take you and take your concerns,  
20 and address your concerns. Stay with you, right, behind  
21 you.

22 MS. HANKINS: Okay. But can you all put a clock here?  
23 Because I would've started from the back forward. I  
24 thought I had like two minutes or something.

25 CHAIRPERSON WOODS: It was two minutes.

1 MS. HANKINS: Okay. There's no way for me to know.

2 CHAIRPERSON WOODS: Yeah, I know. I understand.

3 COMMISSIONER PRESSLEY: Through the Chair.

4 CHAIRPERSON WOODS: Yes. Hold on, ma'am.

5 COMMISSIONER PRESSLEY: Can we also send with her one  
6 of our investigators? For the complaint against Officer  
7 Parker, I think it was his or her name. Thank you.

8 MS. HANKINS: Can I ask a question?

9 CHAIRPERSON WOODS: Yes, ma'am.

10 MS. HANKINS: To speak with somebody with the  
11 authority to honor what the first officers did. In other  
12 words, to protect me so I can move the obstruction so I  
13 can get my vehicles back on my property.

14 CHAIRPERSON WOODS: Deputy Chief, can you have  
15 someone, you know, a supervisor to speak with her?

16 MS. HANKINS: Okay. Alright, thank you.

17 CHAIRPERSON WOODS: Alright.

18 MS. UNDERWOOD: Through the Chair. Next we have Joyce  
19 E. Jennings.

20 CHAIRPERSON WOODS: Hold on one second before we get  
21 started. Are you good, Commissioner?

22 COMMISSIONER HERNANDEZ: Can't hear it.

23 CHAIRPERSON WOODS: Okay, go ahead. Alright. You may  
24 be heard, ma'am. And then we will give you the 32 second  
25 warning, the 22 second warning. And then a final warning.

1 Thank you. And we apologize that we are having problems  
2 with our technology, and so we'll work with you as best  
3 we can, but they'll help to give you some verbal warnings  
4 to let you know where you are on the clock, okay?

5 MS. JENNINGS: Yes, sir.

6 CHAIRPERSON WOODS: Alright. Thank you.

7 MS. JENNINGS: Good afternoon, everyone today. Thank  
8 you for your presence and your service.

9 CHAIRPERSON WOODS: Thank you.

10 MS. JENNINGS: Good afternoon. If we don't deal, we  
11 don't heal. This month is recognized as domestic violence  
12 awareness month.

13 COMMISSIONER BERNARD: Microphone.

14 MS. JENNINGS: On November 2nd, 2017, my mother,  
15 Patricia Diane Jennings, passed at 64 years old. I'm the  
16 oldest of 6 children, and I grew up in a home impacted by  
17 domestic violence. In my mother's latter years, she was  
18 impacted by elder abuse related to one of my siblings.  
19 When you have grown up in a family where the person who  
20 has been impacted also grooms you to protect the person  
21 that is the violator, and when they finally get to the  
22 point when they need help, it can be confusing. But I've  
23 always been the type of person, I'm not afraid to speak  
24 up about what is righteous. And I would like for our  
25 department to look at how we are looking at domestic

1 violence or elder abuse or sexual abuse reports. Because  
2 I did come to the police department with the  
3 documentation that the hospital as well as Chief Bevans  
4 and his staff from the prosecutor's office helped me to  
5 put together. But at the DPD, the detective asked, do you  
6 really want to do this to your family? But I was coming  
7 at the request of my mother and my grandmother. My mother  
8 is not here today, but before she passed, she said, I may  
9 never live to see the justice that you're fighting for  
10 me. But if you keep fighting, justice will come for  
11 others. So I would just like for us to look as a city,  
12 how we handle as a police department that is to protect  
13 situations where families have been impacted  
14 generationally by different forms of abuse. Thank you,  
15 today.

16 CHAIRPERSON WOODS: Yes, ma'am. And I am sorry for  
17 the trauma. Next.

18 MS. UNDERWOOD: Next we have Jahdante Smith, and then  
19 following Jahdante, we have Ms. Charnita Williams.

20 CHAIRPERSON WOODS: We call Charnita first, Ms.  
21 Williams. You can let the gentleman know as he's outside  
22 or whatever, somewhere. But you come on.

23 MS. WILLIAMS: A couple weeks ago, Deputy Chief Hayes  
24 said that there were no police officers in the shelter  
25 because Chief White had to sign off on it. Unfortunately,

1 that's not the truth. I'm at the Salvation Army now, and  
2 whoever's doing the recruiting, the class has just  
3 graduated. They come from different states. But see, the  
4 problem is they are coming into the state and they are  
5 taking up beds that homeless people should have. Not  
6 someone that can pay rent, start off with 50,000. They  
7 should not even be in that shelter. They are in there  
8 living free with their weapons. There is an issue with  
9 that. Federal buildings; no weapons should be allowed in  
10 there. But like I said, let me talk about my wellbeing  
11 too. I have to deal with a lot of nuts every day, every  
12 time I leave any facility because officers who do not  
13 respect their badge or their oath, whatever the case is,  
14 okay? I am licensed and I live in fear 24 hours a day  
15 when I'm out in this world dealing with these nuts. And  
16 I'll be trying to diffuse the situation, but apparently,  
17 nobody wants to take this seriously. I have been coming  
18 here for over a year and a half. I went to Internal  
19 Affairs, and put this on record too. And I'm going to  
20 continue to talk about this illegal corruption.

21 CHAIRPERSON WOODS: Alright, thank you. Mr. Smith.

22 MR. SMITH: Jahdante Smith for the record. Thank you,  
23 officer. I mean, Commissioner Woods. I wanted to talk  
24 about a few different things. I appreciate the mention of  
25 the contact between the detectives and family members who

1 have murdered relatives. I think it was probably, because  
2 I'm in the room because it's never been talked about  
3 until I started to bring it up. Mothers keeping boots on  
4 the ground, I mentioned this a year ago, and we're still  
5 waiting on our meeting with Chief White. I want to say  
6 it's very interesting that Eva Dewaelsche and Darryl  
7 Woods, our board members of the Detroit Wayne Integrated  
8 Health Network (DWIHN), and now we have Lieutenant Cole  
9 coming out saying that protestors are being monitored.  
10 And now Chief White conveniently wants to move on over to  
11 that board and just escape his scandals that he's created  
12 here.

13 I want to say that this video release needs to  
14 happen when it comes to Sherman Lee Butler just because  
15 this is literally cover up, cover up to cover up. And I  
16 feel like if we ignore it, it's not going to go away.  
17 We're not going to go away. Like my friend Taura Brown,  
18 she is at this point, the queen of FOIA's. And we are  
19 going to get all the information we need, and we are  
20 going to stay putting pressure on you. Also, I just feel  
21 like it's kind of weird to see people who are board  
22 members on several boards sitting here and making  
23 decisions and saying that they're friends with officers  
24 and oh, we have to ask them for permission. You control  
25 the budget; you control what happens. You can suspend



1 officers with or without pay. And it's very, very  
2 interesting to see that we got friendly people here,  
3 especially Officer Woods.

4 CHAIRPERSON WOODS: Your time.

5 MR. SMITH: Officer Woods. I yield my time, whatever.

6 CHAIRPERSON WOODS: All let the record reflect that,  
7 you know, disparaging comments are not tolerated. And  
8 excuse me, sir. It is very disparaging. You came into  
9 this room and threatened me several times and you have  
10 threatened me in other spaces, so please, do not be  
11 disparaging. Thank you. Next person.

12 MS. UNDERWOOD: Next we'll go into Zoom. We have five  
13 commenters, I'm sorry, five speakers. First we'll start  
14 off with Taura Brown, followed by William M. Davis.

15 MS. BROWN: Good evening commissioners. Can you all  
16 hear me?

17 CHAIRPERSON WOODS: Yes, ma'am.

18 MS. BROWN: I just want to say I'm really  
19 disappointed that the chief got up and left before public  
20 comment because I don't know if anybody realizes it's  
21 been 12 weeks, 83 days since Sherman Butler was murdered.  
22 His family is not being updated, the public is not being  
23 updated. We still have not seen an unedited body cam  
24 video, and no matter how they try to spin it, this is an  
25 ongoing investigation. It does not feel like one. And

1 when people are sitting around waiting to hear back about  
2 whether somebody will be held accountable for the killing  
3 of their loved ones. What they don't want to see are  
4 emails of the prosecutor's office taking the day off at  
5 taxpayer's expense to watch the Tigers game at the  
6 office. What they don't want to see are emails going  
7 around the prosecutor's office about how excited they are  
8 about food trucks coming at 10:45 in the morning.

9 We want to know what happened to Sherman Butler. And  
10 although everybody keeps saying we're providing  
11 transparency, absolutely not. I have FOIA'd several  
12 documents, some of which I don't even believe have to do  
13 with Sherman Butler, and they are denied, denied, denied.  
14 And the denial is, oh, we're denying this because it's an  
15 ongoing investigation; and based on what you're  
16 requesting, it may deny somebody the opportunity for a  
17 fair trial. Are they ever going to trial? Because again,  
18 this has taken longer than what it should have taken. And  
19 I don't expect these investigations to be closed  
20 overnight, like Law and Order, but I do expect there to  
21 be some sort of investigation when somebody's been dead  
22 for almost 90 days and their family still does not know.  
23 And I want you all to hear something really quickly.

24 CHAIRPERSON WOODS: Alright, that's time.

25 MS. BROWN: I know I still have time.

1 CHAIRPERSON WOODS: Oh, okay, I'm sorry. Woody, kick  
2 it.

3 MS. UNDERWOOD: 10 seconds.

4 CHAIRPERSON WOODS: Give her 20 seconds.

5 MS. BROWN: And that was Sherman Butler being shot.  
6 And again, we hear the call is inconsistent with what  
7 we've been told, and we want to see the unedited version  
8 of the body cam video. Thank you.

9 CHAIRPERSON WOODS: Thank you. Next.

10 MR. GILMER-HILL: Good evening. Can I be heard?

11 CHAIRPERSON WOODS: Yes, you may be heard.

12 MR. GILMER-HILL: My name is Chris Gilmer-Hill. I'm a  
13 lifelong resident of the city's Second District. I'm  
14 calling once again to urge this board to do something  
15 about the police department's failure to uphold our Air  
16 Quality Ordinance, specifically our trucks idling  
17 ordinance. As I've mentioned several times now, this has  
18 been on the books for about a decade. This ordinance was  
19 passed to protect our right to clean air, which is a  
20 fundamental environmental protection. This is a human  
21 rights and human life issue. Air pollution in Detroit  
22 kills people. This is something that we know. We know  
23 that the overwhelming presence of industrial pollution,  
24 truck pollution, all of these things have a real impact  
25 on people's lives, especially in places like Southwest

1 down in the Sixth District. We know that the presence of  
2 these pollutants in the air causes high rates of asthma.

3 We know that it literally kills Detroiters. We also  
4 know that the Detroit Police Department in 10 years, has  
5 not issued a single citation under the truck idling  
6 ordinance, even though we know that trucks regularly  
7 ignore that and will just sit in our streets and idle  
8 their engine for as long as they please. I'd like to  
9 thank Commissioner Burton for bringing this up a few  
10 weeks ago. I'd like to point out that the police  
11 department still has not given this board an answer as to  
12 why that ordinance has never been enforced, and what the  
13 next step is. And I'd like to remind Chair Woods that  
14 after my initial comment on this, he said to the public  
15 and to the board that he would follow up with the DPD,  
16 and get an answer as to why this hasn't been taken care  
17 of. It's been several weeks and that hasn't happened. I'd  
18 like to urge this board to follow Commissioner Burton's  
19 lead and really press for an answer on this. This is  
20 urgent. I know it's perhaps been a long time, but that  
21 doesn't mean that we need to keep just waiting on this.  
22 We have the opportunity to hold the DPD accountable to  
23 perform the oversight duty that this board is tasked  
24 with, and to get an answer from DPD, and four steps  
25 forward to protect our clean air. Thank you.

1 CHAIRPERSON WOODS: Thank you.

2 COMMISSIONER BANKS: Through the Chair.

3 CHAIRPERSON WOODS: Yes. I'm asking the attorney to  
4 research that ordinance and give us an answer on this  
5 particular ordinance; and give us some feedback on that.  
6 In terms of this Air Quality Ordinance, if Commissioner  
7 Burton is familiar with the particular ordinance that  
8 he's talking about please send an answer to the board  
9 about this. Yes, sir.

10 COMMISSIONER BANKS: Through the Chair.

11 CHAIRPERSON WOODS: Yes, sir.

12 COMMISSIONER BANKS: Through the Chair: It's been  
13 three months now since Sherman Butler's death. DPD have  
14 not followed up with the family about their loved ones.  
15 Can we get some type of clarity and understanding on this  
16 where we get some type of follow up to follow up with  
17 that family with their loved one? It's been three months.

18 CHAIRPERSON WOODS: Deputy Chief.

19 DEPUTY CHIEF STEWART: So with the advent of the  
20 Chief's new unit family, what I did was take this  
21 information down. I know there have been prior  
22 conversations and the family was supposed to have been  
23 reached out to, so I will follow up to ensure that they  
24 are reached out to, and given an update with regard to  
25 this situation. Oftentimes in some of these

1 circumstances, what ends up happening is various  
2 different members from the family reach out. So  
3 oftentimes when you talk about members of the Homicide  
4 Unit, they prefer to talk to one person. They don't want  
5 6 people calling, having to give the same story. So  
6 what'll happen is this one will call and say, I want to  
7 update the other one who didn't talk to me and give me  
8 the update. And then that kind of takes up a lot of the  
9 investigators time. But I'll ensure that the Family Unit  
10 reaches out to them.

11 CHAIRPERSON WOODS: And so, if I may go ahead,  
12 commissioner. We don't know if the family has been  
13 communicated with or not. And so if you can update the  
14 board in terms of where, as far as the status of where  
15 the investigation is at, we would appreciate that.  
16 Because we don't know the level of communication, that's  
17 going on with the families. When you have a variety of  
18 family members and then you have people in the community,  
19 you know, Homicide is not obligated to communicate with  
20 folks in the community about a specific case. You know  
21 they are obligated to communicate with the family member  
22 and it's a designated family, the next of kin. And so  
23 there is some convoluted stuff there. We don't know  
24 exactly what happened, but if you can update this board  
25 as to the status of this investigation. Does that help

1 Commissioner Banks?

2 COMMISSIONER BANKS: Yeah. Now, Mr. Chair, I'll just  
3 go off of what the lady said, the family have not been  
4 reached out to.

5 CHAIRPERSON WOODS: We don't know that.

6 COMMISSIONER BANKS: That's what I was going off of.

7 CHAIRPERSON WOODS: I understand. But we...

8 COMMISSIONER BANKS: I didn't make this up myself.

9 CHAIRPERSON WOODS: Well, I know that. And so I was  
10 just bringing clarity in the sense that we don't know  
11 who's being communicated with. We don't know who Homicide  
12 has communicated with. We don't know the family members.  
13 We know this is Ms. Brown who's communicating with us.  
14 She's a strong, passionate community advocate and which  
15 we respect, you know. But Homicide is not obligated to  
16 communicate with her about their loved one. Now, as far  
17 as when we have an investigation, you know, hopefully we  
18 can be updated on that, as far as with the investigation  
19 and anything that the community can receive, then we can  
20 appreciate that as well.

21 COMMISSIONER BANKS: I got it now. I appreciate it,  
22 Mr. Chair.

23 COMMISSIONER BERNARD: Just quickly Mr. Chairman, I  
24 think the point of the conversation is that you're going  
25 to find out who to communicate with. But the point is

1 that they're entitled to see the video, the Chief just  
2 said under his existing directive, since it's been more  
3 than 45-days. So what we want to make sure of is that the  
4 family, after you determine who that is, and everything,  
5 sees that video, the whole video, unredacted.

6 DEPUTY CHIEF : STEWART Through the Chair, the  
7 Sherman Butler case, if I'm not mistaken, that's the  
8 bailiff shooting, correct?

9 CHAIRPERSON WOODS: Yes.

10 DEPUTY CHIEF STEWART: That is not an officer  
11 involved shooting, ma'am.

12 CHAIRPERSON WOODS: Right.

13 COMMISSIONER BERNARD: Oh, that was the guy with the...  
14 But he was a former officer and all that.

15 CHAIRPERSON WOODS: But still is not an officer.

16 DEPUTY CHIEF STEWART: That's not an officer involved  
17 shooting. That is a criminal case.

18 COMMISSIONER BERNARD: Well, there was a shooting.

19 CHAIRPERSON WOODS: Yes.

20 DEPUTY CHIEF STEWART : Yeah. It's not an officer  
21 involved shooting.

22 COMMISSIONER BERNARD: No. But the officer pulled the  
23 trigger, but it was a shooting and officers were there.

24 CHAIRPERSON WOODS: Through the Chair. Speak through  
25 the Chair.



1 COMMISSIONER BERNARD: I am. And the point of the  
2 matter is, I mean, if you're not shooting me, let's say,  
3 but Chairman Woods shoots me right here. And you have  
4 video of that as an officer. I mean, if the community  
5 wants to see it, what happened? That's all this is; an  
6 officer was present, and videoing at the time. So they  
7 want to see that video.

8 DEPUTY CHIEF STEWART: So I, I understand that. And  
9 again, that does not meet what we have determined an  
10 officer involved shooting the 45-day release of the video  
11 qualifies as what?

12 COMMISSIONER BERNARD: Then we need to change that.  
13 Okay. I got it. We can do it by motion.

14 CHAIRPERSON WOODS: Yes.

15 COMMISSIONER PRESSLEY: Thank you. Through the Chair.  
16 I just wanted to see if I can seek some clarity on the  
17 instruction you gave to the board attorney relative to  
18 the public commenter statement. I don't know if that will  
19 actually address what they're trying to get at, to find  
20 the details of the ordinance. I think what they wanted to  
21 know is whether or not it's actually been enforced by  
22 DPD. If I can remember Commissioner Burton's comments a  
23 few weeks ago, I think it was like, how many tickets have  
24 actually been written under that ordinance? So I think  
25 that's more of a question for DPD to respond to than the

1 board attorney. Now we can get that information, but I  
2 just want to be able to address it. I'm sure the public  
3 comment is going to ask for that information again, just  
4 to clarify.

5 CHAIRPERSON WOODS: Well, absolutely. Any and all.  
6 But you know, I want to know if the ordinance exists. If  
7 I remember correctly, we need to go into the minutes.  
8 They were saying that they don't address air quality  
9 issues, you know, and when we were at the meeting, at the  
10 community meeting. So I want to track down this ordinance  
11 then to see what this law is. And if it is something that  
12 DPD is not enforcing, then we need to have a conversation  
13 about that as well.

14 COMMISSIONER PRESSLEY: Duly noted.

15 COMMISSIONER CARTER: Through the Chair.

16 CHAIRPERSON WOODS: Yes.

17 COMMISSIONER CARTER: It's an idle link. So the  
18 trucks are standing idle wherever in Southwest Detroit,  
19 wherever it is. A group contacted me this week, Southwest  
20 Truck Coalition, and requested a meeting with me with  
21 regards to this specific issue. So I plan to meet with  
22 them next week to see what their concerns are and to talk  
23 about the ordinance that they say has not been enforced  
24 by DPD.

25 CHAIRPERSON WOODS: Okay. Yep.

1 COMMISSIONER HERNANDEZ: Through the Chair. To add to  
2 that, I'd like to know jurisdiction as well, depending on  
3 the ordinance or the item, there are certain items that  
4 state troopers take on as opposed to City of Detroit  
5 police. So, I think I'd like to know that as well.

6 CHAIRPERSON WOODS: You got that Mr. Attorney?

7 ATTORNEY GOSS: Yes. Commissioner. Actually, there is  
8 an ordinance, Section 46-4-81, for prohibition of  
9 commercial vehicles exceeding gross vehicle weight rating  
10 of 8,500 pounds. So there is a statute from the City of  
11 Detroit.

12 CHAIRPERSON WOODS: Yes, sir. Absolutely. So, Deputy  
13 Chief, we want to know again to the Commissioner's point,  
14 how many tickets have been written for a violation of  
15 that ordinance? Are they enforcing this ordinance or are  
16 they ignoring this ordinance? And are there any resources  
17 directed towards making sure that air quality is there,  
18 you know, they're being protected in the City of Detroit,  
19 and I can appreciate Commissioner Carter having this  
20 meeting with this group. And maybe you probably want to  
21 work with her in that group to get the answers there.

22 DEPUTY CHIEF STEWART: So through the Chair. You can  
23 send something to the Chief's Office detailing the  
24 ordinance that you're speaking of so that we can do our  
25 own investigation as well and provide you an answer.

1 CHAIRPERSON WOODS: Yep. And make sure you tag all of  
2 the commissioners on that. Alright, thank you.

3 MS. UNDERWOOD: Through the Chair. I just wanted to  
4 make a correction. The last speaker was Mr. Chris Gilmer-  
5 Hill, and now William M. Davis will be speaking next.

6 CHAIRPERSON WOODS: Alright, thank you. Commissioner  
7 Davis, you may be heard.

8 MR. DAVIS: Hello?

9 CHAIRPERSON WOODS: Yes, sir. You may be heard. Can  
10 you hear?

11 MR. DAVIS: Hello? it was still saying I was muted.  
12 Anyway, can I be heard?

13 CHAIRPERSON WOODS: Okay. Yeah, we can hear you now.

14 MR. DAVIS: Okay. I'd like to start off by saying  
15 just for informational purposes, I'm sure it was an  
16 oversight or a mistake. I frequently pass out, you know,  
17 on Facebook you all have an agenda posted, and it has  
18 some Zoom numbers for people to punch in. The ones you  
19 all have posted for this week are incomplete. It doesn't  
20 have all the numbers, just so that you all could correct  
21 that for the future. Also I would like to make sure that  
22 the board and the department aggressively protect  
23 citizens, starting with the early voting. Because like  
24 when I was on the board, I know there were a number of  
25 incidents the last time a certain person ran. So I wanted

1 to make sure that people are protected in the City of  
2 Detroit, you know, voting at the early voting sites and  
3 at the collection point where the ballots are going to be  
4 counted at. Because that has been a problem and I expect  
5 it will be a problem. So we want to make sure that our  
6 citizens are protected and they feel comfortable voting  
7 because we want to make sure that we have a high voter  
8 turnout in this city. But just for information purposes,  
9 other municipalities enforce the idle trucking ordinance.  
10 Other municipalities have that on the books like Detroit  
11 has for years and they enforce it. Because I used to work  
12 for the City of Detroit's Water Department and we knew  
13 that that was an enforceable thing because we had to be  
14 worried about running our tracks in idle for too long. So  
15 hopefully, you all will be able to do more to help, more  
16 to help to improve the quality of life and air that we  
17 are all breathing. Because that was a special problem  
18 down in Southwest Detroit. So thank you for your time.

19 CHAIRPERSON WOODS: Yes, thank you very kindly. Yes,  
20 we need to stay on top of that for sure. Any other  
21 comments?

22 MS. UNDERWOOD: We have two more speakers. JoAnn  
23 Warwick with the last numbers of 1, 2, 4, and then  
24 following Cynthia Clark.

25 CHAIRPERSON WOODS: You may be heard, Ms. Warwick.

1 Ms. Warwick?

2 MS. WARWICK: Yes. I was just unmuted. Thank you. Can  
3 you hear me?

4 CHAIRPERSON WOODS: Yes, ma'am.

5 MS. WARWICK: Okay. Thank you. My condolences to the  
6 injured officer. I was very happy to know that an officer  
7 actually tried to save the animal. Sorry to hear what  
8 happened. Also, I am very disappointed that Police Chief  
9 White, as he frequently does almost all the time I've  
10 been here, leaves before public comment, which is why I  
11 don't think he should be appointed to the head of DWIHN  
12 because he doesn't care enough to listen to the residents  
13 who come here. And when we get ignored by this body or in  
14 other places, it's not good for people's mental health.  
15 It's not. For example, I've come to this body repeatedly  
16 asking for an investigation into the mistreatment of me  
17 at the Detroit Detention Center. I was told to call the  
18 OCI, and I did. And there's been no follow up. So that's  
19 very bad that I was falsely arrested you know, dragged  
20 through the mud, the cases went on. Because the case was  
21 dragging on, I was denied an opportunity to work for the  
22 Census, No Hablo Español. So the City of Detroit missed  
23 out because I could have got a lot more responses. So I  
24 urged this body to, as I've urged the Office of  
25 Disability Affairs director, to make sure that people at

1 the city have training about trauma and PTSD because a  
2 lot of the things they do downtown, frankly, makes the  
3 job of the police officers a lot harder, especially with  
4 all this gentrification that they are encouraging,  
5 approving, et cetera. I mean, I don't want to see it, but  
6 I would not be surprised if we have another 1967. And  
7 there are some very nice officers, but unfortunately,  
8 there are some that are not so good; and that makes it  
9 difficult for others. Also, somebody cut down a tree that  
10 I owned in part, and there is a MCOLES criminal statute  
11 on it, and the police keep telling me..

12 CHAIRPERSON WOODS: That was her time. Alright, next  
13 speaker, final speaker. What's the name?

14 MS. UNDERWOOD: Ms. Cynthia Clark.

15 CHAIRPERSON WOODS: Ms. Clark, you may be heard.

16 MS. CLARK: Hello?

17 CHAIRPERSON WOODS: Yes, you may be heard.

18 MS. CLARK: Okay. I just want to address jurisdiction  
19 politically because if we address a jurisdiction  
20 politically with the pastor who's representing the  
21 priesthood, it would eliminate a lot of, what the chief  
22 said, a transparency that's not really transparent. And  
23 also a lot of this confusion. We just followed the  
24 supreme law of the land. And I'm talking to you, pastor,  
25 because you represent the Jesuit order that runs this

1 land. You need to present people with the true  
2 constitution because everybody's sitting on the body of  
3 government is politically confused, including the people.  
4 Now they're calling out for political justice. However,  
5 you lead these meetings with these prayers, but you  
6 introduce hell throughout. If somebody's going to be on  
7 the record, you have to give them more than two minutes  
8 to speak because it's, we, the people, our rights have  
9 been converted into benefits and privileges, and you guys  
10 are receiving our rights and our liberties.

11 So as the pastor, I'm addressing you. And also you  
12 need to address every captain of the ship. That means the  
13 lieutenant, all high ranking officers, because they have  
14 these officers out here, these policemen and women out  
15 here on the land that don't know the order of law that's  
16 on the land. So the jurisdiction politically needs to be  
17 addressed because we are under what's called a democracy,  
18 which is contrary to the republic form of government. And  
19 this meeting needs to be re-adjourned. The Constitution  
20 needs to be brought back to the record, and it needs to  
21 be readdressed because the people clearly do not  
22 understand what jurisdiction means. Because if you  
23 clearly understood jurisdiction, you wouldn't be going  
24 back and forth with a body of people who have no  
25 political authority in the first place. So, understand



1 jurisdiction, it covers territories. So, pastor, I need  
2 for you, the next time that we come to any meeting, you  
3 need to bring the truth because you are blindly leading  
4 these people. Hold the prayer and bring the truth and  
5 stand in honor.

6 COMMISSIONER BANKS: Through the Chair.

7 CHAIRPERSON WOODS: Yes.

8 COMMISSIONER BANKS: Who was she talking about,  
9 because you have two pastors on the board, me and...

10 CHAIRPERSON WOODS: And if she's talking to... Yeah.  
11 And we caution citizens that it's not allowed to talk to  
12 any citizen across the mic like that, you know, so we  
13 don't know, but let's go to...

14 DR. JACKSON: The report from the Board Secretary.

15 CHAIRPERSON WOODS: Board Secretary's Report.

16 MS. GARNIER: Excuse me. The incoming information is  
17 included in your binders as listed for the two police  
18 officers, Section A, Section B, Section C is OCI's weekly  
19 inventory report for the dates 9-21 through 9-27. The  
20 announcements are as follows. The next community meeting  
21 is next Thursday, October 10th at 6:30 PM, and it will be  
22 in the 3rd Precinct at Goodwill Industries Career Center,  
23 located 2777 East Grand Boulevard, Detroit 48211. The  
24 following board meetings scheduled to be held here at  
25 Public Safety Headquarters are as follows, Thursday,

1 October 17th, Thursday, October 24th, and Thursday,  
2 October 31st, all at 3:00 PM. The monthly committee  
3 meetings scheduled for the remainder of the month of  
4 October is the Policy Committee Meeting, which is now  
5 scheduled for Tuesday, October 29th, 2024, at 5:00 PM,  
6 here at Public Safety Headquarters. And that ends the  
7 report, sir.

8 CHAIRPERSON WOODS: Okay. New business. We have the  
9 citizen Complaints Committee memorandum.

10 COMMISSIONER PRESSLEY: Thank you. Through the Chair.  
11 Again, in your package, you should find a memorandum from  
12 the Citizens Complaint Committee meeting that was held on  
13 October 1st, 2024. There are no action items to be voted  
14 on this memorandum, and so I won't read it to delay the  
15 time. But again, I'm excited that we are able to continue  
16 the work that the former Chair, Commissioner Banks  
17 started, and again, to refocus our energies on our  
18 citizen complaint reports. And so Mr. Chair, with that, I  
19 thank you for your time.

20 CHAIRPERSON WOODS: Thank you. Policy Committee.

21 DR. JACKSON: Mr. Chairman.

22 CHAIRPERSON WOODS: Yes.

23 DR. JACKSON: You have to ask if the board has any  
24 questions about that report.

25 CHAIRPERSON WOODS: Okay. Thank you all. Any

1 questions? There being no questions, we go to the Policy  
2 Committee report.

3 COMMISSIONER BERNARD: The Policy Committee met on  
4 October 1st, of this week. The board attendees were  
5 myself, Commissioner Dewaelsche, and Commissioner Woods.  
6 There were a number of community attendees, including the  
7 board Secretary and our staff people, the board  
8 Secretary, Ms. Garnier, Ms. Taylor, Administrative  
9 Assistant, Mary Barber, Civilian Oversight Analyst,  
10 Felicia Tyson, our new Policy Manager who just started  
11 this week. Molly Moening was there. Attorney Molly  
12 Moening, she's a postgraduate fellow at the law school.  
13 Captain Tanya Leonard participated from the Office of  
14 Workplace and Community Resiliency, Commander Ryan Connor  
15 also participated from Organized Crime. Lieutenant James  
16 Johnson from the General Assignment Bureau. And Victoria  
17 Camille from District 7, Grand River Community Block  
18 Club. And she also represents the Coalition for Police  
19 Transparency and Accountability. There was a request for  
20 approval of the CIOGS Specification Report for dumping  
21 cameras.

22 There was an extensive discussion led by the  
23 officers in charge of that unit. It was discovered we  
24 have 276 cameras that are actively used for monitoring  
25 dumping activities alongside 250 decoy cameras. So we

1 just set up in the trees to make people think there's a  
2 camera. These cameras are distributed across 75 active  
3 camera locations where there's been dumping in the past.  
4 The bottom line was that the department had requested to  
5 buy, I think, 10 new cameras, costing about \$10,000. And  
6 we are recommending to this board that purchase be  
7 authorized. Secondly, there was a discussion about the  
8 BolaWrap wrap, the thing that wraps around a person that  
9 freezes them in place so they can't move.

10 Again, Attorney Molly Moening was very... I can't see,  
11 I'm sorry. I have my glasses... Was very adroit with  
12 respect to the policy. I did not know, for example, that  
13 the BolaWrap should only be deployed for this part of  
14 your body, the center of your body, never above your  
15 chest or your head, because it can cause blindness. There  
16 are little things in it that attach itself and can pierce  
17 the skin and obviously, your garments. In any event she  
18 did a very good job preparing a proposed policy for us,  
19 and discussing the matter. The final policy will be  
20 prepared for the next meeting, and we will be bringing it  
21 back to this board for approval, and action. Finally,  
22 incidentally, there are like only two or three cities in  
23 the country that use this. So there's not a lot of  
24 information on them. Finally, she also did... Well, it's  
25 about the BolaWrap policy. I think I already discussed

1 that, Mr. Chairman, I don't need to go back over it. So,  
2 the next meeting is scheduled for October 29th. The only  
3 thing that I would want the board's approval on, and  
4 answer in response to our parliamentarian, is that the  
5 board approve their purchase, the department's purchase  
6 of the additional cameras that are only to be used for  
7 dumping purposes.

8 DR. JACKSON: Your motion would be on behalf of the  
9 Policy Committee to authorize the expenditure of \$10,000  
10 to purchase additional cameras, which would then only be  
11 used for and state that. But it's important that you say,  
12 by direction of the Policy Committee, because this is not  
13 your personal motion; it is the committee's motion. And  
14 that distinction is important. And as I have trained you,  
15 when a motion is being brought by a committee of more  
16 than one person, no second is required.

17 CHAIRPERSON WOODS: That's right, you trained us  
18 well.

19 DR. JACKSON: Motion coming from the Policy  
20 Committee, by direction of the Policy Committee.

21 CHAIRPERSON WOODS: Can we have a discussion before  
22 the...

23 DR. JACKSON: No, you have to have a motion first.

24 CHAIRPERSON WOODS: Okay. Yes, ma'am.

25 COMMISSIONER BERNARD: The motion is that the Policy

1 Committee would like the board to approve the purchase of  
2 the 10 additional cameras at a cost of \$10,000.

3 DR. JACKSON: Madam Commissioner, I would urge you,  
4 because you stated it, that would be used for your  
5 specific purposes. That's an important part of that  
6 motion.

7 It can't be divided because it's an indivisible  
8 issue, but it can be subject to Seriatim, which means you  
9 can take one section and then the other section, I'm not  
10 sure I'm being clear.

11 COMMISSIONER BERNARD: No, I understand.

12 DR. JACKSON: The board can vote on the issue of  
13 authorizing the money and the board can vote on the  
14 discussion of whether or not the purposes for which the  
15 money's being authorized. Those are two separate things.  
16 They're in one motion. You can't divide them, but you  
17 can't take them seriatim. Thank you.

18 COMMISSIONER BERNARD: Thank you.

19 COMMISSIONER DEWAELSCHÉ: Mr. Chair. I just want to  
20 clarify. Madam Chair, there were 20 cameras according to  
21 the report. That's the only thing.

22 COMMISSIONER BERNARD: Okay.

23 CHAIRPERSON WOODS: Thank you. Alright,

24 DR. JACKSON: Now, Mr. Chairman, you need to state  
25 the motion before it can be open for debate.

1 CHAIRPERSON WOODS: Okay. There was a motion made by  
2 the Policy Committee to, let me go there, to approve the  
3 expenditure of \$10,000 for 20 cameras to be used only for  
4 the purpose of dumping.

5 DR. JACKSON: There you go.

6 CHAIRPERSON WOODS: Any discussion? Any objections?

7 All those in favor say aye. COMMISSIONERS: Aye.

8 CHAIRPERSON WOODS: Anyone opposed?

9 COMMISSIONER BURTON: I'm going to vote no, on this  
10 one.

11 CHAIRPERSON WOODS: Okay.

12 DR. JACKSON: Motion carried.

13 CHAIRPERSON WOODS: Motion is carried.

14 DR. JACKSON: Thank you.

15 CHAIRPERSON WOODS: Yep. Thank you. So we will go  
16 into closed session.

17 COMMISSIONER BANKS: No, we are still into new  
18 business. Right?

19 CHAIRPERSON WOODS: It's on the agenda.

20 COMMISSIONER HERNANDEZ: We're in new business.

21 CHAIRPERSON WOODS: We're operating new business.

22 COMMISSIONER HERNANDEZ: Mr. Chairman.

23 CHAIRPERSON WOODS: Yeah.

24 COMMISSIONER HERNANDEZ: I'll make a motion that we  
25 go into closed session pursuant to Section 8(8) of the

1 Open Meetings Act, MCL 15.268(a). Request for the board  
2 to consider an employee evaluation

3 CHAIRPERSON WOODS: Motion made by Commissioner  
4 Hernandez.

5 COMMISSIONER PRESSLEY: Support.

6 CHAIRPERSON WOODS: Second by Commissioner Pressley.  
7 All in favor. Oh. Any discussion? All in favor say aye.

8 COMMISSIONERS: Aye.

9 CHAIRPERSON WOODS: Anyone opposed? The motion is  
10 carried.

11 DR. JACKSON: You call for a recess so they can...

12 CHAIRPERSON WOODS: This will be a three-minute  
13 recess, or should I make it five or you all good? Anybody  
14 have to relief?

15

16 (Whereupon the Board Entered into Closed Session)

17

18 CHAIRPERSON WOODS: It's October 3rd, 2024. The time  
19 is 5::20. We are back in open session. Please call the  
20 roll.

21 MS. GARNIER: Commissioner Woods - Present.

22 MS. GARNIER: Commissioner Smith - Present.

23 MS. GARNIER: Commissioner Bernard. Present.

24 MS. GARNIER: Commissioner Banks - Present.

25 MS. GARNIER: Commissioner Bell -



1 MS. GARNIER: Commissioner Burton - Present.

2 MS. GARNIER: Commissioner Carter -

3 MS. GARNIER: Commissioner Moore - Excused.

4 MS. GARNIER: Commissioner Hernandez - Present.

5 MS. GARNIER: Commissioner Pressley - Here.

6 MS. GARNIER: Commissioner Dewaelsche - Present.

7 CHAIRPERSON WOODS: We have a quorum. What is your  
8 pleasure, Commissioner Hernandez?

9 COMMISSIONER HERNANDEZ: All right. I'll make a  
10 motion for Chair Darryl Woods to complete and submit the  
11 performance process for the discussed employee

12 COMMISSIONER DEWAELSCHE: Support.

13 CHAIRPERSON WOODS: Motion made by Commissioner  
14 Hernandez for Chair Woods to submit the discuss
