 - A. Presentation Eric S. Poe, Chief Executive Officer of Cure Insurance presented information on the State of Car Insurance in the City of Detroit. The City of Detroit has the highest car insurance rates in the U.S. The car insurance industry uses credit-based insurance scoring, redlining, educational attainment and occupation basis to determine what they are going to charge for car insurance, I have testified twice before Congress. We do not use credit scores at all in our basis for car insurance. Non-police authorized tow companies, or private tow companies; tow 75% of cars towed in Detroit. If a Detroit police officer calls a tow truck, you as a citizen cannot pay more than \$200, per the city ordinance. Advocating DPD educate citizens concerning DPD towing versus private towing to minimize inflated storage and miscellaneous fees and unaffordable rates for towing in the City of Detroit.

- WHEREAS Captain Petty was the deserving recipient of the following awards: Lifesaving Citation and Medal, Chief's Unit Award, Fireworks Award, both Consent Judgment Awards, two Chiefs Merit Awards, Detroit Chamber of Commerce, the Major League Baseball All-Star Recognition Award, the Rosa Parks Funeral Recognition Award, and the Super Bowl XL Recognition Award, as well as numerous letters of commendation from citizens and superiors; and
- WHEREAS These many accolades are only part of a remarkable testament to Captain Petty's outstanding and steadfast performance throughout a career that spanned five decades. During changes in law enforcement and society, Captain Petty tirelessly served the Detroit Police Department, the citizens of Detroit and its neighboring communities for 47 years. He has served the Detroit Police Department and the citizens of the City of Detroit with loyalty, professionalism, integrity and dedication, and is widely respected throughout the law enforcement community as the consummate professional.
