## **RESOLUTION HONORING SERGEANT SHERLEY BLEDSOE**

WHEREAS Sherley Bledsoe was appointed to the Detroit Police Department on January 23, 1978. Upon graduating from the Detroit Metropolitan Police Academy, Officer Bledsoe began her career at the First Precinct; and

The City of Detroit underwent a financial crisis that resulted in the layoffs of more than 1,000 police officers in

1979 and 1980, which interrupted Officer Bledsoe's public service to Detroit but never changed her steadfast commitment to protect and serve the community. Upon her return in 1985, Officer Bledsoe's assignments included the Special Events Section, Sex Crimes Division, and the Armed Robbery and Home Invasion Unit; and

Officer Bledsoe displayed tremendous knowledge and leadership skills, and she was promoted to Investigator on July 24, 1998. Investigator Bledsoe was assigned to the Office of the Chief Investigator, whose sworn staff worked for the Board of Police Commissioners in objective investigations of non-criminal complaints against officers. Her diligence and professionalism impressed the community and her superior officers. On March 1, 2004, she earned promotion to the rank of Sergeant and continued her dedication in improving both the Department and Detroit police-community relations by thoroughly addressing citizen complaints. On

September 14, 2005, Sergeant Bledsoe was assigned to the Western District. On February 2, 2009, she was assigned to the 12th Precinct, where she served until her retirement on September 20, 2024; and

Sergeant Bledsoe was the deserving recipient of the following awards: Chief Citation and Medal, both Consent Judgment Awards, the Ford Fireworks Award, the Major League Baseball All-Star Recognition Award, the Rosa Parks Funeral Recognition Award, and the Super Bowl XL Recognition Award. She also received numerous letters of commendation from citizens and superiors; and

Sergeant Bledsoe played a pivotal role in strengthening the bridge between police, residents, and stakeholders as she tirelessly served the Detroit Police Department and the residents, visitors, and stakeholders of Detroit for more than 40 years. She has served the Detroit Police Department and Detroit community with loyalty, professionalism, integrity and dedication, and is widely respected throughout the law enforcement community as the consummate professional.

#### **NOW THEREFORE BE IT RESOLVED**

That the Detroit Board of Police Commissioners, speaking on behalf of the residents of the great City of Detroit, recognizes and honors the lifelong contributions and commitment to excellence in public service of Sergeant Sherley Bledsoe. Her display of courage and unwavering community spirit has improved the quality of life in our City, and she is deserving of our best wishes in all her future endeavors.
