- A. **Commissioner Pressley** motioned “that the Board of Police Commissioners postpone Item A until our next meeting.” The motion passed.

B. **Chief of Police Interviews**

Chairperson Woods indicated all interviews of candidates for the Chief of Police must be held pursuant to the Open Meetings Act, MCL 15.268(f). Pursuant to the City of Detroit Charter Article 7. The Executive Branch, Chapter 8. Police, Section 7-805, Chief of Police. The following is to occur; the Board of Police Commissioners shall conduct a professional search with an executive search firm to identify candidates for Chief of Police and to provide the Mayor a list of three (3) qualified candidates. TJA Staffing, Inc. have identified candidates as announced at last week's meeting and are listed on today's agenda.

Mr. Tom Adams of TJA Staffing & Associates are present today to assist with this interview process pursuant to the Open Meetings Act, MCL 15.268(f). All interviews of candidates for the Chief of Police will be held today in open session. Support material, instructions and guidelines for the interview process have been received by all commissioners in advance of this meeting. After the interviews pursuant to the City of Detroit Charter Article 7. The Executive Branch, Chapter 8. Police, Section 7.805. Chief of Police. The Board is to select the top three (3) candidates as the Board's qualified list of candidates. The final list of candidates' names will be adopted by the Board in open session, and then submitted to the Mayor for final consideration.

The Board held interviews for Chief of Police for the following candidates: Todd Bettison, Detroit, MI; Joel Fitzgerald, Denver, CO; and Joshua Wallace, Chicago, IL. Candidate's Oakley, and Fear declined their interviews.

- C. **Commissioner Pressley** motioned “that the Board of Police Commissioners go into Closed Session pursuant to the Open Meeting Act, MCL 15.268(f) to consider the qualifications, competence, performance, character, and fitness conditions of appointment employee.” The motion passed.

Commissioner Hernandez motioned “that the Board of Police Commissioner submit the following candidate names to the Mayor for consideration for the appointment to the Chief of Police for the City of Detroit. Pursuant to Section 7.805 of the Detroit City Charter, Todd Bettison, Joel Fitzgerald, and Joshua Wallace.” The motion passed.

Chairperson Woods thanked the Board, Mr. Tom Adams and TJA Staffing, Inc. for the stellar job that they did interviewing dozens of candidates.
