On behalf of the Board of Police Commissioners ("BOPC") Policy Committee, key updates from the committee meeting held Tuesday, May 13, 2025 are as follows:

Board Attendees: Committee Chairperson Linda Bernard and Commissioner Eva Dewaelsche

Community/Committee Attendees: Lydia Garnier-Secretary to the BOPC, Felecia Tyson – BOPC Executive Policy Manager, Deputy Chief Michael Parrish – DPD Professional Development Division, Victoria Camille – Coalition For Police Transparency and Accountability, Molly Moening – Wayne State Law School, Professor Rebecca Robichaud – Wayne State Law School, and Sergeant Sean Hochradel and Jacob Hebner – DPD Domestic Violence Unit

Discussion Items:

- Felecia Tyson, Executive Policy Manager, reported that the <u>backlog of special orders</u> is on track to completion, highlighting strong interdepartmental collaboration and viable community input.
- Sergeant Sean Hochradel led the discussion on the Special Order <u>Domestic Violence Intimate</u> <u>Partner Violence (IPV) Arizona Intimate Partner risk Assessment Instrument System (APRAIS), which</u> <u>is being conducted in the 10th Precinct and the 5th Precinct on a trial basis.</u>

Action Item: The BOPC Committee moved to forward the following seven (7) proposed policy directives to the BOPC Board Meeting, May 15, 2023.

- Directive 102.6: Citizen Complaints
- Directive 201.3: Domestic Violence
- Directive 202.1: Arrests
- Directive 204.7: Special Events And Escorts
- Directive 205.4: First Amendment
- Directive 301.1: Radio Procedures
- Directive 303.5: Uniforms And Appearance

Revisions to the following directives were discussed and agreed upon:

Directive 302.4: Use of Force - Section 304.2-6 "Members are prohibited from attending..." was replaced with "Members shall not be approved to attend..."

Directive 202.1: Arrests – The last paragraph of Section 202.1 (Policy) regarding juvenile offenders will have its passage **bolded**.

Directive 102.6: Citizen Complaints – Section 102.6 – 4.9 (Homicide Task Force) the word "of" was added to the sentence: "The Homicide Task Force shall investigate the criminal aspects of all officer-involved shootings"

The next Policy Committee meeting is scheduled for June 10, 2025 at 5:00 p.m.
