3 COMMISSIONER DEWAELSCHE, PRO TEM: Good afternoon  
4 everybody. Thank you for being here this afternoon. I'd  
5 like to call the Board of Police Commissioners meeting  
6 for June 5th to order, please, and do we have Commander  
7 Chaplain Stanley Mobley.

8 DR. JACKSON: Madam, Pro Tem, if you could please  
9 announce that there is not a quorum.

10 COMMISSIONER DEWAELSCHE, PRO TEM: Yes, ma'am. We do  
11 not have a quorum, so we'll have our invocation and then  
12 go directly to public comment.

13 CHAPLAIN MOBLEY: Good afternoon.

14 COMMISSIONER DEWAELSCHE, PRO TEM: Good afternoon.

15 CHAPLAIN MOBLEY: Yes, I would like to just stand in  
16 agreement with prayer concerning this afternoon's  
17 meeting. Father, we just want to thank you for this very  
18 wonderful and beautiful day just because you bless us. I  
19 pray, Lord, for the authority of those that are  
20 represented here. You said, pray for all men, for all in  
21 authority. And so, father, I pray for your grace, your  
22 mercy. I pray your wisdom, unity, governs each and every  
23 one that has been given so much and too much is given  
24 much is required. I pray, Father God, for this city. I  
25 pray for the leadership therein. I ask Father God, that

1 your grace would be sufficient. And I pray, Father, that  
2 everyone represented here, their families, and all will  
3 walk in your blessing, your provision, and under your  
4 guidance. I thank you for the opportunity this day to  
5 stand up for those who can't stand for themselves, but  
6 stand up for such a great city. We pray this in our Lord  
7 and savior's name, Jesus Christ, amen.

8 COMMISSIONER DEWAELESCHE, PRO TEM: Amen. Thank you  
9 Chaplain. And our chair Darryl Woods is here, and I'm  
10 going to turn the meeting over to him.

11 CHAIRPERSON WOODS: Thank you very kindly. Good  
12 afternoon everyone. As we continue to wait for a quorum  
13 to come in we will go into public comment.

14 MS. UNDERWOOD: Thank you, Mr. Chair. Our first  
15 speakers will be Ms. Sanders, Ms. Lisa Lane, and then  
16 after Ms. Lane, Ms. Fredia Butler. Please state your name  
17 in the mic.

18 MS. SANDERS: Ye. Hello. Honorable Body. Thank you  
19 for affording me this time. My name is Cheryl Sanders and  
20 I've been very active in policing, having drafted what  
21 many across the country call the first of its kind and  
22 policing legislation that would standardize policing  
23 across the nation, but would also allow local authorities  
24 to retain control of very functional parts of policing.  
25 It's been reviewed by constitutional lawyers across the

1 country. And it's being, you know, applauded as that. I  
2 am here today because I am a resident of Detroit. I ran  
3 for mayor in 2009 against Tom Barrow. And today I became  
4 a convicted person. My parents, 93 and 90 years old, left  
5 my home to provide them with care. And in doing so, I had  
6 some siblings who have never done anything for them, who  
7 decided they wanted to take everything they have.

8 My father actually brought the ornamental storm  
9 doors you see here, the black doors in all the houses. He  
10 was responsible for that. So he was a man of means. My  
11 father was assaulted and literally murdered. He was  
12 brought into probate court under the guise of being  
13 incapacitated. And I have a video. He was of an  
14 exceedingly sound mind. My siblings have been a literal  
15 crime ring operating in Detroit. I've got a stack of  
16 police reports that are affiliated with people in the  
17 judicial community that have completely gone unaddressed.  
18 His body, a Korean War vet, was stolen using fraud from  
19 Henry Ford Hospital and a police lieutenant at the 12th  
20 Precinct named it fraud. And guess what? Still nothing  
21 done. Nothing these people do are held accountable for  
22 including going into court today, putting a person on the  
23 stand who wasn't present when police arrested me for  
24 being assaulted.

25 CHAIRPERSON WOODS: Okay. Thank you ma'am. That's the

1 time. And do you have a complaint?

2 MS. SANDERS: A request?

3 CHAIRPERSON WOODS: Do you have a complaint?

4 MS. SANDERS: A Complaint? I do.

5 CHAIRPERSON WOODS: Okay. Alright. And so what would  
6 happen?

7 MS. SANDERS: Come on.

8 CHAIRPERSON WOODS: Excuse me. Excuse me. Sorry. What  
9 will happen is someone from the Office of the Chief  
10 Investigator ---

11 MS. SANDERS: I've been there

12 CHAIRPERSON WOODS: Okay. And so it's on file. And so  
13 it's been investigated? And so we going through the  
14 investigative stage on our end in terms of what we can  
15 do, if you have any complaints against the police  
16 department? As far as the other judicial matters, that is  
17 not under our purview; and we have no authority  
18 whatsoever to deal with any type of criminal cases or  
19 anything of that nature in the court that's dealing with  
20 you and your personal situation.

21 MS. SANDERS: I understand that and I seed the floor,  
22 but before I do, I am asking that my complaints be  
23 investigated. I've been to everybody there is. And I  
24 would like someone in this room to make sure that my  
25 reports are investigated. Because if you're a senior

1 citizen in Detroit, people can take your stuff and kill  
2 you, and there is nothing you can do about it.

3 CHAIRPERSON WOODS: Okay. Thank you very kindly. Next  
4 speaker.

5 MS. LANE: Hello, everyone.

6 CHAIRPERSON WOODS: Hello, how are you doing?

7 MS. LANE: Good. How about yourself?

8 CHAIRPERSON WOODS: Great.

9 MS. LANE: Great. I am the cousin of this wonderful -  
10 --

11 COMMISSIONER BERNARD: I can't hear you.

12 CHAIRPERSON WOODS: Can you talk on the mic for me,  
13 please?

14 MS. LANE: Is this better?

15 CHAIRPERSON WOODS: Thank you.

16 MS. LANE: I said my name is Lisa Lane and I am the  
17 cousin of Jerroll Sanders; and I am here because of all  
18 the complaints that her and I ---

19 CHAIRPERSON WOODS: Speak up a little bit, speak up.  
20 Yeah, that's better.

21 MS. LANE: Okay. My name is Lisa Lane. Hello  
22 everyone. And I am the cousin of Jerroll Sanders, and I  
23 am here with her to address the issues that I would like  
24 to make a complaint with you if there's a forum. If  
25 there's not a forum, who can you direct me to, who's over

1 the chief of investigators? Because I called and I left a  
2 message for Chief Warfield. I have not gotten one call  
3 back. I have called numerous times. We went down to the  
4 office; no response from no one as of yet. That's why  
5 we're here.

6 CHAIRPERSON WOODS: Okay. Well, that's him right  
7 there, and you will have a personal conversation today.  
8 That's within the purview of the Office of the chief  
9 investigator to be able to communicate.

10 MS. LANE: Because ---

11 CHAIRPERSON WOODS: No, you're talking with him  
12 today.

13 MS. LANE: Okay. I'll get a chance to speak with him  
14 today?

15 CHAIRPERSON WOODS: Absolutely.

16 MS. LANE: Awesome. I appreciate it. Thank you for --  
17 -

18 CHAIRPERSON WOODS: Well, I got this. You want to  
19 finish your time? Are you done or your main thing is you  
20 want to be able to talk to the chief investigator?

21 MS. LANE: The purpose of why we're here is for that  
22 specific reason, because I wanted to go into the police  
23 department and make a complaint that all of the  
24 complaints that my family has made have been false  
25 allegations. And so we were trying to reach out to the

1 detectives in the police department of the 12th Precinct.  
2 No one returned our calls. We would come into the office  
3 and ask for lieutenants or whoever the chief commander is  
4 for that day. We're not getting any feedback. It's like,  
5 someone knows someone or, you know, do I have to be a  
6 police officer, like sisters and brothers to get ---?

7 CHAIRPERSON WOODS: Absolutely not. And the assistant  
8 chief is here as well. And he's going to make sure that  
9 someone from the department speaks with you too. And so,  
10 chief investigator, if you can communicate with her. I  
11 would want you to talk to her personally and to --- you  
12 go with them first and then you will be able to have a  
13 conversation with the chief investigator himself.

14 I appreciate it.

15 Okay. Thank you.

16 MS. LANE: Thank you for your time.

17 DR. JACKSON: You have a quorum, Mr. Chairman?

18 FEMALE SPEAKER: James Darrell. Okay, great.

19 CHAIRPERSON WOODS: Right, right. Alright. Thank you  
20 so much. We do have a quorum. Please call the roll.

21 MS. GARNIER: Chairperson Woods - Present.

9 CHAIRPERSON WOODS: Thank you very kindly, and we  
10 have a quorum. I entertain a motion for the approval of  
11 the January 5th, 2025, agenda.

12 COMMISSIONER MOORE So move.

13 COMMISSIONER DEWAEELSCHÉ: Second.

14 CHAIRPERSON WOODS: Moved by Commissioner Moore.

15 Second by Commissioner Dewaelsche. Any discussion? All in  
16 favor say aye.

17 COMMISSIONERS: Aye.

18 CHAIRPERSON WOODS: Anyone opposed? The motion is  
19 carried. I entertain a motion for the approval of the  
20 minutes of May 22nd, 2025.

21 COMMISSIONER BERNARD: So moved.

22 COMMISSIONER MOORE: Support.

23 CHAIRPERSON WOODS: Moved by Commissioner Bernard and  
24 supported by Commissioner Moore. Any discussion. All in  
25 favor say aye.

1 COMMISSIONERS: Aye.

2 CHAIRPERSON WOODS: Anyone opposed? The motion is  
3 carried. I entertain the motion for the approval of the  
4 minutes of May 29, 2025.

5 COMMISSIONER MOORE: So moved.

6 Moved by Commissioner Moore, and second by someone?.

7 COMMISSIONER DEWAELSCHÉ: Second.

8 CHAIRPERSON WOODS: Second by Commissioner  
9 Dewaelsche. Any discussion? All in favor, state aye.

10 COMMISSIONERS: Aye.

11 CHAIRPERSON WOODS: Anyone opposed? The motion is  
12 carried. Please introduce the BOPC Staff, Chief of Police  
13 and Elected Officials and Representatives and Community  
14 Leaders

15 MS. GARNIER: Corporation Counsel Conrad Mallett.

16 CHAIRPERSON WOODS: Can you talk into the mic more?  
17 There you go. Thank you.

18 MS. GARNIER: Present today, registered as of this  
19 time, Corporation Counsel Conrad Mallett, Chief  
20 Investigator Jerome Warfield, Drew Fries, Mary Barber,  
21 Teresa Blossom,. Candace Hayes, Artemisia Joshua, Jonya  
22 Underwood, Investigator Jessica Hunter, Dr. Francis  
23 Jackson, Parliamentarian, DPD HR Director Katrina  
24 Patillo. For Police Chief Todd Bettison, Assistant Chief  
25 A.C. Ewing. Our interpreters today are Ms. Yakata and Dr.

1 Stephanie Beatty. Court reporter Don Handyside, Enrique  
2 Jackson, Audio Visual, Charles Henry Media Services  
3 Video. Elected Officials and Representatives today are:  
4 Marie Overall from State Representative Tyrone Carter's  
5 Office. Fredia Butler, second Precinct, Community  
6 Relations President, LaDon Davis, Office of Council  
7 member Fred Durhal III, Lt. Mark Young, President,  
8 Lieutenants and Sergeants Association. CAC Scotty Bowman,  
9 and former Detroit Police Commissioner William Davis.  
10 Those are all that are registered at this time, sir.

11 CHAIRPERSON WOODS: Okay. Thank you very kindly. And  
12 we do welcome Corporation Counsel here. Thank you for  
13 being here, brother.

14 CORPORATION COUNSEL MALLETT: Good to be here. And  
15 I'll be here, Mr. Chairman, until we can find a  
16 replacement for Dante Goss. A good attorney, a good man;  
17 he has found a different position and we're happy for  
18 him. We always like to see young people move up and  
19 forward in the world. And that's just what happened with  
20 him. The city's onboarding process, as you know, is a  
21 torturous process sometimes, but we're working our way  
22 through it.

23 CHAIRPERSON WOODS: Thank you very kindly.

24 COMMISSIONER BERNARD: Mr. Chairman, if I may. I'd  
25 like to welcome attorney and Corporation Counsel, Conrad

1 Mallett personally. And ladies and gentlemen, if you're  
2 not aware he previously served on this board, both as an  
3 appointed commissioner and as an elected commissioner  
4 from my District; District 2. So, welcome again, Conrad.

5 CORPORATION COUNSEL MALLET: I appreciate it.

6 CHAIRPERSON WOODS: Okay. Chief of Police Report.

7 AC EWING: Good afternoon, everyone.

8 CHAIRPERSON WOODS: Good afternoon.

9 AC EWING: Please, Chair, I'd like to introduce my  
10 staff.

11 CHAIRPERSON WOODS: Absolutely.

12 AC EWING: We have Captain Whitmer from the Family  
13 Unit, Sergeant McIntyre, NPOs Matthews Taylor. And  
14 hopefully I didn't forget anybody else back there. Well,  
15 the rest of the CNL NPOs. I am happy to still report as  
16 we have been in the last couple months, individuals have  
17 been reporting out for the chief and the chief himself to  
18 talk about the crime stats. We're still enjoying  
19 decreases in homicides, non-fatal shootings, robberies,  
20 and overall part one crimes. I'll just give you a few  
21 numbers here, homicides currently are down 17% for the  
22 year. That's 14 less homicides than we had the previous  
23 year. Non-Fatal shootings are down 39%. That equates to  
24 94 less shootings, victims. Robberies are down 14%,  
25 approximately 59 less than last year. And a total part

1 one crimes down 11%. But when you look at it, number  
2 wise, it's almost 500; 500 less part one crimes than the  
3 year before. So, we are doing a fantastic job thus far.  
4 That's in combination with the good work for the Detroit  
5 Police Department and the partnership with the community.  
6 Community updates. DPD recently hired, last week, May  
7 27th, a new media director Jasmin Barmore. She started  
8 with DPD on that date. She comes from Channel 7 News.  
9 She's also worked in Detroit Free Press, Detroit News and  
10 New York Times as a commitment for the Chief of Police to  
11 continue to make continuous improvements in the Detroit  
12 Police Department. He's focusing right now on his media  
13 team to make sure it's a professional media team. So we  
14 welcome her aboard and she's been doing a fantastic job  
15 thus far. Chief of Police Todd Bettison participated in  
16 the 7th Precinct abandoned vehicle tour. And what that  
17 essentially is, is looking at the blight in our city,  
18 quality of life issues. And he took with him the First  
19 Assistant Chief Chuck Fitzgerald, Deputy Chief Arnold  
20 Williams, the 7th Precinct Commander. And they did a tour  
21 of the 7th Precinct. They looked at areas that need to be  
22 addressed in terms of abandoned vehicles; and they're  
23 doing that operation right now in the 7th Precinct. And  
24 that's going to be a similar tour that's going to go  
25 around the city to remove the blight within the city.

1           On Tuesday, June 3rd we did Operation Purple Rain. I  
2   don't want to date myself here, but some of you are  
3   Prince fans. It's my understanding that is exactly where  
4   this name came from. But it was a collaborative effort  
5   between the Detroit Police Department and the Wayne  
6   County Sheriff's Department to go after individuals with  
7   these outstanding warrants. And it was highlighted on the  
8   website, the Facebook website for the Detroit Police  
9   Department, in which our new media director kind of  
10   directed that. Fantastic job. If you haven't gotten a  
11   chance to take a look at it, please do. It highlights  
12   what we're looking forward to in 2025 as we continue to  
13   work with our partners across the city. 8th Precinct,  
14   interesting story. We had some officers who were actually  
15   on an unrelated traffic stop for investigation when they  
16   observed four individuals approach a victim on foot armed  
17   with weapons.

18           How these individuals didn't see the police were  
19   right there at the time, I don't know. But it ended up  
20   being the individuals fled into a home, and it became a  
21   barricaded incident. However, after the Metro division  
22   was called upon about 10 minutes after they arrived on  
23   scene, the suspects gave up without any incident. I'm  
24   just highlighting the great work by all the officers of  
25   the 8th Precinct as we continue to try to drive down

1 crime. The 8th Precinct Commander feels strongly, had the  
2 officers not been vigilant in that effort we would've had  
3 another shooting. Tonight, there is a cycling event being  
4 hosted at the 3rd Precinct. So any of you who want to put  
5 on your little shorts and come on out and get wired with  
6 the DPD, the 3rd Precinct; they're going to be starting  
7 at tonight at 6:00 PM right in front of the 3rd Precinct.

8       So if you feel rambunctious, come on out, enjoy  
9 yourselves. On Saturday, June 7th, the 18th Annual  
10 Silence The Violence rally will be held. They'll be  
11 located at 231 East Grand Boulevard. I believe that is  
12 Pastor Barry's event. Come on out. As you know again,  
13 that's just an annual event where we're trying to make  
14 sure that we keep the shootings down and the violence  
15 down in the City of Detroit. So we welcome all the  
16 community to come out and, and take part because this is  
17 a collaborative effort between us and the community.  
18 Wednesday, June 11th, the chief will be hosting another  
19 walk-a-mile Wednesday. It'll be in the 3rd Precinct. The  
20 first two have been very well attended. We're hoping that  
21 the 3rd Precinct is looking to make sure that they have  
22 more people than the past one. And we're going to make  
23 this a competitive nature here. Come on out and join the  
24 chief walk a mile. And I assure you, it is a mile. We are  
25 not going past that. It'll be a mile. Just come on out,

1 I'll be there also. Let's just put your shoes on; it's a  
2 slow walk, the chief engages the public and finds out  
3 what the issues are in those particular areas, and we try  
4 to address those as we do wraparound services.

5 The 4th Precinct, on Wednesday, June 11th, will be  
6 hosting a family fun day at the precinct. It would  
7 include food, beverages, music, and community resources  
8 and bounce houses. So feel free to come out to that. Just  
9 real quickly, I'm pleased to report that there are no  
10 critically or injured individuals in the Detroit Police  
11 Department to report for this week. That's great. And  
12 lastly, recruitment efforts. We're always looking to  
13 recruit and hire for the Detroit Police Department. We  
14 did so over this past weekend at the Detroit Grand Prix.  
15 We took some applications, and there are interested  
16 people in for that. Tomorrow we will be on the RiverWalk  
17 with flyers, and also down at the Motor City Pride  
18 Parade. And, in addition to that, they will be at the 4th  
19 Precinct next week for the family fun day to try to  
20 recruit. So if you know anybody who wants a good job. As  
21 I've always said, as I've been sitting up here, I'll be  
22 40 years this year with the Detroit Police Department. So  
23 if it has worked out for me. I'm sure it'll work out for  
24 others. That is the Police report. Thank you.

25 CHAIRPERSON WOODS: Thank you so much. Can you also



1 just elaborate very briefly on the procedural justice  
2 aspect in terms of mediating disputes with citizens and  
3 the police department who have had grievances with the  
4 police department?

5 AC EWING: Yes, sir. As the chairperson talks about,  
6 many of you have already attended my police community  
7 summits. But within the Detroit Police Department, what  
8 we're trying to do now is we have situations out there  
9 where law enforcement officers have in Congress,  
10 citizens. We don't always have to wait for my summit. If  
11 that happens, we're prepared to mediate that, sit the  
12 individuals down and have the conversation. If I'm able  
13 to pull the body-cam footage and look at it, maybe  
14 there's a situation where we just need to sit down and  
15 have the conversation. It's a teachable moment, not only  
16 for the citizens, but it's specifically for officers of  
17 the Detroit Police Department. You know, a lot of times  
18 you get involved in these situations, you've been on the  
19 job for a very long time. You get a little monotonous in  
20 something, things you do, you're not paying attention to  
21 what you're saying or how you're saying it, right.

22 We want to make sure that the officers, when they're  
23 engaging the citizens, they're making them feel as though  
24 this is a positive engagement. Not something that we're  
25 trying to broad breed the citizens on. So we're prepared

1 to do that in the Detroit Police Department. As a matter  
2 of fact, coming forward in the coming weeks, I'm in  
3 conversation with the chief now to try to make that a  
4 little bit more robust. Yeah. And it'll be a continuing  
5 program that we'll be able to do. Not waiting for the  
6 summits alone, but being able to engage and maybe we can,  
7 you know, correct some of the harm that's been put out  
8 there sometimes when we engage individuals.

9 CHAIRPERSON WOODS: Absolutely. I've brought some  
10 young folks your way and you know, with some challenging  
11 issues and it worked very, very powerfully with them and  
12 others. So thank you for what you're doing. Any  
13 questions? Yes. Commissioner Moore then Commissioner  
14 Bernard.

15 COMMISSIONER MOORE: Thank you, Mr. Chairman. Chief,  
16 you were down in Washington, DC. What was going on down  
17 there?

18 AC EWING: Oh, that was Police Week, sir. That was  
19 Police Week. We had a young officer who was being honored  
20 at Top Cop. He was involved in a shooting and I'm glad  
21 you brought that up, Commissioner, because Top Cop, if  
22 you don't know that particular ceremony, it's a very  
23 emotional ceremony. It involves individuals who have been  
24 involved in shootings and they're honored there, right,  
25 for surviving. Even the ones who didn't survive are

1 honored there too. Kind of a tough pill to swallow. If  
2 you're sitting up there and you're being honored for a  
3 shooting that occurred, but your partner didn't make it  
4 out. So it's, you know, kind of bittersweet. Very  
5 emotional, very nice ceremony. But I don't want to have  
6 to, in my career, the rest of the time that I have on  
7 this job to ever be honored in that way. Because if I  
8 have to stand up there and not have my partner next to  
9 me, that's something I don't think I can do. But Police  
10 Week as a whole, as you know, is where we go and honor  
11 our fallen officers. And I'm glad to announce that we  
12 didn't have anyone go on the wall this year. So that was  
13 a good thing. But unfortunately next year we will have a  
14 few names go on the wall.

15 COMMISSIONER MOORE: And my last question, Chief  
16 deals with, I think it was a \$25 million lawsuit filed  
17 against the department. Are you aware of that?

18 AC EWING: No, I'm not.

19 COMMISSIONER MOORE: Yeah. Channel 4 had a story on  
20 it. I just read the headlines and I was wondering if you  
21 had any details on it.

22 No, I will take a look at it and then get back with  
23 you.

24 Alright, thank you.

25 Permission, Bernard.

1 Just quickly number one, I noticed that you have a  
2 different account. I'm calling it an accounting type  
3 situation for the time that people will be off for  
4 Juneteenth. It's compensatory time. It's not a holiday,  
5 it's a holiday. What's happening with it? I mean, I  
6 couldn't understand from the administrative message that  
7 you've issued. So, police officers as well as civilian  
8 officers. And I assume that what you're doing applies to  
9 the rest of the city in terms of employees.

10 AC EWING: So that's a holiday that we're recognized  
11 as in the City of Detroit. That is an opportunity for  
12 individuals. That's a day that you can either burn, or  
13 earn.

14 COMMISSIONER BERNARD: I thought you don't get paid.  
15 You could get comp time, but it's not like a paid  
16 Christmas.

17 AC EWING: No, it's not overtime.

18 COMMISSIONER BERNARD: Oh, okay. And then secondly,  
19 you mentioned your mediation and arbitration program. I'm  
20 both a certified mediator and an arbitrator, with the  
21 highest settlement rate of anybody for the federal  
22 government in terms of the postal service and so forth.  
23 I'd be happy to help any way I can, or go to any scene  
24 you want me to go to.

25 AC EWING: Oh, it won't be a scene, Commissioner. We

1 would actually have those individuals on neutral ground;  
2 and be inside and just have the conversation.

3 COMMISSIONER BERNARD: That's fine. I'd love to  
4 participate. Thank you.

5 CHAIRPERSON WOODS: Thank you very kindly. Can you  
6 tell us about this appointment?

7 AC EWING: Yes, sir. Proud to. He is here. I was just  
8 making sure he was in the room, sir. The Chief would like  
9 to bring forth the following individual for consideration  
10 for a promotion. Lieutenant Timothy Jones, can you stand  
11 up please? Lieutenant Jones joined the Detroit Police  
12 Department, May 19th, 2008. He brings over 16 years of  
13 experience in law enforcement. Throughout his career, he  
14 has demonstrated strong leadership, dedication, and  
15 versatility in various roles, including Patrols, Special  
16 Operations, Major Crimes, and Homicide. He was promoted  
17 to sergeant in 2018 and then to lieutenant in 2022. He  
18 served in key administrative investigative positions,  
19 including overseeing federal task forces. He holds a  
20 bachelor of science degree in Criminal Justice from  
21 Cleary State. And he's known for his professionalism, his  
22 communication skills, and strong ethic. Based on his  
23 experience and his leadership, we are recommending him  
24 for promotion to the rank of captain.

25 CHAIRPERSON WOODS: Is there upon order. Is there a

1 motion to accept the recommendation of Chief Bettison to  
2 promote to the rank of captain, Lieutenant Timothy Jones.

3 COMMISSIONER MOORE: Mr. Chairman, I'd like to make a  
4 motion to promote Lieutenant Timothy Jones to the rank of  
5 captain.

6 CHAIRPERSON WOODS: Motion made by Commissioner  
7 Moore.

8 COMMISSIONER BERNARD: Second.

9 CHAIRPERSON WOODS: Second by Commissioner Bernard.  
10 Any discussion? All in favor say aye.

11 COMMISSIONERS: Aye.

12 CHAIRPERSON WOODS: Anyone opposed? The motion is  
13 carried. Congratulations to the captain.

14 CAPTAIN JONES: Thank you to this board, to the body,  
15 the citizens and leadership of this department. A couple  
16 of coworkers here who I work with throughout my career  
17 and officers behind me. This is truly and indeed a great  
18 day for me personally and professionally. I'm overwhelmed  
19 with joy. I only came on the job thinking I had to make  
20 it to lieutenant; and because of the leadership here,  
21 they've given me the chance to become a captain and serve  
22 the city in a different capacity. I will not let you guys  
23 down. Thank you.

24 CHAIRPERSON WOODS: Thank you very much. And thank  
25 you for your service to the citizens of the City of

1 Detroit. God bless you.

2 COMMISSIONER MOORE: Through the Chair.

3 CHAIRPERSON WOODS: Yeah.

4 COMMISSIONER MOORE: Do you know where he is going,  
5 AC?

6 AC EWING: I think you'll be pleased, sir.

7 COMMISSIONER MOORE: Okay. I'll find out tomorrow.

8 AC EWING: Just let me say this if I could. Through  
9 the Chair when we did the interviews for this position to  
10 the rank of captain, I had had the pleasure of sitting in  
11 on this interview with the now Captain Jones. And he  
12 reminded me of an incident he'd had, or I shouldn't say  
13 an incident, but an encounter he had with --- what rank  
14 was I then, Captain?

15 CAPTAIN JONES: That time Deputy Chief.

16 AC EWING: Deputy chief, whatever. I went into the  
17 12th Precinct and saw this particular individual and he  
18 wasn't in the attire that he should have been. He met, I  
19 guess, Deputy Chief Ewing that day. And it kind of  
20 changed his whole trajectory of how he carries himself.  
21 So he mentioned it to me in the interview after it was  
22 already over. So just a testament to listening to some of  
23 the things he's been told. And I can see why he's in the  
24 position he is right now because, in the interview, it  
25 was very, very refreshing and I'm glad that you all

1 approved his promotion. So I think you're going to see  
2 some good things out of him.

3 CHAIRPERSON WOODS: Absolutely. Thank you. And we're  
4 looking forward to continuing to bring the numbers down  
5 in the City of Detroit. We chase it after Boston, you  
6 know, so.

7 AC EWING: Yes, sir.

8 CHAIRPERSON WOODS: That being said, oral  
9 communications; back to oral communications.

10 MS. UNDERWOOD: Thank you, Mr. Chair. We're going to  
11 start with Ms. Fredia Butler; after Ms. Butler, Ms.  
12 Bernice Smith, and Lieutenant Mark Young.

13 MS. BUTLER: Good afternoon.

14 CHAIRPERSON WOODS: Good afternoon,

15 MS. BUTLER: Commissioners, when I was working, I  
16 taught students to speak out, but be respectful. I  
17 believe if more of us would speak up and write letters  
18 about what we see or hear of wrongdoing, we would not be  
19 in the condition that we are in. Let's think and be  
20 consistent and persist in working on issues that affect  
21 all of us. We know and I believe, know right from wrong.  
22 Well, what is happening in Washington and around the  
23 world; let's work on those issues that will make a  
24 difference and not contribute to confusion. We can do  
25 that. We need peace and a quality of life for everyone.



1 Commissioners, you have a very difficult job to do and  
2 some people seem to think that this is all. You do what  
3 they see you doing here, your job is going to become more  
4 difficult in days ahead because of what is happening in  
5 Washington DC. You have a life and other  
6 responsibilities, but you chose to serve in your  
7 capacity. Preferably you will make wise and right  
8 decisions. Thank you.

9 CHAIRPERSON WOODS: Thank you very kindly.

10 COMMISSIONER BERNARD: Can we give Mother Bernice a  
11 round of applause, ladies and gentlemen? I think she  
12 turned 92 this weekend.

13 MS. SMITH: No, you are a year too late.

14 COMMISSIONER BERNARD: Oh, please.

15 MS. SMITH: 93.

16 COMMISSIONER BERNARD: Wow! Congratulations. Bless  
17 you.

18 MS. SMITH: And I appreciate you babies, for making  
19 that announcement, because I was very surprised that my  
20 children took me to New York. Can you imagine that? Oh my  
21 God! Don't go there, you guys. It's crazy. And my police  
22 there, they were very kind because I let them know who I  
23 was. So they were very kind. But they got a job on their  
24 hands. We are doing a wonderful job here in the city of  
25 Detroit. And I will forever be grateful to my police

1 department here in Detroit. Believe me, Chicago doesn't  
2 even come close. But anyway, young man, we're glad to  
3 have you among us.

4 CORPORATION COUNSEL MALLETT: Glad to be here, Mother  
5 Bernice.

6 MS. SMITH: It's been a long time since I was running  
7 for Coleman Young's campaign, that's how I met him. His  
8 dad came running in the office all the time, and he was  
9 running behind him. And then he finally became the judge  
10 in the courts. So I was quite proud of him. But it's good  
11 to have you here with us. Now, what I would like to say  
12 is, I was at a luncheon yesterday with one of the  
13 candidates, and it was very nice. It was in our former  
14 police commissioner's building. And you know who that is?  
15 Reverend, what's his name?

16 COMMISSIONER BERNARD: Reverend Holley.

17 MS. SMITH: Holley. Doggone. See, I'm up here in age  
18 now, Holley's building. Alright. It was beautiful. The  
19 seniors there, they were very kind to us, and they let me  
20 speak. Believe it or not, I spoke there. So I told  
21 Reverend Holley that it was a beautiful building, and  
22 that we're very proud of him. But he has to get a mic in  
23 there so he can notify the tenants in there when they're  
24 having some affair, so they'd be able to come down to it.  
25 But what I want to say today is the parents here in the

1 City of Detroit, they're letting their children go amuck  
2 with the crime and hijacking that we're encountering  
3 here. I don't like it. And I will continue to talk about  
4 it because of the fact that no one else other than the  
5 police department has been taking care of it on our  
6 behalf. Like the other day, the police had the four men;  
7 I watch the news every week, every 11 o'clock. Four men  
8 had the police at bay, and they had to bring those big,  
9 what do you call them, the tanks is what I call them..

10 Just think they have to jeopardize their lives  
11 because of these people that we have in our city that's  
12 running around here with guns and want to shoot people  
13 for no reason whatsoever. And I'm tired of it. I want to  
14 live peacefully in this city. We have a good city,  
15 believe it or not. It is a lot better than what Chicago  
16 is. And that's my home. So I can tell you, we are living  
17 good here in this city, but our police, they're in  
18 jeopardy at all times when they put that uniform on. And  
19 I tell them, I appreciate the fact that you're putting  
20 that uniform on because you're taking care of all of us.  
21 And I want you to be careful when you go out there.

22 CHAIRPERSON WOODS: You have 10 seconds left.

23 MS. SMITH: You all, why did you tell me that?

24 CHAIRPERSON WOODS: That was 30 seconds.

25 MS. SMITH: I want my police department to be

1 careful. And I want you to know we love you. We really  
2 do. And we need these parents to pay more attention to  
3 their children if they're living at home, find out who  
4 you're going out with and who you're associating with. I  
5 did it with my five children, so I'm very proud of mine.  
6 But the fact is, we have to do better, especially the  
7 parents. And I thank you so much for the duty that you're  
8 doing, and my respect and all the rest of the citizens  
9 here in the City of Detroit. Just be careful. That's all  
10 I'm asking you to be..

11 CHAIRPERSON WOODS: Thank you so much. Alright, next  
12 speaker.

13 MS. UNDERWOOD: Thank you, Mr. Chair. Our last  
14 speaker in the room would be Minister Eric Blount. Oh my  
15 goodness,

16 CHAIRPERSON WOODS: The lieutenant.

17 MS. UNDERWOOD: Forgive me, Lieutenant Mark Young,  
18 then Minister Eric Blount.

19 LT. YOUNG: God bless you. AC Ewing, thank you for  
20 mentioning the Top Cops. I sit on that board and you  
21 know, from sitting there, our people do the Top Cops,  
22 what you see across the nation do every day and they do  
23 it outstandingly. But if you said at the Top Cops, as we  
24 were reviewing those selections that I get it is very  
25 emotional and it'll change you. And that leads me to my

1 next segment. I would like to thank Captain Whitmer,  
2 Sergeant McIntyre, the family team for their compassion  
3 Saturday for retired Officer Kelvin Patrick. That meant a  
4 lot to their family. You represent it well. But Captain  
5 Whitmer, I would like to thank you personally for what  
6 you do for the men and women that has fallen. You go  
7 above and beyond to make sure that they're represented  
8 and they get everything that's due to them. And let me  
9 tell you something, I appreciate that, and the men and  
10 women of our department do.

11 CAPTAIN WHITMORE: Thank you.

12 LT. YOUNG: The National Law Enforcement Memorial  
13 Wall says, is not how these heroes died, but it's how  
14 they lived. And that was never clearer than Kelvin  
15 Patrick, Mike, Todd, Lloyd, Mike Todd, let's get it  
16 right. Patrick Hill and Walters Johnson. These  
17 individuals suffered; many individuals that represent the  
18 city suffered.

19 When you think about Kelvin Patrick suffering from  
20 29 years paralyzed, if the public saw what I saw on the  
21 video of how this guy lived off duty and on duty, they  
22 would look different before they speak negatively. Are we  
23 perfect? No. And that includes this person here. But I'm  
24 going to tell you something. The compassion of him.  
25 Walter Johnson, Mike Todd, Patrick Hill and a host of

1 others. If you ever saw these individuals off duty, you  
2 will never speak ill of them again.

3 CHAIRPERSON WOODS: Next speaker. Thank you.

4 MINISTER BLOUNT: Good afternoon board.

5 CHAIRPERSON WOODS: Good afternoon. So many issues.  
6 So little time. I've been around here long enough to see  
7 a board lawyer or legal counsel, Jermaine Wyrick, who was  
8 never employed at the city and employed or did work for  
9 the Board of Police Commissioners. So, through the Chair,  
10 Conrad Mallett, I really need you to help us understand,  
11 because for reasonable people, it's viewed that someone  
12 in your position, playing attorney for the board and  
13 working for the city is plaintiff and defendant at the  
14 same time. So that conflict of interest, just nags just  
15 questions the nagging part of it. NACOLES, The National  
16 Association of Civilian and Law Enforcement has a pillar  
17 of its principles, independence from the police  
18 department. So I hope you stay here long enough to help  
19 us understand how it's not a conflict of interest. The  
20 Purple Rain program, along with cutting social services  
21 and nonprofit services like Job Corps that takes  
22 individuals of homelessness, but now is being defunded.  
23 Purple rain, even as I understand it, goes after people  
24 with tether problems. Can we please, as a society, have  
25 our priorities in better shape? Commissioner Bell, his

1 opinion letter really can be summed up by me as just  
2 wanting to get paid for doing less work; for not focusing  
3 on police officer misconduct. These surveillance systems  
4 are just another way of many people describing black  
5 faces in power places that support white supremacy. You  
6 cannot have a system in law enforcement that  
7 discriminates against black people and yet not support  
8 white supremacy. That's all I have.

9 Thank you. Next speaker.

10 MS. UNDERWOOD: Mr. Chair. We're going to go into  
11 Zoom. Our first speaker will be Mr. Roo, followed by  
12 former Commissioner Davis, and "You Matter".

13 MR. ROO: Okay? It was a aka, Mr. Rio, attached to  
14 that name. Now Conrad, you can hear me clearly. Listen  
15 up. Now, the certificate of occupancy for 19327 is down  
16 there in 4 34. For certificate compliance, it needs to go  
17 25-50 feet down the hallway to where they issued the  
18 occupancy certificate. I need that. We need that. Now, it  
19 doesn't matter. It's more important to me than Tanisha's  
20 death. The cover up of the coverup of the coverup. Now  
21 Dante found that out when I talked to him and explained  
22 to him that there's no, it's physically impossible for  
23 Kaneisha to have shot herself like that. Now, I want to  
24 switch to another important matter. And that's Steve  
25 Wasco, that's the director over there at St. Suzanne's

1 Church. St. Suzanne's Resource Center. Cody Rhodes  
2 Resource Center. That's your buddy. You know who I'm  
3 talking about. Now, he needs to call the police.

4 I just was in court, and saw it. It's an affidavit  
5 that's been filed in court by Lorenzy Yoke's attorney.  
6 And what I'm finding out is, Steve is up to no good. I  
7 talked to him personally a couple weeks ago. He said he  
8 didn't have any problem with what he was doing over in  
9 19327. And that's the Veterans housing facility now. So,  
10 Conrad, in your legal expertise, I'm going to need you to  
11 stand down and get out the way. You all have been cheated  
12 on by Janice Winfrey and Gina Avery Walker. And I'm the  
13 one that uncovered it along with Ramon Jackson. That's  
14 why that federal lawsuit is right now with you all cannot  
15 beat in court. That's why you all don't want it to go to  
16 court.

17 CHAIRPERSON WOODS: Thank you. Next speaker.

18 MR. DAVIS: Good afternoon, could I be heard?

19 CHAIRPERSON WOODS: Yes, sir. Good afternoon.

20 MR. DAVIS: I think that there's a need to do more in  
21 the precincts. I think there's a need to do more about  
22 people running red lights, because I see it all the time  
23 all over the city. You know, I think we need to have a  
24 greater emphasis. You know, Downtown is doing great.  
25 Downtown is well protected, but I think there's a need



1 for better protection in the local precincts and local  
2 communities. You know, I think that also, officers need  
3 to be reminded of the duty to intercede, because I keep  
4 hearing reports all over the city. You may not know, but  
5 while I was still an elected police commission, I did a  
6 white paper on the duty to intercede that made national  
7 recognition. But, you know, far too often I keep hearing  
8 reports about officers stopping young black men and  
9 Hispanics and just patting them down asking where they  
10 are going, what they're doing.

11 It's almost like we back to you know the big 4, or  
12 stress, because I'm getting more and more reports of  
13 this. And we shouldn't be going through this. If it  
14 continues, I'm going to make this a national story and I  
15 can easily do that. They would have a need to make sure  
16 things are better in the City of Detroit, especially for  
17 black people. As far too often it looks like, in some  
18 ways some things are regressing. So that's all I have for  
19 today. I'm still watching.

20 CHAIRPERSON WOODS: Thank you. Next speaker.

21 MS. UNDERWOOD: You matter.

22 YOU MATTER: May I be heard?

23 CHAIRPERSON WOODS: Yes, ma'am.

24 YOU MATTER: Okay. Thank you. You know, I've never  
25 said the police officers have an easy job. I met some

1 police officers recently who did some outstanding work in  
2 the community. They weren't in Detroit, though. There are  
3 some nice police officers here, but I've also had the  
4 problem where I call up to report a crime, and people  
5 tell me it's a civil matter and I try to incite the MCL  
6 statute, and they don't even want to hear it and even  
7 hang up. So, you know, if you don't want to take care of  
8 people like that, then people get fed up and leave. And  
9 Commissioner Bernard, I want to tell you what the city  
10 law department is up to. So the city is very disgustingly  
11 using eminent domain to take people's private property  
12 for solar farms, as if this city doesn't have enough  
13 publicly owned land already.

14 And then the city's going around presenting this  
15 false narrative that they're not pushing anybody out of  
16 their homes. Well, that's not true. I spoke to a woman  
17 who told me about the city's bullying, her threatening,  
18 her threatening to cut off services, which I don't think  
19 is legal, and I'm going to be pursuing that because it's  
20 a violation of the Charter. We got somebody here as  
21 Corporation Counsel who's supposed to uphold the Charter  
22 but doesn't uphold it. There are numerous provisions of  
23 the Charter that do not get upheld, like Charter, Section  
24 7-201. The city is supposed to be providing adequate  
25 mental and physical health services. It doesn't provide

1 any mental health services. And that puts all the  
2 officers and the rest of us at risk. You can't rely on  
3 DWHIN. That is not what the Charter says. And no one at  
4 the OCI ever investigated the abuse of me at the jail.  
5 But I know I'm on the do not help list in this city. And,  
6 and so, you know, but you ---

7 MS. UNDERWOOD: The next three speakers will be CAC  
8 Scotty Bowman, caller with the last three digits, 973.  
9 And the last caller will be the caller with the last  
10 three digits. 989.

11 CHAIRPERSON WOODS: Before we go there Chief Warfield  
12 makes sure that's been addressed. Okay? All right. Just  
13 want to make it a matter of record. Alright. Thank you.

14 MS. UNDERWOOD: Mr. Chair, I don't see Scotty Boman  
15 anymore, so we're going to go with 973.

16 CHAIRPERSON WOODS: Okay. Thank you. Next speaker.  
17 Are you there?

18 MS. UNDERWOOD: 973. Can you unmute?

19 973: Yes, can you hear me?

20 CHAIRPERSON WOODS: Yes. Can you identify yourself?

21 MS. GEORGE: Yes. My name is Michelle George. Good  
22 evening to the board. How are you?

23 CHAIRPERSON WOODS: Good evening.

24 MS. GEORGE: To the commissioners. Well, a couple of  
25 comments. Hopefully. I know the Trump administration has

1 put certain things in place where a lot of the consent  
2 decrees have been taken away from stations like Breonna  
3 Taylor and George Floyd. So hopefully it will not  
4 embolden what Mr. Davis was saying, it will not embolden  
5 a lot of officers to take advantage of what the  
6 administration, and the illegal things they're doing. So  
7 hopefully that's not the case. And I also want to say  
8 thanks to the officers, we do respect the officers. A lot  
9 of us that put their lives on the line every day, much  
10 appreciated. 'cause I do see a lot of work they're doing,  
11 especially in mental health. A lot of things are going on  
12 in mental health. Also I found out that the City Council  
13 had passed an ordinance legalizing recreational  
14 marijuana.

15 And so, there was a caller on the phone on the  
16 Mildred Gaddis Show on Sunday, mentioning that they're  
17 vaping on some of the buses. So I also feel that when I  
18 get time and will go before the City Council, that  
19 they're putting a lot of burden on the police with these  
20 things. Because this new marijuana is very dangerous,  
21 almost like this plant they brought in for China, that  
22 fungus plant. So it's really dangerous. And right now we  
23 see the studies where they're causing six times more  
24 heart attacks for 50 and under and also causing strokes  
25 and dementia. So now we have the evidence base that we're

1 seeing, and a lot of times in the medical centers, and I  
2 was speaking to a trauma surgeon the other way, will not  
3 operate on a patient that smokes. They have to stop  
4 smoking because they see a lot of the damage that's being  
5 done when they have to, you know, operate and cut a  
6 patient open and knowing that they smoke. So that's  
7 something the City Council will be reaching out to them  
8 because it's not helping our youth in our city to have  
9 access to all of this weed.

10 CHAIRPERSON WOODS: Thank you.

11 MS. UNDERWOOD: Mr. Chair, our last speaker will be  
12 CAC Scotty Boman?

13 CHAIRPERSON WOODS: Yes, sir.

14 MR. BOMAN: Yeah. Hello. I don't know why you didn't  
15 see me earlier. I've been here all along. Okay. Anyway, a  
16 couple of things. The first thing I want to bring up here  
17 is about the whole fact that we still don't have a board  
18 appointed attorney in here, which we had for a couple  
19 years, and suddenly we don't. The City Charter does  
20 empower the board to have its own attorney, and it should  
21 have its own attorney because the police are appointed by  
22 the mayor's office, who also appoints the Corporation  
23 Counsel. You have a case where if the board is also, in  
24 some cases, having to oversee and investigate police,  
25 that there may at some point be a difference of interest

1 between the corporation counsel and the Board. And for  
2 that reason you need to have a separate attorney to  
3 handle these cases separately.

4 That's the only reasonable way to have it similar to  
5 negotiating a contract. So you have different powers for  
6 different parts of the city government discussed and the  
7 City Charter empowers the board in certain ways. In the  
8 past, the city has actually done a rather poor job of  
9 properly negotiating labor contracts that comply with the  
10 City Charter and rather have contracts that end up doing  
11 end runs around the City Charter. So there's a number of  
12 reasons that we want to have an independent Corporation  
13 Counsel that and we need to go back to that. I urge all  
14 the board members to work toward getting that done. And I  
15 hope those who are seeking election if reelected will  
16 join me in seeking to appoint a board attorney. Thank  
17 you.

18 CHAIRPERSON WOODS: Thank you. Please attention to the  
19 Board of Madam Secretary

20 MS. GARNIER: Under tab 6, the weekly facial  
21 recognition report and the ShotSpotter weekly report.

22 Also announcements of upcoming meetings. The next board  
23 meeting is a community meeting for Thursday, June 12th,

24 6:30 PM The meeting location is Sacred Heart Activities

25 Building 3451 Rivard Street in Detroit, and that's in the

1 7th Precinct. And in July, the community meeting will be  
2 held Thursday, July 10th, 6:30 PM, 6th Precinct at New  
3 Providence Baptist Church, which is located 18211  
4 Plymouth Road in Detroit. Next week, two committee  
5 meetings, Citizen Complaints will be held next Tuesday,  
6 June 10th, 3:00 PM here at headquarters, and the policy  
7 committee will follow at 5:00 PM Tuesday, June 10th. And  
8 that's the report for today, sir.

9 CHAIRPERSON WOODS: Thank you very kindly. We have  
10 some unfinished business. I want to entertain a motion  
11 contingent on the office as Administrative Assistant,  
12 Board of Police Commissioner to Jasmine Espinoza and Dior  
13 Mathis, at an annual salary of \$54,815.50 cents.

14 COMMISSIONER DEWAELSCHE: So moved.

15 COMMISSIONER MOORE: Second.

16 CHAIRPERSON WOODS: Moved by Commissioner Dewaelsche,  
17 and supported by Commissioner Moore. Any discussion? All  
18 in favor, say Aye.

19 COMMISSIONERS: Aye.

20 CHAIRPERSON WOODS: Anyone oppose? White the motion  
21 is carried, we have new business.

22 COMMISSIONER MOORE: Yes, Mr. Chairman. First of all,  
23 I want to thank President Fredia Butler and Michelle  
24 George, because they laid the foundation for this motion  
25 that I'm about to read. Resolution, strengthening and

1 unleashing local control of law enforcement to pursue  
2 accountability and protect constitutional rights and  
3 standing and opposition of executive order number 14288.

4 WHEREAS We are living in a time when human dignity  
5 and human rights are under siege. Executive order number  
6 14288, which authorizes federal police and military  
7 deployment to local communities, conflicts squarely with  
8 established policies and procedures of the Detroit Police  
9 Department, as well as federal law. Various actions by  
10 federal government disregarding co constitutional  
11 protections of free speech due process and access to  
12 legal counsel are occurring with increasing breadth and  
13 frequency; and,

14 WHEREAS: Federal law enforcement officials are  
15 violating minimum standards of conduct expected of every  
16 Detroit Police Department officer, including probable  
17 cause to interfere with the actions of a person, clear  
18 identification of officers during interactions, act of  
19 body-worn cameras, and respectful treatment of people  
20 placed in custody; and,

21 WHEREAS for more than six decades, Detroit has  
22 developed the principles of civilian oversight over the  
23 Detroit Police Department. In 1974, in the aftermath of  
24 Detroit Rebellion and the dismantling of the infamous  
25 Stress Unit, Detroit residents voted for a City Charter



1 amendment that gave broad oversight authority over the  
2 police to an elected board and created the civilian  
3 Detroit Board of Police Commissioners. The Detroit Board  
4 of Police Commissioners is invested with responsibilities  
5 for oversight on policies and procedures, citizen  
6 complaints of abusive behavior, promotions, discipline,  
7 and budgetary matters; and.

8 WHEREAS civilian control over the police have been  
9 reaffirmed in all City Charters since 1974 and is  
10 explicitly affirmed in the City Charter of 2012, which  
11 was approved by a vote of the people and accepted by the  
12 state legislature. The Charter establishes the city's  
13 police forces are in all cases and at all times of strict  
14 subordination to civil.

15 COMMISSIONER BANKS: We just lost our quorum.

16 COMMISSIONER MOORE: That's that.

17 CHAIRPERSON WOODS: Yeah. But finish the resolution.

18 COMMISSIONER MOORE: I'll finish reading. Thank you,  
19 Mr. Chairman. We just can't vote on it. Is that correct,  
20 Madam Parliamentarian?

21 COMMISSIONER BANKS: There will not be any violation  
22 or anything, will there?

23 DR. JACKSON: The issue is that the Open Meetings Act  
24 allows you to discuss matters of interest without making  
25 a decision. So the question for the parliamentarian and

1 for the attorney is whether or not this is not a  
2 resolution that's being presented for action versus an  
3 issue that is being discussed as members of the board.

4 COMMISSIONER MOORE: I can just read it next week.

5 CHAIRPERSON WOODS: Okay.

6 COMMISSIONER BANKS: He is continuing this?

7 DR. JACKSON: The issue of whether or not this is the  
8 matter that's coming before the Board for action. If it  
9 is, then no, it cannot be discussed. If the board is  
10 discussing matters of mutual interest without making a  
11 decision, you can do that. My understanding is that this  
12 is a matter that is being presented for action by the  
13 board under those circumstances. It cannot be presented.  
14 Now, this is the Open Meetings Act and this is the  
15 attorney's playpen.

16 CHAIRPERSON WOODS: Okay. Counsel, he just read  
17 something, you know what I'm saying? We are not voting on  
18 it today. But I get it. He digressed. And so we will  
19 finish it up next week. But I appreciate you presenting  
20 that. Because, you know, the fact of the matter is, we've  
21 been talking diligently with the department under the,  
22 the atmosphere, under the atmosphere that we are in. And  
23 I'm very, very pleased that the chief is committed to  
24 making sure that he's advocating strongly for  
25 constitutional protections of citizens. And this won't be

1 a rogue police department because of what's happening,  
2 nationally. In fact Chief Bettison has testified and  
3 supported the police accountability bills in Lassen in  
4 both the State House as well as in the State Senate to  
5 show his commitment to constitutional policing in the  
6 City of Detroit.

7 And so I'm very, very pleased that he supports the  
8 legislative package statewide. And quite frankly, the  
9 City of Detroit, through his policies, are already  
10 adhering to, I believe 99.9% of the legislation already.  
11 And so, thank you for uplifting that, Commissioner Moore.  
12 And the citizens should know that we would never go back  
13 to pre Coleman Young years. That would not happen ever in  
14 the City of Detroit under our watch or anybody else's  
15 watch, you know, because the community demands excellence  
16 in its policing and we are not perfect, but definitely  
17 would not go back to that, you know? So thank you for  
18 uplifting that. And that being said we are ---

19 DR. JACKSON: I'm sorry. This matter would be under  
20 unfinished business for next week's agenda.

21 CHAIRPERSON WOODS: Yes, ma'am.

22 DR. JACKSON: Thank you, sir.

23 CHAIRPERSON WOODS: Yes, ma'am. You are the boss. We  
24 are out of here. We can't even make a motion. So this  
25 meeting is adjourned.

1 DR. JACKSON: Meeting to adjourn is an order even in  
2 the absence of a quorum.

3 CHAIRPERSON WOODS: Thank you.

4 DR. JACKSON: The OMA requires that a motion of  
5 adjournment be made.

6 CHAIRPERSON WOODS: Yes.

7 COMMISSIONER BANKS: Move for adjournment.

8 COMMISSIONER MOORE: Second.

9 CHAIRPERSON WOODS: Motion made by Commissioner Banks  
10 and second by Commissioner Moore. Any discussion? All in  
11 favor say aye.

12 COMMISSIONERS: Aye.

13 CHAIRPERSON WOODS: The motion is carried. The  
14 meeting is adjourned.
