4. **Chairperson Woods** requested the approval of the Agenda for Thursday, June 5, 2025. The motion was accepted and adopted.

8. **Chief of Police Report.**

**Assistant Chief Eric Ewing** reported on current CompStat Crime/Statistical Data for Violent Crime and Property and recent critical incidents impacting the community. Assistant Chief Ewing reported that DPD recently hired a new media director, Jasmine Barmore. Chief Bettison participated in the 7% abandoned vehicle tour, which is looking at blight in the City of Detroit. A tour of the Seventh Precinct was completed to look at areas that need to be addressed in terms of abandoned vehicles. A similar tour will be occurring across the city to remove blight within the city. On Tuesday, June 3, 2025, the Detroit Police Department did Operation Purple Rain. It was a collaborative effort between Detroit Police Department and Wayne County Sheriff's Department to go after individuals with outstanding felony warrants.

Community Updates from the Precincts are as follows: Eighth Precinct officers on an unrelated traffic stop observed 4 armed individuals approach a victim on foot. Individuals fled into a home and it became a barricaded incident. Metro Division became involved and about 10 minutes after arrival to the scene, individuals surrendered without incident. Third Precinct will be hosting a cycling event, Thursday, June 5, 2025 at 6PM. It is open to the public. On Saturday, June 7, 2025, the annual Silence the Violence Rally will be held at 231 East Grand Boulevard. On Wednesday, June 11, 2025, Chief Bettison will be hosting another Walk a Mile Wednesday in the Third Precinct. The Fourth Precinct will be hosting a family fun day at the precinct on Wednesday June 11, 2025. There are no critically injured individuals in Detroit Police Department this week. Detroit Police Department is always looking to recruit.

**Commissioner Woods** requested that Assistant Chief Ewing elaborate on procedural justice in terms of mediating disputes between citizens and police department. **Assistant Chief Ewing** stated that citizens don't have to wait for the procedural justice summit to mediate their disputes.

**Commissioner Moore** inquired on what was going on in D.C. **Assistant Chief Ewing** stated that it was police week and DPD had a young officer that was being honored at top cop. **Commissioner Moore** also inquired if AC Ewing was familiar with the 25 million dollar lawsuit that was filed against the Department. **Assistant Chief Ewing** stated that he was not aware of that but would look into that and follow up with Commissioner Moore.

**Commissioner Bernard** inquired on the accounting time for officers that will be off on Juneteenth. **Assistant Chief Ewing** stated that officers can either burn or earn but it is not overtime. **Commissioner Bernard** commented on mediation and arbitration program and stated that she would be happy to provide her services. **Assistant Chief Ewing** stated that individuals would be on neutral ground and thanked Commissioner Bernard for her willingness to participate.

**Commissioner Moore**, "Motioned to promote Lieutenant Timothy Jones to the Rank of Captain." The motion passed.
