# **Resolution Honoring Lieutenant Ronald Lockhart**

Whereas,

Lieutenant Ronald Lockhart was appointed to the Department on January 20, 1986. After the successful completion of the Police Academy, he began his admirable career assigned to the Eighth Precinct. He has been assigned to various commands including Internal Controls, Eastern Operations, Tenth Precinct, Training, Technical Support, Communications Operations, Internal Affairs, Northwestern District, Sixth Precinct, and the Eleventh Precinct Investigative Operations Unit. He was promoted to the rank of Sergeant on July 6, 1995, and to the rank of Lieutenant on January 22, 1999. On March 6, 2017, he was assigned to the Second Precinct,

which is his current assignment; and

Whereas, As an officer in his various commands, he was responsible for coordinating efforts to reduce crime and patrol

response times. He was also accountable for increasing positive relationships with the City's communities and

business stakeholders where he served; and

Whereas, During his career Lieutenant Lockhart was the recipient of several meritorious awards, commendations,

citations and letters of appreciation from the citizens of Detroit. He received the All Star Game Award, Rosa Parks Award, Superbowl Award, Confinement Judgement Award, Ford Fireworks Award, and the Conclusion of

Consent Judgement Award; and

Whereas.

He served the Detroit Police Department and the citizens of the City of Detroit with loyalty, professionalism, integrity and dedication. He is highly respected throughout the law enforcement community. Through his sharing of procedural knowledge, skills and techniques he has contributed to the development of many officers.

Now Therefore Be It Resolved

That the Detroit Board of Police Commissioners, speaking on behalf of the citizens of the great City of Detroit, recognizes and honors the lifelong contributions and commitment to excellence in public service of Lieutenant Ronald Lockhart. His display of unwavering community spirit has improved the quality of life for the citizens of Detroit.

## 8. Chief of Police Report.

Deputy Chief Kari Sloan reported on current CompStat Crime/Statistical Data for Violent Crime and Property and recent critical incidents impacting the community. Deputy Chief Sloan reported that last week, Neighborhood Police Officers from the Chief's Neighborhood Liaison patrolled the Twelfth Precinct. Officers addressed blight in the area, abandoned vehicles, parking violations, conducted Project Greenlight business checks and stopped by community barbecues. On Monday, July 21, 2025, Chief of Police and members of the Executive Team appeared before City Council to speak about increasing the fine for parental responsibility for curfew violators. On Wednesday, July 23, 2025, Walk-a-Mile Wednesday took place with DPD and citizens in the Eighth Precinct. Residents were able to talk with the Chief regarding issues in their neighborhood. On Friday, July 25, 2025, a promotional and appointment ceremony will be held at Greater Grace Temple, located at 23500 West 7 Mile in Detroit for the 15 officers that the Board of Police Commissioner recently approved. On Saturday, July 19, 2025, the Department's 1 Day Hiring event was held at the Training Center, located at 6050 Linwood in Detroit. 402 people attended the event, with 352 of those applying to police officer positions.

Commissioner Bernard inquired on the resignation showing on the separation report. The reason for the separation shows the candidate cited 'no family support' as the reason for the resignation. **Deputy Chief Sloan** stated that there are various aids available to students in the academy to provide support them through the academy. Stated that she is unfamiliar with this particular student so couldn't speak on specifics surrounding it.

Commissioner Bell inquired on the homicide rate being down nationally. Deputy Chief Sloan stated that yes that is correct.

**Commissioner Bernard** inquired about the skeletal remains found in the garage of new homeowners that is reported on the 24 Hour Summary Report for July 23, 2025. **Deputy Chief Sloan** stated that the new homeowners of the home found skeletal remains in the garage. Homicide went out to the scene and is currently investigating. No determination has been made at this time on what happened or who it is.
