OCI'S Progress


The Office of the Chief Investigator's strategic focus on legacy cases has resulted in a **46% reduction** in the total case backlog since January of this year.

We are closing cases significantly faster than new complaints are coming in, and we have a clear view of the work ahead.

Our primary goal has been to aggressively clear the backlog while efficiently managing new cases. The data shows we are succeeding.


This represents a net reduction of 598 cases from our active workload. We are outpacing intake by more than 43%.








CLOSED CASES AS OF AUGUST 25, 2025








OPEN CASES AS OF AUGUST 25, 2025




Total Caseload: Reflecting this progress, our total number of open cases has dropped from 2,711 in January to 2,113 today.



CASES RECEIVED VS CLOSED VS INVESTIGATORS – YTD 2024






