Whereas,

Youth sports are vital to ensuring children learn social and life skills that help make them productive and thriving members of society. Organized sports offer positive ways for youth to spend time and energy as they grow up. Competition provides for healthy and structured activities while allowing youth to learn important lessons about fairness, personal responsibility, group dynamics, and sportsmanship, as well as how to handle defeat and victory; and

Whereas,

The Police Athletic League, in partnership with the Detroit Police Department, was founded to provide recreational, educational, and mentoring opportunities for youth achievement. PAL deserves accolades for its organized sports leagues that have benefitted generations of Detroit youth and their families, including the sports and cheer teams for the Eastside Colts; and

Whereas,

The Eastside Colts and their cheer team recently saw their 2025 season suspended by PAL. The teams, which are comprised of youth ages 12 and under, were looking forward to playing with their friends and teammates and having a great season. Sadly, the Colts season was cancelled due to the appalling behavior and actions of adults, who rightly have been suspended. However, the children did nothing wrong and are suffering an unjust punishment. The cancelation of the season is unfair to the youth; it also teaches the wrong lesson about standards of personal behavior and responsibility; and

Whereas,

Research shows youth participation in organized play and learning activities lessen the risks associated with crime, especially the gun violence that is now a major public health threat in Detroit and throughout the United States. Restoration of the Colts season after the installation of new coaches is in the public interest, as well as in the best interest of the impressionable youth and their families. It also aligns with the long-held mission of PAL in serving and uplifting community youth. Therefore be it

The Board of Police Commissioners calls upon the Police Athletic League to work with the Eastside Colts on an equitable resolution to restore the 2025 season for the team by ensuring the Colts have new coaches committed to PAL values for youth sports.

She is currently the president of the Springdale Woodmere Block Club, the treasurer of the Southwest Hope Radio Patrol, and a member of the Fourth Precinct Police-Community Relations Council. In addition, she is the president of Friends of Patton Parks and represents the group on the Detroit Parks Coalition, where she also serves on the subcommittee working for park and greenway safety in partnership with the Detroit Police Department. Because Mrs. Mullens rarely says no when she can help people, the recent Fourth Precinct backpack giveaway saw her distributing items with her great-grandson at her side; and

A retired daycare provider, she is a mentor to youth, chaperones school field trips, and welcomes new families to the neighborhood. She is a great resource to all for information about the community and city ordinances. She also leads by example. Mrs. Mullens purchased the lot next to her home and turned it into a lovely flower garden. When the city sidewalk fell into disrepair and city crews never fulfilled years of promises to fix it, Mrs. Mullens hired a contractor and had the sidewalk repaired at her own expense. **Vice Chair Woods**, on behalf of the Board of Police Commissioners, presented Amulen Rozmus with a \$1,000 scholarship check.

## 9. Chief of Police & 4th Precinct Report.

Chief Todd A. Bettison reported on current CompStat Crime/Statistical Data for Violent Crime and Property and recent critical incidents impacting the community and the 4th Precinct. Community updates include recent activities. On September 4, 2025 Detroit Police Narcotics Unit executed a search warrant in the 10,300 block of Crocuslawn and also the 1400 block of Pinewood. Officers made felony arrests, confiscated cocaine, fentanyl, methamphetamines, white powder, 3 firearms, 1 rifle, 2 handguns and approximately \$1,500 in cash. Chief Bettison spoke about the accidents occurring on Gratiot. Gratiot is a large road, with several lanes, and drivers tend to speed. With Gratiot being owned by the State, Chief Bettison will be submitting requests to have infrastructure put in to address the high accident rate. In the interim, Chief Bettison has increased traffic enforcement on Gratiot and the next enforcement operation will be this weekend. Over the past 2 days, the traffic enforcement unit have wrote 242 speeding tickets and investigated 277 vehicles. Chief Bettison also spoke about the Porta Potty incident involving a young woman being sexually assaulted. The Wayne County Prosecutor's Office denied charges for the sexual assault due to the parties knowing one another and the victim becoming upset when the suspect didn't pay. As additional information is provided on the incident, the victim may be facing charges for making a false felony police report. At this time, the incident is still under investigation. Chief Bettison spoke about the 9-11 incident, how it has impacted our country, communities and first responders lives and together, we will continue to pay our respects to those who lost their lives during that tragedy. Tomorrow, September 12, 2025, 20 student police officers will be graduating. They will be taking their oath and working on the streets of Detroit. September is Suicide Awareness Month. If someone is in crisis, they can call 911 where there are behavioral health specialist embedded in the 911 call center and they can get the citizen the help they need. Additionally, if someone is feelings suicidal, they can call 988.

**Chair Dewaelsche** asked about the department wide phone outage and if everything has been restored to proper working order. **Chief Bettison** stated that everything is good and the outage did not affect 911. All the land lines at the precincts were affected as well as lines in the fire department.

Commander Shelly Holderbaum reported on current CompStat Crime/Statistical Data for Violent Crime and Property and recent critical incidents impacting the 4th Precinct. Commander Holderbaum discussed 4NET, which is the Neighborhood Engagement Team, an intervention aspect dealing with addicted and unsheltered individuals. In conjunction with Judge Shannon Holmes, specialty court programs and resources are provided to this population so as to equip them with better opportunities. 4NET is staffed by one sergeant and four police officers. Since the implementation of the program in August of 2024 there have been 225 referrals to specialty court, 23 narcotic related house closures, 121 felony arrests, 2,166 tickets, 1,061 traffic stops, 3,428 persons investigated, and 1,276 police runs.

Commissioner Carter requested that the Commander or Captain address INS/ICE activities within the 4th Precinct. Captain Gonzalez stated that the Detroit Police Department does not work with the federal entities or inquire about citizen's status. Additionally, community events have been held to educate the public on who DPD is and what their uniforms, vehicles, etc. look like. DPD is not working with or assisting INS/ICE in any way.

**Chair Dewaelsche** inquired if they are noticing a decrease in calls for service due to the presence of INS/ICE. **Commander Holderbaum** stated that she has not noticed a decrease in calls for service.
