 - A. **Resolution Honoring Lieutenant Richard Baker (Posthumously)**

Resolution Honoring Lieutenant Richard Baker (Posthumously)

WHEREAS From an early age, Richard Baker made a personal commitment to serving the community. His dedication led him to join the Detroit Metropolitan Police Academy. Upon graduation, Police Officer Baker was appointed to the Detroit Police Department on August 19, 1968; and

WHEREAS Police Officer Baker excelled in his assignments and exhibited excellence in leadership. He earned promotion to the rank of Sergeant on April 5, 1976 and was assigned to the Narcotics Section until September 1, 1982. Sergeant Baker's assignments also included the Fourth Precinct and the Twelfth Precinct. On July 24, 1998, he earned promotion to the rank of Lieutenant and was assigned to the Eighth Precinct followed by Western Operations and the Eight Precinct again. On July 16, 2002, Lieutenant Baker was assigned to Eastern Operations, where he served until his retirement on July 10, 2004; and

WHEREAS During 34 years of service, he was the deserving recipient of numerous accolades from area residents, as well as praise from peers and superiors who considered him a consummate law enforcement professional; and

WHEREAS Retired Lieutenant Baker never stopped working with the community, always showing the same engaging manner that had helped the Police Department build trust and improve police-community relations. He remained devoted to mentoring young officers, school students, and other youth, including participants in the Police Explorers program. He continued working with community groups and civic organizations, and he positively touched and influenced thousands. Many knew him by his nickname, Cookie, and as a member of the Kappa Alpha Psi Fraternity. He had a tremendous impact on Detroit because of the many strong connections and contributions that he made as a community leader, as well as a law enforcement professional. Sadly, he passed away December 25, 2025. The Board of Police Commissioners extends sincere condolences to his family and friends, who will celebrate his life on January 10, 2026 at 11 a.m. at Greater New Mt Moriah Baptist Church.

B. Resolution Honoring Sergeant Nathaniel Rucker (Posthumously)

Resolution Honoring Sergeant Nathaniel Rucker (Posthumously)

WHEREAS Nathaniel Rucker pursued his interest in serving the community and in criminal justice by applying to the Detroit Metropolitan Police Academy at a pivotal time in the city's history. Upon graduation, he was appointed to the Detroit Police Department on July 14, 1969, and

WHEREAS Police Officer Rucker excelled in his assignments and duties as he served the residents and communities with fairness and integrity. As Detroit still sought reforms to address the racism and police brutality at the root of the 1967 Rebellion, Police Officer Rucker made a priority of providing public safety while building trust and credibility with residents. He exhibited excellence in leadership and earned promotion to the rank of Sergeant on January 14, 1976. Sergeant Rucker's assignments included the Third Precinct from August 15, 1980 to October 22, 1984; and

WHEREAS His next assignment was to the Office of the Chief Investigator, where Sergeant Rucker worked closely with the Board of Police Commissioners for 15 years. The 1974 City Charter had established the Board to provide revolutionary, community-led oversight of the Police Department and gave the new Board robust powers over complaints about police officers. With his dedication to having a Police Department that made all residents proud, Sergeant Rucker diligently worked to achieve the most effective process for taking, investigating, and reporting on complaints about police abuse and policy violations, which helped the Board and Department address problems and make important changes; and

WHEREAS During his 30-year career, Sergeant Rucker was the deserving recipient of numerous accolades from area residents, as well as praise from his peers and superiors who considered him a consummate law enforcement professional. After retiring in 1999, he continued to work with residents and community groups for neighborhood safety and Detroit's progress. Sadly, retired Sergeant Nathaniel Rucker recently passed away. The Board of Police Commissioners extends sincere condolences to his family and friends, who will celebrate his remarkable life on January 12, 2026.

C. Resolution Honoring Police Officer Steven Schmekel (Posthumously)

Resolution Honoring Police Officer Steven Schmekel (Posthumously)

WHEREAS A native Detroiter, Steven Floyd Schmekel found his calling in law enforcement and joined the Detroit Metropolitan Police Academy on April 21, 1986. Upon his graduation, Police Officer Schmekel was assigned to the Seventh Precinct and began his law enforcement career on August 25, 1986; and

WHEREAS Police Officer Schmekel dutifully served the Seventh Precinct for 14 years and became well-known to the residents and stakeholders as he patrolled eastside neighborhoods and strengthened police-community relations throughout the area. On April 26, 2000, he was assigned to the Harbormaster Unit; and

WHEREAS Police Officer Schmekel found the Harbormaster Unit a perfect assignment for his dedication to law enforcement and his deep appreciation for nature. As someone who enjoyed fishing and other outdoor activities, he thrived for 25 years with the Harbormaster. Sadly, Officer Schmekel passed away on duty on December 19, 2025; and

WHEREAS Throughout his 40-year career, Officer Schmekel was the deserving recipient of numerous awards and honors, including the 2005 Major League Baseball All Star Game Award, the Rosa Parks Funeral Award, the NFL Super Bowl XL Award, both Consent Judgement Awards, and the 2014 Ford Fireworks Award. He also received many accolades from metro area residents, as well as praise from his peers and superiors who considered him a consummate law enforcement professional. A memorial service on December 27, 2025 celebrated the life and career of Police Officer Schmekel, and the Board continues to extend sincere condolences to his beloved family, friends, and fellow officers.

Commissioner Carter motioned “to adopt the resolution honoring Police Officer Steven Schmekel (Posthumously).” The motion was adopted.

9. Chief of Police and 12th Precinct Report.

Chief Todd A. Bettison reported on current CompStat Crime/Statistical Data for Violent Crime and Property and recent critical incidents impacting the community. On January 4, 2026 at a Detroit lounge/bar, officers were on the scene for a stabbing incident. During that time, a shooting incident occurred between two individuals, with the suspect striking the victim in the left shoulder. The suspect that committed the shooting is in custody and the Wayne County Prosecutors Office has charged him with first degree felony murder and resisting and obstructing a police officer. The Department is still actively looking for the suspect involved in the stabbing. Over the past week the Department’s Narcotics Unit has executed several search warrants that has led to three felony arrests, seven misdemeanor arrests, recovered cocaine, fentanyl, pills, and a firearm. As it pertains to traffic enforcement, the Department’s Traffic Enforcement Unit was active across the city in the ninth, tenth, and eleventh precincts, focusing on traffic intersections and areas with high numbers of deadly crashes. Officers issues 127 speeding tickets. On January 9, 2026, there will be a graduation ceremony for 26 student policy officers. That will be taking place at Second Ebenezer Church at 2:00 p.m.

Commissioner Carter stated that there were other DPD members present that were not introduced by the Chief of Police. **Chief Bettison** introduced Commander Donna McCord and Captain Timothy Jones. Chief Bettison instructed Commander McCord to introduce the twelfth precincts chaplains and neighborhood police officers. **Commissioner Carter** inquired if Chief Bettison introduced his Chief of Staff. **Chief Bettison** introduced his Chief of Staff Commander Shonda T. Starks. Chief Bettison also introduced Deputy Chief Jacqueline Pritchett.

Commissioner Watts inquired if the downward trend in the crime numbers can be attributed to community engagement. **Chief Bettison** stated absolutely. Various organizations in the City of Detroit have contributed to the downward trend in crime in the city.

Vice Chair Woods inquired if officers are administering Narcan when responding to calls pertaining to an overdose. **Chief Bettison** stated absolutely. Officers are carrying and administering Narcan. **Vice Chair Woods** requested that a report be provided to the Board that shows how many lives have been saved by administering Narcan and how many times it has been administered. **Chief Bettison** stated yes.

Commander Donna McCord reported on current CompStat Crime/Statistical Data for Violent Crime and Property and recent critical incidents impacting the 12th Precinct.

Vice Chair Woods recognized the neighborhood police officers of the twelfth precinct.

Chair Dewaelsche introduced Commissioner Lavish T. Williams as the newly appointed commissioner for District 2. **Commissioner Williams** provided remarks.

Commissioner Camille motioned “that as a Board, we collectively draft and issue a public statement denouncing the use of any law enforcement agency to quash dissent and repress anyone from exercising their first amendment rights and further that this body is committed to explore and use our power that we may have to prevent such activity in Detroit.” The motion passed.
