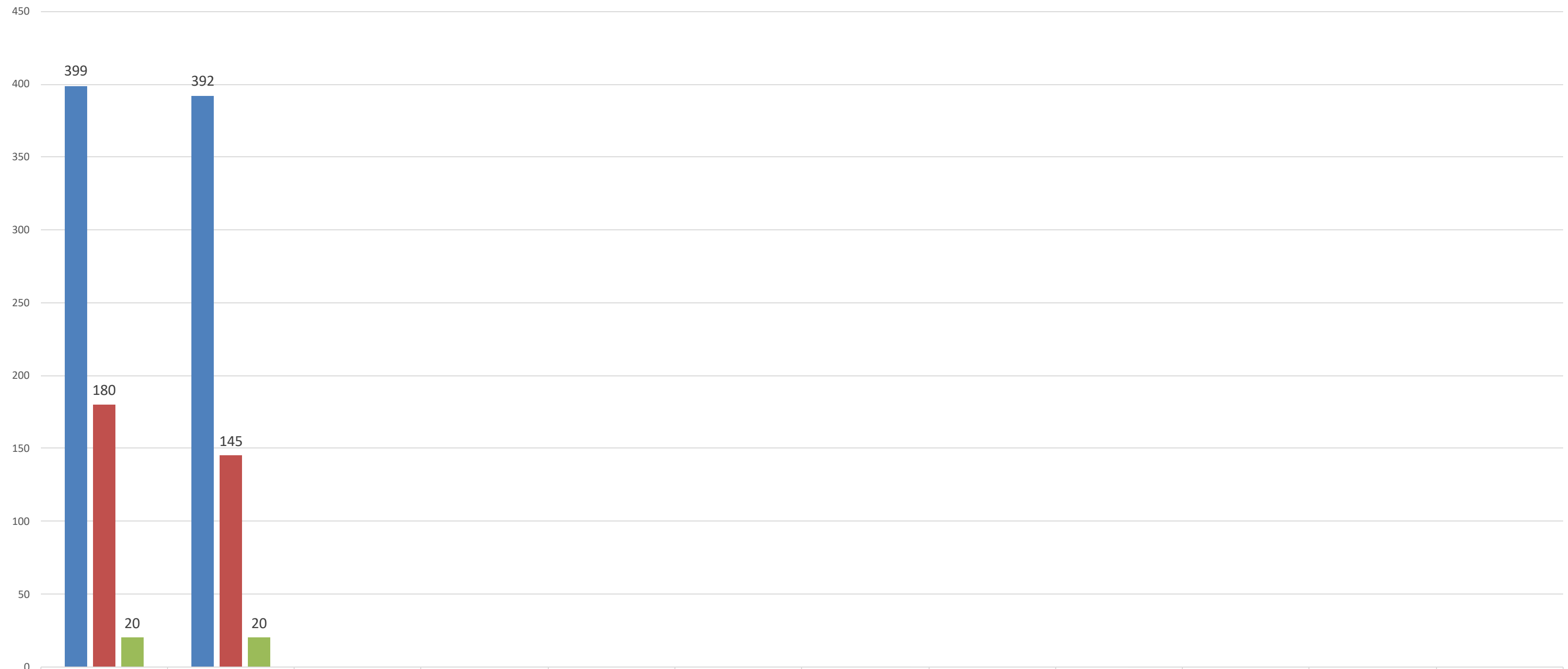


# OCI MISSION STATEMENT

# CASES RECEIVED VS CLOSED VS INVESTIGATORS – YTD 2026



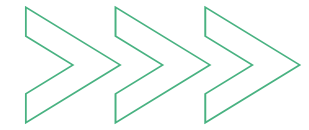

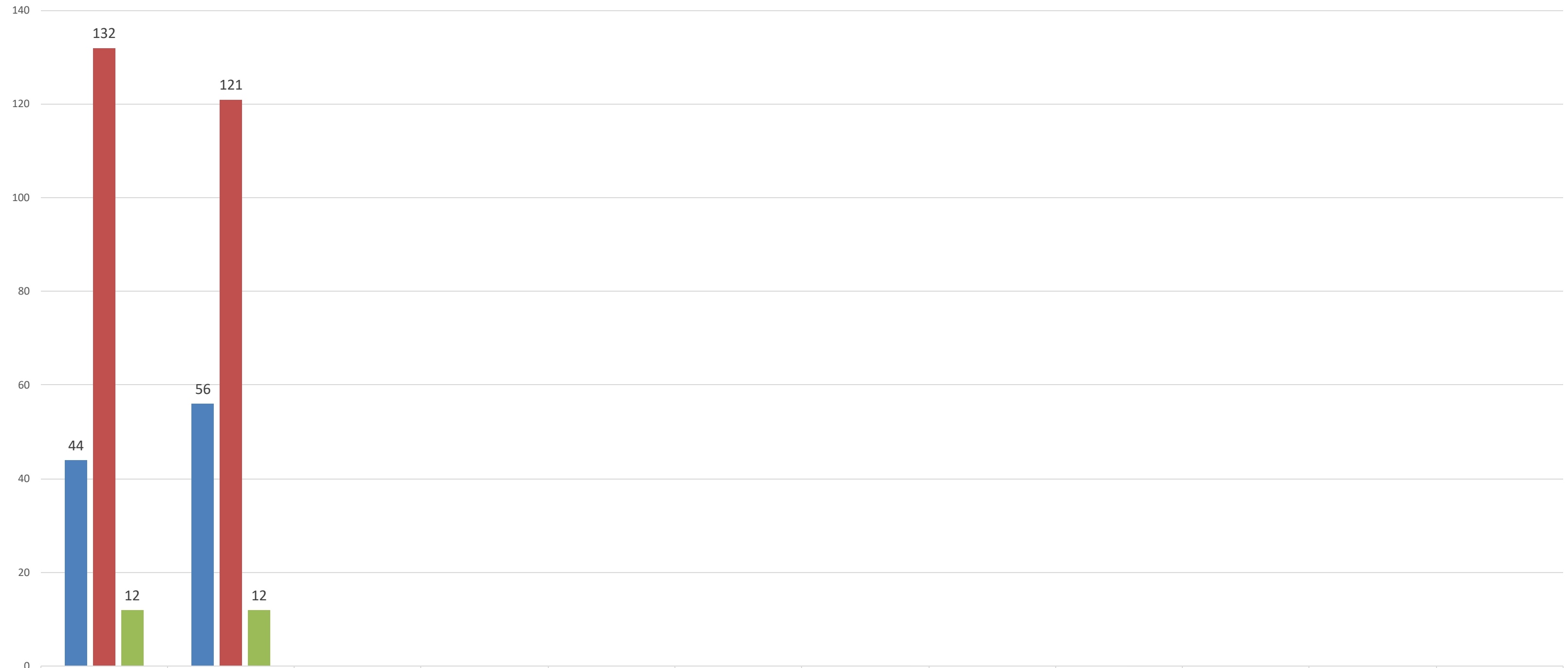

# CASES RECEIVED VS CLOSED VS INVESTIGATORS – YTD 2024



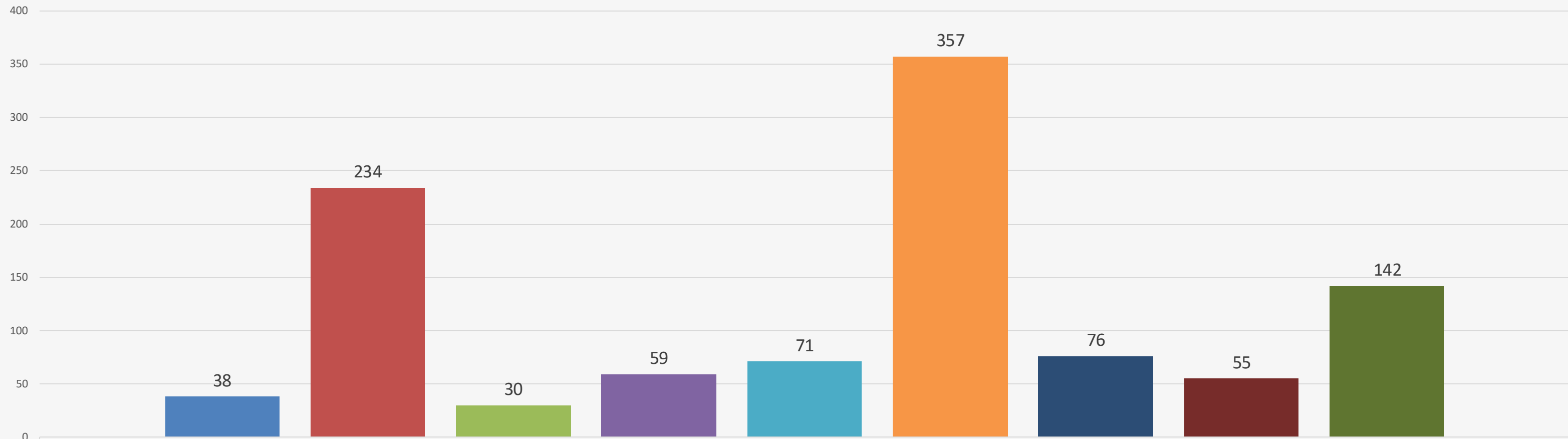

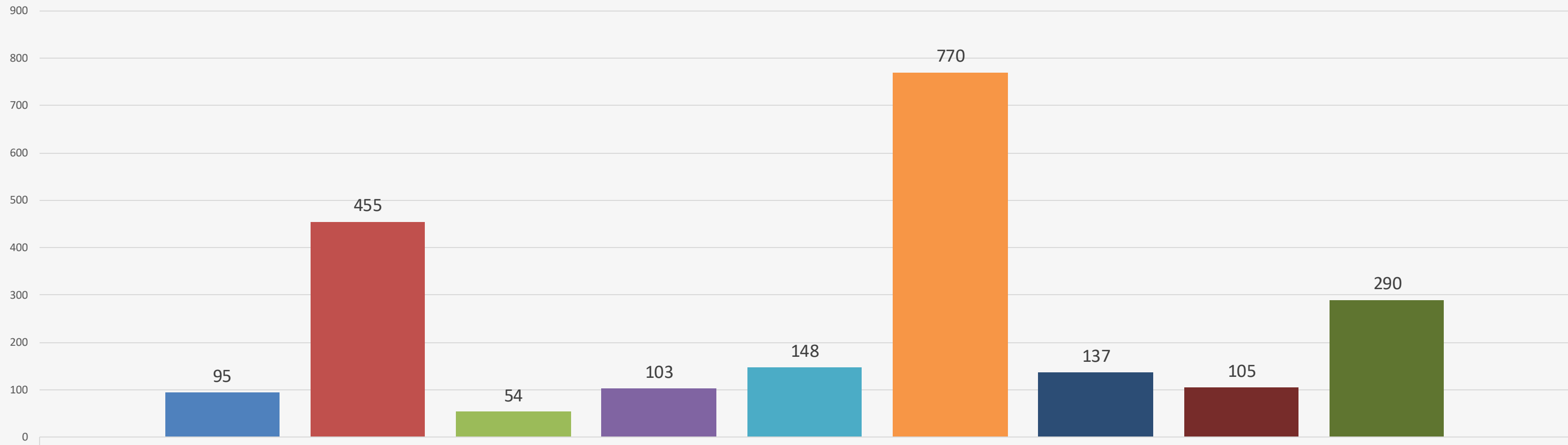
